

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Naracoorte
Racecourse by the Naracoorte Racing Club on
Sunday, 27 June 2021



RACINGS A

Stewards: T. Vanderstok (A/Chairman), G. Rudolph (HT) & D. Holland (F) (Stewards), D. Jonas, J. Patton & J. Forster (Deputy Stewards), Dr D. Goulding (Veterinary Surgeon).

TRACK: Soft 6 (Moist but not badly affected track)
Downgraded to Soft 7 at 12:42 pm retrospective to Race 1.
(Rain affected track that will chop out)

RAIL: Out 3 metres 900 metres to 600 metres, Out 2 metres 600 metres to winning post, Out 1 metre 1600 metres to 1400 metres, Out 1.5 metres in chute.

WEATHER: Fine

RACE 1: GIRLS WEEKEND AWAY BENCHMARK 68 HANDICAP - 1200 Metres

DISSOLUTE (S. Metcalfe) - commenced to weaken from near the 400 metres.

THIS KID ROCKS (G. O'Loughlin) - raced keenly in the early and middle stages of the event.

CHALLICUM (K. Crowther) - near the 400 metres until approaching the 300 metres was awkwardly placed to the inside of DISSOLUTE which commenced to weaken.

RACE 2: WESTERN AG CLASS TWO HANDICAP- 1200 Metres

The start of this event was delayed approximately two minutes.

LUXITORAH (D. Tourneur) - difficult to load. A warning was placed on the filly in relation to its barrier manners. Stood flat-footed and was slow into stride losing several lengths. A warning was also placed on the filly for standing flat-footed. A post-race veterinary examination revealed no visible abnormalities.

PICAROON (G. O'Loughlin) - shifted in on jumping away and contacted SPACE EQUITY. Raced keenly in the early stages of the event.

SPACE EQUITY (S. Logan) - slow to begin. Shortly thereafter, was contacted when PICAROON shifted in.

RACE 3: NUTRIEN AG SOLUTIONS MAIDEN PLATE - 1000 Metres

SANDHILL KNIGHT (L. Halliday) - near the 800 metres was inconvenienced when contacted by DISCO TILMORN, which shifted in. Raced greenly and hung out throughout the event and proved difficult to ride out over the concluding stages. A warning was placed on the gelding in relation to its racing manners. Rider explained, over the concluding stages she had difficulty putting the gelding under full pressure as it continued to hang out and she was aware of DISCO TILMORN racing to her outside. A post-race veterinary examination revealed no visible abnormalities.

COMRADE BILL (J. Opperman) - on jumping away dipped.



RACE 3: NUTRIEN AG SOLUTIONS MAIDEN PLATE - 1000 Metres (Cont'd)

ATTACK THE PIN (S. Logan) - laid out under pressure in the straight. Rider reported the mare did not handle the track conditions in today's event. A post-race veterinary examination revealed no visible abnormalities.

OAMARU POPPY (J. Maund) - jumped away awkwardly. Near the 900 metres momentarily steadied away from the heels of PURDEET which shifted out.

DISCO TILMORN (K. Crowther) - raced greenly in the early stages of the event. Near the 800 metres shifted in onto SANDHILL KNIGHT. Taken wider rounding the home turn when SANDHILL KNIGHT hung out. A post-race veterinary examination revealed no visible abnormalities.

SCENIC HOST (D. Tourneur) - laid in under pressure in the straight.

PURDEET (R. Hurdle) - raced greenly in the early stages of the event. Near the 900 metres shifted out onto OAMARU POPPY which had to be momentarily steadied.

RACE 4: NRC 21/22 MEMBERSHIPS OUT SOON MAIDEN HANDICAP - 1430 Metres

KZSCZOT (J. Maund) - rider was found guilty of a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by J. Maund and noted that he used his whip on six occasions over the last 100 metres.

NED AND POWER (J. Opperman) - raced ungenerously in the early and middle stages of the event.

SANDHILL KHAN (L. Halliday - rider reported the gelding did not handle the track conditions in today's event.

HONOUR DE HERO (J. Eaton) - laid out under pressure in the straight.

KEETTOM (E. Boyd) - raced ungenerously in the early and middle stages of the event. Laid out under pressure in the straight.

MISS MAROON (E. Annells) - slow to begin.

SEE YOU LATER NOW (K. Crowther) - laid in under pressure in the straight.

RACE 5: NARACOORTE SEEDS BENCHMARK 58 HANDICAP - 1000 Metres

REWARDING LAUGHTER (B. Price) - shifted out on jumping away and contacted EARLY PLEA becoming momentarily unbalanced. Rider explained the mare travelled well early and approaching the 500 metres hung out and lost ground. Near the 200 metres shifted out abruptly becoming awkwardly placed on the heels of EARLY PLEA and from this point on, the rider became concerned with the action of the mare and did not ride out his mount in his usual manner. A post-race veterinary examination revealed no visible abnormalities.

EARLY PLEA (D. Tourneur) - hampered on jumping away when tightened between ATUM, which shifted in and REWARDING LAUGHTER, which shifted out. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by D. Tourneur and noted that he used his whip on three occasions over the last 100 metres.

LUCIAN (J. Opperman) - jumped away awkwardly, shifted in and contacted FIRST REWARD.

EMPEROR'S STAR (R. Hurdle) - Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

FIRST REWARD (K. Crowther) - contacted on jumping away by LUCIAN which shifted in. Laid out under pressure in the straight.





RACE 5: NARACOORTE SEEDS BENCHMARK 58 HANDICAP - 1000 Metres (Cont'd)

ATUM (S. Logan) - underwent a pre-race veterinary examination and was passed fit to race. Shifted in on jumping away contacting EARLY PLEA becoming momentarily unbalanced. Near the 150 metres was taken wider by FIRST REWARD which shifted out under pressure.

RACE 6: MARAKI MUSTER BENCHMARK 58 HANDICAP - 2000 Metres

STOGURSEY PRINCE (B. Price) - contacted on jumping when LUCADONIS shifted in. Hung in under pressure rounding the home turn and laid in under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Ms. G. Browne, was advised that a Veterinary Certificate of Fitness is required prior to any future race or trial.

BACK IN ACTION (D. Tourneur) - rolled out in the vicinity of the 1800 metres momentarily inconveniencing GASWORX (NZ).

CHU CHU CHARLIE (A. Chung) - jumped away awkwardly.

GASWORX (NZ) (J. Opperman) - jumped away awkwardly. Momentarily inconvenienced when BACK IN ACTION rolled out in the vicinity of the 1800 metres.

CLEVER MAN (K. Crowther) - resaddled on arrival at the barriers.

PAINT THIS CITY (A. Jordsjo) - near the 300 metres dipped. Rider reported the gelding did not feel comfortable in its action from this point and she did not ride the gelding out in her usual manner. A post-race veterinary examination revealed no visible abnormalities.

BEAR ARMS (S. Logan) - laid in under pressure in the straight.

LUCADONIS (E. Boyd) - shifted in on jumping away and contacted STOGURSEY PRINCE. Inside the 100 metres dipped. Rider reported the gelding did not handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: NRC VOLUNTEERS BENCHMARK 54 HANDICAP - 1430 Metres

OLIVE GROVE (J. Eaton) - A post-race veterinary examination revealed no visible abnormalities.

UNCLE BOB (B. Price) - raced ungenerously in the early and middle stages.

ELIZA'S GOLD (E. Boyd) - slow to begin.

SENTRY GATE (K. Crowther) - laid in under pressure in the straight.

YOUNG LARS (A. Jordsjo) - slow to begin. Near the 50 metres dipped.

HAFU (S. Logan) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.
