

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Bordertown
Racecourse by the Bordertown Racing Club on
Wednesday, 7 July 2021

RACE 1: BORDERTOWN HAULAGE MAIDEN HANDICAP - 1100 Metres

VIPER PILOT (C. Lions) - over-raced in the early stages.

WANDERING EYE (D. Stra) - rider pleaded guilty to charge under AR131(b) in that she failed to ride her mount out to the finish and was fined \$400.

CHEH CHEH CHARLEE (T. Pannell) - approaching the 700 metres shifted in momentarily before being corrected by its rider.

PURDEET (D. Tourneur) - over the concluding stages could not be fully tested when awkwardly placed close to the heels of TEESHA.

FIOURUKI (E. Annells) - at the start was tightened for room between PURDEET, which shifted out on jumping away, and L'ENFANT, which shifted in slightly. Approaching the 700 metres had to be checked and lost ground when tightened for room by L'ENFANT, which shifted in and away from CHEH CHEH CHARLEE, which shifted in momentarily before being corrected by its rider.

L'ENFANT (S. Metcalfe) - approaching the 700 metres shifted in and away from CHEH CHEH CHARLEE, tightening the running of FIOURUKI, which had to be checked.



RACE 2: WOOLSHED INN MAIDEN HANDICAP - 1100 Metres

TARASQUE (A. Jordsjo) - slow to begin. Near the 600 metres had to be steadied away from the heels of FOREXTRA. Approaching the 250 metres had to be checked away from the heels of GREAT REBELLION, which shifted out when insufficiently clear.

SCENIC HOST (D. Tourneur) - jumped away awkwardly and shifted out slightly.

GOLDRHUM (K. Walters) - slow to begin.

FOREXTRA (K. Crowther) - after being crossed by SUGAR GLIDER near the 800 metres, when the pace slackened, the saddle slipped, placing K. Crowther at a disadvantage for the remainder of the event. Rider retired the filly from the event near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

MELISSA KATE (NZ) (L. Halliday) - jumped away awkwardly.

SUGAR GLIDER (E. Annells) - had to be restrained off the heels of EQUA near the 700 metres when the pace slackened. Near the 150 metres had to be checked away from the heels of GREAT REBELLION, which shifted in under pressure when insufficiently clear.

GREAT REBELLION (A. Chung) - near the 900 metres had to be steadied away from the heels of EQUA, which shifted out slightly. Approaching the 250 metres shifted out when insufficiently clear of TARASQUE, resulting in that gelding having to be checked. Near the 150 metres shifted in under pressure when insufficiently clear of SUGAR GLIDER, which had to be checked. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence immediately following a suspension incurred at Port August on Sunday, 4 July 2021, the effect being that his licence to ride in races is suspended from midnight Saturday, 17 July 2021 to conclude at midnight Wednesday, 28 July 2021, a period of four meetings.

RACE 3: BORDERTOWN PUMPS & REFRIGERATION MAIDEN PLATE - 1550 Metres

GOLIOTUS (C. Jones) - approaching the 200 metres shifted out abruptly when insufficiently clear of KEETTOM when getting into clear running to the outside of EXALTED DENNIS. Rider was advised to exercise greater care when executing similar manoeuvres.

M'LADY LOIS (J. Opperman) - slow to begin.

SEE YOU LATER NOW (B. Price) - near the 1200 metres had to be steadied away from the heels of EXALTED DENNIS. A post-race veterinary examination revealed no visible abnormalities.

CLUB QUEEN (J. Potter) - raced wide without cover.

RACE 4: BORDERTOWN STONE SUPPLIES BENCHMARK 70 HANDICAP - 1200 Metres

THIS KID ROCKS (G. O'Loughlin) - laid out rounding the home turn.

BEEOKAY (M. Aitken) - weakened in the straight. Steadied near the 100 metres when ANRUSHKA shifted out slightly under pressure. A post-race veterinary examination revealed no visible abnormalities.

ANRUSHKA (J. Maund) - approaching the 900 metres shifted in when insufficiently clear of DISHY'S, which had to be steadied and alter course to the outside of that filly. Rider was reprimanded under AR131(a) for careless riding. Near the 100 metres shifted out slightly under pressure.

SOCIALITE MISS (J. Eaton) - bounded on jumping away and lost ground.

DISHY'S (J. Opperman) - approaching the 900 metres was inclined to over-race and had to be steadied away from the heels of ANRUSHKA, which shifted in. Inclined to over-race in the middle stages and was obliged to race three wide for some distance.



RACE 5: BORDER AG BENCHMARK 54 HANDICAP - 1000 Metres

COMRADE BILL (D. Stra) - over-raced in the middle stages. Near the 150 metres was inclined to lay out and had to be steadied away from the heels of CIBACHROME.

TURF TAPPER (J. Potter) - shifted in at the start. Shifted out under pressure over the concluding stages and bumped CIBACHROME. Rider was advised to exercise greater care when shifting ground. Rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip with an action that raised his arm above shoulder height and was fined \$200.

ARACHNATTACK (J. Opperman) - slow to begin.

CIBACHROME (B. Price) - dipped on jumping away. Over the concluding stages was bumped by TURF TAPPER, which shifted out under pressure.

ATUM (J. Eaton) - underwent a pre-race veterinary examination on arrival on course and passed fit to start. Underwent a further pre-race veterinary examination on arrival at the barriers at the request of the rider and was found to be lame in the near foreleg. Acting on this advice Stewards withdrew ATUM at 2.30 pm. Trainer, Mr R. Daniel, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. Mr Daniel advised that he would now have the gelding fully vetted with the intention of having it undergoing a nerve block examination, the results of which he will report back to the Stewards.

SARAH'S JULE (T. Pannell) - tightened for room on jumping away between COUNTER SPIN, which shifted out, and TURF TAPPER, which shifted in. Weakened over the concluding stages. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer, Mr M. McClean, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

COUNTER SPIN (E. Boyd) - hampered at the start between AZZURO BIANCO, which shifted in, and SARAH'S JULE, which was taken out by TURF TAPPER. Held up in the early part of the straight and was obliged to shift out across the heels of runners to obtain clear running.

RACE 6: MCCARTHY TRANSPORT BENCHMARK 62 HANDICAP - 2000 Metres


BEAR ARMS (E. Boyd) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by E. Boyd and noted that she used it on three occasions over the concluding 100 metres of the event. The only explanation E. Boyd could provide was that the race was not run to suit the mare today and she got further out of her ground than she had anticipated in the early and middle stages. She stated that when the race developed into a sprint home BEAR ARMS was left flat footed and was then inclined to hang in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

EUROGEM (K. Zechner) - passing the 700 metres had to be steadied off the heels of PLAISIR, which commenced to weaken from this point.

RACE 7: TASCO BENCHMARK 58 HANDICAP - 1550 Metres

CHALLICUM (B. Price) - rider stated that the gelding never travelled well in the run and was disappointing. He added that CHALLICUM became unbalanced passing the 1300 metres approaching the first turn and did not handle the deteriorating track conditions. A post-race veterinary examination revealed no visible abnormalities.

KZSCZOT (J. Maund) - rider explained that the gelding hung out throughout the event, particularly rounding the home turn and in the straight and for this reason he could not fully test his mount in the run to the finish. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr R. Nicholson, stated that the gelding has been somewhat difficult to train due to his racing manners, and undertook to report to the Stewards on his immediate racing plans. Mr Nicholson was nevertheless advised that a warning would be placed on KZSCZOT in relation to its racing manners.



RACE 7: TASCO BENCHMARK 58 HANDICAP - 1550 Metres (Cont'd)

ZEZE ULATER (J. Eaton) - rider explained that the mare over-raced in the middle stages of the event and she attempted to restrain her mount for a short distance passing the 1200 metres in order to get her to settle. She added that in the straight she was unable to fully test her mount as KZSCZOT laid out and made contact with her mount on a number of occasions.

AMMO LOCO (E. Wong) - Stewards permitted apprentice E. Wong to claim 2.5 kg of his permitted 3.0 kg on the gelding as this was a late notification ride this morning on a second emergency. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by E. Wong and noted that he did not use it over the concluding 100 metres of the event.

UNCLE BOB (C. Lions) - jumped awkwardly and lost ground.

RACE 8: DOAN PHARMACIES BENCHMARK 54 HANDICAP - 1300 Metres

OUTINTHESTREET (K. Crowther) - got its off hind leg up in the barrier. Was inspected by the Club's vet and passed fit to start. A post-race veterinary examination revealed a small laceration to the left lip.

HARBOURING (M. Aitken) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by M. Aitken and noted that he used his whip on three occasions over the last 100 metres.

ROSSTART (E. Boyd) - Co-trainer, Mr J. Jaensch, was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The gelding was permitted to start as it was able to be identified from records held by the Stewards.

LOOSE LIP LLOYD (G. O'Loughlin) - slow to begin. Passing the 900 metres when was inclined to lay out, had to be steadied when SQUADRON LEADER was inclined to get in and away from IS THAT SO which shifted in slightly. Rider, K. Zechner was advised to ensure that he is sufficiently clear when shifting ground. Past the 800 metres LOOSE LIP LLOYD, which was still inclined to over-race in the middle stages of the event, had to be steadied away from the heels of SQUADRON LEADER which momentarily shifted in before the pressure was relieved by its rider, C. Lions.

POLLYANNA (B. Price) - rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$200.
