

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Jamestown
Racecourse by the Jamestown Racing Club on
Saturday, 2 October 2021



RACINGS A

TRACK: Good 4 (Track with some give in it)
Upgraded to Good 3 at 11.30 am (Track with good grass coverage and cushion)
Upgraded to Firm 2 at 3.11 pm retrospective to Race 4
(Firm track with reasonable grass coverage)

RAIL: True

WEATHER: Fine

RACE 1: JAMESTOWN CONTAINER DEPOT/JAMESTOWN CONCRETE/SWAN PHARMACIES/WEBB'S TYRE SERVICE BM64 HANDICAP - 1000 Metres

LOFTY TYCOON (K. Sardelic) - jumped away awkwardly. Near the 700 metres shifted in onto **ALEDA**, which had to be steadied. Rider reminded of his obligations under AR131(a) and advised to ensure he is sufficiently clear when shifting ground in future. Laid in under pressure in the straight.

ALEDA (D. Stra) - near the 700 metres had to be momentarily steadied when **LOFTY TYCOON**, shifted in.

RACE 2: KELLY TOYOTA/KERIN LANDMARK RURAL/JAMESTOWN ENGINEERING & MANUFACTURING MAIDEN PLATE - 1000 Metres

GILHANINA (F. Atkinson) - on jumping away bumped with **STASIA**, which was taken out by **LULU DESIGN**. Over-raced in the early stages of the event and got its head up on a number of occasions whilst being restrained.

LULU DESIGN (E. Wong) - jumped away awkwardly, shifted out and tightened **STASIA** onto **GILHANINA**. Raced keenly in the early and middle stages of the event. Hung out under pressure from the vicinity of the 600 metres for the remainder of the event and proved difficult for its rider to ride out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

STASIA (NZ) (A. Chung) - on jumping away was tightened onto **GILHANINA** by **LULU DESIGN**. Hung out under pressure rounding the home turn.

TOUCH MY HEART (S. Metcalfe) - laid in under pressure in the straight.



RACE 3: REDDEN BROS/RYNNE'S HARDWARE AND SPORTS STORE MAIDEN PLATE - 1340 Metres

FOX COUNTRY (M. Collett) – inside the 400 metres was taken wider on the track by **VONDEXTER**, which shifted out. Laid in under pressure in the straight. Rider reported that she was concerned with the gelding's action throughout the event. A post-race veterinary examination revealed no visible abnormalities.

GREY FOLLY (A. Livesey) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

KENDALL RIVER (E. Annells) – a post-race veterinary examination revealed no visible abnormalities.

POCKET PENNY (E. Wong) – laid out under pressure in the straight.

SUNNY GREEN (C. Lions) – raced wide without cover throughout the event.

VONDEXTER (A. Chung) – inside the 400 metres shifted out taking **FOX COUNTRY** wider on the track.

RACE 4: MURRAY PEST CONTROL/FINANCIAL SERVICES SA/QUALITY LIVESTOCK BENCHMARK 60 HANDICAP - 1340 Metres

HURRICANE SONNY (A. Livesey) – laid in under pressure in the straight.

CHARMED INDIVIDUAL (NZ) (A. Chung) – on jumping away got its head up and struck the rider in the face. Approaching the 100 metres shifted to the outside of **HURRICANE SONNY** to obtain clear ground.

DAVEEDO (M. Henderson) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip by M. Henderson and noted that he used it on five occasions over the concluding 100 metres of the event.

PARISIANS (C. Lions) – jumped away awkwardly.

SCALLOP (E. Annells) – slow to begin.

RACE 5: RAILWAY HOTEL / COOPERS JAMESTOWN CUP - 1800 Metres

ROYAL BOWER (C. Lions) – contacted on jumping away.

AUGUSTA ROCK (M. Vassallo) – raced keenly in the early and middle stages of the event. Near the 800 metres was obliged to be restrained and lost its position when **I'M BULLETPROOF** shifted in when insufficiently clear.

BALDY (F. Atkinson) – jumped away awkwardly, shifted out and contacted **ROYAL BOWER**. Raced wide without cover from the vicinity of the 800 metres. Laid in under pressure in the straight.

MARYMOUNT LASS (A. Livesey) – raced keenly in the early and middle stages of the event.

I'M BULLETPROOF (K. Sardelic) – underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Near the 800 metres shifted in when insufficiently clear of **AUGUSTA ROCK**, which was obliged to be restrained and lost its position. Rider was severely reprimanded for careless riding under AR131(a).



RACE 6: MICHAEL NOONAN MEMORIAL BENCHMARK 54 HANDICAP - 1200 Metres

GRINZINGER STRASSE (NZ) (C. Lions) – slow to begin.

DOUG'S JOURNEY (M. Vassallo) - near the 100 metres shifted out around the heels of GRINZINGER STRASSE (NZ) to obtain clear ground.

RUSTYDUSTYSUNSHINE (E. Annells) - raced wide without cover throughout the event. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

VEGAN (F. Atkinson) - underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Laid in under pressure in the straight.
