

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville
Racecourse by the South Australian Jockey Club on
Saturday, 9 October 2021

RACE 1: FURPHY HANDICAP - 1100 Metres

BROTHER'S SHADOW (NZ) (J. Opperman) - contacted and inconvenienced at the start. Rider explained that the gelding travelled well and was comfortable in its action, however, when asked for an effort, failed to respond to his riding and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

MAGIC MAX (J. Holder) - began awkwardly, shifted out and contacted BROTHER'S SHADOW (NZ), which was inconvenienced. Over-raced in the early and middle stages of the event. Inside the 800 metres became awkward on the heels of BROTHER'S SHADOW (NZ), shifted out and inconvenienced BALLYNORA, which was taken wider for a number of strides. Laid out rounding the home turn. Rider reported the gelding travelled well, however, was disappointing when asked for an effort. A post-race veterinary examination revealed no visible abnormalities.

PHILONIZE (B. Price) - began awkwardly, shifted in and contacted GARRIRE, which was hampered. Rider reported that his saddle shifted to the off side after making contact with GARRIRE at the start, which placed him at a disadvantage for the remainder of the event.

BALLYNORA (K. Crowther) - raced keenly in the early stages of the event and inside the 800 metres was inconvenienced by MAGIC MAX, which shifted out. Inclined to lay in over the concluding stages.

GARRIRE (T. Voorham) - contacted at the start, was hampered and was unable to maintain its position. Rider explained that it was her intention to settle in a more forward position but was unable to do so as a consequence of suffering interference at the start.

RACE 2: WHITE CLAW HANDICAP - 2500 Metres

EPERDUMENT (M. Collett) - raced keenly in the early stages of the event. Inclined to lay in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: WHITE CLAW HANDICAP - 2500 Metres (Cont'd)

SLIPINTOTHIS (NZ) (T. Pannell) - began awkwardly, shifted out and contacted NATIVE BLUE. Raced wide without cover throughout the event.

HE EKSCELS (NZ) (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

NATIVE BLUE (E. Boyd) - contacted at the start.

SOSTENIDO (NZ) (C. Lions) - underwent a pre-race veterinary examination and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: SPRING RACING CARNIVAL AT MORPHETTVILLE - OCT. 16 - NOV 6 HANDICAP - 1200 Metres

THRILL KILL (B. Price) - slow to begin. Rider reported that the gelding stood flat-footed as the gates were released and as a consequence was slow to begin. He added that owing to being slow to begin, he was unable to take up a more forward position as intended.

THE BILLIONAIRE (J. Holder) - raced keenly in the early stages of the event.

THE RAVEN (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

TULLYS GOLD (T. Pannell) - near the 300 metres elected to alter course and shifted to the outside of VIEIRA, which laid in and shifted in.

VIEIRA (E. Finnegan) - raced wide without cover throughout the event. Laid in, in the straight and near the 300 metres shifted in towards the running line of TULLYS GOLD, which elected to alter course to VIEIRA'S outside.

OCEAN REWARD (B. Vorster) - had its tongue-tie replaced at the start.

Correct weight was delayed to allow T. Pannell (TULLYS GOLD), placed sixth and Trainer Mr R. Balfour, to view the vision in the straight. After doing so T. Pannell lodged an objection against VIEIRA (E. Finnegan) placed fifth, alleging interference near the 300 metres. After considering the evidence, viewing the official vision and acting on their own observations Stewards *dismissed* the protest.

RACE 4: HILL SMITH STAKES - 1800 Metres

JUNGLE MAGNATE (NZ) (J. Holder) - began awkwardly, shifted out and contacted BLACKCOMB. Raced very keenly in the early stages of the event.

MAX FIRE (B. Price) - raced keenly in the early stages of the event.

WHEELS OF COURAGE (R. Hurdle) - near the 100 metres R. Hurdle was accidentally struck on his upper right arm by the whip of J. Toeroek the rider of MAN OF HEART. Inside the 100 metres was obliged to be steadied when tightened by CERBERUS, which shifted out under riding.

CERBERUS (T. Pannell) - from inside the 100 metres shifted out under riding tightening WHEELS OF COURAGE, which had to be steadied. Rider was severely reprimanded and advised to take greater care in future when his mounts commence to shift ground.

MAN OF HEART (J. Toeroek) - shifted in on jumping away and contacted the hindquarters of ABIT RATTLEY, which shifted out on jumping away. From near the entrance to the straight was unable to obtain clear running and was obliged to shift to the outside of the field from near the 250 metres and thereafter laid in for the remainder of the event. Rider accidentally struck the upper right arm of R. Hurdle, rider of WHEELS OF COURAGE, with his whip near the 100 metres.

ABIT RATTLEY (J. Maund) - shifted out on jumping away and contacted MAN OF HEART.



RACE 4: HILL SMITH STAKES - 1800 Metres (Cont'd)

BLACKCOMB (B. Vorster) - contacted at the start. Held up for clear running from the entrance to the straight when racing behind CASSOWARY and to the inside of CERBERUS and was only able to obtain clear running from approaching the 150 metres. A post-race veterinary examination revealed no visible abnormalities.

CASSOWARY (A. Jordsjo) - raced wide without cover throughout the event.

RACE 5: THE JUNCTION HANDICAP - 1050 Metres

CALL ME CURTIS (T. Voorham) - laid in, in the straight.

RUSTY HALO (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

GRAND HOST (T. Pannell) - raced keenly in the early stages of the event.

FRENCH ROCK (B. Vorster) - underwent a pre-race veterinary examination and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

SKARA BRAE (C. Lions) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: ADELAIDE GALVANISING HANDICAP - 1600 Metres

HINCHPIN (B. Vorster) - a post-race veterinary examination revealed no visible abnormalities.

OURKHANI (C. Jones) - began awkwardly, shifted out and contacted MARINA.

EXALTED FIRE (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

SEBONNA (K. Zechner) - was disappointed for clear running for a short distance near the entrance to the straight and was obliged to shift out to obtain clear running.

RAPID RAISER (B. Price) - raced very keenly in the early stages of the event. Approaching the 1500 metres became awkward inside RISING THUNDER, which shifted in and had to be restrained for several strides. Inside the 1400 metres got its head up when being restrained and raced a little ungenerously when awkward on the heels of RISING THUNDER. A post-race veterinary examination revealed no visible abnormalities.

WILD IMAGINATION (NZ) (J. Toeroek) - laid in, in the straight

SO BENE (P. Gatt) - underwent a pre-race veterinary examination and was passed fit to race.

MARINA (A. Jordsjo) - contacted at the start.

RISING THUNDER (C. Murray) - Stewards permitted C. Murray to ride the gelding 0.5 kg above its declared weight of 54.0 kg. Shifted in shortly after the start and near the 1500 metres tightened RAPID RAISER for several strides. Rider was reminded of his obligations when shifting ground in future.

RACE 7: CANADIAN CLUB HANDICAP - 1100 Metres

The start of this event was delayed approximately five minutes.

ALLEBOOM (J. Opperman) - raced wide without cover throughout the event.

SAVS FINALE (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

TAKEN OFF (K. Crowther) - lost its near fore plate en route to the barriers and had to be re-shod on arrival at the barriers. Underwent a pre-race veterinary examination at the barriers and was passed fit to race. Inclined to lay in, in the early part of the straight.



RACE 8: JOHN "MACCA" MACDONALD 50TH BIRTHDAY HANDICAP - 1200 Metres

PIMM'S PARTY (T. Voorham) - awkward and slow to begin.

SO SAY ANGEL (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

LADY DUNMORE (C. Jones) - slow to begin.

POINT BLAZE (K. Crowther) - near the 100 metres, after shifting in and away from LADY DUNMORE became awkward outside the heels of ANOTHER AWARD as that horse shifted out slightly under pressure and had to be steadied.

SHE'S STYLISH (K. Zechner) - a post-race veterinary examination revealed no visible abnormalities.

INDIAN GAZELLE (B. Vorster) - rider reported the mare laid out rounding the home turn and under pressure in the straight.

ADDICTIONS - acting on confirmed advice from Trainer Mr T. Montgomerie that the mare had abrasions to its near fore knee, Stewards declared ADDICTIONS a late scratching at 8.15am on veterinary advice. Mr Montgomerie was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

RACE 9: GRAND SYNDICATES HANDICAP - JOIN TEAM GRAND HANDICAP - 1200 Metres

ALL IN WAR (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

THANASI (J. Opperman) - rider reported that the gelding laid in under pressure in the straight. A post-race veterinary examination revealed a minor laceration to its off hind leg.

JONQUEST (J. Holder) - rider reported that it was his intention to settle in a more forward position, however, the gelding never travelled in the early stages of the event and as a consequence, he was obliged to settle further back in running. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Co-Trainer, Mr L. Macdonald, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

ALLURING GRACE (C. Murray) - laid out in the straight. Lost its near hind plate during the event.

GRANDMA GAIL (G. Lo) - underwent a pre-race veterinary examination and passed fit to race. Raced keenly in the early stages of the event.

ZERO INN (M. Aitken) - raced keenly in the early stages of the event.

SCOTCH ON THE ROCK (J. Toeroek) - Trainer Mr R. Wilkinson advised Stewards prior to the event of a change of tactics, that being that he would instruct his rider to ride the gelding in a positive manner in the early stages and attempt to lead to take benefit from its inside barrier draw. Settled mid-field. A post-race veterinary examination revealed no visible abnormalities.

HE WILL BOOM (S. Logan) - became held up for clear running for a short distance from inside the 200 metres when racing between STRIKE THE NIGHT and GRANDMA GAIL.

RACE 1: GBJC WELCOMES AARON BAIN RACING MAIDEN PLATE - 2100 Metres

GWAIHIR - on Wednesday, 6 October 2021, Trainer Mr R Balfour reported to Stewards that the gelding was receiving treatment for an injury to its near side eye. GWAIHIR will continue to be monitored and a decision will be made as to whether the stable continue on with the gelding's preparation.
