RACE 1: B DUNSTAN MAIDEN HANDICAP - 1800 Metres

PITRAIN (S. Logan) - jumped away awkwardly, shifted out and tightened DUGGEE'S BOY onto EYES OF DUBAI.

DUGGEE'S BOY (C. Murray) - slow to begin. Shortly thereafter was obliged to be checked when tightened between PITRAIN and EYES OF DUBAI which both shifted ground. Raced ungenerously in the early stages of the event. Rider could offer no explanation for the gelding's performance in today's event. A post-race veterinary examination revealed no visible abnormalities.

EARL OF SANDWICH (G. Lo) - underwent a pre-race veterinary examination and was passed fit to race. A post-race veterinary examination revealed no visible abnormalities. Lost its near fore plate during the event.

EYES OF DUBAI (M. Aitken) - re-saddled on arrival at barriers. Jumped away awkwardly, shifted in and tightened DUGGEE'S BOY onto PITRAIN.

MILITARY PRESS (K. Crowther) - near the 500 metres was held up for a short distance.

PAINTED ON (J. Potter) – lost its near fore plate en route to barriers and was reshod. Underwent a pre-race veterinary examination and was passed fit to race.



RACE 1: B DUNSTAN MAIDEN HANDICAP - 1800 Metres (cont'd)

DOROTHY ROSE (E. Boyd) - over-raced in the early and middle stages of the event. Laid in under pressure in the straight.

MISS HENDRIX (J. Eaton) – a post-race veterinary examination revealed that the gelding was lame in the off hind. Trainer, Mr B. Jones, was advised that a Veterinary Certificate of Fitness was required prior to future trial or race start.

RACE 2: I SOMMERVILLE HANDICAP - 1100 Metres

LUCKY DOG (A. Jordsjo) - jumped away awkwardly.

BARACONI (J. Eaton) - laid in under pressure in the straight.

LORD VARYS (D. Caboche) - underwent a pre-race veterinary examination as the gelding had not raced since December 2020 and was passed fit to race. Co-Trainer, Mrs. N. Searle made a submission to Stewards that hoof pads (front) be removed from the geldings gear in today's event. Stewards accepted this request. Co -Trainer, Mrs. N. Searle was reprimanded under AR206(2).

MRS HYDE (E. Wong) - raced keenly in the early and middle stages of the event and weakened from the vicinity of the 250 metres. A post-race veterinary examination revealed no visible abnormalities.

TWO ODD SOX (M. Aitken) - laid in under pressure in the straight.

A THOUSAND DEGREES (F. Atkinson) - near the 250 metres had to be momentarily steadied when awkwardly placed on the heels of LORY VARYS and MRS HYDE, which was weakening.

RACE 3: M VANDELEUR HANDICAP - 1200 Metres

ARCHWAY TO HEAVEN (D. Tourneur) - jumped away awkwardly and was slow to begin approximately two lengths.

HURRICANE SONNY (F. Atkinson) - rider explained that it was her intention to settle on pace in today's event however; after beginning well, elected to take up the lead. Trainer, Mr. D. Page, confirmed the instructions.

WATERBOM (NZ) (E. Wong) - slow to begin.

RACE 4: BARRY KING MAIDEN PLATE - 1100 Metres

SO SILENT (A. Chung) - rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

CHEH CHEH CHARLEE (T. Pannell) - raced keenly in the early and middle stages of the event.

DAZZLING HARMONY (A. Jordsjo) – near the 250 metres was disappointed for a narrow run inside of STAR ESPRESSO resulting in DAZZLING HARMONY having to be steadied and altering course to the outside of STAR ESPRESSO. Near the 50 metres was accidently struck over the nose by the whip of D. Tourneur rider of STAR ESPRESSO.

HACKERESS (S. Logan) - trainer, Mr H. Montgomerie, was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards.

JULIEJULIEJILLY (F. Atkinson) - prior to the start of the event, Trainer, Mr R. Atkinson, advised Stewards of change of tactics in that he would instruct the rider to attempt to gain cover in today's event. Settled back of mid-field. Jumped away awkwardly, shifted in and contacted SO SILENT. Raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. Lost an off fore plate during the event.

RACE 4: BARRY KING MAIDEN PLATE - 1100 Metres (cont'd)

CHEROKEE QUEEN (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

STAR ESPRESSO (D. Tourneur) - laid in under pressure in the straight.

SUGAR BABY LOVE (C. Murray) - the tongue tie was replaced prior to the start of the event on arrival at the barriers.

WITCH QUEEN (E. Boyd) - laid out under pressure in the straight. Rider explained that the mare felt uncomfortable in its action during today's event. A post-race veterinary examination revealed that the mare was slow to recover.

VERVET BLUU (B. Price) - near the 900 metres became unbalanced for a short distance of its own accord. Raced keenly in the early and middle stages of the event.

Correct weight for this event was delayed to allow A. Jordsjo (DAZZLING HARMONY), placed second, and trainer, Mr M. Magro, to view the vision.

RACE 5: JH KNAPPSTEIN HANDICAP - 1800 Metres

CHARMED INDIVIDUAL (NZ) (F. Atkinson) - rider reported that the gelding laid out from the vicinity of the 1100 metres for the remainder of the event.

OH GEORGIA (E. Annells) - slow to begin losing approximately three lengths. Laid out under pressure in the straight. Trainer, Mr M. Mychajlin, was advised that a warning was placed on the mare for being slow to begin.

PELADERA (D. Caboche) - raced wide without cover throughout the event. Laid in from the vicinity of the 900 metres.

RACE 6: JIM BARRY CLARE VALLEY CUP (BENCHMARK 72 HCP) - 1800 Metres

The start of this event was delayed approximately two minutes owing to AUGUSTA ROCK contacting the chute running rail which had to have remedial work done prior to the start of the event.

SPLASH SOME CASH (K. Sardelic) - slow to begin and shortly thereafter was hampered on jumping away when tightened between BIARCHI and ROBE BAY. Over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SEBONNA (K. Zechner) - raced keenly in the early and middle stages of the event.

EXALTED RUTH (T. Pannell) - raced wide without cover throughout the event.

ROBE BAY (P. Gatt) - hampered jumping away when taken in onto BIARCHI by ROYAL BOWER, which shifted in.

BIARCHI (K. Crowther) - jumped away awkwardly, shifted out and contacted SPLASH SOME CASH which was tightened onto ROBE BAY. Rider reported that the mare hung out under pressure in the straight.

ROYAL BOWER (C. Lions) - jumped away awkwardly, shifted in onto ROBE BAY.

IOWA HAWKEYE (D. Caboche) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

AUGUSTA ROCK (B. Price) - en route to the barriers made contact with the chute running rail which was damaged as a consequence. On arrival at the barriers the gelding underwent a prerace veterinary examination and was passed fit to race. Raced wide without cover in the early and middle stages of the event.

RACE 7: T HEINJUS HANDICAP - 1200 Metres

The start of this event was delayed by approximately five minutes.

PHILLYVONNE (E. Boyd) - rider explained that the mare felt uncomfortable in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

FREE OF SIN (G. Lo) – held up from inside the 200 metres until approaching the 100 metres when awkwardly placed on the heels of TOUGH LASSIE and GATSBY'S GIRL, was obliged to shift out and in doing so tightened SAND CAT onto YEELANNA. Laid in over the concluding stages of the event.

YEELANNA (K. Sardelic) - jumped away awkwardly.

SAND CAT (C. Lions) - over-raced in the early and middle stages of the event. Approaching the 100 metres was tightened onto YEELANNA by FREE OF SIN which shifted out.

TRIVAGO GIRL (E. Wong) - lost it's off fore plate en route to barriers and was reshod. Underwent a pre-race veterinary examination and was passed fit to race.

TWICE FORGOTTEN (A. Chung) - lost it's near fore plate en route to barriers and was reshod. Underwent a pre-race veterinary examination and was passed fit to race. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

GENERAL

Stewards undertook an inspection of the male and female jockey's room for the presence of mobile phones. At a subsequent inquiry, B. Price and C. Lions pleaded guilty to a charge under AR218(4)(b) in that they had in their possession a mobile phone after the running of race 3 and was fined \$200 each. In assessing penalty, Stewards considered their good records, guilty plea and the fact that they had not used their mobile phone whilst present in the jockey's room.
