

# Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Port Lincoln  
Racecourse by the Port Lincoln Racing Club on  
Friday, 31 December 2021

RACE 1: BK & BJ SOUTHAM TV & LINE INSTALLATION 3YO BENCHMARK 60 HANDICAP - 1210  
Metres

ORIEDOS (K. Crowther) - shifted in near the 150 metres and brushed ROWDY DIVA.

ROKUN (F. Atkinson) - was momentarily crowded for room near the 1000 metres and became awkward on the heels of ROWDY DIVA, which shifted in.

KURIMUZON (G. Lo) - laid out over the concluding 100 metres when placed under pressure.

ROWDY DIVA (E. Wong) - underwent a pre-race veterinary examination at the barriers and was passed fit to start. Shifted in near the 1000 metres resulting in ROKUN becoming awkward on its heels. Rider was advised to exercise more care in future. Near the 150 metres was brushed by ORIEDOS, which shifted in.

RACE 2: AVIS PORT LINCOLN MAIDEN PLATE - 1000 Metres

BARBADSON (C. Jones) - raced awkwardly with its head up in the vicinity of the 800 metres.

LORAINÉ'S FLOWJO (C. Lions) - shifted in at the start and bumped STRIP CLUB.

RIGHT TURN (E. Annells) - underwent a pre-race veterinary examination at the barriers and was found to be lame in the near foreleg. Acting on this advice Stewards withdrew RIGHT TURN at 2.32 pm. Trainer Mr B Cozamanis was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

TWO BEERS (E. Boyd) - underwent a pre-race veterinary examination at the barriers and was passed fit to start.

VON GEORGE (E. Wong) - slow to begin.

ALSAMENU (S. Callow) - following declaration of acceptances Trainer J. Stoetzer made a gear application to add blinkers to the mare's gear. Stewards acceded to the request and fined Ms. Stoetzer \$200 under AR206(2). A post-race veterinary examination revealed that the mare showed signs of heat stress. First Aid was administered.

HOT TRIM (A. Chung) - bumped at the start by KOYA to its outside.



RACE 2: AVIS PORT LINCOLN MAIDEN PLATE - 1000 Metres (Cont'd)

STRIP CLUB (G. Lo) - bumped at the start by LORRAINE'S FLOWJO to its outside. Laid in, in the straight when placed under pressure.

KOVA (K. Crowther) - jumped away awkwardly, shifted in and bumped HOT TRIM.

RACE 3: FISHERIES ASSET BROKERS BENCHMARK 64 HANDICAP - 1350 Metres

CHARLTON (K. Crowther) - slow to begin.

FEARLESS AL (G. Lo) - laid in, in the straight.

LADY CONQUISTADOR (C. Jones) - a post-race veterinary examination revealed a small laceration to the near fore pastern.

TIME WARRIOR (F. Atkinson) - a post-race veterinary examination revealed a small laceration to the near hind leg.

SHINSEKI (C. Murray) - laid in, in the straight.

BONIFACE (NZ) (E. Boyd) - jumped away awkwardly with its head up and lost ground. Held up and unable to obtain clear running over the final 100 metres behind MIRTHDALE and SWING IT SISTER and as a result, was not fully tested to the line.

RACE 4: SOUTHERN CROSS AUSTEREO BENCHMARK 68 HANDICAP - 1960 Metres

PAULO PACE (K. Sardelic) - shifted in at the start and bumped DESERT MINTY.

ICE GHOST (S. Metcalfe) - rider reported her horse failed to travel throughout and proved disappointing. Crowded and had to be steadied near the 400 metres when weakening between BRAMFIELD and GIVEPEACE A CHANCE, which was taken out by DUKE OF CHRISTOPHE. A post-race veterinary examination revealed a small laceration to the off hind leg.

LEONARDA (K. Crowther) - bumped by DUKE OF CHRISTOPHE at the start.

DIAMONDS ARE (D. Caboche) - slow to begin.

GIVEPEACE A CHANCE (F. Atkinson) - near the 400 metres was crowded between ICE GHOST and DUKE OF CHRISTOPHE, which shifted out when insufficiently clear.

DUKE OF CHRISTOPHE (E. Wong) - bumped by LEONARDA at the start. Shifted out near the 400 metres and crowded GIVEPEACE A CHANCE out onto ICE GHOST, which had to be steadied. Rider was severely reprimanded.

BELLS 'N' BOWS (J. Doyle) - slow to begin.

DESERT MINTY (E. Annells) - bumped at the start by PAULO PACE. Raced wide in the early and middle stages and improved forward near the 1200 metres to sit outside the leader at approximately the 900 metres.

RACE 5: LINCOLN ESTATE WINES BENCHMARK 54 HANDICAP (1) - 1350 Metres

RELAXED (C. Jones) - shifted in at the start and bumped with JAY PEE BEE (NZ).

ART MUSIC (E. Boyd) - eased momentarily on straightening away from the heels of BRUTAL POWER, which shifted out slightly.

TYCOON DREAMING (A. Chung) - raced wide without cover throughout the event.

JAY PEE BEE (NZ) (K. Crowther) - bumped at the start by RELAXED. Raced in restricted room approaching the winning post behind ART MUSIC and CHARGING FIRE.





## RACE 6: PB & KG GASKELL CONTRACTORS BENCHMARK 54 HANDICAP (2) - 1350 Metres

GOTTABITON (C. Jones) - lost its off fore plate during the event.

LUGA LAD (C. Murray) - crowded and buffeted shortly after the start between BRAZEN HEAD and COMPARDY, which shifted in. Approaching the 200 metres was crowded and checked away from BRAZEN HEAD, which shifted out.

CONFINEMENT (E. Annells) - shortly after the start was crowded and had to be checked between TRIVAGO GIRL, which shifted in slightly and COMPARDY, which shifted out to relieve pressure from LUGA LAD to its inside which was being crowded.

BRAZEN HEAD (K. Sardelic) - buffeted and lost ground shortly after the start between CENTRE SCOOTA and LUGA LAD. Near the 200 metres shifted out when insufficiently clear of LUGA LAD, which was crowded and had to be checked. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 9 January and to conclude at midnight on Sunday, 16 January 2022: a period of four meetings.

CHUCKLES (C. Lions) - lost ground near the 950 metres when racing tight to the inside of CENTRE SCOOTA, which shifted in and away from BRAZEN HEAD.

GREY VITALITY (E. Wong) - disappointed for a run near the 250 metres between COMPARDY and LUGA LAD. A post-race veterinary examination revealed no visible abnormalities.

## RACE 7: PORT LINCOLN REAL ESTATE BENCHMARK 54 HANDICAP - 1000 Metres

A THOUSAND DEGREES (J. Doyle) - Shifted in near the 800 metres, away from LULU DESIGN and in doing so crowded RAHEEBA onto CARALUE, resulting in both horses having to be checked. Rider was advised to exercise more care in future. Shifted in near the 100 metres to obtain a clear run when not quite clear of VIRAGO MISS, which was eased.

I'M OH SO PRETTY (C. Jones) - jumped awkwardly and raced in restricted room early between A THOUSAND DEGREES and RAHEEBA.

LULU DESIGN (K. Crowther) laid in, in the straight.

VIRAGO MISS (E. Wong) - eased near the 100 metres away from the heels of A THOUSAND DEGREES which shifted in.

CARALUE (E. Boyd) - crowded and checked near the 800 metres on the inside of CARALUE, which was taken in by A THOUSAND DEGREES.

RAHEEBA (C. Lions) - crowded and checked near the 800 metres on the inside of A THOUSAND DEGREES.

## RACE 8: BETTA ELECTRICAL BENCHMARK 74 HANDICAP - 1210 Metres

ARTFUL AMBITION (K. Sardelic) - fractious in the barriers, reared as the start was affected and lost ground. Rider explained, as a result of being slow to begin the gelding races further back than intended. Raced wide for the majority of the event.

RIVERSIDE ROCK (C. Murray) - raced keenly with its head up near the 900 metres.

ISA SECRET (E. Wong) - shifted out abruptly at the start and lost ground.

ROCK HARD (E. Annells) - rider reported the gelding laid in from the 400 metres.

IT'S HUMPHREY (C. Lions) - rider reported the gelding hung out throughout the event.



RACE 9: HAPPY MACCA'S NYE BENCHMARK 58 HANDICAP - 1210 Metres

JAKAZONE (K. Sardelic) - laid out when placed under pressure in the straight.

JUSTICA (C. Jones) - fractious in the barriers, put its head down when the start was affected and lost ground (3 lengths). Rider explained, despite the mare being slow to begin, she intended to race in a rearward position. Trainer B. Clarke was advised a warning had been placed on the mare regarding its starting manners. Raced wide without cover for the majority of the race.

PRESCIENT (C. Murray) - laid out throughout the event.

THE MASTER (E. Annells) - rider reported the gelding hung in from the 600 metres and proved difficult to ride.

AMANI FARASI (C. Lions) - raced very keen in the early and middle stages of the event.

ZARAFSHAN (A. Chung) - a post-race veterinary examination revealed no visible abnormalities.
