RACE 1: QUALITY WOOL & RODEO BY THE SEA MAIDEN PLATE - 1000 Metres

LADY BERLINETTA (C. Murray) - which had not raced in over 12 months, underwent a pre-race veterinary examination and was passed fit to start. Slow to begin.

POCKET PENNY (J. Doyle) - inclined to lay in, in the straight.

TYPAR (L. Overall) - rolled about in the straight.

RACE 2: LETCHER MORONEY CHARTERED ACCOUNTANTS & YOUR FINANCIAL EDGE BENCHMARK 62 HANDICAP - 1000 Metres

RASHYATHERE (C. Murray) - which had not raced in over 12 months, underwent a pre-race veterinary examination and was passed fit to start. Raced ungenerously in the early and middle stages of the event.

ORIENTAL GIFT (J. Doyle) - slow to begin.

RACE 3: CHRIS GEORGIU BUILDING BENCHMARK 54 TROPHY - 1200 Metres

WHEN STARS ALIGN (L. Overall) - slow to begin. Shortly after the start was inconvenienced by RAHEEBA, which shifted out. Rider explained that the gelding did not travel in the early and middle stages of the event; however, when able to get to the outside of the field in the straight, finished the event off well. He added that it was the gelding's first race start in 10 months.



RACE 3: CHRIS GEORGIU BUILDING BENCHMARK 54 TROPHY - 1200 Metres (cont'd)

SPECIAL BOOM (P. Crich) - slow to begin.

SECOND LAST CHANCE (M. Vassallo) - slow to begin. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by M. Vassallo and noted that he used his whip on three occasions over the last 100 metres.

RAHEEBA (H. Yuen) - jumped away awkwardly, shifted out and inconvenienced WHEN STARS ALIGN.

RACE 4: CLEARWATER COVE ESTATE BENCHMARK 62 HANDICAP - 1350 Metres

RIVERSIDE ROCK (L. Overall) - laid in, in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300. In determining penalty Stewards had regard for the totality of the use of the whip by L. Overall and noted that he used it on thirteen occasions over the final 100 metres of the event.

FIOURUKI (E. Annells) - rider reported the gelding was inclined to lay out in the straight. A post-race veterinary examination revealed no visible abnormalities.

SURVEY LANE (C. Murray) - jumped away awkwardly, shifted in tightening CHUCKLES. Rider explained that the gelding never travelled throughout the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Ms J. Stoetzer, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start

FIRE THUNDER (P. Crich) - raced ungenerously in the early and middle stages of the event. Rider explained that the mare never travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

CHUCKLES (D. Tootell (Snr)) - shortly after the start lost its position when tightened between SURVEY LANE, which shifted in and FIRE THUNDER, which shifted out.

ICE HUNT (M. Vassallo) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty, Stewards had regard for the totality of the use of the whip by M. Vassallo and noted that he used his whip on four occasions over the last 100 metres.

SHOWBAG (J. Doyle) - hung out from the 600 metres.

RACE 5: XXXX & STREAKY BAY COMMUNITY HOTEL STREAKY BAY CUP - 1800 Metres

GRINZINGER STAR (NZ) (L. Overall) - made the turn out of the straight awkwardly.

PAULO PACE (C. Murray) - rolled in over the concluding stages of the event tightening the running of KORODON (NZ).

DIAMONDS ARE - as there was no rider available Stewards declared DIAMONDS ARE a late scratching at 11:30 am.

KORODON (NZ) (H. Yuen) - tightened over the concluding stages of the event by PAULO PACE, which rolled in. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence midnight Wednesday, 30 March 2022 and to conclude midnight Saturday, 2 April 2022, a period of 2 meetings. In determining penalty, Stewards had regard for the totality of the use of the whip by H. Yuen and noted that she used her whip on three occasions over the last 100 metres.



RACE 6: KERRIN MCEVOY SCULPTURE PROJECT BENCHMARK 54 TROPHY - 1800 Metres

RELAXED (P. Crich) - on jumping away was tightened and lost its position between HAND TO HAND (NZ) and JAY PEE BEE (NZ), which shifted out. At the entrance to the straight, shifted out taking DESERT MINTY wider on the track. Rider was reminded of his obligations and, in future, to only shift ground when entitled to do so.

ROAR (J. Doyle) - laid in, in the straight.

DESERT MINTY (E. Annells) - at the entrance to the straight was inconvenienced and taken wider on the track by RELAXED.

JAY PEE BEE (NZ) (L. Overall) - jumped away awkwardly, shifted out and tightened RELAXED. In the vicinity of the 200 metres was disappointed for a run between HAND TO HAND (NZ) and ROAR, which rolled in and was obliged to shift in to obtain clear running.

AKUBRA BLACK - as there was no rider available Stewards declared AKUBRA BLACK a late scratching at 8:40 am.

REDENZO BULLET - as there was no rider available Stewards declared REDENZO BULLET a late scratching at 12:15 pm.

Correct weight for this event was delayed to allow Stewards to view the vision of the start.
