Report on Race Meeting held at Oakbank
Racecourse by the Oakbank Racing Club on
Wednesday, 30 March 2022

RACE 1: MAGAIN REAL ESTATE MAIDEN PLATE - 1900 Metres

REDENZO BULLET (M. Collett) - jumped away awkwardly and was slow to begin.

WHOSEZOU (C. Rawiller) - near the 700 metres rolled in slightly onto GOLDEN BEAUTY. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by C. Rawiller and noted that he used it on five occasions over the final 100 metres of the event.

TUPOLEU (O. Ridge) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by O. Ridge and noted that he used it on two occasions over the final 100 metres of the event.

GREY FOLLY (M. Vassallo) - slow to begin.



RACE 1: MAGAIN REAL ESTATE MAIDEN PLATE - 1900 Metres (cont'd)

GOLDEN BEAUTY (E. Boyd) - near the 700 metres was momentarily inconvenienced when WHOSEZOU rolled in slightly.

Correct weight for this event was delayed to allow E. Boyd (GOLDEN BEAUTY), placed second, to view the vision in the vicinity of the 700 metres.

RACE 2: TAB MAIDEN PLATE - 1050 Metres

JINGWEI (C. Murray) - upon arrival on course, underwent a pre-race veterinary examination and was found to have injured its near fore tendon and ruled unfit to start. Acting on this advice Stewards withdrew JINGWEI at 1.57 pm. Trainer, Mr S. Lenehan, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

CASSABELLA (H. Yuen) - approaching the 200 metres rider accidentally dropped her off side rein for a short distance.

SERBIAN GIRL (E. Wong) - jumped away awkwardly and shifted in. Laid in under pressure in the straight.

BARBRA'S WISH (J. Eaton) - trainer, Mr G. Young advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle behind midfield with cover, if possible. Settled back. Stewards reminded Trainer, Mr G. Young of his obligations under AR100(1)(b) in relation to advising any change of tactics, no later than 30 minutes prior to the start of the event.

MAGICAL EFFORT (A. Lindsay) - contacted on jumping away. Inclined to lay in under pressure in the straight.

SUGGESTIVE MISS (P. Gatt) - jumped away awkwardly and shifted out onto MAGICAL EFFORT.

RACE 3: EMMETTS BENCHMARK 62 HANDICAP - 2150 Metres

FLOW METER (J. Maund) - underwent a pre-race veterinary examination and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

REX GOLIATH (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

MUFFLA (D. Tourneur) - laid in under pressure in the straight.

CONQUEST OF TEARS (B. Price) - slow to begin. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by B. Price and noted that he used it once over the final 100 metres of the event.


PIERRE BIZEL (M. Vassallo) - proved difficult to load. Trainer, Mrs S. Ratsch was advised that a warning had been placed on the gelding in relation to its barrier manners. Raced keenly in the early and middle stages of the event.

RACE 4: WICKHAM FLOWER BENCHMARK 62 HANDICAP - 1400 Metres

ANGRY ANT (J. Potter) - shifted out shortly after the start.

LIGHT'S VISION (P. Gatt) - proved difficult to load. Trainer, Mr M. O'Leary was advised that a warning had been placed on the gelding in relation to its barrier manners. Slow into stride.

TOMMY TOMATO (C. Murray) - knuckled shortly after the start.



VEGAS DESTINY (NZ) (M. Vassallo) - jumped away awkwardly and shifted out onto A MIDNIGHT SHADOW. Had difficulty obtaining clear ground for a short distance near the 100 metres when attempting the same run as AMBER HAZE.

ZESTEND (E. Wong) - laid in under pressure in the straight.



RACE 4: WICKHAM FLOWER BENCHMARK 62 HANDICAP - 1400 Metres (cont'd)

TOLKIEN (NZ) (J. Toeroek) - raced wide without cover throughout the event. Shortly after passing the winning post clipped the heels of ZESTEND, knuckled and dislodged its rider. J. Toeroek was examined by the First Care Medical personnel and declared unfit to ride. J. Toeroek was advised that he would require a Medical Certificate of Fitness before engaging in any form of riding. An inquiry into this incident was adjourned to a date and time to be fixed to allow D. Caboche to be present.

A MIDNIGHT SHADOW (D. Tourneur) - jumped away awkwardly.

OPUS DAI (K. Crowther) - raced wide without cover throughout the event.

SET TO ROCK (D. Caboche) - after passing the winning post became awkward in its action when attempting to avoid contacting fallen rider, J. Toeroek and as a result dislodged its rider, D. Caboche. D. Caboche was attended to by the First Care Medical personnel and was transported to hospital for further assessment and observation. D. Caboche was advised that he would require a Medical Certificate of Fitness before engaging in any form of riding.

AMBER HAZE (S. Logan) - disappointed in the vicinity of the 100 metres when attempting the same run as VEGAS DESTINY (NZ).

GENERAL

Following the running of this race Stewards became aware of the general demeanour displayed by rider, E. Wong when he returned to the Jockeys' room. After consultation with E. Wong and his master, Trainer Mr G. Searle, Stewards requested that E. Wong be examined by the First Care Medical personnel. After considering that report and acting on their own observations, Stewards, under the provisions of AR21(d), stood down E. Wong from his remaining engagements.

Due to the delay in relation to the ambulance transporting D. Caboche to hospital following the running of Race 4, the race times for the remainder of the meeting were amended as follows:

Race 5: 4:35 pm,

Race 6: 5:10 pm,

Race 7: 5:36 pm.

RACE 5: KLOSE'S SUPERMARKET BENCHMARK 62 HANDICAP - 1100 Metres

INSPIRED SUN (P. Gatt) - slow to begin.


BRAZILLIANT (A. Lindsay) - fractious on arrival at the barriers dislodging its rider. A. Lindsay was examined by the First Care Medical personnel and declared unfit to ride. Acting on this advice Stewards withdrew BRAZILLIANT at 4:43 pm. A. Lindsay was advised that she would require a Medical Certificate of Fitness before engaging in any form of riding. Trainer, Mr D. Oxlade, was advised that a warning had been placed on the gelding in relation to its pre-race manners.

BARACONI (M. Collett) - rider reported that the mare made excess respiratory noise during the event and upon pulling up. A post-race veterinary examination revealed the mare to have a slower than expected recovery. Trainer, Mr M. Huxtable, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

LUCKY DOG (A. Jordsjo) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

OAKFIELD GERONIMO (J. Doyle) - raced wide without cover throughout the event.

TURF TAPPER (J. Potter) - jumped away awkwardly.



EFFORTKAT (D. Tourneur) - approaching the 400 metres laid out and became awkwardly placed on the heels of TURF TAPPER for a short distance.

PALE ALE (E. Boyd) - inclined to lay out under pressure in the straight.

RACE 6: ADELAIDE HILLS INSURANCE BROKERS BENCHMARK 54 HANDICAP - 1900 Metres

HASTY (K. Crowther) - raced wide without cover throughout the event. Laid in severely in the straight. Rider reported that the gelding laid in throughout the event but more so under pressure in the straight.

FORAOISE (B. Price) - upon arrival at the barriers underwent a pre-race veterinary examination and was passed fit to start.

SEMYORKA (C. Rawiller) - a post-race veterinary examination revealed no visible abnormalities.

VANCOUVER VELVET (S. Logan) - laid out under pressure in the straight.

I'LL BE GONE (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

SAWTELL (NZ) (J. Potter) - had difficulty obtaining clear ground from the entrance to the straight until near the 300 metres.

BLUE BEAR (P. Gatt) - held up from the entrance to the straight until approaching the 200 metres.

ANOTHER WHINE (J. Maund) - rider reported that the gelding did not travel well during the event and made excess respiratory noise. A post-race veterinary examination revealed the gelding to have a lower than expected heart rate.

NANAMU (E. Annells) - rider reported that the mare laid in throughout the event.

RACE 7: NEUTROG BENCHMARK 54 HANDICAP - 1050 Metres

FERGIE (E. Finnegan) - severely hampered in the vicinity of the 500 metres when taken wider by SKARA BRAE, which had been taken out.

RICHEDE (K. Crowther) - laid in under pressure over the concluding 300 metres.

GEANDGE (J. Doyle) - rider reported that the mare laid out rounding the home turn.

MAID IN MILAN (P. Gatt) - hung out rounding the home turn.

SKARA BRAE (J. Eaton) - raced keenly in the early and middle stages of the event. Inside the 600 metres was severely hampered when contacted by ARACHNATTACK and taken out onto FERGIE.

CASINO ANGEL (M. Collett) - laid out under pressure in the straight.

ARACHNATTACK (B. Price) - raced keenly in the early and middle stages of the event. Commenced to hang out severely near the 600 metres making contact with the hind quarters of VIETTI and then continuing out making heavy contact with SKARA BRAE, which was taken out onto FERGIE. Trainer, Mr S. Lenehan was advised that the gelding would now be required to jump out or trial around a bend to the satisfaction of Stewards in an Official Barrier Trial or Approval to Race jump-out prior to a future race start. A post-race veterinary examination revealed no visible abnormalities.

GOLDEN RIPPLES (J. Maund) - in the vicinity of the 200 metres was reluctant to improve and then became disappointed when attempting a tight run between DEXTER DUTTON and MAID IN MILAN.
