

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphettville
Racecourse by the South Australian Jockey Club on
Saturday, 9 April 2022

RACE 1: ADELAIDE RACING CARNIVAL APRIL 30TH TO MAY 21ST HANDICAP - 1200 Metres

LEFT HAND MAN (A. Chung) - knuckled at the start and was awkward to begin. Inclined to lay out in the straight and shifted out slightly inside the 200 metres.

CALYPSO REIGN (K. Crowther) - approaching the 200 metres was disappointed for clear running when attempting to improve between POINT BLAZE and FRANCE'S BOY as POINT BLAZE commenced to roll in and was obliged to shift to the outside of POINT BLAZE to obtain clear running.

MR MARATHON MAN (GB) (J. Opperman) - underwent a pre-race veterinary examination and was passed fit to race. Raced keenly in the early stages of the event. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

POINT BLAZE (P. Gatt) - approaching the 200 metres rolled in and inconvenienced CALYPSO REIGN, which was obliged to shift to its outside to obtain clear running.

NICAJON (B. Vorster) - from inside the 200 metres had difficulty obtaining clear running between FRANCE'S BOY, which rolled in and LEFT HAND MAN, which was inclined to lay out and shifted out slightly, and as a consequence was not able to be fully tested until inside the 100 metres.



RACE 2: THOMAS FARMS HANDICAP - 2032 Metres

ALL HARD WOOD (M. Lawrence) - over-raced for a short distance in the middle stages of the event.

PRINCE OF FENCES (B. Price) - raced keenly in the early stages of the event and thereafter, raced wide without cover from approaching the 1600 metres and laid in, in the straight. Rider explained that his instructions were to allow the horse to settle where comfortable, however, he stated that owing to the formation of the field approaching the first turn, after passing the crossing near the 1800 metres, he raced in restricted room for a short distance to the inside of ALL HARD WOOD, and was unable to maintain his position, and consequently was obliged to initially settle further back before improving to take up a slightly more forward position but was then caught wide without cover. He added the gelding failed to respond to his riding at the entrance to the straight, commenced to lay in and failed to finish the event off and was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

DOES IT (NZ) (J. Toeroek) - laid in, in the straight.

RACE 3: THE JUNCTION HANDICAP - 1050 Metres

LIBIAMO (K. Crowther) - laid in approaching the 200 metres, shifted in and brushed with JAAZEB.

VALUABLE WITNESS (P. Gatt) - raced keenly in the early stages of the event.

JAAZEB (J. Bowditch) - approaching the 200 metres was brushed by LIBIAMO, which laid in and shifted in.

DARING MOVE (J. Toeroek) - rider reported the filly raced like a tired horse and hung out throughout the event. Co-Trainer Mr R. Jolly advised Stewards the filly would now be going for a spell.

RODEO (C. Murray) - a post-race veterinary examination revealed the filly had bled from both nostrils. Co-Trainer, Mr R. Jolly, was advised that as this was the filly's first bi-lateral bleed RODEO would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

FOUR WINDS (A. Jordsjo) - underwent a pre-race veterinary examination on arrival at the barriers, after it was kicked by another runner, which revealed the filly had lacerations to its off hind stifle. Acting on veterinary advice, FOUR WINDS was a late scratching by order of Stewards at 1.21pm.

RACE 4: HAPPY 60TH CP HANDICAP - 1600 Metres

DANON ROMAN (JPN) (C. Rawiller) - raced keenly in the early stages of the event.

MY MATE SONNY (C. Jones) - inside the 200 metres shifted in to improve and tightened CROWN MINT, resulting in J. Bowditch being obliged to take hold and restrain his mount to avoid the heels of MY MATE SONNY. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 10 April and to conclude at midnight on Monday, 18 April 2022; a period of four meetings.

TONGSAI BOSS (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

CROWN MINT (J. Bowditch) - inside the 200 metres was tightened by MY MATE SONNY, which shifted in to improve and as a consequence, had to be restrained to avoid the heels of MY MATE SONNY and was hampered for several strides.

ANNIKA (A. Chung) - raced keenly in the early and middle stages of the event. Approaching the 100 metres rider dropped his whip.





RACE 5: DEQUETTEVILLE STAKES - 1050 Metres

BISTRO (Z. Spain) - raced keenly in the early stages of the event.

AITCH TWO OH (J. Toeroek) - rider reported it was his intention to lead, however, having regard for the fact that the filly was slightly slow to begin, he was unable to do so.

WEE NESSY (P. Moloney) - raced greenly in the straight.

ROCKSTAR MEGGSY (J. Bowditch) - proved fractious after being loaded into its barrier stall, was removed and underwent a pre-race veterinary examination and was passed fit to race. Trainer Mr J. O'Connor was advised that a warning had been placed on the filly regarding its barrier manners. Awkward to begin. Approaching the 100 metres was momentarily inconvenienced by NAICONI, which shifted in abruptly.

NAICONI (B. Vorster) - raced keenly in the early stages of the event. Approaching the 100 metres raced greenly and shifted in abruptly of its own accord and momentarily inconvenienced ROCKSTAR MEGGSY.

AESCULUS (D. Tourneur) - awkward to begin.

KILLIAKO (K. Crowther) - laid out rounding the home turn and raced greenly in the straight. A post-race veterinary examination revealed no visible abnormalities.

VALLENCOURT (J. Hill) - raced keenly in the early stages of the event. Raced greenly in the straight.

RACE 6: M'S FABULOUS BIRTHDAY HANDICAP - 1526 Metres

CAFE RIZU (B. Price) - raced keenly in the early stages of the event. Laid in, in the straight. A post-race veterinary examination revealed cardiac arrhythmia. Trainer Mr W. Clarcken was advised the results of an ECG are to be forwarded to the RSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the mare performing satisfactorily in an Official Barrier Trial.

AMBIDAZZLE (C. Rawiller) - lost its near hind plate during the event.

PUDDING (NZ) (P. Gatt) - awkward to begin, shifted in and contacted HARBELLE, which was awkward to begin and shifted out. Inside the 1200 metres became awkward on the heels of HARBOURING for a short distance, owing to the lack of pace in the event. Near the 100 metres was hampered when taken wider by WHEELS OF COURAGE, which was taken out by HARBELLE, which shifted out to improve. A post-race veterinary examination revealed no visible abnormalities.

HARBOURING (J. Opperman) - very awkward to begin. Raced very keenly in the early and middle stages of the event. Near the 900 metres was obliged to shift away from the heels of BIG SUE after becoming awkward on the heels of that runner owing to the lack of pace in the event.

BIG SUE (K. Crowther) - raced keenly in the early stages of the event.

BIARCHI (S. Logan) - inclined to lay out in the straight.

WHEELS OF COURAGE (J. Toeroek) - laid out from near the 600 metres and near the 100 metres was tightened by HARBELLE, which shifted out to improve and as a consequence, was taken out onto PUDDING (NZ) making contact with that horse. A post-race veterinary examination revealed no visible abnormalities.

HARBELLE (T. Voorham) - was awkward to begin, shifted out and contacted PUDDING (NZ), which was awkward to begin and shifted in, as a consequence HARBELLE was hampered and lost its position at the start. Near the 100 metres, shifted out to improve its position and in doing so tightened WHEELS OF COURAGE onto PUDDING (NZ), resulting in these two runners making contact and both being hampered when taken wider. Rider was severely reprimanded and advised to take greater care when shifting ground in future.

FOX D'OR (W. Price) - underwent a pre-race veterinary examination as it had backed up after racing at Balaklava on 6 April 2022 and was passed fit to race.



RACE 7: AURARIA STAKES - 1800 Metres

BON'S A PEARLA (J. Hill) - awkward to begin, shifted in onto THE MAP at the start which was inconvenienced.

MAC 'N' CHEESE (B. Vorster) - raced keenly in the early and middle stages of the event. Approaching the winning post had its running taken by MY WHISPER, which shifted out and as a consequence, had to be checked away from the heels of that runner.

MY WHISPER (W. Price) - approaching the winning post shifted out taking the running of MAC 'N' CHEESE resulting in that horse having to be checked away from the heels of MY WHISPER. Rider pleaded guilty to a charge of careless riding under AR131(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 10 April and to conclude at midnight on Sunday, 17 April 2022; a period of three meetings.

STRAY (J. Toeroek) - held up for clear running from near the 500 metres and on entering the straight, shifted out in an attempt to improve and contacted ALWAYS ON MY MIND, which was slightly hampered.

DARZELA (Z. Spain) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by Z. Spain and noted that he used it on one occasion over the concluding 100 metres of the event.

THE MAP (B. Price) - tightened at the start between BON'S A PEARLA and SAVONIA, which both began awkwardly and shifted ground.

ALWAYS ON MY MIND (P. Moloney) - near the entrance to the straight was contacted by STRAY, which shifted out in an attempt to improve, had its hindquarters turned and was slightly hampered.

MORRISSETTE (K. Crowther) - near the entrance to the straight was inconvenienced when awkward on the heels of ALWAYS ON MY MIND, which was hampered by STRAY which shifted out, and as a consequence became held up for a number of strides.

SAVONIA (R. Downey) - awkward to begin and shifted out onto THE MAP.

Correct weight was delayed for this event to allow B. Vorster (MAC 'N' CHEESE), placed third and Trainer Mr T. McEvoy to view the vision in the straight.

RACE 8: PORT ADELAIDE GUINEAS - 1800 Metres

The start of this event was delayed approximately five minutes owing to a rider change for TOROPEAK being required after rider R. Tan's late arrival on course owing to delays experienced with his flight from Melbourne.

SAINT TROPEZ (J. Bowditch) - laid in, in the straight.

HARLEYSMOVEN (R. Hurdle) - awkward to begin, shifted in and contacted ALORS TU CROIS.

RESIDUE (J. Eaton) - Prior to the entrance to the straight attempted to improve inside RESET THE JAZZ, shifted out and contacted that horse but was unable to shift that horse wider and as a consequence, became held up between that horse and TOROPEAK, which shifted out slightly. As a consequence, RESIDUE was unable to improve its position, had to be steadied and became awkward on the heels of TOROPEAK for several strides before again attempting to improve to the outside of that horse approaching the 200 metres but then became held up as TOROPEAK rolled out and was unable to improve its position for a short distance thereafter.

RESET THE JAZZ (C. Murray) - contacted prior to the entrance to the straight by RESIDUE which shifted out slightly. A post-race veterinary examination revealed no visible abnormalities.

SHALAGA (B. Vorster) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

AITCH D'AMICO (P. Gatt) - approaching the 100 metres was obliged to alter course to the outside of ALORS TU CROIS, which shifted in.

RACE 8: PORT ADELAIDE GUINEAS - 1800 Metres (Cont'd)

BLACKCOMB (J. Toeroek) - underwent a pre-race veterinary examination on arrival on course and was passed fit to race.

ALORS TU CROIS (W. Price) - awkward to begin, shifted out and contacted HARLEYMOVEN and as a consequence, became severely hampered. Near the 100 metres shifted in and inconvenienced AITCH D'AMICO, which was obliged to shift to its outside.

TOROPEAK (M. Lawrence) - raced keenly in the early stages of the event. Near the entrance to the straight shifted out and momentarily tightened RESIDUE, which was hampered and thereafter near the 200 metres, rolled out and hampered RESIDUE for several strides. Rider was reminded of her obligations when her mounts commence to shift ground.

SUSANNE JOY (J. Hill) - raced keenly in the early stages of the event.

RACE 9: GRAND SYNDICATES - NEW YEARLINGS AVAILABLE NOW! HANDICAP - 1100 Metres

ASTON RAPOVA (C. Rawiller) - contacted at the start. Shifted in near the winning post and inconvenienced THREE TEARS. Rider was spoken to regarding his use of the whip, with specific reference to him using his whip in a manner that raised his arm above shoulder height over the concluding stages.

CALL ME CURTIS (T. Voorham) - awkward to begin, shifted out and contacted ASTON RAPOVA and as a consequence, became unbalanced.

STAR OF MANHATTAN (W. Price) - fractious in the barrier. Removed from the barriers and underwent a pre-race veterinary examination and was passed fit to race. Trainer Mr H. Dwyer was advised that a warning had been placed on the mare in relation to its barrier manners. Was off the bridle prior to the entrance to the straight and commenced to weaken noticeably in the straight. A post-race veterinary examination revealed a poor post-race recovery.

THREE TEARS (L. Lafferty) - raced keenly in the early stages of the event. Was held up for a short distance rounding the home turn. Near the winning post was tightened by ASTON RAPOVA, which shifted in under pressure.
