RACE 1: THE JUNCTION HANDICAP - 2500 Metres

GRINZINGER STAR (NZ) (A. Chung) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by A. Chung and noted that he used it on three occasions over the concluding 100 metres of the event. A post-race veterinary examination revealed no visible abnormalities.

PEARL BANDIT (T. Voorham) - near the 800 metres was forced to race in restricted room for a number of strides when SO BENE shifted out and TURF MAN held its line.

SO BENE (B. Vorster) - raced keenly in the early and middle stages of the event. Near the 800 metres shifted out slightly onto PEARL BANDIT, which was tightened onto TURF MAN.

TURF MAN (J. Maund) - raced keenly in the middle stages of the event. Laid out over the concluding 800 metres.

RACE 2: ADELAIDE RACING CARNIVAL - APRIL 30TH - MAY 21ST HANDICAP - 1050 Metres

SEVEN SECRETS (T. Voorham) - laid out under pressure over the concluding 200 metres.

PRAIRIE FLOWER (W. Price) - shifted out on jumping away contacting SOLAR BLAST.

SCORPION KING (C. Jones) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SOLAR BLAST (A. Chung) - contacted on jumping away. Raced extremely greenly throughout the event and was inclined to shift about throughout.





RACE 2: ADELAIDE RACING CARNIVAL - APRIL 30TH -MAY 21ST HANDICAP - 1050 Metres (Cont'd)

WALLY WEST (R. Hurdle) - jumped away awkwardly. On pulling up, shifted out abruptly dislodging it rider. R. Hurdle was examined by the First Care Medical Personnel and was passed fit to fulfil his remaining engagements. WALLY WEST galloped riderless for a short distance prior to being recaptured.

ORACLE SON (K. Crowther) - slow to begin. In the vicinity of the 300 metres was obliged to alter course to the outside of SNOW FALCON, which shifted in slightly, to obtain clear ground.

SNOW FALCON (Z. Spain) – near the 300 metres rolled in slightly onto ORACLE SON. Rider explained the filly travelled well in the early and middle stages of the event however, was under pressure from inside the 800 metres. He added that in his opinion had not appreciated the track condition. A post-race veterinary examination revealed the filly had bi-lateral shin soreness. Trainer Mr P. Stokes advised that SNOW FALCON would now be spelled.

RACE 3: FLEURIEU MILK COMPANY THREE-YEAR-OLD MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately two minutes.

APACHE KISS (S. Logan) - hung out rounding the home turn and under pressure in the straight.

BOOGIE NIGHTS (C. Jones) - lost its off hind plate during the event.

CAMBERWOOD (P. Gatt) – proved difficult to load. Trainer Mr J MacMillan was advised that the gelding would be required to load without delay in an official trial prior to a future race. Rider reported the gelding hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

QUEMAN (J. Potter) - raced keenly in the early and middle stages of the event.

STRIKE AWARD (R. Hurdle) - shifted in on jumping away and contacted WETSHOT.

WETSHOT (J. Toeroek) – lost its off fore plate en route to the barriers and required Farrier attention at the start. Contacted on jumping away. Hung out over the concluding 600 metres. A post-race veterinary examination revealed the colt to be lame in the off foreleg. Co-Trainer, Mr G. Richards, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

ALASKAN STORM (L. Neindorf) - laid in under pressure in the straight.

FONSALETTE (NZ) (J. Eaton) - jumped away awkwardly. Laid in under pressure in the straight.

RACE 4: KEEP THE LEGACY PROMISE THIS ANZAC DAY HANDICAP - 1050 Metres

LARKHAM (C. Rawiller) – in the vicinity of the 800 metres rolled in slightly onto SMOKIN' VAL. Inside the 100 metres was forced to take hold as it was taken in slightly onto the hindquarters of SMOKIN' VAL, which then rolled out slightly resulting in LARKHAM having to be aware of the heels of EXTREMELY LUCKY.

SMOKIN' VAL (D. Tourneur) – inside the 800 metres was inconvenienced when LARKHAM rolled in. Near the 500 metres dipped for no apparent reason. Inside the 100 metres had its hindquarters brushed by LARKHAM unbalancing the mare which, shifted out slightly taking LARKHAM out onto EXTREMELY LUCKY.

PIMM'S PARTY (J. Eaton) - jumped away awkwardly and was slow to begin. Lost its off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.



SACRED ARMOUR (NZ) (B. Vorster) - raced wide without cover throughout the event.

RACE 4: KEEP THE LEGACY PROMISE THIS ANZAC DAY HANDICAP - 1050 Metres (Cont'd)

EXTREMELY LUCKY (K. Crowther) - slow to begin. Had difficulty obtaining clear ground from the entrance to the straight until near the 100 metres. Inside the 100 metres shifted in slightly onto LARKHAM, which was taken in onto the hindquarters of SMOKIN' VAL.

RACE 5: GRAND SYNDICATES - NEW YEARLINGS AVAILABLE NOW! HANDICAP - 1200 Metres

TOMMY BLUE (C. Rawiller) – laid out rounding the home turn and under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ANOTHER AWARD (J. Eaton) - raced wide without cover throughout the event.

LA RICHESSE (B. Price) – rider reported the mare travelled well in the early and middle stages however, when asked for an effort, failed to respond and weakened from the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 6: R N IRWIN STAKES - 1100 Metres

TREKKING (G. Schofield) – slow to begin and shortly after was inconvenienced by DEXELATION, which shifted out. Near the 500 metres shifted out in an attempt to improve and in doing so, brushed SHAMINO. Rider explained the gelding travelled well in the early stages however, in the vicinity of the 500 metres, when he attempted to push out he was unable to do so due to the positioning of SHAMINO. He added when asked for an effort in the straight, TREKKING was unable to make any ground on other runners, in his opinion, due to the pattern of the race. A post-race veterinary examination revealed no visible abnormalities.

DEXELATION (J. Toeroek) – shifted out on jumping away onto TREKKING. A post-race veterinary examination revealed the gelding was exhibiting signs of the thumps. First aid administered.

OUTLAWS REVENGE (C. Rawiller) - a post-race veterinary examination revealed no visible abnormalities.

BELLA VELLA (K. Crowther) - laid out under pressure in the straight.

RACE 7: FURPHY HANDICAP - 1600 Metres

HARBOURING (Z. Spain) – underwent a pre-race veterinary examination and was passed fit to start. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

BIG SUE (K. Crowther) - laid out under pressure in the straight.

PUDDING (NZ) (P. Gatt) – inside the 500 metres was taken out slightly by REBEL LEE and then became awkwardly placed on the heels of ZOUSTORM before shifting out abruptly across that gelding's heels. Laid in under pressure in the straight.

RAPID RAISER (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip D. Tourneur and noted that he used it on three occasions over the concluding 100 metres of the event.

REBEL LEE (T. Voorham) – inside the 500 metres shifted out slightly onto PUDDING (NZ). Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by T. Voorham and noted that she used it on two occasions over the concluding 100 metres of the event. A post-race veterinary examination revealed no visible abnormalities.



RACE 7: FURPHY HANDICAP - 1600 Metres (Cont'd)

SEMYORKA (W. Price) - Stewards acceded to a request from Trainer Mr R. Balfour to have the gelding race in visors in this event. Having regard for the fact that the request was made after acceptance, Stewards, while acceding to the request, imposed a fine of \$200 under AR206(2). Shifted in slightly in the vicinity of the 1200 metres onto ZOUSTORM. A post-race veterinary examination revealed no visible abnormalities.

ZOUSTORM (B. Vorster) - jumped away awkwardly. In the vicinity of the 1200 metres was awkwardly placed for a short distance when racing to the inside of SEMYORKA, which shifted in slightly. At the entrance of the straight raced in restricted room for a short distance between SEMYORKA and PUDDING (NZ). Rider reported that he felt something amiss with his horse behind for a short distance inside the 500 metres. A post-race veterinary examination revealed a lower than expected heart rate.

RACE 8: REDELVA STAKES - 1100 Metres

The start of this event was delayed approximately two minutes.

BACCHANALIA (G. Schofield) – got its off hind leg up momentarily in the barrier structure after being loaded and was backed out. Underwent a pre-race veterinary examination and passed was passed fit to race. Jumped away awkwardly. Near the 900 metres shifted in onto MAGIC MAX, which was forced to be steadied. Rider was reprimanded and advised in future to ensure he was sufficiently clear prior to commencing to shift ground.

HERESY (K. Crowther) – became awkwardly placed on heels for a number of strides near the 500 metres and was obliged to alter course to the inside to obtain clear ground.

MAGIC MAX (L. Neindorf) – contacted on jumping away. Near the 900 metres had to be steadied when BACCHANALIA shifted in.

DIRECT (J. Bowditch) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

LIBIAMO (W. Price) – jumped away awkwardly and shifted in onto MAGIC MAX.

RACE 9: MURRAY AND BARB STEWART'S 64TH ANNIVERSARY HANDICAP - 1600 Metres

DANON ROMAN (JPN) (J. Bowditch) - raced keenly in the early and middle stages of the event.

MAGNETIC EDGE (J. Maund) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by J. Maund and noted that he used it on six occasions over the concluding 100 metres of the event. Awkwardly placed on the heels of DANON ROMAN (JPN) form the vicinity of the 1000 metres until near the 700 metres.

NOT USUAL GLORIOUS (P. Gatt) - laid in under pressure in the straight.

PERFECT ROUTE (B. Vorster) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

AESOP (IRE) (Z. Spain) - slow to begin.

FEUERMOND (GER) (J. Eaton) – slow to begin. Lost its near fore plate during the event. Rider reported the gelding travelled well in the early and middle stages of the event however, when asked for an effort failed to let down and was disappointing over the final 200 metres. A post-race veterinary examination revealed no visible abnormalities.



GETOUTTHEWAY (K. Crowther) - inclined to lay in under pressure in the straight.

ADDITONAL REPORT <u>STRATHALBYN - Wednesday, 20 April 2022</u> <u>RACE 7: SPRINGFIELD FARM BENCHMARK 62 HANDICAP</u> - 1200 Metres

INSPIRED SUN (P. Gatt) - A post-race veterinary examination revealed the gelding was lame in the near foreleg. Trainer Mr D. Jolly was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.
