## RACE 1: G.H. MUMM HANDICAP - 1400 Metres (Parks track)

YULONG PATROL (IRE) (J. Opperman) - raced wide without cover in the middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by J. Opperman and noted that he used it on seven occasions over the final 100 metres of the event.

DROP THE MIC (J. Mott) - shifted out at the start onto GOING GAGA.

METRO LEGEND (A. Jordsjo) - contacted at the start.

GOING GAGA (M. Collett) - awkward to begin and shortly thereafter was tightened between DROP THE MIC, which shifted out and CHILL WITH TEEJAY, which shifted in.



RACE 1: G.H. MUMM HANDICAP - 1400 Metres (Parks track) (cont'd)

RIALTOR (A. Chung) - late scratching by order of the Stewards at 9.00 am acting on confirmed advice from Trainer, Mr S. Padman, that the gelding had an elevated temperature and would be unfit to start.

CHILL WITH TEEJAY (L. Neindorf) - shifted in at the start onto GOING GAGA.

MR METRICS (C. Williams) - awkward to begin, shifted out and contacted METRO LEGEND.

MARINA (J. Maund) - awkward to begin.

RACE 2: PFD FOODS HANDICAP - 1250 Metres (Parks track)

MIROKU (B. Price) - awkward to begin, shifted out and contacted GARRIRE.

DANISH FORTUNE (C. Williams) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by C. Williams and noted that he used it on seven occasions over the final 100 metres of the event.

WARMINSTER (A. Chung) - awkward to begin.

RIVALDO (J. Mott) - shifted in at the start onto BON PEGASUS.

BON PEGASUS (K. Crowther) - tightened shortly after the start between RIVALDO, which shifted in and GARRIRE, which was taken out by MIROKU and as a consequence was hampered for several strides.

SHE'S A TOFF (S. Logan) - awkward to begin. Raced keenly in the early and middle stages of the event. Inclined to lay out over the concluding stages of the event.

L'IL PIPER (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

GARRIRE (P. Gatt) - contacted at the start. Shortly after the start was tightened between MIROKU, which shifted out and BON PEGASUS, which was taken in by RIVALDO and as a consequence was hampered for several strides.

RACE 3: THOMAS FARMS HANDICAP - 1000 Metres (Parks track)

STAR HILLS (A. Chung) - shifted out abruptly over the concluding stages of the event and hampered TANJA'S DREAM, which shifted in slightly. Rider was severely reprimanded under AR131(a) and advised to take greater care when shifting ground.

HEKA EXPRESS (S. Logan) - raced keenly in the early stages of the event.

IRISH MINT (L. Neindorf) - awkward to begin.

METEORITE (J. Kah) - lost its off hind plate during the event. Held up for clear running from near the entrance to the straight until approaching the 200 metres.


RACE 4: H C NITSCHKE STAKES - 1400 Metres (Parks track)

HOPON HARRY (D. Oliver) - held up for clear running from shortly after the entrance to the straight when racing behind ASYMMETRICAL and LIBIAMO and was unable to improve its position until inside the 150 metres where it was obliged to shift to the outside of LIBIAMO.

KNIGHTSTOWN (R. Hurdle) - rider accidentally lost control of his near side rein near the 100 metres and regained it shortly thereafter.

PRINCE JOFRA (J. Allen) - awkward to begin, shifted in and contacted SOMEWATT FABULOUS.





#### RACE 4: H C NITSCHKE STAKES - 1400 Metres (Parks track) (cont'd)

ASYMMETRICAL (D. Moor) - awkward to begin, shifted out and tightened DISAGREEABLE MISS onto ZOURISKY at the same time as that horse was tightened by STAR OF CHAOS, which was awkward to begin and shifted in. As a consequence, ZOURISKY had to be severely checked and DISAGREEABLE MISS was unable to maintain its position. Raced keenly in the early stages of the event.

LIBIAMO (K. Crowther) - raced keenly in the early stages of the event.

PERCEPTIVE (J. Kah) - raced keenly in the early stages of the event.

SOMEWATT FABULOUS (J. Toeroek) - awkward to begin, shifted out and contacted PRINCE JOFRA.

DEFINING (NZ) (B. Vorster) - lost its near fore plate during the event. Held up for clear running from shortly after the entrance to the straight until near the 300 metres, where it was obliged to shift to the inside of PRINCE JOFRA to obtain clear running.

DISAGREEABLE MISS (J. Eaton) - tightened at the start between ASYMMETRICAL, which shifted out and ZOURISKY, which was taken in and as a consequence was unable to maintain its position. Rider reported that as a consequence of suffering interference at the start, she was unable to take up a more forward position as intended.

ZOURISKY (D. Thornton) - tightened at the start between DISAGREEABLE MISS, which was tightened by ASYMMETRICAL and STAR OF CHAOS, which was awkward to begin and shifted in and as a consequence had to be severely checked. Rider reported that as a consequence of suffering interference at the start, he was unable to take up a more forward position as intended. Raced keenly in the early stages of the event.

STARSONGARI (P. Gatt) - late scratching by order of the Stewards at 7.45 am acting on veterinary advice. An inquiry into the circumstances surrounding the late scratching of the filly will be conducted at a date and time to be fixed.

#### RACE 5: BREEDERS' STAKES - 1200 Metres (Main track)

TWIN STARS (B. Vorster) - laid in, in the straight.

EYE OF THE EAGLE (J. Mott) - raced very keenly in the early and middle stages of the event. Laid in over the concluding stages of the event.

SPENCER'S SPIRIT (P. Gatt) - raced very keenly in the early stages of the event.

SIR GRUMPY (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.


STREET DELIGHT (D. Oliver) - underwent a pre-race veterinary examination and was passed fit to start. Disappointed for clear running from shortly after the entrance to the straight, became held up for clear running and inside the 200 metres was obliged to shift out wider on the track to improve its position.

#### RACE 6: CHAIRMAN'S STAKES - 2000 Metres (Main track)

HARLEYMOVEN (R. Hurdle) - rider explained that his instructions were to ride the gelding quietly from its wide barrier in an attempt to get cover and to avoid being caught wide without cover. He added that although the plan was to ride the gelding quietly, it got further back than expected as the gelding relaxed in the run after being restrained. Co-Trainer, Mr Dan Clarken confirmed the instructions and also stated that he had not anticipated the early pace to be as strong as it was, the result of which left HARLEYMOVEN a little further out of its ground than planned.

SON OF EMPEROR (J. Kah) - raced keenly in the early stages of the event. Approaching the 200 metres was obliged to be steadied when its running was taken by ALPINE BEAU which shifted out to improve. Rider reported that the colt laid out during the event. A post-race veterinary examination revealed no visible abnormalities.

ASHY BOY (J. Eaton) - awkward to begin.



RACE 6: CHAIRMAN'S STAKES - 2000 Metres (Main track) (cont'd)

PALANI (J. Allen) - raced keenly in the early stages of the event.

BOOLCUNDA KING (D. Tourneur) - near the 1600 metres got its head up and raced ungenerously for a short distance.

THE MAP (B. Price) - approaching the 100 metres attempted a run to the outside of ALPINE BEAU and contacted the hind quarters of that gelding.

PUDDING (NZ) (P. Gatt) - approaching the 200 metres rolled out slightly and in doing so impacted on ALPINE BEAU, which had improved to its outside. Rider was reminded of his obligations when his mounts commence to shift ground.

FLIGHT DECK (NZ) (L. Neindorf) - raced wide without cover from near the 1600 metres.

ALPINE BEAU (J. Maund) - approaching the 200 metres shifted to the outside of PUDDING (NZ) to improve, as that horse rolled out slightly and took the running line of SON OF EMPEROR, resulting in that horse having to be steadied as a consequence. Rider was severely reprimanded under AR131(a) and advised to take greater care when shifting ground. Approaching the 100 metres had its hind quarters turned by THE MAP, when that horse attempted to improve to its outside.

RACE 7: GRAND SYNDICATES AUSTRALASIAN OAKS - 2000 Metres (Main track)

BARB RAIDER (C. Williams) - near the crossing in the vicinity of the 1800 metres shifted in slightly and momentarily inconvenienced STRAY.

DAISIES (M. Zahra) - laid in, in the straight. Rider was reprimanded under AR132(6)(a) for using his whip forward of his horse's shoulder on one occasion.

BON'S A PEARLA (J. Hill) - held up from inside the 400 metres until inside the 300 metres.

MY WHISPER (J. Kah) - approaching the crossing near the 1800 metres had its hind quarters contacted and turned by ROOTS which, when being restrained after racing in restricted room to the inside of STRAY, shifted in slightly. Held up for a number of strides from near the entrance to the straight.

MAC 'N' CHEESE (B. Vorster) - approaching the 1600 metres was tightened by LADY CHANT, which rolled in and away from DAISIES, which shifted in momentarily, and as a consequence contacted the inside running rail and was hampered. Had difficulty obtaining clear running from approaching the 100 metres and was unable to be fully tested over the final 100 metres of the event. Rider reported that the filly was not suited by the tempo in today's event and over the concluding stages he was unable to fully improve into clear running. A post-race veterinary examination revealed no visible abnormalities.

GLINT OF HOPE (JPN) (D. Moor) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by D. Moor and noted that he used it on seven occasions over the final 100 metres of the event.

LADY CHANT (G. Schofield) - trainer, Mr B. Lewthwaite was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card for this filly. The horse was permitted to start as it was able to be identified from records held by the Stewards.

STRAY (J. Toeroek) - near the 1800 metres was obliged to steady away from the heels of BARB RAIDER, which shifted in slightly.

ROOTS (D. Thornton) - approaching the crossing near the 1800 metres was obliged to race in restricted room to the inside of STRAY, which steadied away from the heels of BARB RAIDER and as a consequence ROOTS shifted in and contacted the hind quarters of MY WHISPER. Laid in under pressure in the straight.



RACE 8: CITY OF ADELAIDE HANDICAP - 1400 Metres (Parks track)

GROUNDSWELL (M. Zahra) - rider reported that the gelding was disappointing in its performance. A post-race veterinary examination revealed the gelding to have a small laceration to its near fore fetlock and it to be lame in the near foreleg. First aid was administered. Co-trainer, Mr A. Freedman was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

ROYAL MILE (J. Opperman) - shifted in at the start and contacted MY MATE SONNY. A post-race veterinary examination revealed no visible abnormalities.

BOLD STAR (L. Neindorf) - approaching the 100 metres shifted in and inconvenienced MY MATE SONNY.

ONE MORE JACK (J. Potter) - contacted on a number of occasions in the straight by MY MATE SONNY, which laid in and shifted in.

STRUCK BY (P. Gatt) - over raced in the early stages of the event. Inside the 1200 metres got its head up when being restrained and raced ungenerously for a number of strides.

MY MATE SONNY (C. Jones) - Stewards permitted C. Jones to ride the gelding 0.5 kg over its declared weight of 54.0 kg. Shifted out at the start and contacted ROYAL MILE. Laid in, in the straight and contacted ONE MORE JACK on a number of occasions. Approaching the 100 metres was momentarily inconvenienced and had to be steadied, when awkward inside the heels of BOLD STAR, which shifted in.

RACE 9: JAMES SQUIRE HANDICAP - 1300 Metres (Parks track)

EXTRA TIME (T. Voorham) - rider reported that the gelding was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

JAGUARY (NZ) (D. Tourneur) - near the 100 metres was obliged to be steadied after improving onto the heels of LEFT HAND MAN, shifted out to improve and over the concluding stages was contacted by WILD IMAGINATION (NZ), which rolled in and as a consequence was inconvenienced.

MY BOY BIRMINGHAM (J. Kah) - raced very keenly in the early stages of the event.

GIGGLON (M. Collett) - very awkward to begin. Raced wide without cover from inside the 1200 metres.

YABADABADOO (NZ) (B. Vorster) - awkward to begin. Laid in for a short distance near the 600 metres.

SKILLED BUNCH (J. Eaton) - held up from inside the 400 metres until inside the 100 metres and as a consequence the mare was untested for the majority of the straight.

TUBBY TWO TRACKS (C. Murray) - laid out in the straight.

WILD IMAGINATION (NZ) (J. Toeroek) - Stewards permitted J. Toeroek to ride the mare 0.5 kg over its declared weight of 54.0 kg. Unable to obtain clear running throughout in the straight and as consequence was untested to the line, and over the concluding stages rolled in and contacted JAGUARY (NZ).
