RACE 1: WESLO SECURITY HANDICAP - 1100 Metres

NO DRAMA (NZ) (J. Fry) – proved fractious in its barrier stall after being loaded. Awkward to begin. Shifted its off hind plate during the event.

RUBINI (Z. Spain) - slow to begin. Near the 900 metres was hampered for a number of strides when tightened by TE PIRO, which shifted in, and as a consequence had to be steadied. A post-race veterinary examination revealed the gelding to be lame in the near hind leg. Co-Trainer, Mr G. Richards, was advised that a Veterinary Clearance was required prior to a future trial or race start.

TAPINFORPAR (R. Hurdle) - raced greenly in the early stages and inside the 800 metres shifted in and brushed the inside running rail for several strides.

I'M A DEXSTAR (D. Caboche) - contacted at the start. Raced keenly in the early stages of the event.

FIELD THE MOMENT (K. Crowther) - began awkwardly, shifted in and contacted I'M A DEXSTAR.

IMAPARTYGIRL (P. Gatt) – awkward to begin. Commenced to weaken shortly after the entrance to the straight and was eased down by its rider from inside the 200 metres. A post-race veterinary examination revealed the filly to be lame in the off hind leg. Co-Trainer, Mr G. Richards, was advised that a Veterinary Clearance was required prior to a future trial or race start.

# RACE 1: WESLO SECURITY HANDICAP - 1100 Metres (Cont'd)

REBEL CONSORTIUM (T. Voorham) - slow to begin. Raced keenly in the early and middle stages of the event. Rider reported that as a consequence of being slow to begin, she was unable to settle in a more forward position as intended.

TE PIRO (J. Holder) - near the 900 metres shifted in and hampered RUBINI for a number of strides. Rider was severely reprimanded and advised to take greater care when shifting ground in future.

#### RACE 2: THE JUNCTION HANDICAP - 1200 Metres

KENYAN WONDER (C. Rawiller) - as a consequence of being tightened by GO BUNDLE, lost its position at the start. Laid in, in the straight.

KAYSERI (NZ) (B. Price) - very awkward to begin and shortly thereafter was tightened between SIDEARM, which maintained its line and KENYAN WONDER, which was taken out by GO BUNDLE, which began awkwardly and shifted out. Raced very keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

GO BUNDLE (B. Vorster) - began awkwardly, shifted out and contacted KENYAN WONDER at the start. A post-race veterinary examination revealed no visible abnormalities.

CLASSY KENNY (J. Maund) – raced keenly in the early stages of the event. Held up for clear running from near the entrance to the straight until near the 100 metres.

SIDEARM (T. Pannell) - raced very keenly in the early and middle stages of the event.

#### RACE 3: LECONFIELD HANDICAP - 2500 Metres

ONE MORE TRY (B. Vorster) - slow to begin. Rider reported the mare never travelled during the event, was off the bridle and disappointing in its finishing effort. A post-race veterinary examination revealed no visible abnormalities.

REFLECT THE STARS (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

SMILING ASSASSIN (E. Boyd) - laid in, in the straight. Rider lost control of her near side rein inside the 100 metres, and regained control shortly after the winning post.

MANZALA (B. Price) - Trainer Ms A. Downing informed Stewards of a change in tactics in that she would instruct her rider to settle further forward than at its last start. Settled on pace.

OURKHANI (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 0.5 kg over its declared weight of 54kg.

RISING RENOWN (NZ) (J. Benbow) - had its cross over nose band readjusted at the start.

SANTELMO FUEGO (C. Murray) - Stewards permitted C. Murray to ride the gelding 0.5 kg over its declared weight of 54kg.

STAYING STRONG (D. Caboche) - raced wide without cover throughout the event.

#### RACE 4: GEORGE PAGE MEMORIAL HANDICAP - 1200 Metres

DARCEANDERMILL (S. Logan) - began awkwardly, shifted in and contacted FAST AND FLEXIBLE.

OUR HEIDI (K. Crowther) - shifted out on jumping away and contacted RUN AND TELL. A post-race veterinary examination revealed the filly to be lame in the off hind leg. Trainer, Mr P. Stokes, was advised that a Veterinary Clearance was required prior to a future trial or race start.

RUN AND TELL (A. Chung) - contacted at the start. A post-race veterinary examination revealed no visible abnormalities.

# RACE 4: GEORGE PAGE MEMORIAL HANDICAP - 1200 Metres (Cont'd)

STAR ESPRESSO (P. Gatt) - rider reported the filly never travelled, was off the bridle and felt awkward in its action during the event. A post-race veterinary examination revealed no visible abnormalities.

VERBANO (Z. Spain) - shifted in on jumping away and contacted CHICAGO STORM. Laid in, in the straight.

SABERMETRIC (B. Price) - raced keenly in the early stages of the event. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

SADLER'S SONG (T. Voorham) - lost its off fore plate during the event.

FAST AND FLEXIBLE (J. Potter) - contacted at the start.

#### RACE 5: FLEURIEU MILK COMPANY HANDICAP - 1524 Metres

ANOTHER RALLY (NZ) (M. Payne) - raced keenly in the early stages of the event. Inside the 1300 metres became awkward on the heels of EL CORDOBES and had to be steadied.

SIX FOOT SONG (T. Pannell) – rider reported the gelding never travelled, was off the bridle in the early and middle stages and raced flat in its manner. Rider did not persevere with his riding from shortly after the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr J. MacMillan advised the gelding would now be spelled.

EN FRANCAIS (K. Crowther) - awkward and slow to begin.

GARRIRE (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

#### RACE 6: HAPPY 40TH BIRTHDAY BEN AREZINA HANDICAP - 1200 Metres

OUTLAWS REVENGE (C. Rawiller) - a post-race veterinary examination revealed no visible abnormalities.

EXTRA TIME (J. Holder) - hung out from rounding the home turn, A post-race veterinary examination revealed no visible abnormalities.

EXTRA MILE (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 0.5 kg over its declared weight of 54kg.

HANKSTAR (E. Annells) - awkward and slow to begin and thereafter was slow into stride, losing contact with the field.

### RACE 7: GRAND SYNDICATES - NEW YEARLINGS AVAILABLE NOW! HANDICAP - 1600 Metres

JAGUARY (NZ) (J. Benbow) - contacted at the start. A post-race veterinary examination revealed no visible abnormalities.

LEFT HAND MAN (J. Holder) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SOMERSET MAUGHAM (IRE) (T. Pannell) - raced wide without cover in the middle stages of the event.

LAKE'S FOLLY (A. Chung) - shifted out at the start and contacted JAGUARY (NZ).

SKILLED BUNCH (P. Gatt) - rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was fined \$400.

KISSINGER (NZ) (J. Fry) - underwent a pre-race veterinary examination and was deemed unsuitable to race after sustaining multiple abrasions to the near hind and being found to be lame in the same leg. KISSINGER (NZ) was declared a late scratching, by order of Stewards, at 9.45 am on veterinary advice. Trainer, Mr L. Smith, was advised that a Veterinary Clearance was required prior to a future trial or race start.

# RACE 7: GRAND SYNDICATES - NEW YEARLINGS AVAILABLE NOW! HANDICAP - 1600 Metres (Cont'd)

HYPERCANE (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

#### RACE 8: FURPHY HANDICAP - 1050 Metres

The start of this event was delayed by approximately three minutes.

FIGHTING MCLAREN (C. Rawiller) - a post-race veterinary examination revealed no visible abnormalities.

MODEAR (A. Chung) - inconvenienced near the entrance to the straight by ZARACE which shifted out.

ASTON RAPOVA (B. Vorster) - raced keenly in the early stages of the event.

WOTUWANT (D. Caboche) - awkward to begin. Raced keenly in the early stages of the event.

GRAND HOST – acting on confirmed advice from Trainer Mr M. Seyers that the gelding had sustained an injury to its off hind fetlock Stewards declared GRAND HOST a late scratching at 9.52am. Trainer, Mr M. Seyers, was advised that a Veterinary Clearance was required prior to a future trial or race start.

CHOSEN BLONDE (J. Toeroek) - a post-race veterinary examination revealed speedy cuts to both hind legs.

LAMOREE (P. Gatt) - hung out from near the entrance to the straight, shifted out and inconvenienced MISS DANIEL near the 200 metres, resulting in that horse having to alter course to its inside. Thereafter continued to hang out for the remainder of the event.

ZARACE (A. Jordsjo) - had its cross over nose band re-fitted at the barriers. Approaching the entrance to the straight shifted out, took the running of MODEAR inconveniencing that horse.

# RACE 9: CHARLES MELTON WINE LUNCH - SATURDAY JULY 16TH HANDICAP - 1800 Metres

YABADABADOO (NZ) (C. Rawiller) - laid in, in the straight.

ALSVIOR (P. Gatt) - raced keenly for a short distance approaching the 1600 metres. Held up for clear running from approaching the 400 metres until inside the 300 metres.

PRINCE OF FENCES (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr M. Hickmott, was advised that a Veterinary Clearance was required prior to a future trial or race start.

ALL HARD WOOD (J. Maund) - raced keenly in the early stages of the event.

SILENT DON (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

UNDERSTATEMENT (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 0.5 kg over its declared weight of 54kg.
