RACE 1: MAGIC MILLIONS TWO-YEAR-OLD PLATE - 1200 Metres

TAPINFORPAR (L. Neindorf) - in the vicinity of the 600 metres commenced to hang in and shifted in onto LORD BENTLEY and continued to hang in for the remainder of the event.

ATTRITION (J. Holder) - slow to begin. Difficulty obtaining clear ground from the entrance to the straight until near the 300 metres and was then disappointed for a run to the inside of LORD BENTLEY, which shifted in and as a result, was obliged to alter course to obtain clear ground.

JAJITTA BUG (J. Potter) - inconvenienced near the 600 metres when tightened by LORD BENTLEY onto PRANCE 'N' DANCE.

LORD BENTLEY (S. Metcalfe) - inconvenienced near the 600 metres when contacted by TAPINFORPAR and taken in onto JAJITTA BUG. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

MONSEAGLE (R. Hurdle) - inconvenienced in the vicinity of the 1100 metres when TAPINFORPAR shifted in slightly at the same time that TEST THE LAW shifted out slightly. Approaching the 200 metres had to momentarily steady when it was taken out slightly by ATTRITION onto the heels of CELTIC VADER, which shifted in slightly.



RACE 1: MAGIC MILLIONS TWO-YEAR-OLD PLATE - 1200 Metres (Cont'd)

PRANCE 'N' DANCE (S. Logan) - inconvenienced near the 600 metres when contacted by JAJITTA BUG. Rider reported that the filly had raced flat and had not travelled during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: KIMBOLTON WINES HANDICAP - 1000 Metres

SHAMINO (L. Neindorf) - slow to begin. Laid in under pressure in the straight.

AADELAD (J. Toeroek) – approaching the 200 metres was disappointed when attempting a tight run to the inside of ALLEBOOM, which shifted in slightly and was obliged to alter course to that gelding's outside to obtain clear ground.

TYDEUS (D. Caboche) - laid in under pressure in the straight.

MAGIC DELTA (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

RACE 3: GIPSIE JACK WINES HANDICAP - 1800 Metres

SCOTTISH DANCER (B. Price) – shifted out at the entrance to the straight in an attempt to improve and in doing so, made heavy contact with LAKE'S FOLLY. Rider of LAKE'S FOLLY held his line resulting SCOTTISH DANCER becoming awkwardly placed on the heels of HIGHLAND JAKK (NZ) for a number of strides before shifting in to obtain clear ground. Rider accidentally dropped his whip near the 300 metres. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr A. Bobbin, was advised that a Veterinary Clearance was required prior to a future trial or race start.

BEA TEMPTED (M. Lawrence) – rider explained that her instructions had been to settle in a position two to three lengths off the field, to work into the race and present the mare at the entrance to the straight. She added that she was able to comply with the instruction however, BEA TEMPTED had only travelled fairly in the early and middle stages of the event and when asked for an effort at the entrance to the straight, had only sprinted for a short distance from near the 400 metres until the 200 metres and then had been one paced to the finish. Trainer Mr P. Payne confirmed the instructions provided and undertook to report any abnormalities with the mare on return to his stables.

LAKE'S FOLLY (A. Chung) - raced keenly in the early and middle stages of the event. Inconvenienced at the entrance to the straight when contacted by SCOTTISH DANCER.

HIGHLAND JAKK (NZ) (T. Pannell) - had blood in its mouth on arrival at the barrier. Underwent a pre-race veterinary examination and was deemed suitable to race. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

ICHIBANSAN (J. Holder) - raced keenly in the early and middle stages of the event. Rider was reminded of his obligations in riding his horse out to the end of the race in accordance with AR131(b).

RACE 4: BEYOND INK HANDICAP - 1400 Metres

SHORT STORIES (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

TAKE ME NORTH (T. Voorham) - underwent a pre-race veterinary examination as it had not raced since 5 August 2021 and was deemed suitable to race. Held up from the entrance of the straight until near the 100 metres when awkwardly placed between the heel of PAINTED ON and HEADPHONES.

AROUND THE HORN (J. Potter) - contacted on jumping away. Inconvenienced near the 600 metres when HEADPHONES rolled in.

CANIDAE (J. Maund) - jumped away awkwardly.



RACE 4: BEYOND INK HANDICAP - 1400 Metres (Cont'd)

SUNNY GREEN (R. Hurdle) - jumped away awkwardly, shifted in and brushed AROUND THE HORN.

HEADPHONES (E. Boyd) - raced wide without cover throughout the event. Near the 600 metres rolled in slightly onto AROUND THE HORN. A post-race veterinary examination revealed no visible abnormalities.

SEAFARING (NZ) (S. Logan) – rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by S. Logan and noted that she used it on four occasions over the concluding 100 metres of the event.

RACE 5: FESTIVAL HIRE HANDICAP - 1400 Metres

SOWETO HAZE (C. Rawiller) - rolled in approaching the 100 metres onto WHISKEY 'N' WOMEN. A post-race veterinary examination revealed no visible abnormalities.

LONRODEX (L. Neindorf) - jumped away awkwardly and shifted out onto ZOUSTORM.

A KNIGHT IN PARIS (J. Potter) - raced wide without cover throughout the event.

EQUAL BALANCE (T. Pannell) - raced wide without cover throughout the event.

SMART CHARGE (E. Wong) - near the 100 metres had to be momentarily steadied, as it commenced to weaken, when SOWETO HAZE rolled in sightly.

WHISKEY 'N' WOMEN (E. Boyd) - slow to begin.

MAID IN MILAN (S. Metcalfe) - held up rounding the home turn. Had difficulty obtaining clear ground from in the straight until near the 200 metres.

ZOUSTORM (C. Jones) - hampered on jumping away when tightened onto FREE OF SIN by LONRODEX.

FREE OF SIN (B. Price) - laid in under pressure in the straight.

EM BRYAN (M. Vassallo) - jumped away awkwardly and then raced in restricted room for a short distance between YURI ROYALE, which shifted out slightly at the same time as THE MARKLE SPARKLE shifted in slightly.

RACE 6: TAB THREE-YEAR-OLD PLATE - 1200 Metres

The start of this event was delayed approximately one minute.

KARACASU (J. Toeroek) - laid in under pressure in the straight. Lost its off fore plate during the event. Rider explained that he had settled just behind mid-field just as he had anticipated and that the gelding had travelled well in the early and middle stages of the event however, when asked for an effort in the vicinity of the 500 metres, had not had responded in its normal manner and had been disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

KNIGHTSTOWN (T. Pannell) - slow to begin. Raced in restricted room over the concluding 100 metres.

QUEMAN (J. Potter) - difficult to load. Trainer Mr S. Oxlade was advised a warning had been placed on the gelding in relation to proving difficult to load.

PRINCE JOFRA (S. Metcalfe) - raced wide without cover throughout the event.

MAGIC MORRISS (B. Vorster) - jumped away awkwardly.



RACE 6: TAB THREE-YEAR-OLD PLATE - 1200 Metres (Cont'd)

APACHE KISS (J. Maund) – slow to begin and failed to maintain contact with the field. Rider reported that despite his efforts, the gelding was unable to maintain contact the field and did not respond to his riding when asked to improve. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr G. Lynch was advised that the gelding would be required to prove competitive in an Official Barrier Trial prior to accepting for a future race.

PRINCESS RAFFLES (C. Jones) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 200 metres.

RACE 7: NORTHPOINT MURRAYLANDS HANDICAP - 1200 Metres

JAAMINT (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

ANGASTON (A. Chung) - a post-race veterinary examination revealed a slower than expected recovery.

CONFIDANT (C. Rawiller) - slow to begin.

OH MO (B. Vorster) - slow to begin.

MR MARATHON MAN (B. Price) – held up at the entrance to the straight until in the vicinity of the 50 metres. Rider explained that upon entering the straight, he initially attempted to improve to the inside of UPPER EAST SIDE however, that gelding rolled in slightly resulting in him being disappointed for the run. He added he had then shifted out in an attempt to improve to the outside of that gelding and to the inside of JAAMINT however, when attempting to take that run, his mount laid out and he had become awkwardly placed on the heels of JAAMINT for a short distance. He further added that he had then attempted to improve between those runner however, both runners shifted marginally, resulting in him becoming held up until in the vicinity of the 50 metres where he was able to ease back and shift around the heels of JAAMINT to obtain clear ground.

RACE 8: DUTTON'S EASY TO DO BUSINESS WITH!! HANDICAP - 2500 Metres

LORD BOUZERON (NZ) (A. Chung) - raced keenly in the middle stages of the event.

GREY KHAN (C. Rawiller) - laid out under pressure in the straight.

CAPRICORN RIDGE (L. Neindorf) - jumped away awkwardly.

ZOFFALA (B. Vorster) - contacted on jumping away. Laid out under pressure in the straight.

AZZUREOUS (T. Pannell) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

PERFECT ILLUSION (GB) (J. Toeroek) - raced keenly in the early and middle stages of the event. Rider reported the gelding over-raced throughout and had never settled.

BEAR ARMS (T. Voorham) - inclined to lay in at the entrance to the straight and had difficulty obtaining clear ground for a short distance.

MONGOLIAN PRIDE (NZ) (E. Annells) - jumped away awkwardly and shifted in onto ZOFFALA.

RACE 9: CARLTON DRAUGHT HANDICAP - 1600 Metres

HARBOURING (C. Rawiller) - jumped away awkwardly. Laid out under pressure in the straight.

NEXT DIMENSION (NZ) (J. Holder) - near the 200 metres had to be steadied momentarily when tightened between YANACOCHA, which rolled out marginally as it commenced to weaken and KUTAYHA, which shifted in marginally.

YANACOCHA (S. Logan) - raced keenly in the early and middle stages of the event.

RACE 9: CARLTON DRAUGHT HANDICAP - 1600 Metres (Cont'd)

CHROMATICA (NZ) (B. Price) – was fractious in its float en route to the course. Underwent a prerace veterinary examination on arrival at the course who reported the filly had injured its off hind leg and would be unsuitable to race. Acting on this advice Stewards declared CHROMATICA (NZ) a late scratching at 1.35 pm.

RACE 10: LAKE BREEZE WINES HANDICAP - 1000 Metres

The start of this event was delayed approximately three minutes.

REWARD WITH RETURN (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

DAUNTING MAGIC (K. Crowther) - proved difficult to load. Trainer Mr D. Jolly was advised that the gelding would be required to load without delay in an official barrier trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

JIMMYS EDGE (T. Voorham) - underwent a pre-race veterinary examination as it had not raced since 31 March 2021 and was deemed suitable to race. Proved difficult to load. Co-Trainer Mr G. Richards was advised that a warning had been placed on the gelding in relation to its loading manners.

GLOVED (NZ) (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr W. Clarken, was advised that a Veterinary Clearance was required prior to a future trial or race start.

HONEY GO LIGHTLY (B. Vorster) - near the 150 metres improved onto the heels of GLOVED (NZ), which commenced to give ground and became held up for a short distance. A post-race veterinary examination revealed no visible abnormalities.

INEBRIATING (E. Boyd) - raced in restricted room for a short distance near the 200 metres.

THE PUBLIKIN (J. Toeroek) - slow to begin. Raced wide without cover throughout the event.

THE RAVEN (S. Metcalfe) – got its off foreleg up in the gates after being loaded. Underwent a prerace veterinary examination and was deemed unsuitable to race. Trainer Mrs K. Evans was advised that the gelding would be required to prove tractable in the barriers in an official barrier trial prior to accepting for a future race.
