Saturday, 30 July 2022

INTERIM

RACE 1: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1050 Metres

WHATSANAMEGEORGE (P. Gatt) - laid out under pressure in the straight.

NORTHUMBRIA (A. Kelly) - jumped away awkwardly. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

LOOKS LIKE A LADY (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2: THOMAS FARMS MAIDEN PLATE - 1100 Metres

LUCKY BLUE (T. Pannell) - inconvenienced on jumping away.

BORN TO RUN (NZ) (R. Hurdle) - rider pleaded guilty to a charge under AR132(7)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by R. Hurdle and noted that he used it on eight occasions over the concluding 100 metres of the event.

AWEN (IRE) (K. Crowther) - jumped away awkwardly and shifted in onto LUCKY BLUE. A post-race veterinary examination revealed no visible abnormalities.



RACE 2: THOMAS FARMS MAIDEN PLATE - 1100 Metres (Cont'd)

FINAL JEDI (J. Toeroek) - raced three wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

KATIM'S CLUB (C. Murray) - inclined to shift about under pressure in the straight.

RACE 3: FURPHY HANDICAP - 1800 Metres

The start of this event was delayed approximately three minutes to avoid a clash with an Interstate race.

SIGN OF USSURI (A. Kelly) - near the 150 metres was inconvenienced when taken in onto KHOEKHOE by ICHIBANSAN.

KHOEKHOE (K. Crowther) - raced keenly in the early and middle stages of the event. Near the 150 metres had to be momentarily steadied when SIGN OF USSURI was taken in. Rider reported the gelding had commenced to race keenly after being crossed in the middle stages and was inclined to lay out. She added, when placed under pressure in the straight, had not sprinted and had been one paced to the finish.

GATE CRASH (NZ) (T. Pannell) - rider report that the gelding had only travelled fairly in the early and middle stage and was inclined to lay in. He added, on straightening, when placed under pressure, GATE CRASH (NZ) commenced to lay in more severely and did not respond to his riding. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr P. Payne, was advised that a Veterinary Clearance was required prior to a future trial or race start.

SESTAR (C. Murray) - raced keenly in the early stages while being restrained.

ICHIBANSAN (J. Holder) - near the 150 metres shifted in and away from MISS GOBCAIN onto SIGN OF USSURI.

GETOUTTHEWAY (C. Jones) - jumped away awkwardly.

RACE 4: SPRING CARNIVAL AT MORPHETTVILLE (OCTOBER 8TH - NOVEMBER 5TH) HANDICAP - 1100 Metres

TEQUILA TIME (T. Voorham) - jumped away awkwardly and shifted out onto SHAMINO. Near the 500 metres shifted out slightly and contacted GREAT LEVELLER.

SHAMINO (L. Neindorf) - inconvenienced on jumping away when tightened between TEQUILA TIME and SPANISH HEIRLOOM.

SPANISH HEIRLOOM (J. Benbow) - shifted in on jumping away onto SHAMINO. A post-race veterinary examination revealed no visible abnormalities.

PINDARIC (T. Pannell) - jumped away awkwardly.

GREAT LEVELLER (E. Boyd) - raced three wide without cover throughout the event. Near the 500 metres shifted in slightly and contacted TEQUILA TIME.

WOTUWANT (J. Holder) - jumped away awkwardly. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Saturday, 6 August and to conclude at midnight on Wednesday, 10 August 2022: a period of two meetings. In determining penalty Stewards had regard for the totality of the use of the whip by J. Holder and noted that he used it on six occasions over the concluding 100 metres of the event.





RACE 5: THE JUNCTION HANDICAP - 1600 Metres

MONTEPULCIANO (J. Toeroek) - rider reported that the gelding travelled fairly in the early and middle stages however, when asked for an effort had only momentarily responded and then been one paced to the finish. A post-race veterinary examination revealed no visible abnormalities.

ANGELIC SCENT (D. Thornton) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by D. Thornton and noted that he used it on three occasions over the concluding 100 metres of the event.

KYSHAKA (S. Metcalfe) - Trainer Mr P. Hardacre informed Steward of a change in tactics in that he would inform his rider to attempt to settle further back with cover, if possible, from a wide barrier. Settled back.

FREDDY MAC (A. Kelly) - raced keenly in the early and middle stages of the event. Rider reported that the gelding travelled well in the early and middle stages however, when asked for an effort, failed to let down and was disappointing, She added in her opinion, FREDDY MAC may have come to the end of its preparation. Trainer Mr D. Bourne advised the gelding would now be spelled. A post-race veterinary examination revealed no visible abnormalities.

TURFITT (J. Holder) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

LITTLEBITFUNNY (D. Caboche) - rider reported that he had become concerned with the gelding's breathing in the straight and for this reason did not ride it out in his normal manner. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr K. Sweeney, was advised that a Veterinary Clearance was required prior to a future trial or race start.

SCOUT'S HONOUR (J. Benbow) - raced keenly in the early and middle stages of the event.

RACE 6: DOMINANT HANDICAP - 1600 Metres

KNIGHT BATCHELOR (B. Vorster) - rider reported the gelding travelled well in the early and middle stages however, when asked for an effort had not responded to his riding and had been disappointed to the finish. He added, in his opinion, KNIGHT BATCHELOR did not handle the track conditions. A post-race veterinary examination revealed a slow recovery.

RISING LEGEND (T. Voorham) - lost both hind plates during the event. Shifted out on jumping away onto THE BIG KAHUNA. Raced fiercely in the early and middle stages of the event. Stewards questioned rider in relation to the instructions she had been provided and she advised that she had been instructed to get cover from a wide gate however, expected to be in a mid-field position but found herself further back than she had anticipated. Trainer Mr S. Westover confirmed the instructions however, had anticipated that the gelding would be on pace with cover. After considering his explanation, Stewards took no further action however, reminded him of his obligations under AR100(1)(a) in notifying Stewards of any instruction that a horse is to be ridden in a different manner to how it was ridden at its most recent start.

DIVINA SHOW (NZ) (R. Hurdle) - jumped away awkwardly and shifted in onto MORNINGTON MASK. Rider reported the filly had only travelled fairly and when asked for an effort, inside the 600 metres, had not responded, commenced to give ground and he had become concerned with its action. A post-race veterinary examination revealed no visible abnormalities.

PRINCE JOFRA (L. Neindorf) - raced three wide without cover throughout the event.

THE BIG KAHUNA (J. Maund) - inconvenienced on jumping away. Held up from near the 500 metres until near the 300 metres.

MORNINGTON MASK (J. Eaton) - shifted out at the entrance to the straight to obtain clear ground.

MISS KERMIE (C. Jones) - laid out under pressure in the straight.

JOURNEY IN TIME (C. Murray) - jumped away awkwardly.





RACE 6: DOMINANT HANDICAP - 1600 Metres (Cont'd)

DASHING REBEL (C. Puls) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Co-Trainer, Mr B. McKnight, was advised that a Veterinary Clearance was required prior to a future trial or race start.

RACE 7: GRAND SYNDICATES - JOIN TEAM GRAND TODAY! HANDICAP - 1050 Metres

ZION (NZ) (T. Pannell) - near the 200 metres had to momentarily steady as it commenced to give ground when MAGIC PHANTOM was taken out by ULTIMATE VICTORY. Trainer Mr W. Clarken reported to Stewards that the gelding had bled from both nostrils following the event. Mr W. Clarken, was advised that as this was the gelding's first bi-lateral bleed ZION(NZ) would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race.

ARROANCE (J. Holder) - rider reported the mare travelled well in the early and middle stages however, when placed under pressure was disappointing. He added in his opinion, ARROANCE did not handle the track conditions. A post-race veterinary examination revealed no visible abnormalities.

JAAZEB (L. Neindorf) - rider reported the gelding raced flat in today's event.

ULTIMATE VICTORY (B. Vorster) - hampered on jumping away when tightened onto LOPE DE WOLF by TYCOON GIRL. Rider reported the gelding was inclined to lay in throughout the event.

LOPE DE WOLF (J. Toeroek) - hampered on jumping away when contacted and taken in by ULTIMATE VICTORY.

SHE'S A TOFF (S. Logan) - laid out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by S. Logan and noted that she used it on five occasions over the concluding 100 metres of the event.

TYCOON'S GIRL (J. Benbow) - jumped away awkwardly and shifted in contacting ULTIMATE VICTORY and as a result, the filly's hindquarters were turned resulting in it being hampered.

RACE 8: LIGHTNING STAKES - 1050 Metres

KALLOS (K. Crowther) - laid out under pressure in the straight.

UNFLINCHING (D. Thornton) - a post-race veterinary examination revealed no visible abnormalities.

MAGIC MAX (L. Neindorf) - approaching the 100 metres was momentarily inconvenienced when NO BABY NO shifted in.

EXTREMELY LUCKY (T. Pannell) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining penalty Stewards had regard for the totality of the use of the whip by T. Pannell and noted that he used it on five occasions over the concluding 100 metres of the event. Rider was reminded of his obligations with regards to celebratory gestures in accordance with AR131(c).

SCORCHED EARTH (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

I AM BENE (P. Gatt) - raced greenly in the straight.

CALLA DREAM (R. Hurdle) - raced three wide without cover throughout the event.

ROYAL DRESS (A. Kelly) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: LIGHTNING STAKES - 1050 Metres (Cont'd)

MIETTA (B. Vorster) - jumped away awkwardly. A post-race veterinary examination revealed a lacerations to the near hind which is consistent with being galloped and was found to be lame in the near hind leg. Co-Trainer, Mr T. McEvoy was advised that a Veterinary Clearance was required prior to a future trial or race start.

NO BABY NO (J. Benbow) - raced four wide without cover throughout the event. Approaching the 100 metres shifted in slightly onto MAGIC MAX.

RACE 9: ZILZIE WINES HANDICAP - 1200 Metres

MODEAR (K. Crowther) - slow to begin.

LOGO LOGIC (C. Puls) - near the 1100 metres shifted out abruptly onto MAY BE FATE. Raced keenly in the early and middle stages of the event.

MR MARATHON MAN (GB) (J. Eaton) - jumped away awkwardly and was slow to begin.

AGRIMONY (GB) (T. Pannell) - rider reported the gelding travelled well in the early and middle stages however, when asked for an effort, had not let down as he had anticipated. He added that in his opinion, due to the formation of the field he had found himself in the worse part of the track. A post-race veterinary examination revealed no visible abnormalities.

MAY BE FATE (C. Murray) - near the 1100 metres was inconvenienced when contacted by LOGO LOGIC.

OCEAN REWARD (B. Vorster) - acting on advice from trainer Mr M. Webb that the gelding had become cast in its box, injured it near hind leg and would be unsuitable to race, Stewards withdrew OCEAN REWARD at 1.30 pm.

I'M A LEGEND (L. Neindorf) - rider was reminded of his obligations in riding his mounts out to the finish in accordance with AR131(b).

CIRCLE OF MAGIC (NZ) (A. Kelly) - raced three wide without cover throughout the event.

EYES NEVER LIE (C. Jones) - near the 1100 metres was inconvenienced when taken wider by MAY BE FATE.

CLAMARC (J. Toeroek) - rider reported that in his opinion the gelding had chocked down near the 600 metres and was eased from the event. A post-race veterinary examination revealed cardiac arrhythmia. Trainer advised the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Clearance would be required prior to performing satisfactorily in an Official Barrier Trial.
