RACE 1: CONGRATULATIONS JESS & JAMES - ENGAGED 3YO MAIDEN PLATE - 1000 Metres

DECLARED (B. Vorster) - at the entrance to the straight was inconvenienced when contacted by FAITH IN THE RIVER.

KARAKA KIWI (NZ) (E. Boyd) - slow to begin. Raced keenly in the early and middle stages of the event. Held up from the 500m until the entrance to the straight.

KUSU (J. Toeroek) - slow to begin. Raced keenly in the early and middle stages of the event. Shifted out to improve at the entrance to the straight and in doing so, took MISSILE STAR wider.

LANCELOTTO (C. Jones) - slow to begin.

FAITH IN THE RIVER (E. Annells) - jumped away awkwardly. At the entrance to the straight shifted out and away from MISSILE STAR and brushed DECLARED.



RACE 1: CONGRATULATIONS JESS & JAMES – ENGAGED 3YO MAIDEN PLATE – 1000 Metres (cont'd)

LADY WAIRUA (NZ) (K. Crowther) – a post-race veterinary examination revealed no visible abnormalities.

MISSILE STAR (S. Logan) – inconvenienced at the entrance to the straight when taken wider by KUSU. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: FRED VELLA TYRE & CRASH REPAIRS HANDICAP – 2500 Metres

LORD BOUZERON (NZ) (B. Price) – raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip with an action that raised his arm above shoulder height and was fined \$400.

DIXIE WHISTLER (L. Neindorf) – rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip by L. Neindorf and noted that he used it on two occasions over the final 100m of the event.

KING OF AVALON (NZ) (B. Vorster) – raced keenly in the early and middle stages of the event.

SPACE EQUITY (D. Caboche) – raced keenly in the middle stages of the event.

Following the running of this event, rider L. Neindorf was examined by the First Care Medical personnel and was ruled unfit to fulfil his remaining engagements.

RACE 3: MAGIC MILLIONS HANDICAP – 1600 Metres

BIG SUE (K. Crowther) – a post-race veterinary examination revealed a slow post-race recovery.

WICKED ADDICTION (C. Jones) – inconvenienced on jumping away. Shifted out near the 400m and momentarily inconvenienced ZIGGI ROCKS.

MOSCOW RED (NZ) (W. Price) – raced keenly in the early and middle stages of the event.

REVUE (B. Vorster) – jumped away awkwardly, shifted in and brushed WICKED ADDICTION.

ZIGGI ROCKS (J. Benbow) – jumped away awkwardly. Raced fiercely in the early and middle stages of the event. Near the 400m was obliged to alter course when WICKED ADDICTION shifted out.

JACK'S A CRACKER (J. Eaton) – when Stewards questioned rider in relation to the instructions she was provided in today's event, she explained that she had been instructed to ride the gelding quiet in an attempt to have it run on, as it had been disappointing at its most recent start. She added that her instructions at that most recent start were to position the gelding in a forward position. Trainer, Mr G. Young confirmed the instructions in today's event were to have the gelding ridden more quietly. After considering Mr Young's explanation, Stewards laid a charge against him under AR100(1)(a) in that he failed to notify the Stewards of an instruction that a horse is to be ridden in a different manner to how it was ridden at its most recent start. Mr Young pleaded guilty and was fined \$200.

RACE 4: WEDDINGS @ BRIDGES EVENT CENTRE HANDICAP – 1000 Metres

RUSTY HALO (C. Jones) – underwent a pre-race veterinary examination and was found to be lame in the off hind leg (2/5) and declared unsuitable to race. Acting on this advice RUSTY HALO was declared a late scratching by order of Stewards at 1.46 pm. Trainer, Mr B. Bogarts was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

CORK HARBOUR (B. Price) – near the 200m shifted out under pressure onto MANAGE THE CYCLE.



RACE 4: WEDDINGS @ BRIDGES EVENT CENTRE HANDICAP - 1000 Metres (cont'd)

SPEAK NO EAGLE (K. Crowther) - which had not raced since 5 September 2021, underwent a pre-race veterinary examination and was deemed suitable to race. Slow to begin. Rider explained that the gelding was a touch slow to begin; however, had not travelled in the early and middle stages of the event. She added that when placed under pressure the gelding had not responded as she had anticipated and been one pace to the finish. A post-race veterinary examination revealed no visible abnormalities.

MANAGE THE CYCLE (J. Benbow) - jumped away awkwardly. Raced keenly and was inclined to lay out in the early and middle stages of the event. Near the 400m was brushed by KISHSTAR, which rolled in. Near the 200m shifted out and away from CORK HARBOUR onto KISHSTAR.

KISHSTAR (E. Wong) - rolled in slightly near the 400m and brushed MANAGE THE CYCLE. Inconvenienced near the 200m when contacted by MANAGE THE CYCLE.

LUNATIC (E. Boyd) - raced keenly in the early and middle stages of the event. Rider reported that the mare raced erratically and was difficult to control at stages during the event.

RACE 5: TAB HANDICAP - 1400 Metres

DON'TDREAMIT'SOVER (GB) (J. Eaton) - raced keenly in the early and middle stages of the event.

BLACK SYRAH (C. Puls) - slow to begin. Raced keenly in the early and middle stages of the event.

INFLUENTIAL JACK (T. Pannell) - jumped away awkwardly, shifted out and contacted KENYAN WONDER. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr S. Zahra was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

IMPOSSIBLE ACTION (J. Toeroek) - jumped away awkwardly.

KENYAN WONDER (J. Benbow) - inconvenienced on jumping away when contacted by INFLUENTIAL JACK.

MY KHALIFA (C. Hefel) - raced keenly in the early and middle stages of the event.

RACE 6: VALE KEN SMITH AM HANDICAP - 1400 Metres

MONTEPULCIANO (B. Price) - raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height. After considering the matter, Stewards advised B. Price that he would be required to attend the Riders Advisory Group in accordance with AR144(2), as soon as practicable, in relation to his whip action.

DAMNED (FR) (D. Holland) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.


DAZZLING PROSPECT (J. Maund) - contacted on jumping away. Raced keenly in the early and middle stages of the event.

RACE AGAINST TIME (B. Vorster) - rider explained that the gelding travelled fairly in the early and middle stages of the event; however, was under pressure early and did not respond to his riding when asked for an effort. A post-race veterinary examination revealed no visible abnormalities.

STADIUM OF LIGHT (NZ) (T. Pannell) - jumped away awkwardly, shifted in and contacted DAZZLING PROSPECT. Raced keenly in the early and middle stages of the event.

SEA OF SECRETS (K. Crowther) - lost its near fore plate during the event. Hung in under pressure in the straight. Trainer, Mr P. Stokes was advised that a warning had been placed on the gelding in relation to its racing manners.

DR COPPER (M. Collett) - underwent a pre-race veterinary examination and was deemed suitable to race.



RACE 7: CARLTON DRAUGHT HANDICAP - 1000 Metres

THOMPSON'S REWARD (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

WAR CORRESPONDENT (W. Price) - rider reported that the gelding over raced in the early and middle stages of the event and as a result did not finish the event off. A post-race veterinary examination revealed no visible abnormalities.

GREAT LEVELLER (J. Holder) - laid in under pressure in the straight.

EXTRA MILE (B. Vorster) - near the 100m was obliged to alter course to the inside of WOLFLANDS, which laid out.

MAGIC MAX (B. Price) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the entrance to the straight until near the 200m.

WOLFLANDS (C. Hefel) - laid out under pressure in the straight.

RACE 8: DUTTON'S EASY TO DO BUSINESS WITH !!! HANDICAP - 1200 Metres

VENUSIAN (J. Benbow) - jumped away awkwardly and shifted in onto INTREPID EAGLE. Raced keenly in the early and middle stages of the event.

CLASSY KENNY (J. Maund) - raced keenly in the early and middle stages of the event.

FOX GEM (T. Pannell) - slow to begin.

VICTORY CLUB (K. Crowther) - shifted in on jumping away and brushed MARACOURT.

MARACOURT (J. Holder) - shifted out on jumping away and brushed VICTORY CLUB.

SUGAR AND SWEET (W. Price) - slow to begin.

TOMODACHI (E. Wong) - which had not raced since 2 August 2021, underwent a pre-race veterinary examination and was deemed suitable to race. Raced keenly in the early and middle stages of the event.

YE HELLA (C. Jones) - inconvenienced on jumping away when tightened onto CLASSY KENNY by NOT A SINGLE BID. Raced keenly in the early and middle stages of the event when awkwardly placed on the heels of TOMODACHI.

NOT A SINGLE BID (J. Eaton) - shifted in on jumping away onto YE HELLA. A post-race veterinary examination revealed no visible abnormalities.

INTREPID EAGLE (B. Vorster) - laid in under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (2/5). Co-trainers, Mr T & Mr C. McEvoy were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 9: SPRY CIVIL CONSTRUCTION HANDICAP - 1200 Metres

CHELOON (D. Holland) - laid out under pressure over the concluding 200m.

GRANDMA GAIL (J. Toeroek) - rider explained that the mare travelled well; however, failed to let down when placed under pressure. He added on pulling up he had become concerned with the mare's action. A post-race veterinary examination revealed no visible abnormalities.

DISCO TILMORN (T. Voorham) - which raced on 16 August 2022 underwent a pre-race veterinary examination and was deemed suitable to race. Contacted on jumping away. Rider reported that in her opinion the mare had not handled today's track condition and was disappointing.

RACE 9: SPRY CIVIL CONSTRUCTION HANDICAP - 1200 Metres (con't)

RUBY MOCKINGBIRD (C. Hefel) - slipped behind on exiting the mounting yard. Underwent a pre-race veterinary examination and deemed suitable to race.

CONCONI (C. Jones) - underwent a pre-race veterinary examination which revealed that the mare had bled from both nostrils. Trainer, Ms E. Hubbard was advised that as this was the mare's first bi-lateral bleed and CONCONI would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000m in the presence of a Steward prior to accepting for a future jump-out, trial or race.

FIELDS OF ATHENRY (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

GRACEFUL EAGLE (J. Eaton) - slow to begin.

SUNNY GREEN (S. Fawke) - jumped away awkwardly, shifted in and contacted DISCO TILMORN. Near the 100m was disappointed for a run between DISCO TILMORN, which shifted in and FIELDS OF ATHENRY and was obliged to be steadied and alter course to obtain clear ground.

JIVE BABY (T. Pannell) - slow to begin.
