RACE 1: THE JUNCTION MAIDEN PLATE - 2008 Metres

HOTFOOTIT (J. Toeroek) - jumped away awkwardly, shifted out and brushed COLOUR ME GONE.

MARGIN OF ERROR (J. Potter) - shifted out on jumping away onto PLAYBOY CHARLIE.

PLAYBOY CHARLIE (B. Vorster) - inconvenienced on jumping away when tightened onto FOXY EAGLE by MARGIN OF ERROR. Laid in over the concluding 200m of the event.



RACE 1: THE JUNCTION MAIDEN PLATE - 2008 Metres (cont'd)

SOARLIKEANEAGLE (P. Gatt) - raced keenly in the early and middle stages of the event. The saddle on the gelding shifted forward near the 1000m placing the rider at a disadvantage for the remainder of the event.

SUPERB TIME (D. Caboche) - raced keenly in the early and middle stages of the event.

CHENIAH (A. Jordsjo) - shifted in on jumping away and contacted FOXY EAGLE.

COLOUR ME GONE (R. Hurdle) - contacted on jumping away.

FOXY EAGLE (A. Livesey) - hampered on jumping away when tightened between PLAYBOY CHARLIE and CHENIAH.

GOLDEN BEAUTY (D. Tourneur) - underwent a pre-race veterinary examination and deemed suitable to race. Laid in under pressure over the concluding stages of the event.

VIC REEL (E. Boyd) - inclined to lay out under pressure in the straight.

RACE 2: GRAND SYNDICATES THREE-YEAR-OLD MAIDEN PLATE - 1050 Metres

FAMOUS KNIGHT (J. Potter) - jumped away awkwardly. Near the 200m was inconvenienced when SUPER ALANA (NZ) shifted in.

NOBLE MAGNATE (J. Toeroek) - approaching the 600m had to be eased momentarily when DAUNTING DECISION shifted in.

RED WRAITH (A. Jordsjo) - on jumping away was inconvenienced when tightened between SUPER ALANA (NZ) and DAUNTING DECISION. Laid in under pressure in the straight.

DAUNTING DECISION (B. Vorster) - Stewards permitted rider, B. Vorster to replace Apprentice rider, J. Hampson as she was unable to make the weight and no other claiming apprentice was on course. J. Hampson pleaded guilty to a charge under AR190(3) for being overweight and was fined \$100. In addition, Stewards placed a weight embargo on J. Hampson of 54.0kg and raised her minimum riding weight to that figure effective midnight Tuesday, 1 November 2022. Jumped away awkwardly and shifted in onto RED WRAITH. Approaching the 600m shifted in and away from UMARELL onto NOBLE MAGNATE.

EMMOOKI MAGIC (D. Tootell (Snr)) - laid in under pressure in the straight.

SUPER ALANA (NZ) (A. Livesey) - jumped away awkwardly and shifted out onto RED WRAITH. Raced fiercely in the early and middle stages of the event. Laid in under pressure in the straight and near the 200m shifted in onto FAMOUS KNIGHT. A post-race veterinary examination revealed minor abrasions to its near foreleg.

RACE 3: FOTOBASE GROUP MAIDEN PLATE - 1600 Metres

BARDOUTES (R. Hurdle) - jumped away awkwardly and shifted out abruptly.

FINAL REIGN (J. Potter) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

FLITTELL (B. Price) - slow to begin.

I'M A MILLENNIAL (J. Toeroek) - stood flat and was slow to begin.

MARDENE (P. Gatt) - laid in under pressure in the straight.

VANITY STAR (B. Vorster) - near the 500m was momentarily inconvenienced when BARDOUTES was taken out slightly by ZARATSU.





RACE 3: FOTOBASE GROUP MAIDEN PLATE - 1600 Metres (cont'd)

ZARATSU (S. Logan) - Trainer, Mr B. Campbell was advised that a warning had been placed on the gelding in relation to its pre-race behaviour. Jumped away awkwardly. In the vicinity of the 1200m had to be steadied for a short distance when it improved onto the heels of BARDOUTES.

PIER SEVENTEEN (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: REXCO PEOPLE MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately one minute.

BUTTS (J. Maund) - taken in on jumping away onto SIR KINGSFORD. Raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

PLATINUM WOLF (J. Potter) - proved difficult to load. Trainer, Ms K. Evans was advised that a warning had been placed on the gelding in relation to its barrier manners.

SHOURI LAD (J. Opperman) - raced keenly in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

TAN TAT BEAU (B. Vorster) - raced three wide without cover throughout the event.

LORD GEORGE (R. Hurdle) - following the declaration of acceptances Co-trainer, Mr D. Moyle made a gear application to remove blinkers to the gelding's race gear. Stewards acceded to this request and acting under AR206(2) fined Mr G. Richards and Mr D. Moyle \$200. Shifted in abruptly on jumping away onto BUTTS.

SIR KINGSFORD (M. Henderson) - hampered on jumping away when tightened onto RITZ by BUTTS.

SOLAR BLAST (J. Toeroek) - raced wide without cover throughout the event. Laid in under pressure in the straight.

RITZ (E. Annells) - severely hampered and lost its position on jumping away when taken in across the heels of SEAFARING (NZ) by SIR KINGSFORD. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: ADELAIDE GALVANISING INDUSTRIES CLASS ONE HANDICAP - 1050 Metres

The start of this event was delayed approximately two minutes.

LUNAR SOLAR (P. Gatt) - Stewards questioned Trainer, Mr D. McCarthy in relation to the late arrival of LUNAR SOLAR on course. After considering his explanation, Mr McCarthy was charged under AR165(1) for failing to arrive on course by the prescribed time under LR8.9. Mr McCarthy pleaded guilty to the charge and was fined \$100. Laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

BAJAN BELLE (A. Livesey) - laid out throughout the event.

SABERMETRIC (B. Vorster) - proved difficult to load. Co-trainers, Mr G. Richards and Mr D. Moyle were advised that a warning had been placed on the gelding in relation to its barrier manners.

TICKETY BOOM (T. Voorham) - slow into stride.

HEAVEN'S WISH (J. Toeroek) - raced wide without cover and laid out from near the 700m until the entrance to the straight. A post-race veterinary examination revealed a slower than normal post-race recovery.

LUCKY FORTUNA (A. Jordsjo) - jumped away awkwardly. Rider reported that the filly resented the kickback during the event. A post-race veterinary examination revealed no visible abnormalities.



RACE 5: ADELAIDE GALVANISING INDUSTRIES CLASS ONE HANDICAP - 1050 Metres (cont'd)

MENDOORAN (D. Tourneur) - dipped on jumping away.

SUGAR GLIDER (K. Sardelic) - raced wide without cover throughout the event.

RACE 6: THOMAS FOODS CLASS TWO HANDICAP - 1200 Metres

MR METRICS (J. Hampson) - jumped away awkwardly.

VICTORY CLUB (J. Opperman) - slow into stride. Laid in under pressure in the straight.

KADENA (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

SOUTHERN MAGNOLIA (NZ) (D. Tourneur) - jumped away awkwardly. Laid out over the concluding 200m of the event. Approaching the finish shifted out onto CENTRE SCOOTA. Rider was reminded of his obligations when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

CENTRE SCOOTA (B. Vorster) - slow to begin. Inconvenienced approaching the finish when tightened onto KADENA by SOUTHERN MAGNOLIA (NZ).

WILD TYCOON (E. Boyd) - rider reported that the gelding hung out over the concluding 600m. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: FURPHY BENCHMARK 64 HANDICAP - 2008 Metres

BLACK SYRAH (D. Tourneur) - inconvenienced on jumping away when tightened between SO BENE and VINO DECASA NOSTRA (NZ). Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

BUSKER'S BALLAD (A. Livesey) - inconvenienced approaching the crossing when MAKE IT A DOUBLE shifted out abruptly. Raced wide without cover throughout the event.

AFRICAN AWESOME (T. Voorham) - lost its near hind plate during the event.

BELLAVARDO (NZ) (J. Doyle) - slow to begin. Held up from the entrance to the straight until approaching the 200m. A post-race veterinary examination revealed no visible abnormalities.

SO BENE (B. Vorster) - jumped away awkwardly and shifted out onto BLACK SYRAH. Raced keenly in the early stages of the event.

VINO DECASA NOSTRA (NZ) (S. Logan) - Trainer, Mr J. Lynch advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to settle further back in the event from the wide barrier. Settled back. Jumped away awkwardly and shifted in onto BLACK SYRAH.

AMERICAN TROUBLE (J. Maund) - laid out rounding the home turn. Rider explained that the mare settled fairly in the early stages however would have been better suited in a race with a quicker tempo. He added that AMERICAN TROUBLE was not comfortable race between other runners from near the 700m until straightening. He stated that despite having form on rain affected tracks the gelding felt like it did not have good traction on straightening and in his opinion did not handle the track condition. A post-race veterinary examination revealed no visible abnormalities.

MAKE IT A DOUBLE (P. Gatt) - Stewards permitted P. Gatt to ride the gelding 0.5 kg over its declared weight of 54.5 kg. Approaching the crossing shifted out abruptly into the running line of BUSKER'S BALLAD. Raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$300. In determining penalty Stewards had regard for the totality of the use of the whip by P. Gatt and noted that he used it on ten occasions over the final 100m of the event.

SWANKYTOFF (K. Sardelic) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.



RACE 8: HOUSE OF ARRAS BENCHMARK 58 HANDICAP - 1100 Metres

LUNAR HERO (H. Blanc) - shifted out on jumping away onto OLD TIME ROCK and became awkward when its hind quarters were turned.

SACRED ARMOUR (NZ) (D. Tourneur) - jumped away awkwardly. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (2/5). Trainer, Mr T. Doudle was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

OLD TIME ROCK (K.Sardelic) - inconvenienced on jumping away.

JEAN VALJEAN (C. Murray) - slow into stride.

JUST KAPPY (J. Potter) - raced wide without cover throughout the event. Rider reported that the gelding never travelled and when asked for an effort at the entrance to the straight did not respond and he had become concerned with its action and for that reason had not ridden his mount out in his normal manner. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (3/5). Trainer, Mr B. Potter was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

FINAL CHANCE (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

SHOWUSYOURMOTOR (M. Collett) - jumped away awkwardly.

TWICE FORGOTTEN (D. Caboche) - Stewards received a request from Mr. J. Ruberry representing Trainer Mrs M. Ruberry, that the mare be withdrawn due to the track downgrade. Stewards accepted this request and declared TWICE FORGOTTEN a late scratching at 3:10 pm.

RACE 9: G.H.MUMM BENCHMARK 62 HANDICAP - 1600 Metres

AMEGDUL (H. Blanc) - shifted out on jumping away and contacted LORD LUKER (IRE). A post-race veterinary examination revealed no visible abnormalities.

LOMAX (M. Collett) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

AKTOLGALI (J. Maund) - Stewards received a request from Co-trainer, Mr. J. Hickmott that the mare be withdrawn due to the track downgrade. Stewards accepted this request and declared AKTOLGALI a late scratching at 3:40 pm.

SAVILLE (R. Hurdle) - jumped away awkwardly and was slow into stride. Co-trainer, Mr G. Lesnikowski was advised that a warning had been placed on the gelding in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

LORD LUKER (IRE) (B. Price) - contacted on jumping away.

CHARM SLINGA (NZ) (P. Gatt) - late scratching by order of the Stewards at 3:50 pm acting on confirmed advice from Trainer, Mr J. Hyam that the gelding had slipped over when being walked to the course, had numerous lacerations and would be unsuitable to start.

REBEL LEE (T. Voorham) - laid in under pressure in the straight. Rider reported that in her opinion the mare had not handled today's track condition.

WHEELS OF COURAGE (B. Vorster) - laid out under pressure in the straight. Rider reported that the gelding was inclined to lay out throughout the event.

Correct weight was delayed to allow rider, M. Collett (LOMAX), unplaced, to view the vision of the start. After viewing the vision, M. Collett put a submission to Stewards that LOMAX be declared a non-starter under AR204(1) as in her opinion the gelding had been held by the barrier attendant when the gates had opened. After considering her report, taking evidence from the Starter and Assistant Starter, viewing the vision and acting on their own observations, Stewards declared LOMAX to be a starter and declared correct weight.
