Report on Race Meeting held at Port Lincoln
Racecourse by the Port Lincoln Racing Club on
Wednesday, 2 November 2022

RACE 1: LEADER DISTRIBUTORS MAIDEN PLATE - 1000 Metres

DANIEL MY BROTHER (A. Livesey) - on jumping away lost its position when tightened onto TELEPORTATION as LEVEE shifted out. Inside the 100m was awkwardly placed between the heels of OPAL BEACH, which was laying in and FAMILY TIES, which laid out.

LEVEE (K. Sardelic) - on jumping away, shifted out onto DANIEL MY BROTHER, which lost its position. From shortly after the start hung out for the remainder of the event. When hanging out rounded the home turn awkwardly. Co-trainer, Ms J. Branford was advised that a warning had been placed on the gelding in relation to its racing manners.

PERFECT VOYAGE (T. Voorham) - jumped away awkwardly. Hung in, in the straight.

THUNDERANLIGHTNING (S. Logan) - proved fractious in the barriers after being loaded. Trainer, Mr M. Cornell was advised that a warning had been placed on the gelding in relation to its barrier manners. Jumped away awkwardly and as a result was slow to begin (approximately 2-3 lengths). Tailed the field throughout the event. Beaten by approximately 44 lengths. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr M. Cornell was advised that the gelding would be required to prove competitive in an Official Barrier Trial prior to a future race start.

VARIARA (J. Hampson) - near the 500m was awkwardly placed on the heels of TELEPORTATION, which was being restrained and lost ground. Rounding the home turn was awkwardly placed inside NATION HERO and was obliged to be restrained. From thereafter was held up until near the 200m and was obliged to shift out to obtain clear racing room. Near the 100m was awkwardly placed on the heels of DANTELA (NZ), which shifted out.

FAMILY TIES (S. Fawke) - laid out in the straight.

DANTELA (NZ) (B. Price) - near the 100m shifted out onto VARIARA.



RACE 1: LEADER DISTRIBUTORS MAIDEN PLATE - 1000 Metres (Cont'd)

OPAL BEACH (K. Crowther) - laid in under pressure in the straight.

TELEPORTATION (E. Annells) - near the 900m lost its position when racing tight to the outside of LEVEE, which was hanging out and shifted out. Near the 600m was awkward on the heels of LEVEE for a short distance, which dipped and lost ground.

NATION HERO (D. Caboche) - jumped away awkwardly and as a result was slow into stride. Approaching the finish was awkwardly placed on the heels of FAMILY TIES, which was weakening.

RACE 2: GREAT NORTHERN MAIDEN PLATE - 1210 Metres

The start of this event was delayed approximately two minutes owing to a number of horses being unruly behind the barriers.

AYLLA'S PRIDE (E. Boyd) - kicked by another runner on arrival at the barriers. Underwent a pre-race veterinary examination and was deemed suitable to start.

BEERS ON BILL (E. Annells) - hung in under pressure in the straight and proved difficult for its rider to ride out in her normal manner.

INOTELL (K. Crowther) - jumped away awkwardly and shifted out.

FORGIVING (J. Hampson) - shortly after the start was tightened between SWANNIE and AYLLA'S PRIDE, which both shifted ground. Near the 900m was awkwardly placed for several strides on the heels of SWANNIE.

LENTINO (B. Price) -re-saddled on arrival at the barriers.

MIS GUIDED CHOICE (D. Caboche) - proved difficult to load. Co-trainer, Mr J. Dunn was advised that a warning had been placed on the mare in relation to its barrier manners. Hung in under pressure in the straight.

ROWDY DIVA (S. Logan) - fractious in its barrier after being loaded. Stood flat footed and as a result was slow to begin. Trainer, Mr S. Drewitt was advised that a warning had been placed on the mare in relation to its barrier manners. A post-race veterinary examination revealed no visible abnormalities.

SUBUKI (T. Voorham) - jumped away awkwardly and shifted out.

SWANNIE (J. Doyle) - as no other senior rider was available, Stewards permitted apprentice J. Doyle to replace C. Murray on the mare in this event.

TIAMAT (A. Livesey) - Proved unruly when attempting to load and was difficult to load. Co-Trainer, Mr J. Dunn was advised the mare was now required to load without delay in an Official Barrier Trial or Approval to Race jump-out prior to a future race start. Jumped away awkwardly, shifted in and bumped RAMBLER GAMBLER.

RAMBLER GAMBLER (C. Murray) - jumped away awkwardly, shifted out and bumped TIAMAT.

RACE 3: AVIS PORT LINCOLN BENCHMARK 80 HANDICAP - 1350 Metres

MY MATE SONNY (D. Caboche) - laid in under pressure in the straight.

EXALTED TRAVELLER (A. Livesey) - which had not raced since April 2021, underwent a pre-race veterinary examination and was deemed suitable to race. Near the 150m was obliged to be steadied when placed awkwardly on the heels of RED DYNAMO (NZ), which shifted out when insufficiently clear.





RACE 3: AVIS PORT LINCOLN BENCHMARK 80 HANDICAP - 1350 Metres (Cont'd)

RED DYNAMO (NZ) (B. Wong) - near the 150m shifted out when insufficiently clear of EXALTED TRAVELLER, which was obliged to be steadied and shift to the inside of that gelding. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Friday, 11 November 2022 and to conclude midnight Saturday, 19/11/22, a period of 4 meetings. In determining penalty, Stewards took into account B. Wong's careless riding record and her guilty plea. Stewards further noted her incurred a suspension at Strathalbyn on Wednesday 26 October 2022 and given this was her second suspension in a week, Stewards directed, under AR144, that B. Wong is required to attend a riding skills panel for mentoring and remedial training prior to recommencing riding, following her suspensions.

CHONCAPE (E. Boyd) - jumped away awkwardly, shifted out and lost ground.

NEAR MAGIC (E. Annells) - slow to begin.

RACE 4: EYRE PENINSULA SEAFOODS BENCHMARK 72 HANDICAP - 1750 Metres

The start of this event was delayed approximately one minute.

MOUNT MADEIRA (NZ) (B. Wong) - over raced in the early and middle stages of the event.

ALLUSION (K. Crowther) - laid out over the concluding stages of the event.

FORAOISE (A. Livesey) - raced keenly in the early stages of the event.

SHINSEKI (B. Price) - shortly after the start was hampered by JAY PEE BEE (NZ), which shifted in.

MISS HENDRIX (D. Caboche) - underwent a pre-race veterinary examination on arrival at the barriers and was found to be lame in the near hind leg (3/5) and deemed unsuitable to race. Acting on this advice MISS HENDRIX was declared a late scratching at 2.28 pm. Trainer, Mr R. King was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

VANCOUVER VELVET (S. Logan) - held up for clear running from the 400m until near the 200m. Stewards questioned S Logan in relation to the options available to her at the entrance to the straight. She stated that she had anticipated a run developing between LEAN THY ARMS and GIVEPEACE A CHANCE on entrance to the straight, one off the rail, however SHINSEKI had improved to her inside and obtained that run. She further stated shortly after she elected to shift out across the heels of GIVEPEACE A CHANCE and EM BRYAN to obtain clear running. She added that in hindsight she should have attempted to shift to the outside of EM BRYAN from the entrance to the straight. Stewards noted S Logan's explanation.

JAY PEE BEE (NZ) (J. Doyle) - jumped away awkwardly, shifted in and bumped SHINSEKI. Hung in throughout the event.

RACE 5: M&M GROUP BENCHMARK 62 HANDICAP - 1000 Metres


The start of this event was delayed approximately six minutes owing to QUIERO requiring farrier attention.

ARTFUL AMBITION (K. Sardelic) - jumped away awkwardly and shifted in. A post-race veterinary examination revealed no visible abnormalities.

MESSERSCHMITT (B. Wong) - slow into stride and shortly after was unable to improve its position as ARTFUL AMBITION and DEFACTOR both shifted ground. A post-race veterinary examination revealed no visible abnormalities.

A THOUSAND DEGREES (J. Hampson) - dislodged its rider on exiting the mounting yard. Rider was re-examined on arrival at the start by First Care Medical personnel and passed suitable to ride. Jumped away awkwardly and shifted out onto DEFACTOR.

ANOTHER BIT (S. Logan) - jumped away awkwardly, shifted out and as a result the rider became unbalanced.



RACE 5: M&M GROUP BENCHMARK 62 HANDICAP - 1000 Metres (Cont'd)

DEFACTOR (T. Voorham) - on jumping away was taken out onto ARTFUL AMBITION by A THOUSAND DEGREES and shortly after the rider became awkward for a short distance.

QUIERO (D. Caboche) - which had not raced since May 2019, underwent a pre-race veterinary examination and was deemed suitable to race. Lost it's off fore plate on arrival at the barriers and was required to be reshod. Underwent a pre-race veterinary examination and was deemed suitable to race.

RACE 6: SCHWEPES BENCHMARK 54 HANDICAP (1) - 1210 Metres

ORIEDOS (E. Annells) - jumped away awkwardly, shifted out and bumped HIGHLY RIGHTEOUS. Near the 900m was obliged to be eased as HIGHLY RIGHTEOUS shifted in.

SASSY MANEUVER (S. Logan) - reared on jumping away and as a result was slow to begin.

FINCH 'N' CHIPS (A. Livesey) - laid out in the straight.

COMPARDY (J. Doyle) - jumped away awkwardly, shifted out and bumped ODDSOCK. Hung out under pressure in the straight.

HIGHLY RIGHTEOUS (K. Sardelic) - jumped away awkwardly, shifted in and bumped ORIEDOS. Near the 900m shifted in onto ORIEDOS, which was obliged to be eased. Rider was reminded of his obligations under AR131(a) and advised to take greater care when shifting ground, in future.

MISS PARMIGIANA (B. Wong) - difficulty obtaining clear ground from the entrance to the straight until inside the 100m.

WIFE FREE ZONE (D. Caboche) - as no claiming apprentice was available, Stewards permitted D. Caboche to replace F. Atkinson on the gelding in this event.

GOODARCHIE (K. Crowther) - laid in under pressure in the straight.

Correct weight for this event was delayed to allow rider, S. Logan (SASSY MANEUVER), unplaced and the Trainer, Mr S. Drewitt to view the vision of the start.

RACE 7: TAB BENCHMARK 54 HANDICAP - 1210 Metres

BIGNOTA (D. Caboche) - Stewards permitted the gelding to race without the bit lifter as Trainer Mr B. Cozamanis had failed to present BIGNOTA in that gear. Trainer was reprimanded under AR106 and advised to ensure he presents his horses in the correct gear in future.

BONIFACE (NZ) (B. Wong) - jumped away awkwardly.


THE ALBION (NZ) (S. Fawke) - jumped away awkwardly, shifted in and bumped SCOUT'S HONOUR. Inclined to lay out under pressure in the straight.

SCOUT'S HONOUR (T. Voorham) - on jumping away bumped THE ALBION (NZ), which shifted in. Laid in under pressure in the straight.

HARDASHIAN (K. Sardelic) - over-raced in the middle stages of the event and Hung out from the 600m was unable to be ridden out in his normal manner from rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

SHOWBAG (E. Boyd) - slow into stride.

RACE 8: MCDONALDS PORT LINCOLN BENCHMARK 64 HANDICAP - 1350 Metres



AHSO (B. Wong) - underwent a pre-race veterinary examination as it had not raced since February 2021 and was deemed suitable to race. Jumped away awkwardly. Near the 1100m bumped with MR WHITACRE, which attempted to shift in.



RACE 8: MCDONALDS PORT LINCOLN BENCHMARK 64 HANDICAP - 1350 Metres (Cont'd)

CROWNED KING (B. Price) - shortly after the start shifted in onto SORRIDERE. A post-race veterinary examination revealed no visible abnormalities.

BRAZILLIANT (J. Doyle) - inclined to lay out under pressure in the straight.

LINAS MAGIC (J. Hampson) - raced keenly in the early and middle stages of the event. Near the 150m rolled in slightly and away from AUGUSTA ROCK onto SINO WITNESS. A post-race veterinary examination revealed had a slow recovery. Trainer, Mr A Bain was advised on review of the vision that the mare has a lateral excursion of the near fore leg at a gallop. Mr Bain was advised a warning had been placed on the mare in relation to its action and that the Racing SA Stewards will continue to monitor the mare's action in any future event. Mr Bain notified the Stewards that it would be his recommendation to the owners to retire the mare.

MR WHITACRE (K. Crowther) - near the 1100m shifted in and bumped AHSO.

SINO WITNESS (K. Sardelic) - near the 150m was awkwardly placed between the heels of LINAS MAGIC, which rolled in slightly and GOTTABITON and was obliged to be restrained.

SORRIDERE (T. Voorham) - shortly after the start lost its position when tightened onto SMART CHARGE as CROWNED KING shifted in. Rider reported it was her intention to settle more forward however, due to the manner in which the mare began, she was unable to do so.

AUGUSTA ROCK (A. Livesey) - held up for clear running from inside the 400m until shortly after the entrance to the straight.

RACE 9: LINCOLN SAND FILLIES & MARES BENCHMARK 58 HANDICAP - 1000 Metres

The start of this event was delayed approximately two minutes.

STRAWBERRY SWING (K. Sardelic) - laid in under pressure in the straight and proved difficult for the rider to ride out in his normal manner.

KURIMUZON (T. Voorham) - resaddle on arrival at the barriers.

VIRTUE (NZ) (D. Caboche) - proved difficult to load. Co-Trainer Mr J. Dunn was advised a warning had been placed on the mare. A post-race veterinary examination revealed a slow recovery.

ATTACK THE PIN (E. Annells) - on jumping away bumped with NORDIC LASS. Near the 600m shifted out when awkwardly placed on the heels of LITTLE MISS RICH.

ISA SECRET (S. Logan) - near the 100m rolled out slightly.

STAR PARFAIT (B. Wong) - jumped away awkwardly and got its head up when being restrained. Near the 100m was disappointed for a run between LITTLE MISS RICH and ISA SECRET, which rolled out slightly.

WATERHEAD (J. Hampson) - near the 150m rolled in onto NORDIC LASS, which raced in restricted room for a number of strides. Rider was reminded of her obligations under AR131(a) for careless riding and advised to take greater care in future.

NORDIC LASS (B. Price) - jumped away awkwardly, shifted in and bumped ATTACK THE PIN. Near the 150m raced in restricted room to the inside of WATERHEAD for a short distance. Stewards questioned rider in relation to his riding of the gelding in the straight and with particular reference to the concluding 50m of the event. Rider pleaded guilty to a charge under AR131(b) in that he failed to ride his mount out to the end of the race, approximately the last eight strides. In assessing penalty Stewards took into account his record, guilty plea and other mitigating factors and was fined \$100.
