

Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Morphetville
Racecourse by the South Australian Jockey Club on
Saturday, 26 November 2022

RACE 1: THOMAS FARMS HANDICAP - 1100 Metres

TEST THE LAW (K. Crowther) - jumped away awkwardly, shifted out and bumped ZUFASTA.

ZUFASTA (L. Neindorf) - on jumping away bumped TEST THE LAW. Laid in under pressure over the concluding stages of the event.

PRECONI (B. Price) - on jumping away bumped HEAVEN'S WISH. Inclined to lay in under pressure in the straight. Rider could offer no explanation in relation to the filly's performance. A post-race veterinary examination revealed no visible abnormalities.

HEAVEN'S WISH (J. Eaton) - jumped away awkwardly, shifted out and bumped PRECONI.

LUCKY FORTUNA (A. Jordsjo) - held up for clear running from approaching the 400m until near the 300m and shifted in to obtain clear running.



RACE 2: FURPHY HANDICAP - 1600 Metres

MY MATE SONNY (D. Caboche) – raced keenly in the early and middle stages of the event. Hung in under pressure in the straight.

LAKE'S FOLLY (E. Wong) – raced keenly in the early and middle stages of the event. Approaching the 400m, when racing in restricted room to the inside of PERFECT ROUTE and behind MY MATE SONNY, became awkward on the heels of MY MATE SUNNY clipped the heels of that gelding, dipped, unbalanced the rider and lost ground. Rider was reprimanded under AR131(a) and advised in future to make a greater effort to restrain his mounts and not allow them to race up onto heels. A post-race veterinary examination revealed no visible abnormalities.

MAGNETIC EDGE (J. Maund) – raced keenly in the early and middle stages of the event.

RACE 3: TWILIGHT RACES AT MORPHETTVILLE - FRIDAY DECEMBER 16TH MAIDEN PLATE - 1100 Metres

JEDIAH (L. McNeil) – jumped away awkwardly, shifted out and bumped SPIRIT ABOVE. Raced greenly throughout and near the 100m, for a number of strides, was reluctant to improve into a run between MELANIE'S JOY and ARTY MISS, and after obtaining that run rolled in onto ARTY MISS.

SPIRIT ABOVE (D. Caboche) – on jumping away bumped with JEDIAH.

SWIFT TERCEL (E. Wong) – on jumping away was taken out by SHEMA.

VARIARA (M. Collett) – jumped away very awkwardly and shortly after lost its position when tightened onto SWIFT TERCEL as FLY THE LINE shifted in.

ARTY MISS (B. Price) – near the 100m was taken in by JEDIAH onto SHEMA, which was hampered. Rider explained that the mare travelled well in the early and middle stages of the event; however, when asked for an effort from shortly after entering the straight failed to let down and was disappointing to the finish. A post-race veterinary examination revealed the mare to be lame in the near foreleg (3/5). Trainer, Mr W. Clarcken, was advised that a Veterinary Clearance was required prior to a future jump-out, trial, or race start.

FLY THE LINE (C. Murray) – on jumping away shifted in onto VARIARA.

MELANIE'S JOY (S. Logan) – near the 200m became awkwardly placed on the heels of ARTY MISS, which had commenced to weaken, and shifted out.

SHEMA (L. Neindorf) – jumped away awkwardly and shifted out taking SWIFT TERCEL out. Near the 100m was hampered as ARTY MISS was taken in.

RACE 4: THE JUNCTION HANDICAP - 2500 Metres

SEBONNA (L. McNeil) – on jumping away was hampered as TOYETIC shifted out.

DESIGNS (J. Holder) – jumped away awkwardly. Raced keenly in the early and middle stages of the event. Rider explained that the mare would derive benefit from today's run. A post-race veterinary examination revealed no visible abnormalities.

OATH OF OMERTA (J. Eaton) – raced wide without cover throughout the event. Rider explained that she was caught three wide during the event; however, she was comfortable with how the gelding travelled, but when asked for an effort it did not let down as she had expected. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr M. Hickmott, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

TOYETIC (A. Jordsjo) – jumped away awkwardly and shifted out hampering SEBONNA.

SWELTER MAGIC (NZ) (K. Crowther) – laid out under pressure in the straight. lost its off fore plate during the event.



RACE 4: THE JUNCTION HANDICAP - 2500 Metres (cont'd)

BUSKER'S BALLAD (A. Livesey) - near the 300m was disappointed when attempting a tight run between SWELTER MAGIC (NZ) and DESIGNS, and was obliged to shift in to obtain clear ground.

WHITCHETY GRUB (B. Price) - rider reported did not feel comfortable in its action and for this reason he did not ride the mare out in his normal manner from the 200m. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: GRAND SYNDICATES HANDICAP - 1050 Metres

LEBANESE TRADER (D. Caboche) - near the 200m bumped with THE TRANCE FACTOR and was taken in onto LITTLE RICH BOY.

SUPER FAMOUS (A. Lindsay) - approaching the 200m shifted in when insufficiently clear of THE TRANCE FACTOR, which was obliged to be steadied and lost its position when tightened onto LEBANESE TRADER. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at midnight on Wednesday, 30 November and conclude on Wednesday, 7 December 2022; a period of four meetings.

BAJAN BELLE (A. Livesey) - laid out under pressure in the straight.

HONGBAO (K. Crowther) - near the 600m raced in restricted room to the inside of LITTLE RICH BOY and lost ground. Near the 200m was tightened and became awkward to the inside of LITTLE RICH BOY, which was taken in.

THE TRANCE FACTOR (B. Price) - jumped away awkwardly and as a result was slow to begin. Inside the 300m improved into a run between LEBANESE TRADER and SUPER FAMOUS, which shifted in when insufficiently clear, and as a result was obliged to be steadied, lost its position and shifted out. Over the concluding 50m bumped with LEBANESE TRADER on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

HOT SPARKY (E. Boyd) - rider reported that it was her intention to be more forward in today's event; however, due to the wide barrier and the formation of the field in the early stages she was reluctant to be caught wide and elected to restrain her mount shortly after the start in an attempt to gain cover.

LITTLE RICH BOY (J. Maund) - near the 200m was tightened onto HONGBAO.

SANBUCK (R. Hurdle) - shortly after jumping away knuckled and dipped.

RACE 6: THE FOTOBASE GROUP HANDICAP - 1600 Metres

DR DEE DEE (K. Crowther) - held up for clear running for a short distance near the 400m.

MOTELL (M. Lloyd) - slow to begin.

RESIDUE (L. Neindorf) - raced keenly in the early and middle stages of the event.

EXALTED FIRE (J. Eaton) - race wide without cover in the early stages. Rider reported that the gelding was very disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

WILD IMAGINATION (NZ) (J. Toeroek) - jumped away awkwardly shifted out and contacted AKTOLGALI.

AKTOGALI (J. Maund) - on jumping away contacted WILD IMAGINATION (NZ) which shifted out. Raced keenly in the early and middle stages.





RACE 7: TRANSLIQUID SERVICES HANDICAP - 1200 Metres

CLASSY KENNY (J. Maund) - approaching the 100m shifted in onto GRANDMA GAIL, which was obliged to be steadied when tightened onto GYPSY CROWN, which rolled out slightly. Rider severely reprimanded for careless riding under AR131(a) and advised to take greater care when shifting ground in future.

LAST GIRL LOVE (J. Holder) - jumped away awkwardly and was slow to begin. Rider reported the mare would be better suited racing over further distances. A post-race veterinary examination revealed the mare to be lame in the off hind leg (2/5). Trainer, Mr J. O'Connor, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

PARAMEDIC (NZ) (K. Crowther) - dislodged its rider after exiting the mounting yard and galloped free for some distance. Late scratching by order of the Stewards at 3.56 pm. Trainer, Mr D. Jolly, was advised that a warning had been placed on the gelding. K. Crowther was examined by the First Care Medical personnel and ruled fit to fulfil her remaining engagements.

GYPSY CROWN (M. Lloyd) - approaching the 100m rolled out slightly onto GRANDMA GAIL.

DANCING STREAM (E. Wong) - on arrival on course was fractious when being unloaded from its float. Underwent a pre-race veterinary examination which revealed the mare had sustained an abrasion to the off fore tendon region and was deemed suitable to start.

TWO ODD SOX (D. Tourneur) - raced wide without cover throughout the event.

GRANDMA GAIL (T. Voorham) - jumped away awkwardly and was slow to begin. Held up for a number of strides rounding the home turn. Approaching the 100m was awkwardly placed and obliged to be steadied between the heels of GYPSY CROWN, which rolled out slightly and CLASSY KENNY, which shifted in.

RACE 8: CITY OF MARION STAKES - 1200 Metres

FREE OF DEBT (C. Murray) - shortly after the entrance to the straight rolled out onto ASHFORD STREET, which was hampered. Rider was severely reprimanded for careless riding under AR131(a) and advised to take greater care in future. A post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Trainer, Mr C. Bieg, was advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

MORVADA (P. Gatt) - raced keenly in the early and middle stages of the event. Near the 150m shifted out onto KEEP READING taking that horse out onto CALLA DREAM, which was obliged to be eased when tightened onto HE'S A BALTER. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence at midnight Sunday, 27 November and to conclude midnight Wednesday, 8 December 2022, a period of five meetings.

ASHFORD STREET (J. Eaton) - held up for clear running from near the 400m until near the 250m when racing between OUTLAWS REVENGE and FREE OF DEBT, which had commenced to weaken. Shortly after the entrance to the straight was awkwardly placed on the heels of FREE OF DEBT, which rolled out, and was hampered when tightened onto OUTLAWS REVENGE.

HE'S A BALTER (L. Neindorf) - slow into stride.

OUTLAWS REVENGE (D. Tourneur) - over-raced in the early and middle stages of the event. Was held up for clear running from the entrance to the straight until approaching the 200m. Near the 150m rider dropped his off side rein and regathered it shortly after.

CALLA DREAM (K. Crowther) - at the entrance to the straight rolled in and hampered KEEP READING. Near the 150m when weakening, was eased when tightened onto HE'S A BALTER as KEEP READING was taken out by MORVADA. A post-race veterinary examination revealed no visible abnormalities.





RACE 8: CITY OF MARION STAKES - 1200 Metres (cont'd)

KEEP READING (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 0.5kg over its allotted weight of 54.0kg. At the entrance to the straight was hampered when awkwardly placed between OUTLAWS REVENGE and CALLA DREAM, which rolled in. Thereafter had difficulty obtaining clear ground until near the 200m. Near the 150m was taken out by MORVADA, onto CALLA DREAM which was obliged to be eased. Approaching the finish raced in restricted room between HE'S A BALTER and MORVADA, which both shifted ground.

RACE 9: HAPPY 40TH MATT CLEMOW HANDICAP - 1100 Metres

RUSHAWAY LAD (E. Wong) - hung in under pressure in the straight and near the 150m bumped with ZARACE. A post-race veterinary examination revealed no visible abnormalities.

DAMASCUS MOMENT (L. McNeil) - a post-race veterinary examination revealed no visible abnormalities.

DYNAMIC THINKER (A. Lindsay) - approaching the 1000m shifted in onto SILVER ON RED, which was obliged to be steadied and shortly thereafter commenced to over-race. Rider was severely reprimanded for careless riding under AR131(a) and advised to take greater care in future.

SILVER ON RED (P. Gatt) - jumped away awkwardly, shifted in and bumped OUTPOST. Near the 1000m was obliged to be steadied as DYNAMIC THINKER shifted in, and then commenced to race fiercely. Over-raced in the early and middle stages of the event. Hung out rounding the home turn. Approaching the 200m rolled out onto SMOKIN' VAL.

OUTPOST (J. Holder) - on jumping away bumped with SILVER ON RED. Near the 500m was awkwardly placed on the heels of LADY SIMONE, which had commenced to give ground, was obliged to be steadied, lost ground and shifted in, in an attempt to obtain clear running.

SMOKIN' VAL (R. Hurdle) - held up for clear running from near the 400m until near the 200m when racing between MAGIC PHANTOM and SILVER ON RED, which rolled out near the 200m.

LADY SIMONE (J. Toeroek) - rider reported that the mare did not feel comfortable in its action, commenced to give ground rounding the home turn and for this reason he elected not to ride it out from the 100m. A post-race veterinary examination revealed the mare to be lame in the near hind leg (2/5). Co-trainers, Mr R. Jolly & Miss C. Jolly, were advised that a Veterinary Clearance was required prior to a future jump-out, trial or race start.

LIANNE (E. Boyd) - shortly after the start was slow to muster speed despite the efforts of its rider.

ZARACE (C. Murray) - raced keenly in the early and middle stages of the event. Near the 150m bumped with RUSHAWAY LAD.
