## RACE 1: WISTOW BAKERY AND CAFE MAIDEN PLATE - 1350 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

ALWAYS SOMETIMES (J. Potter) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

CAMBERWOOD (E. Wong) - hung out from the 600m.

KING FOX (K. Sardelic) - Trainer, Mr R. Day was advised that a warning had been placed on the gelding in relation to its competitiveness.

QUIETLY SPOKEN (NZ) (A. Lindsay) - near the 150m was obliged to alter course to the outside of ALWAYS SOMETIMES to obtain clear running.

MONSEAGLE (L. Neindorf) - raced keenly in the middle stages of the event.

FEAT OF FURY (F. Atkinson) - jumped away slowly. Rider reported that after being slow to begin the mare raced greenly throughout the event.



RACE 1: WISTOW BAKERY AND CAFE MAIDEN PLATE - 1350 Metres (cont'd)

MISS NOSY ROSIE (T. Voorham) - laid in, in the straight. Inside the 100m was momentarily inconvenienced by MONSEAGLE, which shifted in.

STELLA POLARIS (A. Livesey) - following the declaration of acceptances Trainer, Mr J. Cannon made a gear application to remove winkers and add a nose roll to the filly's race gear. Stewards acceded to this request and acting under AR206(2) fined Mr Cannon \$200. Rider reported that the filly raced greenly throughout the event.

RACE 2: CREEK CRUISER MAIDEN PLATE - 1100 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

A MIDNIGHT SHADOW (J. Holder) - jumped away awkwardly, shifted out and bumped LONDRES (NZ). Held up from the 400m until the 100m. Near the 200m was disappointed for a run between ROUGE RENARDE and BLANCA A ROSA, when both runners shifted ground.

NO ENTITLEMENT (F. Atkinson) - jumped away awkwardly, shifted out and bumped BLANCA A ROSA.

PETRA'S GIRL (J. Potter) - laid in, in the straight. A post-race veterinary examination revealed a laceration to the mare's medial near fore pastern. First aid administered.

SO I PRAY (A. Livesey) - a post-race veterinary examination revealed the mare had bled from one nostril. Trainer, Mr P. Nolan was advised that SO I PRAY would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future race in accordance with AR79(8). Mr P. Nolan advised Stewards that the mare would be retired.

TIAMAT (S. Logan) - laid in over the final 100m.

BLANCA A ROSA (D. Caboche) - bumped on jumping away by NO ENTITLEMENT.

BUGATTI GOLD (B. Wong) - proved difficult to load. Trainer, Mr J. O'Connor was advised the filly was now required to load without delay in an Official Barrier Trial or Approval to Race jump-out prior to a future race start.

JILLADORA (M. Collett) - raced keenly in the middle stages of the event.

MEDAL QUEST (J. Eaton) - held up from the 200m until approaching the 100m.

VALENTINA CHARM (K. Crowther) - laid in, in the straight. A post-race veterinary examination revealed the filly's off hind leg had been galloped on and had a laceration to its gaskin.

LONDRES (NZ) (E. Wong) - jumped away awkwardly, shifted in and bumped A MIDNIGHT SHADOW. Rider reported that he became concerned with the mare's action at the entrance to the straight and for that reason did not ride his mount out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: LAKE BREEZE BENCHMARK 58 HANDICAP (APP. RIDERS ONLY) (HEAT 1 MONTGOMERIE/FORREST APPRENTICE SERIES) - 1350 Metres

MADAM BOITIER (NZ) (L. Neindorf) - lost its off fore plate during the event.

ALPHAEUS (E. Wong) - laid out under pressure in the straight.

EQUAL BALANCE (E. Annells) - raced wide without cover throughout the event. Laid in, in the straight. Near the 200m was obliged to stop riding and straighten her mount. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by E. Annells and noted that she used it on five occasions over the final 100m of the event.



RACE 3: LAKE BREEZE BENCHMARK 58 HANDICAP (APP. RIDERS ONLY) (HEAT 1 MONTGOMERIE/FORREST APPRENTICE SERIES) - 1350 Metres (cont'd)

CENTRE SCOOTA (J. Doyle) - slow to begin.

HONOR THE MOMENT (Z. Lloyd) - underwent a pre-race veterinary examination and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities. Slow to begin.

RACE 4: GIPSIE JACK CLASS TWO HANDICAP - 1600 Metres

BADONKIDONK (B. Price) - rider explained that the gelding never travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

FOX GEM (E. Wong) - held up from the 400m until inside the 200m. From the 200m until the 100m had difficulty obtaining clear ground.

KING OF AVALON (NZ) (S. Logan) - jumped away awkwardly and was slow to begin. Raced keenly in the early stages of the event.

RACE 5: BREMERTON WINES VIGNERONS' CUP - 1350 Metres

WINGS OF PASTRAMI (L. Neindorf) - raced wide without cover throughout the event.

NEXT DIMENSION (NZ) (D. Tourneur) - raced keenly in the early stages of the event.

RACE 6: BLEASDALE WINES BENCHMARK 62 HANDICAP - 2050 Metres

EXALTED RUTH (A. Lindsay) - jumped away awkwardly, shifted out and bumped HILUMIERE. Approaching the winning post on the first occasion shifted in and crossed the running line of NATIVE BLUE, which had to be eased to avoid the heels of EXALTED RUTH. Rider was severely reprimanded under AR131(a) and advised, in future, to only shift ground when entitled to do so. A post-race veterinary examination revealed the mare to be lame in the near foreleg (2/5). Trainer, Mr G. Lynch was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RED SEQUOIA (J. Eaton) - in the vicinity of the 200m shifted out and took HAPPY ATOM out onto STAYING STRONG. Rider was severely reprimanded under AR131(a) and advised, in future to take greater care when shifting ground.

NATIVE BLUE (E. Boyd) - approaching the winning post on the first occasion had to be steadied to avoid the heels of EXALTED RUTH.

SASUN (A. Livesey) - raced keenly in the middle stages of the event.

HAPPY ATOM (K. Crowther) - near the 200m was taken out onto STAYING STRONG by RED SEQUOIA.

UP THE STAIRS (L. Neindorf) - laid out in the straight.

VINO DECASA NOSTRA (NZ) (S. Logan) - near the 200m had its hindquarters turned by STAYING STRONG.

BRIABELLA (E. Wong) - raced keenly in the middle stages of the event. Got its head up on a number of occasions whilst being restrained.

STAYING STRONG (D. Caboche) - near the 200m was tightened and hampered for a short distance between VINO DECASA NOSTRA (NZ) and HAPPY ATOM, which was taken out.



RACE 7: LANGHORNE CREEK WINE REGION BENCHMARK 56 HANDICAP - 1200 Metres

FERGIE (A. Livesey) - jumped away awkwardly.

BLUDOG (L. Neindorf) - laid in, in the straight. Approaching the 100m had to be steadied away from the heels of OAKFIELD GERONIMO. A post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Trainer, Mr D. Jolly was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

POLLYANNA (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

SEE YOU LATER NOW (J. Holder) - jumped away awkwardly.

GRAVITY (T. Voorham) - jumped away awkwardly.
