RACE 1: CARLTON DRAUGHT MAIDEN PLATE - 1000 Metres

BASE OF FIRE (J. Holder) - hampered on jumping away when contacted by IT'S DOLLY TO YOU.

TOSEN LAD (S. Payne) - jumped away awkwardly.

IT'S DOLLY TO YOU (J. Potter) - jumped away awkwardly, shifted out and contacted BASE OF FIRE.

NOITULOVER (A. Jordsjo) - shifted in abruptly near the 300m onto WHO'S AFRAID. Rider reported that the filly raced greenly throughout the event.

SIXTEEN REASONS (L. Neindorf) - raced wide without cover throughout the event. Laid in under pressure in the straight.

WHO'S AFRAID (S. Fawke) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 300m. Hampered near the 300m and became unbalanced when NOITULOVER shifted in abruptly.



## RACE 2: NORTHPOINT MURRAYLANDS HANDICAP - 1400 Metres

EXTRA TIME (J. Holder) - shifted in on jumping away onto BLACK SYRAH. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (2/5). Co-trainers, Mr L. Macdonald & Mr A. Gluyas were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

BLACK SYRAH (D. Tourneur) - slow to begin and shortly after was inconvenienced when contacted by EXTRA TIME.

## RACE 3: MARSHALL & BROUGHAM HANDICAP - 2500 Metres

PLATFORM (NZ) (D. Tourneur) - raced wide without cover for the majority of the event. Near the 1200m had to be steadied momentarily when DIXIE WHISTLER shifted out. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr T. Doudle was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

WHEELS (NZ) (J. Holder) - slow to begin. Laid out under pressure in the straight.

DIXIE WHISTLER (L. Neindorf) - raced keenly in the early and middle stages of the event. Near the 1200m shifted out to improve and in doing so inconvenienced PLATFORM (NZ). Rider was reminded of his obligations under AR131(a) when shifting ground. Laid out under pressure in the straight.

BATTING ABOVE (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

BUSKER'S BALLAD (A. Livesey) - slow to begin.

## RACE 4: MAGIC MILLIONS SA 2YO CLASSIC (QUALIFIED HORSES) - 1200 Metres

SURPRISE COMING (J. Eaton) - near the 1100m laid in onto SOLAR MIST, which was inconvenienced. Continued to lay in for the remainder of the event.

DODD (C. Jones) - laid out under pressure in the straight. Had difficulty obtaining clear ground for a short distance inside the 300m.

RUSCHEYNE (J. Potter) - shifted out on jumping away and bumped HARLEEN.

SOLAR MIST (K. Crowther) - had to be steadied for a number of strides near the 1100m when SURPRISE COMING rolled in slightly.

HARLEEN (T. Voorham) - hampered on jumping away when contacted by RUSCHEYNE.

FURLANETTO (T. Pannell) - a post-race veterinary examination revealed a slower than normal post-race recovery.

## RACE 5: MAGIC MILLIONS SA 3 & 4YO CLASSIC (QUALIFIED HORSES) - 1200 Metres

TREPORTI (L. Riordan) - was restrained approaching the 800m to obtain cover. Near the 400m had to be momentarily steadied when awkwardly placed on the heels of EXTRAVAGANT CHOICE, which had been taken out slightly.

EXTRAVAGANT CHOICE (T. Pannell) - shifted in shortly after the start and bumped MAINBAR on a number of occasion. A post-race veterinary examination revealed no visible abnormalities.

MAINBAR (J. Eaton) - inconvenienced on jumping away when contacted on a number occasions by EXTRAVAGANT CHOICE. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

DIVINE MISTRESS (S. Metcalfe) - Trainer, Ms E. Hubbard advised Stewards prior to the event of a change of tactics in that she would instruct her rider to attempt to gain cover in the event if possible. Settled midfield with cover. Slow to begin.



## RACE 6: TOTAL WORKFORCE SOLUTIONS HANDICAP - 1400 Metres

The start of this event was delayed approximately five minutes.

KUSHAN KHANIVALE (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

MISSION SUPREME (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

MONSEAGLE (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

ANDREW'S MEMORY (J. Maund) - near the 300m was momentarily steadied when taken out slightly onto the heels of WARCHIME by LORD GEORGE. Near the 200m had to be steadied when it shifted out and away slightly from LORD GEORGE onto WARCHIME, which shifted in slightly.

FIORADA LAD (S. Payne) - jumped away awkwardly, shifted in and contacted DUAL FUEL (NZ).

MERCHANT BOSS (J. Opperman) - raced wide without cover throughout the event.

WARCHIME (L. Riordan) - inclined to shift about under pressure in the straight. Near the 100m shifted in abruptly and contacted LORD GEORGE. Rider reported that the gelding was wayward in the straight and he had not ridden out over the concluding stages as he was of the opinion that WARCHIME may shift in abruptly again onto runners racing to his inside.

LORD GEORGE (L. Neindorf) - inclined to shift about under pressure in the straight. Near the 300m shifted out slightly and contacted ANDREW'S MEMORY. Inconvenienced near the 100m when contacted by WARCHIME, which shifted in abruptly.

DUAL FUEL (NZ) (A. Jordsjo) - contacted shortly after the start. Laid in under pressure in the straight.

PRETTY RELIABLE (NZ) (E. Boyd) - held up over the concluding 100m when racing behind FIORADA LAD, which had commenced to give ground. Rider reported that the gelding had jumped away better than expected and had found itself further forward in the event than she had anticipated.

## RACE 7: ADELAIDE EVENT CATERING HANDICAP - 1000 Metres

LUNAR HERO (A. Livesey) - laid in under pressure in the straight. Rider reported that the gelding was disappointing when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

QEYAADY (B. Price) - raced keenly in the early and middle stages of the event. Rider reported that he had become concerned with the geldings action over the concluding stages of the event. A post-race veterinary examination revealed a slow post-race recovery.

ALPHA FLIGHT (S. Tomlinson) - reared on jumping away. Raced wide without cover throughout the event. Hung in under pressure in the straight and as result the rider was unable to ride out over the concluding 200m of the event. A post-race veterinary examination revealed no visible abnormalities.

RICH GINA (D. Tourneur) - slow to begin.

THEY CALL ME ALVIN (J. B Potter) - shifted in on jumping away and contacted BUBBLE OVER.

BUBBLE OVER (T. Voorham) - hampered on jumping away when tightened onto LUNAR HERO by THEY CALL ME ALVIN. Shifted about under pressure in the straight. Had difficulty obtaining clear ground from inside the 300m until near the 250m when it was able to shift out to the inside of THEY CALL ME ALVIN to obtain clear ground.

LITTLE RICH BOY (J. Eaton) - jumped away awkwardly.





RACE 7: ADELAIDE EVENT CATERING HANDICAP - 1000 Metres (cont'd)

TANJA'S DREAM (S. Metcalfe) - underwent a pre-race veterinary examination on arrival on course which found that the mare had an injury to its near fore tendon region and was deemed unsuitable to race. Acting on this advice TANJA'S DREAM was declared a late scratching by order of Stewards at 1.34pm. Trainer, Mr G. Kluske was advised that a Veterinary Clearance and findings of an ultrasound were required prior to nominating for a future jump-out, trial or race.

WAKANJEJA (K. Crowther) - a post-race veterinary examination revealed a slow post-race recovery.

STORM VOYAGER (J. Holder) - Stewards permitted J. Holder to ride the mare 0.5 kg over its declared weight of 54.0kg.

RACE 8: BEYOND INK HANDICAP - 1800 Metres

The start of this event was delayed approximately three minutes.

TRUMPSTA (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

HERE COMES LENNI (NZ) (C. Rawiller) - a post-race veterinary examination revealed no visible abnormalities.

FRANKEL STAR (J. Opperman) - laid in under pressure in the straight.

WETAKEMANHATTAN (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

AMMO AMOR (S. Metcalfe) - raced wide without cover throughout the event.

KYSHAKA (T. Voorham) - rider reported that the mare travelled well in the early and middle stages of the event; however, when asked for an effort did not finish off as anticipated. A post-race veterinary examination revealed the mare to be lame in the off foreleg (1/5). Trainer, Mr P. Hardacre was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

LAST GIRL LOVE (L. Neindorf) - slow to begin and shortly after was inconvenienced when SANTELMO FUEGO shifted out. Laid in under pressure in the straight until near the vicinity of the 100m. Laid out over the concluding 100m of the event.

GETOUTTHEWAY (L. Riordan) - jumped away awkwardly.

SANTELMO FUEGO (J. Eaton) - shifted out on jumping away onto LAST GIRL LOVE. Had difficulty obtaining clear ground from the entrance to the straight until approaching the 300m. Laid in under pressure in the straight.

OUR SELECTION (NZ) (S. Logan) - raced keenly in the early and middle stages of the event.


SEAFARING (NZ) (J. Potter) - raced keenly in the early and middle stages of the event.

RACE 9: SPRY CONCRETE PUMPS HANDICAP - 1600 Metres

IMPOSING SUSPECT (NZ) (L. Neindorf) - hampered on jumping away when tightened onto TEA RAV (NZ) by IMBIBE. Shifted out inside the 300m in an attempt to improve and in doing so contacted SALUTE THE STARS.

BENZ BARON (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

SALUTE THE STARS (C. Jones) - inconvenienced inside the 300m when contacted by IMPOSING SUSPECT (NZ).



WHISKEY 'N' WOMEN (S. Payne) - approaching the finish shifted out under riding onto TANAAWOL (NZ). Rider was severely reprimanded under AR131(a) and advised, in future, to make a greater effort to keep his mounts straight.

RACE 9: SPRY CONCRETE PUMPS HANDICAP - 1600 Metres (cont'd)

IMBIBE (K. Crowther) - shifted out on jumping away onto IMPOSING SUSPECT (NZ). Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MOJO CLASSIC (T. Pannell) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 200m.

IN THE DARKNESS (NZ) (J. Toeroek) - slow to begin. Rider reported that he had anticipated settling further forward however after jumping away slow he was unable to obtain the position he had anticipated.

TEA RAV (NZ) (D. Tootell (Snr)) - slow to begin. Hampered on jumping away when tightened onto LAST ZERPRISE by IMPOSING SUSPECT (NZ).
