INTERIM REPORT

RACE 1: TAB ADELAIDE CUP DAY - MONDAY MARCH 13TH HANDICAP - 1400 Metres

GARGANTUAN (S. Tomlinson) - shifted in on jumping away and bumped DASH IT. Raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

AGRIMONY (GB) (T. Pannell) - laid out under pressure in the straight.

SHEZ BETTY (A. Livesey) - hampered and lost its position on jumping away when tightened onto DASH IT by BILLIE BRONX. Raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

BILLIE BRONX (C. Murray) - shifted out on jumping away onto SHEZ BETTY.

DASH IT (T. Voorham) - hampered on jumping away and lost its position when tightened between SHEZ BETTY, which was taken out, and GARGANTUAN, which shifted in. Laid out rounding the home turn and under pressure in the straight.

SWAMP VIXEN (B. Price) - slow to begin.



RACE 2: THOMAS FARMS TWO-YEAR-OLD MAIDEN PLATE - 1000 Metres

BONA FIDE STAR (L. Neindorf) - a post-race veterinary examination revealed no visible abnormalities.

DOUBTING EYE (T. Pannell) - held up from the entrance to the straight until the 200m when racing behind OK GERRY and inside NASHO.

JEWEL BAY (K. Crowther) - laid in under pressure in the straight.

MOREDREAM (D. Caboche) - jumped away awkwardly.

NASHO (J. Potter) - near the 200m was hampered and had to be steadied momentarily when OK GERRY rolled out slightly.

PROHIBITED (C. Jones) - slow to begin.

SIR PANAMA (J. Holder) - jumped away awkwardly. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

OK GERRY (J. Toeroek) - near the 200m rolled out slightly onto NASHO.

RACE 3: CHALK HILL WINES THREE-YEAR-OLD MAIDEN PLATE - 1000 Metres

The start of this event was delayed approximately two minutes.

AUNTIE JAKE'S BAR (J. Toeroek) - slow to begin and shortly after was severely hampered when contacted by I LOVE MUM. Had difficulty obtaining clear ground at the entrance to the straight and near the 300m had to be momentarily steadied when racing in restricted room between WHISKY SOUR and PULAMBI.

FLYIN' FOR US (C. Murray) - near the 50m was accidentally struck on the nose by the whip of LAKE AGAWAM. Laid out under pressure in the straight. When questioned in relation to his riding in the straight rider explained that he felt he had maintained his position the best he could given that the gelding was laying out, and approaching the 200m was unable to correct his position as LAKE AGAWAM had improved quickly to his inside and claimed that ground.

GOLD BRAID (J. Eaton) - severely hampered on jumping away and lost its position when tightened onto I LOVE MUM by DAUTNING DECISION.

LAKE AGAWAM (K. Crowther) - held up from near the 500m until near the 300m.

LEFT TURN CLYDE (E. Wong) - jumped away awkwardly. Raced wide without cover throughout the event. Laid out over the concluding 700m.


WHISKY SOUR (S. Payne) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

DAUNTING DECISION (S. Tomlinson) - shifted out abruptly on jumping away onto GOLD BRAID. Laid out over the concluding 500m. A post-race veterinary examination revealed no visible abnormalities.

QUEEN IN THE NORTH (C. Jones) - jumped away awkwardly.

SHE'S TUFF ENUFF (B. Price) - hampered on jumping away when its hindquarters were turned out by I LOVE MUM. Raced wide without cover throughout the event. Rider explained that the filly had to work hard in the early stages and was caught wide throughout the wide; however, he could offer no other explanation for the poor performance. A post-race veterinary examination revealed no visible abnormalities. Co-trainer, Mr W. Clarcken, advised Stewards that on return to the stables SHE'S TUFF ENUFF was shin sore in both forelegs.

I LOVE MUM (D. Caboche) - hampered on jumping away and lost its position when taken out onto AUNTIE JAKE'S BAR by GOLD BRAID. Continued out and contacted the hindquarters of SHE'S TUFF ENUFF. A post-race veterinary examination revealed a slower than expected hear rate.



RACE 3: CHALK HILL WINES THREE-YEAR-OLD MAIDENPLATE - 1000 Metres (cont'd)

Trainer, Mr P. Day, was advised that the filly would now be suspended from racing until such time as it could prove competitive in an Official Barrier Trial.

RACE 4: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1300 Metres

MY KHALIFA (E. Wong) - laid in under pressure in the straight.

PERFECT ROUTE (J. Eaton) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

BELLINGER (L. Lafferty) - laid out under pressure in the straight.

TEXAN WINDSTORM (A. Livesey) - near the 900m changed stride for no apparent reason, shifted out and inconvenienced CHICAGO STORM.

CHICAGO STORM (J. Toeroek) - raced keenly in the early and middle stages. Near the 900m was inconvenienced when TEXAN WINDSTORM shifted out.

RACE 5: FURPHY HANDICAP - 1300 Metres

APACHE STAR (G. Lo) - raced keenly in the early and middle stages of the event. Made the turn near the 900m awkwardly and shifted out. Laid out under pressure in the straight.

DIRTY MIND (NZ) (T. Pannell) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Trainers, Messrs A & S Freedman, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

KAYSERI (NZ) (B. Price) - slow to begin. Lost its near hind plate during the event.

TONY MONTANA (J. Holder) - slow to begin.

MASTER AT ARMS (NZ) (J. Toeroek) - laid out from near the 600m until the entrance to the straight.

RACE 6: THE JUNCTION HANDICAP - 1950 Metres

SAMEDI (T. Pannell) - laid out under pressure over the concluding 200m and near the 100m shifted out under riding into the running line of SEAFARING (NZ), which was forced to check and lose its position. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 18 March 2023 to conclude midnight Saturday, 25 March 2023, a period of three meetings.

AMMO AMOR (T. Voorham) - had difficulty obtaining clear ground from near the 400m until near the 300m, and then inside the 200m altered course to the inside of SAMEDI, which shifted out.

SANTELMO FUEGO (J. Eaton) - slow to begin.

FLASH PANTHER (E. Wong) - slow to begin. Rider accidentally dropped his whip near the 300m.

Correct weight for this event was delayed to allow J. Maund (SEAFARING (NZ)) placed fifth, and T. Voorham (AMMO AMOR) placed second, and that gelding's trainer, Ms K. Evans, to view the vision in the straight. After doing so J. Maund lodged an objection against SAMEDI (T. Pannell) being declared the winner on the grounds of alleged interference over the concluding 150m of the event. T. Voorham also lodged an objection against SAMEDI (T. Pannell) being declared the winner on the grounds of alleged interference inside the 200m. After considering the evidence, viewing the vision and acting on their own observations Stewards *dismissed* both objections.



RACE 7: PFD FOODS HANDICAP - 1550 Metres

CROWN MINT (J. Holder) - jumped away awkwardly.

NOTTARIS (L. Neindorf) – raced keenly in the early and middle stages of the event.

SPEARS (E. Boyd) – a post-race veterinary examination revealed the mare to be lame in the near foreleg (2/5). Co-trainers, Messrs G. & D. Alexander, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RACE 8: GRANDSYNDICATES HANDICAP - 1300 Metres

The start of this event was delayed approximately three minutes to avoid a clash with an interstate race.

EYES NEVER LIE (T. Voorham) – a post-race veterinary examination revealed the mare to be lame in the both forelegs (2/5). Co-trainers, Mr L. Macdonald and Mr A. Gluyas, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

TURFITT (L. Neindorf) – shifted out on jumping away onto MERLE THE PEARL. Laid out rounding the turn near the 900m and then raced keenly for a number of strides on the heels of MERLE THE PEARL.

MERLE THE PEARL (S. Payne) – raced keenly in the early stages of the event.

LAKE TITICACA (T. Pannell) – lost its near hind plate during the event. A post-race veterinary examination revealed a slower than expected recovery.

MARQUETTE (E. Wong) – laid out under pressure in the straight.

WINE FROM TEARS (B. Price) – jumped away awkwardly. Raced in restricted room over the concluding stages when awkwardly placed between the heels of TURFITT and LADY DE LUNE.

EXALTED DAME (J. Holder) – hung out rounding the home turn and under pressure in the straight.

LADY DE LUNE (S. Tomlinson) – jumped away awkwardly and shortly after lost its position when tightened between LAKE TITICACA, which shifted in slightly, and MARLE THE PEARL, which was taken out slightly by TURFITT. Near the 900m had to be steadied when it improved onto the heels of TURFITT. Had difficulty obtaining clear ground from near the 300m until near the 100m and then approaching the finish had to alter course to the inside of MARQUETTE, which laid in.

POSSUM BORN (J. Toeroek) – raced wide without cover throughout the event.

SEND IT (A. Livesey) – lost its near fore plate during the event.

RACE 9: CANADIAN CLUB HANDICAP - 1000 Metres

The start of this event was delayed approximately four minutes.

MR HAVE A CHAT (C. Rawiller) – jumped away awkwardly and was slow into stride. Near the 100m had to be steadied when tightened between CORK HARBOUR, which laid out, and MISS EUROZONE, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

SABERMETRIC (L. Neindorf) – inconvenienced near the 150m when taken wider by RUSTY HALO.

LATVIAN (T. Pannell) – inconvenienced near the 150m when taken wider by SABERMETRIC, which had been taken out.

MISS EUROZONE (E. Finnegan) – accidentally dropped her whip approaching the 100m.

DANTREE (E. Wong) – jumped away awkwardly. Held up from near the 500m until near the 300m.

RUSTY HALO (J. Holder) – held up from the entrance to the straight until near the 150m when it shifted out onto SABERMETRIC, which was taken wider. Rider severely reprimanded under AR131(a) and advised in future to ensure there was sufficient ground to shift in future.

RACE 9: CANADIAN CLUB HANDICAP - 1000 Metres (cont'd)

JIMMYS EDGE (S. Payne) - raced wide without cover throughout the event. Laid out under pressure rounding the home turn and in the straight. A post-race veterinary examination revealed a slower than expected recovery.

CORK HARBOUR (B. Price) - took charge of its rider shortly after arriving at the barriers, was able to be restrained after several hundred metres and was returned to the barriers with the assistance of the Clerk of the Course.

Correct weight for this event was delayed to allow L. Neindorf (SABERMETRIC), placed second, and that gelding's co-trainers, Mr G. Richards and Mr D. Moyle, to view the vision in the straight. After doing so L. Neindorf lodged an objection against RUSTY HALO (J. Holder) being declared the winner on the grounds of alleged interference in the vicinity of the 150m. After considering the evidence, viewing the vision and acting on their own observations Stewards *dismissed* the objection.
