RACE 1: GRAND SYNDICATES MAIDEN PLATE - 1100 Metres

SANDHILL KNIGHT (D. Tourneur) - began well. Laid in over the concluding stages of the event.

SON OF VADAMOS (NZ) (S. Payne) - raced greenly in the straight.

AUNTIE JAKE'S BAR (J. Toeroek) - jumped away awkwardly and was slow to begin.

FALAISE (S. Tomlinson) - at the entrance to the straight bumped with SIXTEEN REASONS, which shifted out.

DIVINE MISTRESS (C. Murray) - made contact with a perimeter fence in the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. Weakened from inside the 400m. Rider could offer no explanation in relation to the fillies performance. A post-race veterinary examination revealed a slower than expected recovery and a laceration to the near fore fetlock. First aid applied.

FAITH IN THE RIVER (A. Livesey) - raced greenly in the straight.

SIXTEEN REASONS (B. Price) - inside the 400m was held up for clear running for a short distance. At the entrance to the straight shifted out and bumped FALAISE. A post-race veterinary examination revealed no visible abnormalities.

APOLLO GIRL (C. Tootell) - slow to begin.



RACE 2: HAPPY 40TH HAYDN REID MAIDEN PLATE - 1100 Metres

DRAWN TO WIN (C. Tootell) - near the 800m shifted in onto LOTZA BUBBLES, which shifted in and away onto VIVA LA VIDA, which was obliged to be steadied. Rider was severely reprimanded under AR131(a) and advised in future that her angle of approach should not be as acute.

INTO THE FURY (D. Caboche) - inside the 400m had its hindquarters turned and became unbalanced when taken in onto MELANIE'S JOY, by RICH LADY, which was taken in.

BIG OL' RIG (F. Atkinson) - inside the 400m shifted in onto RICH LADY, which was taken in onto INTO THE FURY, which had its hindquarters turned and became unbalanced when taken in onto MELANIE'S JOY, which was obliged to be severely checked and lost its position. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday 25 March 2023 and to conclude midnight Friday 31 March 2023, a period of three meetings.

VIVA LA VIDA (B. Wong) - near the 800m was obliged to be steadied when LOTZA BUBBLES shifted in and away from DRAWN TO WIN.

LOTZA BUBBLES (K. Crowther) - near the 800m shifted in and away from DRAWN TO WIN onto VIVA LA VIDA.

RICH LADY (J. Holder) - jumped away awkwardly. Held up for clear running from near the 400m until near the 200m. Near the 300m was taken in onto INTO THE FURY by BIG OL' RIG which shifted in.

RULING GODDESS (J. Toeroek) - laid in under pressure in the straight.

ROLLING DUCK (L. Neindorf) - Stewards permitted L. Neindorf to ride the filly 1.0 kg over its allocated weight of 53.0 kg. A post-race veterinary examination revealed no visible abnormalities.

MELANIE'S JOY (Z. Lloyd) - inside the 400m was obliged to be severely checked and lost its position when tightened by INTO THE FURY, which had its hindquarters turned and became unbalanced when taken in onto this mare by RICH LADY, which was taken in by BIG OL' RIG.

RACE 3: RANVET -NATIONAL APPRENTICE RACE SERIES BM60 HANDICAP - 1350 Metres

LITTLE RICH BOY (Z. Lloyd) - shortly after the start was inconvenienced when GARRIRE shifted out abruptly.

BONNIE GANGSTER (E. Lang) - bumped at the start by GARRIRE.

GARRIRE (A. Livesey) - jumped away awkwardly, shifted in and bumped BONNIE GANGSTER, and shortly after shifted out abruptly onto WILLIAM'S QUEST, which lost its position. Hung out rounding the home turn and was inclined to shift out abruptly on a number of occasions in the straight. A post-race veterinary examination revealed no visible abnormalities.

WILLIAM'S QUEST (H. Yuen) - on jumping away lost its position when tightened onto LITTLE RICH BOY as GARRIRE shifted out abruptly.

RACE 4: DAISH IRRIGATION & FODDER MAIDEN PLATE - 1350 Metres

The start of this event was delayed by approximately six minutes.

BIT OF A REBEL (C. Munro) - dislodged its rider en route to the barriers. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. Rider was uninjured in the incident.

DIFFLIN COUNTY (D. Caboche) - near the 100m was hampered as BACK ME UP BENNY shifted out when racing greenly.

SIP OF SODA (S. Fawke) - near the 900m was inconvenienced as CALL ME AL shifted out.





RACE 4: DAISH IRRIGATION & FODDER MAIDEN PLATE - 1350 Metres (cont'd)

BACK ME UP BENNY (S. Metcalfe) - near the 500m was taken in by CALL ME AL, which was racing greenly, onto MONEY OR THE BOX. Raced greenly under pressure in the straight. Near the 100m, when racing greenly, shifted out onto DIFFLIN COUNTY, which was hampered. Approaching the finish became awkwardly placed on the heels of LADY NELSON. A post-race veterinary examination revealed no visible abnormalities.

CALL ME AL (L. Neindorf) - near the 900m shifted out onto SIP OF SODA, which was inconvenienced. Near the 500m when racing greenly shifted in onto BACK ME UP BENNY.

MISS NIPPY (S. Tomlinson) - on jumping away was hampered by SERBIAN GIRL, which shifted out abruptly. A post-race veterinary examination revealed no visible abnormalities.

SERBIAN GIRL (E. Wong) - jumped away awkwardly, shifted out abruptly and hampered MISS NIPPY. Over-raced in the early and middle stages of the event. A post-race veterinary examination revealed a lower than expected heart rate.

EVAJADE (J. Toeroek) - jumped away awkwardly and shortly after dipped. Raced keenly in the early and middle stages.

MONEY OR THE BOX (Z. Lloyd) - near the 500m was hampered when tightened by BACK ME UP BENNY. Held up for clear running from shortly after the entrance to the straight until approaching the 100m when racing between BACK ME UP BENNY and DIFFLIN COUNTY, and was obliged to shift in in an attempt to gain clear ground.

POWERFUL FLYER (J. Potter) - lost its near hind plate en route to the barrier and required to be reshod. Proved fractious and was unable to be reshod. The farrier then made an attempt to remove the off hind shoe; however, was unable to do so due to the gelding continuing to be fractious. Acting on this advice Stewards declared POWERFUL FLYER a late scratching at 2.20 pm.

RACE 5: WISTOW ON HIGH MAIDEN PLATE - 1350 Metres

DANS LE SAVOIR (S. Tomlinson) - on the request of its rider underwent a pre-race veterinary examination on arrival at the barriers and was found to be lame in its off foreleg (2/5), and therefore was deemed unsuitable to race. Acting on this advice Stewards declared DANS LE SAVOIR a late scratching at 2.48 pm. Trainer, Mr R. Wilkinson, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

FINGOLFIN (NZ) (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

JACOBS GATE (L. Neindorf) - held up for clear running from the 400m until near the 300m when racing behind GALLIUM. Lost its near hind plate during the event.

WINE BARRON (NZ) (J. Eaton) - raced wide without cover throughout the event.

RED ROOF (S. Metcalfe) - hung in throughout the event.

GALLIUM (K. Crowther) - a post-race veterinary examination revealed a slower than expected recovery.

SEATTLE GRACE (J. Potter) - hung out throughout the event. Lost its near hind plate during the event.

RACE 6: ELDERS GOOLWA CLASS ONE PLATE - 2050 Metres

CARRY ON FLYING (C. Murray) - inside the 200m was momentarily held up when racing between CALL ME VEXATIOUS and FLYING TIVACI.

FLITTELL (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

MOJO CLASSIC (J. Toeroek) - held up for clear running from rounding the home turn and was unable to be fully tested to the line. A post-race veterinary examination revealed no visible abnormalities.



RACE 6: ELDERS GOOLWA CLASS ONE PLATE - 2050 Metres (cont'd)

OUR SELECTION (NZ) (S. Payne) - near the 1000m shifted out taking LAST ZERPRISE wider.

LAST ZERPRISE (Z. Lloyd) - near the 1000m was taken wider by OUR SELECTION (NZ), which shifted out. Hung in under pressure in the straight.

JAJITTA BUG (J. Potter) - over-raced in the early stages. Raced wide without cover from near the 1200m.

BONNIESIX (K. Crowther) - acting on advice from trainer, Mr A. Clarcken, that the mare was lame in the off foreleg and would be unfit to race Stewards declared BONNIESIX a late scratching at 1.18 pm. Mr Clarcken was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

FLYING TIVACI (NZ) (S. Fawke) - over-raced in the early and middle stages. Hung in under pressure in the straight.

RACE 7: APPRENTICE ACADEMY SA - NATIONAL APPRENTICE RACE SERIES BM58 HANDICAP - 1600 Metres

LI'L HANK (E. Lang) - near the 300m shifted out onto FOREIGN LEGION, which had commenced to weaken and was obliged to be steadied when tightened onto WARRANDYTE ROAD which was taken in marginally. Rider was severely reprimanded under AR131(a) and advised to take greater care in future.

AGUSTEEN (T. Chapman) - raced keenly in the early and middle stages of the event.

FOREIGN LEGION (I. Luximon) - near the 300m, when weakening, was obliged to be steadied as LI'L HANK shifted out and WARRANDYTE ROAD was taken in marginally.

LORD OF DARKNESS (NZ) (F. Atkinson) - laid in under pressure in the straight.

WARRANDYTE ROAD (C. Baker) - near the 300m was taken in marginally onto FOREIGN LEGION by SWAMP VIXEN, which was hanging in and shifted in.

SWAMP VIXEN (E. Wong) - near the 300m, when hanging in, shifted in onto WARRANDYTE ROAD taking that gelding in.

APPLIED (C. Munro) - slow to begin.

I'M BULLETPROOF (R. Milnes) - jumped away awkwardly.

RACE 8: BUILT WATER SYSTEMS FILLIES & MARES CLASS TWO HANDICAP - 1200 Metres

SMILING FROM ABOVE (S. Payne) - near the 900m dipped. Held up for clear running from the 300m until near the 200m.

FREEDOM DAY (C. Tootell) - jumped away awkwardly, shifted in and bumped MAI TIME. Laid in under pressure in the straight. A post-race veterinary examination revealed a slower than expected recovery.

COEUR DE PARIS (C. Murray) - rider explained in relation to the mare's performance that it will derive benefit from today's first up run. A post-race veterinary examination revealed a slower than expected recovery.

NO ENTITLEMENT (F. Atkinson) - rider explained in relation to the mare's performance that it was obliged to work hard in the early stages due to the wide barrier draw, which may have had a bearing on the way it performed. A post-race veterinary examination revealed a slower than expected recovery.

MURIWAI (E. Boyd) - held up for clear running from the entrance to the straight until the 100m.



RACE 8: BUILT WATER SYSTEMS FILLIES & MARES CLASS TWO HANDICAP - 1200 Metres

COMANCHE QUEEN (R. Milnes) - as B. Price was overweight Stewards permitted claiming apprentice R. Milnes to replace him as no other senior rider or non-claiming apprentice rider was available.

RACE 9: HORSERECORDS BENCHMARK 56 HANDICAP - 1200 Metres

MISSION SUPREME (G. Lo) - on jumping away bumped with SOPHINA DIVA and OMOPLATA, which both shifted ground. A post-race veterinary examination revealed no visible abnormalities.

ANANAGRAM (NZ) (C. Tootell) - made contact with a perimeter fence on exiting the mounting yard. Underwent a pre-race veterinary examination and was found to have an abrasion to the off side stifle, however, was deemed suitable to start. Slow to begin approximately 3-4 lengths. Trainer, Ms L. Whittle, was advised that a warning had been placed on the gelding. Near the 300m dipped. Trainer, Ms L. Whittle, was reminded of her obligations under AR165(3) in relation to her horses remaining on course 30 minutes after the finish of the race.

OMOPLATA (S. Fawke) - on jumping away was contacted by MISSION SUPREME. Shortly after bucked for two strides resulting in the rider losing his off side iron and as a consequence was awkward in the saddle for a number of strides prior to it being regathered. Trainer, Mr S. Whittle, was advised that a warning had been placed on the gelding. Mr. Whittle, was reminded of his obligations under AR165(3) in relation to his horses remaining on course 30 minutes after the finish of the race.

SOPHINA DIVA (J. Maund) - jumped away awkwardly and shifted out onto MISSION SUPREME.

STELLA REALE (F. Atkinson) - on arrival on course underwent a pre-race veterinary examination as it had not raced for over twelve months and was deemed suitable to start. Rider reported that the mare raced greenly during the event.
