RACE 1: CLARE VALLEY TOYOTA TWO-YEAR-OLD MAIDEN PLATE - 1050 Metres

SIR PANAMA (J. Holder) - hung in under pressure in the straight. Had difficulty obtaining clear ground from the entrance to the straight until inside the 150m.

SPLISH SPLASH (S. Tomlinson) - raced greenly under pressure in the straight.

ZARKANA (C. Jones) - slow to begin.

RACE 2: MY BUTCHER MAIDEN PLATE - 2200 Metres

BULL ANDT (B. Wong) - raced wide without cover throughout the event.

HOTFOOTIT (E. Finnegan) - underwent a pre-race veterinary examination on arrival at the barriers and was found to be lame in the near hind leg (2/5) and therefore was deemed unsuitable to start. Acting on this advice Stewards declared HOTFOOTIT at 1.03 pm. Co-trainers, Mr J. Dunn and Ms K. Bishop, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

SOARLIKEANEAGLE (C. Jones) - rider reported that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure did not accelerate as she had anticipated and was one-paced to the finish. A post-race veterinary examination revealed no visible abnormalities.



RACE 2: MY BUTCHER MAIDEN PLATE - 2200 Metres (cont'd)

EXALTED BELLE (D. Tourneur) - rider reported that the mare raced flat.

FLYING TIVACI (NZ) (S. Fawke) - shifted out on jumping away and brushed CONSENSIO.

HUSSLING (A. Livesey) - laid out under pressure in the straight.

INAGURATE (H. Yuen) - raced keenly in the early and middle stages of the event.

PRANCING IBIS (E. Wong) - jumped away awkwardly. Stewards questioned rider in relation to him looking down at his mount rounding the home turn. Rider explained that the mare changed lead legs and became awkward in its action when rounding the turn near the 1000m and for this reason he had looked down at the entrance to the straight to ensure his horse was on the correct lead leg, as he felt it would improve into the race stronger if it was on the correct leg.

RACE 3: ATLAS EVENT & PARTY HIRE MAIDEN PLATE - 1400 Metres

DERVISH (R. Milnes) - rider was reminded of her obligations under AR132(6)(c) in relation to using her whip when her mounts are out of contention.

POWERFUL FLYER (R. Hurdle) - contacted on jumping away and taken in onto KEEP SWINGING. A post-race veterinary examination revealed a minor laceration to the off hind leg.

TOMMY TOMATO (H. Yuen) - jumped away awkwardly and shifted out contacting JUST JOKING.

ZILX (J. Doyle) - rider was reminded of her obligations under AR132(6)(c) in relation to using her whip when her mounts are out of contention.

SIR KINGSFORD (E. Wong) - jumped away awkwardly. Laid out under pressure in the straight.

WHISKY SOUR (S. Payne) - shifted in on jumping away contacting POWERFUL FLYER. Raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by S. Payne and noted that he used it on eleven occasions over the final 100m of the event.

AWEN (IRE) (J. Toeroek) - raced keenly in the early and middle stages of the event.

KEEP SWINGING (B. Wong) - hampered on jumping away when POWERFUL FLYER was taken in across its running line. Laid in under pressure in the straight.

PHAROAH'S PRIDE (A. Livesey) - laid out from near the 800m until the entrance to the straight.

JUST JOKING (T. Voorham) - contacted on jumping away. Laid in under pressure in the straight.

Following the running of this race R. Hurdle was examined by the First Care Medical personnel and ruled unfit to fulfil his remaining engagement.

RACE 4: HAULMARK MAIDEN PLATE - 1400 Metres

THE COMMANDANT (R. Milnes) - slow to begin. Raced keenly in the early and middle stages of the event.

VEE ROD (NZ) (L. Neindorf) - rider accidentally dropped his whip inside the 100m.

GONG HIM RED (H. Yuen) - hung out throughout the event. Rider was reminded of her obligations under AR132(6)(c) in relation to using her whip when her mounts are out of contention. Lost its off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities. Co-trainer, Mrs B. Callanan, was advised that a warning had been placed on the gelding on the gelding in relation to its racing manners.

PINCHBECK (S. Metcalfe) - jumped away awkwardly and shifted out onto TOSEN ROYALE.



RACE 4: HAULMARK MAIDEN PLATE - 1400 Metres (cont'd)

TOSEN ROYALE (S. Payne) - contacted on jumping away.

REBEL MISTRESS (T. Voorham) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

STELLA NOTATION (A. Livesey) - jumped away awkwardly.

RACE 5: BTR EXCAVATIONS MAIDEN PLATE - 1050 Metres

The start of this event was delayed approximately two minutes.

FREYCINET (K. Crowther) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. Near the 100m had to alter course to the outside of FLORAL OASIS, which shifted in.

UNCHAINED LAD (S. Payne) - a post-race veterinary examination revealed no visible abnormalities.

FAMILY TIES (T. Voorham) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

MADDISON MISS (B. Wong) - raced wide without cover throughout the event. Laid in under pressure in the straight and near the 200m shifted in onto KUITPO KISS, which was forced to race in restricted room for a number of strides. Rider was reprimanded and advised in future to make a greater effort to keep her mounts straight when they commence to shift ground.

VIVA LA VIDA (J. Holder) - rider was questioned in relation to his riding in the straight, and in particular his decision not to improve into a run near the 400m between the heels of KUITPO KISS and MADDISON MISS. Rider explained that just prior to the 400m KUITPO KISS had rolled out slightly and MADDISON MISS had shifted in slightly, and he formed the view that both horses may continue to shift ground and he would be better suited in electing to find clear ground to the outside of MADDISON MISS. He added that after finding clear ground the mare had finished the race off fairly. Rider was advised that Stewards would note his explanation, but advised him in future to ride in a manner that did not invite question.

FLORAL OASIS (L. Neindorf) - shifted in on jumping away contacting ROCK'NROLLPRINCESS.

KUITPO KISS (S. Tomlinson) - near the 200m was forced to race in restricted room for a number of strides when MADDISON MISS shifted in. Rider reported that the filly travelled well; however, did not let down as he had anticipated when placed under pressure. A post-race veterinary examination revealed no visible abnormalities.

ROULETTE QUEEN (NZ) (J. Eaton) - slow to begin.


ROCK'NROLLPRINCESS (S. Metcalfe) - inconvenienced on jumping away when contacted by FLORAL OASIS.

RACE 6: ADELAIDE GALVANISING INDUSTRIES FILLIES & MARES BENCHMARK 56
HANDICAP - 1400 Metres

The start of this event was delayed approximately two minutes.

EXCUSEZ MOI (B. Wong) - lost its near fore plate en route to the barrier and required farrier attention. Underwent a pre-race veterinary examination and was deemed suitable to start.

SHE'S A KARAKA (NZ) (C. Tootell) - slow to begin.



JOURNEY IN TIME (E. Wong) - laid out under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip by E. Wong and noted that he used it on four occasions over the final 100m of the event.



RACE 7: COOPERS CLASS TWO HANDICAP - 1050 Metres

LIMITED RISK (K. Crowther) - raced keenly in the early stages of the event. Inclined to lay in under pressure in the straight.

LUCKY FORTUNA (A. Jordsjo) - jumped away awkwardly. Inclined to lay out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

MENDOORAN (S. Metcalfe) - underwent a pre-race veterinary examination and was deemed suitable to start.

RACE 8: TAYLORS WINES RATING 0 - 60 HANDICAP - 1200 Metres

LOMAX (E. Wong) - slow to begin.

DAWNBURST (S. Payne) - jumped away awkwardly. At the entrance to the straight shifted out to improve and in doing so took NOT A SINGLE BID wider.

NOT A SINGLE BID (L. Neindorf) - at the entrance to the straight was taken wider on the track by DAWNBURST, which had improved to its inside. Rider was advised to be mindful of the action of his elbow in similar situations.

LIANNE (J. Holder) - slow to begin. Had difficulty obtaining clear ground from near the 400m until near the 200m when it altered course to the inside of DAWNBURST to obtain clear ground.

RACE 9: TQCSI COLTS, GELDINGS & ENTIRES BENCHMARK 56 HANDICAP - 1400 Metres

RUN AND TELL (B. Wong) - raced keenly in the early and middle stages of the event. Rider explained that the gelding was obliged to do too much work early in the event and for this reason had not finished of the race as she had anticipated. A post-race veterinary examination revealed a slower than expected recovery.

RUBBLE (K. Crowther) - momentarily inconvenienced near the 200m when TALES OF CONFLICT shifted out.

LITTLE RICH BOY (A. Jordsjo) - raced wide without cover throughout the event.

ALWAYS SOMETIMES (S. Fawke) - jumped away awkwardly. Laid out under pressure in the straight. Stewards questioned the rider in relation to his riding of the gelding over the concluding stages. Rider explained that he had been instructed to take a position behind the speed. He advised that the gelding travelled well and he was able to comply with the instructions; however, when presented at the top of the straight ALWAYS SOMETIMES only had a short sprint and responded to his riding until approaching the 200m. He added that from near the 100m the gelding commenced to weaken rapidly of its own accord. He state that, in his opinion, the gelding would be better suited over a shorter distance. After considering his explanation S. Fawke was reprimanded under AR131(b) in relation to riding his mounts out to the finish of the race, and in addition was advised in future to ride his mounts in a manner that did not invite question.

TALES OF CONFLICT (J. Doyle) - inclined to shift about under pressure in the straight and near the 200m shifted out onto RUBBLE.

PIERRE BIZEL (H. Yuen) - lost its off hind plate during the event.

HOT SPARKY (S. Payne) - jumped away awkwardly. Raced keenly in the early and middle stages of the event and near the 800m became awkwardly placed on the heels of POOL PONY for a short distance.
