RACE 1: THE JUNCTION HANDICAP - 1100 Metres

HARLEY'N'ROSE (L. Neindorf) - near the 400m became awkwardly placed between the heels of CHILLED and AIR ASSAULT, became unbalanced and lost ground. Laid in under pressure in the straight.

AIR ASSAULT (J. Holder) - laid out rounding the home turn.

DODD (J. Potter) - laid out under pressure in the straight.

CHEROKEE MISS (J. Toeroek) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

CHILLED (Z. Spain) - laid out under pressure in the straight.

LABORIOSA (W. Price) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

STRETAN Angel (K. Crowther) - raced keenly in the early and middle stages of the event.



RACE 2: CROSER HANDICAP - 1600 Metres

THIRSTY GUEST (T. Pannell) - near the 200m shifted out under riding when insufficiently clear of KARAKA KIWI (NZ), which was forced to check when tightened onto SAILORS BOOK, which became unbalanced when its hind quarters were turned out. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Sunday, 2 April 2023 and to conclude midnight Monday, 10 April 2023, a period of four meetings. Near the 100m rider permitted his mount to shift out when insufficiently clear of KARAKA KIWI (NZ) forcing that rider to take hold when taken out onto the heels of SAILORS BOOK. Rider pleaded guilty to a further charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Sunday, 2 April 2023 and to conclude midnight Wednesday, 12 April 2023, a period of five meetings. Stewards ordered that both suspensions from this race are to be served concurrently. A post-race veterinary examination revealed no visible abnormalities.

TAPINFORPAR (L. Neindorf) - raced wide without cover throughout the event. Laid in under pressure over the concluding 700m of the event. A post-race veterinary examination revealed no visible abnormalities.

SAILORS BOOK (J. Noonan) - jumped away awkwardly. Near the 200m became unbalanced when its hind quarters were turned out by KARAKA KIWI (NZ).

HOLMES (C. Murray) - underwent a pre-race veterinary examination on arrival on course which revealed a minor abrasion to its off fore pastern and was deemed suitable to race. Raced keenly in the early and middle stages of the event.

KARAKA KIWI (NZ) (J. Maund) - in the vicinity of the 200m was forced to check when tightened onto SAILORS BOOK by THIRSTY GUEST, which shifted out when insufficiently clear. Near the 100m was forced to take hold when taken out on to the heels of SAILORS BOOK by THIRSTY GUEST, which shifted out when insufficiently clear.

RACE 3: PETER ELBERG FUNERALS HANDICAP (HEAT 2 SA SPRINT SERIES) - 1050 Metres

LUNAR HERO (S. Tomlinson) - rider reported that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure at the entrance to the straight did not let down as he had anticipated and weakened from the event of its own accord. He added that he became concerned with the action of LUNAR HERO on return to scale. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (3/5). Trainer, Mr P. Hardacre was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

SQUIZZY MIZZY (G. Lo) - shifted in on jumping away and contacted SAMESYN.

MAGIC MAX (L. Neindorf) - laid in under pressure in the straight.

JOSEYLIN (B. Price) - laid out under pressure in the straight. A post-race veterinary examination revealed the mare to be lame in the near foreleg (1/5) and noted a number of coughs. Co-trainers, Mr B & Mr J. Hayes were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.


FIRST DIVISION (J. Noonan) - had difficulty obtaining clear ground from the entrance to the straight until inside the 200m.

SAMESYN (T. Voorham) - shifted out on jumping away and contacted SQUIZZY MIZZY.

RACE 4: FURPHY HANDICAP (HEAT 2 AUTUMN SERIES) - 1200 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

EXTRA MILE (S. Tomlinson) - near the 900m shifted into the running line of WOLFBURN, which had to be eased. Rider was severely reprimanded under AR131(a) and advised, in future, to take greater care when shifting ground. Raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. Rider reported that it was not his intention to lead the event; however, after jumping away well there was no pace to his inside and the gelding improved to the lead of its own accord.



RACE 4: FURPHY HANDICAP (HEAT 2 AUTUMN SERIES) - 1200 Metres (cont'd)

WOLFBURN (G. Lo) - near the 1100m rolled out onto FANMALIA, which was inconvenienced. Near the 900m had to be eased when EXTRA MILE shifted in. Approaching the 200m elected to alter course when EXTRA MILE rolled in. Inside the 100m was disappointed for a run between SIYATA (GB), which shifted out slightly and Knightstown, which rolled in slightly, resulting in the gelding being untested to the finish.

FANMALIA (B. Price) - near the 1100m was inconvenienced when WOLFBURN rolled out onto its running line.

SIYATA (GB) (T. Pannell) - Co-Trainer, Mr W. Clarcken advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to take up a forward position in the event if possible. Horse settled on pace.

BAMYAN BUDDHA (R. Hurdle) - underwent a pre-race veterinary examination on arrival on course which revealed an abrasion above its left eye received en route to course and was deemed suitable to race. Laid out over the concluding 600m of the event. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Trainer, Mr G. Young was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 5: FLEURIEU MILK COMPANY HANDICAP - 2000 Metres

The start of this event was delayed approximately three minutes to avoid a clash with an interstate event.

INORDINATE (W. Price) - a post-race veterinary examination revealed no visible abnormalities.

BACK IN ACTION (J. Opperman) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

PLAISIR (L. Neindorf) - rider explained that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure at the entrance to the straight it did not respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

ISOLA SACRA (NZ) (Z. Spain) - rider explained that the mare did not travel over the concluding 800m and when asked for an effort did not respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

SALUTE THE STARS (K. Crowther) - laid in under pressure in the straight.

SILENT DON (B. Price) - a post-race veterinary examination revealed the thumps.

MOJO CLASSIC (J. Toeroek) - Co-Trainer, Mr W. Clarcken advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to take up a forward position in the event if possible. Horse settled on pace.

QUEBECOIS (J. Eaton) - jumped away awkwardly and was slow into stride. Held up from near the 400m until inside the 300m.

RACE 6: GRAND SYNDICATES SUPPORTING SAROA HANDICAP - 1100 Metres

MESSERSCHMITT (W. Price) - kicked by another runner on arrival at the barriers. Underwent a pre-race veterinary examination and was deemed suitable to race. Slow to begin.

TWO ODD SOX (T. Pannell) - raced wide without cover throughout the event.

YOSEMITE (NZ) (C. Murray) - held up from rounding the home turn until approaching the 200m.

BLUEGRASS BIJOUX (B. Price) - raced keenly in the early and middle stages of the event.

FRENCH ROCK (A. Jordsjo) - underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race.





RACE 6: GRAND SYNDICATES SUPPORTING SAROA HANDICAP - 1100 Metres (cont'd)

CHOSEN MISS (J. Toeroek) - jumped away awkwardly.

MAY'S WEST (D. Caboche) - raced keenly in the early and middle stages of the event. Near the 800m became awkwardly placed between ARCHWAY TO HEAVEN, which rolled out slightly and LAKEHURST, which laid in slightly.

RACE 7: MANIHI CLASSIC - 1100 Metres

ANOTHER AWARD (J. Holder) - had difficulty obtaining clear ground from the entrance to the straight until near the 200m.

HEKA EXPRESS (J. Opperman) - raced wide without cover throughout the event.

PHILONIZE (B. Price) - a post-race veterinary examination revealed no visible abnormalities. Trainer, Mr D. Koch advised that the mare was examined by his stable veterinarian on return back to his stable which revealed that PHILONIZE had excess mucus present. Mr Koch advised that the mare would now be spelled.

QUEMAN (J. Potter) - near the 50m had to be steadied and alter course to the outside of LITTLE MISS KUBI, which shifted out.

TYCOON HUMMA (Z. Spain) - Stewards permitted Z. Spain to ride the mare 0.5 kg over its declared weight of 54.0 kg.

ALL ABOUT EVE (W. Price) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

LITTLE MISS KUBI (J. Toeroek) - laid out under pressure over the concluding 100m. Near the 50m shifted out into the running line of QUEMAN. Rider was reprimanded under AR131(a).

Correct weight was delayed to allow rider, J. Potter (QUEMAN) placed second and Trainer, Mr S. Oxlade to view the vision in the straight.

RACE 8: GRAND SYNDICATES HANDICAP - 1600 Metres

ANGASTON (L. Neindorf) - shifted out on jumping away onto WHISKEY 'N' WOMEN.

MONTEPULCIANO (S. Tomlinson) - a post-race veterinary examination revealed no visible abnormalities.

MOUNT MADEIRA (NZ) (A. Jordsjo) - raced wide without cover throughout the event.

I NEED A DRINK (K. Crowther) - hampered on jumping away when tightened onto PERPETUAL GRACE by WHISKEY 'N' WOMEN.

MISS KERMIE (C. Jones) - laid out under pressure in the straight.

WHISKEY 'N' WOMEN (T. Pannell) - inconvenienced on jumping away when tightened onto NEED A DRINK by MONTEPULCIANO.

PERPETUAL GRACE (T. Voorham) - tightened on jumping away between LI'L HANK, which shifted in and I NEED A DRINK, which was taken out.

RACE 9: CLARE LINDOP STAKES - 1600 Metres

ZENNZELLA (J. Noonan) - jumped away awkwardly. Raced keenly in the middle stages of the event. Near the 800m and again shortly after was inconvenienced when taken in onto BILLIE BRONX by AS TIME GOES BY, which made contact with the running rail.

KIKI EXPRESS (D. Tourneur) - a post-race veterinary examination revealed a slow post-race recovery.





RACE 9: CLARE LINDOP STAKES - 1600 Metres (cont'd)

MORE REWARD (T. Pannell) - jumped away awkwardly.

BRAZEN LADY (J. Eaton) - near the 800m shifted in onto ZENNZELLA, which was inconvenienced when taken in onto BILLIE BRONX forcing that runner in onto AS TIME GOES BY, which made contact with the running rail. Shortly after shifted in again onto ZENNZELLA, which was taken in onto BILLIE BRONX. Rider was severely reprimanded under AR131(a) and advised, in future, not to put undue pressure onto runners on her inside.

AS TIME GOES BY (J. Toeroek) - near the 800m made contact with the running rail when BILLIE BRONX was taken in to its running line.

PARTY PRINCESS (J. Holder) - held up from near the 500m until inside the 400m.

BILLIE BRONX (C. Murray) - near the 800m was inconvenienced when taken into AS TIME GOES BY by ZENNZELLA, which had been taken in. Shortly after was inconvenienced when its hind quarters were turned in by ZENNZELLA, which had been taken in again. A post-race veterinary examination revealed the filly to be lame in the off foreleg (3/5). Trainer, Mr P. Hardacre was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RICH RESULT (B. Price) - shifted in on jumping away onto BONNIE GANGSTER.

FIELD THE MOMENT (Z. Spain) - Trainer, Mr P. Stokes advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to lead in the event if possible. Horse led.

BONNIE GANGSTER (J. Potter) - inconvenienced shortly after the start when tightened onto RICH RESULT, which shifted in and MORE REWARD, which shifted out. Raced wide without cover throughout the event.

PRETTY RELIABLE (NZ) (E. Boyd) - raced wide without cover throughout the event.

RACE 10: GOODWOOD CARNIVAL AT MORPHETTVILLE (APRIL 29TH TO MAY 20TH)
HANDICAP - 1050 Metres

TEST THE LAW (J. Opperman) - slow to begin. Inside the 900m was momentarily inconvenienced when racing to the inside of PLUS FOURS, which had been taken in.

HALLSTATT (L. Neindorf) - inside the 900m was inconvenienced when tightened onto PLUS FOURS by WAKANJEJA, which had been taken in. Rider reported that the gelding travelled well in the early and middle stages of the event; however, he became concerned with its action in the straight and for this reason he did not ride HALLSTATT out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

PRESS DOWN (C. Murray) - near the 900m shifted in and away from MISS ROSEIANO onto PLUS FOURS.

ZABELLA (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

MISS ROSEIANO (Z. Spain) - near the 900m shifted in towards PRESS DOWN, which shifted in and away onto PLUS FOURS. Rider was advised to be mindful of his angle of approach towards other runners.

PLUS FOURS (C. Jones) - near the 900m had to take hold when taken in onto the heels of ZABELLA by PRESS DOWN, which shifted in and away from MISS ROSEIANO. Inside the 900m was hampered and shifted in abruptly when contacted by HALLSTATT, which had been taken in.

NOBLE MAGNATE (S. Tomlinson) - jumped away awkwardly. Inside the 900m shifted in onto WAKANJEJA, which was inconvenienced when tightened onto HALLSTATT, which was taken in onto PLUS FOURS. Rider was severely reprimanded under AR131(a). Laid in under pressure in the straight.

WAKANJEJA (W. Price) - inside the 900m was inconvenienced when tightened onto HALLSTATT by NOBLE MAGNATE.
