RACE 1: CUP LAUNCH LUNCHEON - 1ST SEPTEMBER MAIDEN PLATE - 900 Metres

REPTILIAN (D. Caboche) - over the concluding stages was hampered when tightened for room by ENDLESS FAITH, which was tightened and taken by SURPRISE COMING, which shifted in when insufficiently clear.

ANDAMOOKA (R. Milnes) - near the 100m was hampered and taken off its course by HAVOC, which shifted out before being corrected by its rider.

ENDLESS FAITH (J. Potter) - over the concluding stages was taken in, and then approaching the winning post had to be checked when tightened for room by SURPRISE COMING, which shifted in when insufficiently clear.

SURPRISE COMING (K. Crowther) - laid in, in the straight. Over the concluding stages shifted in tightening the running of ENDLESS FAITH, which in turn was taken in and tightened REPTILIAN, resulting in ENDLESS FAITH having to be checked and REPTILIAN being hampered. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Sunday, 16 July 2023 and to conclude midnight Sunday, 23 July 2023, a period of three meetings.

MISS HOT 'N' SPICY (H. Yuen) - rider reported that the filly raced greenly throughout the event.

HAVOC (S. Payne) - near the 150m laid out, shifted out and hampered ANDAMOOKA, before being corrected by its rider. Rider was reprimanded and advised he would be required to stop riding and straighten his mounts sooner than he had on this occasion in future.

Correct weight for this event was delayed to allow R. Milnes (ANDAMOOKA), placed fourth, to view the official vision in the straight.

RACE 2: FRED VELLA TYRE & CRASH REPAIRS MAIDEN PLATE - 2000 Metres

RITZ (E. Finnegan) - slow to begin.

POMODORO (J. Potter) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SON OF VADAMOS (NZ) (R. Pearson) - dislodged its rider en route to the barrier. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. R. Pearson was examined by the First Care Medical personnel and passed fit to fulfil her engagements.

WHYS (D. Tourneur) - laid in under pressure in the straight.

PRICKLEY PRINCE (NZ) (M. Julius) - raced keenly in the early stages of the event. Raced greenly and laid in under pressure in the straight.

RACE 3: MANNUM HOTEL COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1200 Metres

AIKHAL (NZ) (A. Jordsjo) - rider reported that the gelding laid in, in the straight.

PROPHESIER (C. Tootell) - fractious in the barriers after being loaded. Trainer, Mr S. Cahill, was advised that a warning had been placed on the gelding. Near the 600m had to be checked when tightened for room by AMBITIOUS LOVER, which was taken in by I'M APRANCER, which shifted in when racing greenly despite the efforts of its rider.

AMBITIOUS LOVER (T. Voorham) - near the 600m was tightened by I'M APRANCER, which shifted in when racing greenly despite the efforts of its rider.

CLARENCE (K. Crowther) - fractious in the barriers. Underwent a pre-race veterinary examination and was deemed suitable to start. Trainer, Mr D. Jolly, was advised that a warning had been placed on the gelding.

GUSTY WAY (H. Yuen) - began awkwardly.



RACE 3: MANNUM HOTEL COLTS, GELDINGS & ENTIRES MAIDEN PLATE - 1200 Metres
(cont'd)

I'M APRANCER (D. Tourneur) - rider reported that the gelding race greenly throughout the event.

RUBINI (L. Neindorf) - rider reported that the gelding laid out near the 600m despite his efforts.

THE ICE CUTTER (J. Potter) - hung in under pressure in the straight.

RACE 4: CARLTON DRAUGHT RATING 0-58 HANDICAP - 900 Metres

SHADOW CHASER (C. Jordan) - near the 700m shifted in and away from TICKETY BOOM, and in doing so tightened HOOKED ON WEALTH. Rider was advised she would be required to make a greater effort to straighten her mounts in similar circumstance.

FOURTH POWER (T. Pannell) - near the 700m had to be steadied when tightened for room between GIALLO and HOOKED ON WEALTH, which shifted in and away from SHADOW CHASER. A post-race veterinary examination revealed no visible abnormalities.

TICKETY BOOM (B. Wong) - laid out under pressure in the straight.

HOOKED ON WEALTH (K. Crowther) - near the 700m, when racing keenly, shifted in and away from SHADOW CHASER and after doing so raced tight to the outside of FOURTH POWER, and then had to be steadied to avoid the heels of SHADOW CHASER, which shifted in and away from LOCHEND UMOSA.

CANYONERO (D. Caboche) - slow to begin.

MADAM FURPHY (A. Livesey) - raced keenly in the early stages of the event. Rider reported that the mare laid out in the straight.

SEE YOU LATER NOW (E. Finnegan) - slow to begin.

ROCK HARD (F. Atkinson) - rider reported that her mount laid out under pressure in the straight.

RACE 5: MURRAY BRIDGE HOTEL CLASS TWO HANDICAP - 1200 Metres

ABAN (NZ) (J. Holder) - rider explained that the gelding, which was first up for the stable today, was in his opinion disappointing and didn't respond as he had expected when placed under pressure. He added that the gelding may derive benefit from today's run. A post-race veterinary examination revealed no visible abnormalities.

MORE SUGAR (R. Hurdle) - slow to begin.

THE CASSINI (T. Voorham) - slow to begin.

BRAZEN EAGLE (J. Maund) - shifted out under pressure in the straight.

SWISS TIME (H. Yuen) - passing the 200m had to be eased to avoid the heels of BIG OPTION, which was weakening.

RACE 6: TERMINUS HOTEL BALAKLAVA CLASS TWO HANDICAP - 1200 Metres

BUBBLE OVER (T. Pannell) - slow to begin.

JONQUEST (R. Milnes) - near the 200m shifted in when insufficiently clear of WANALOAN resulting in that filly having to be steadied. Rider was severely reprimanded and advised she would be required to exercise far greater care when shifting ground in future.

TEQUILA SUNSET (C. Jones) - began awkwardly.





RACE 6: TERMINUS HOTEL BALAKLAVA CLASS TWO HANDICAP - 1200 Metres (cont'd)

PELOSI (NZ) (L. Neindorf) - rider explained that the mare over-raced in the early stages and this was detrimental to its chances today. A post-race veterinary examination revealed no visible abnormalities.

WANALOAN (K. Crowther) - held up for clear running from near the 600m until passing the 200m. Approaching the 200m had to be steadied to avoid the heels of JONQUEST, which shifted in.

STARLITE REBEL (C. Tootell) - a post-race veterinary examination revealed the mare had bled from both nostrils. Trainer, Mr K. Healy, was advised that as this was the mare's first bi-lateral bleed STARLITE REBEL would now be suspended from racing for a period of three months in accordance with AR79(4) and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

RACE 7: THE GREAT EASTERN HOTEL BENCHMARK 58 HANDICAP - 2000 Metres

The start of this event was delayed approximately three minutes.

DIFFLIN COUNTY (R. Pearson) - eased down in the straight by its rider. Rider explained that she felt there may be something amiss with the gelding. A post-race veterinary examination revealed the gelding to have cardiac arrhythmia. Co-trainers, Mr. J. Hickmott and Miss C. Riggs, were advised that the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Clearance would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

HOSTESS SUSIE (S. Payne) - slow to begin. Held up for clear running from the 500m until near the 400m. Laid in under pressure in the straight.

MR COYNE (A. Livesey) - raced keenly in the early stages of the event.

THE MINIVAN (R. Hurdle) - rider reported that the gelding laid out under pressure in the straight and that he felt there may have been something amiss with the gelding over the concluding stages, and for this reason he did not ride it out in his usual manner. A post-race veterinary examination revealed no visible abnormalities.

LEADER'S PRIDE (E. Finnegan) - rider reported that the gelding hung out for a short distance near the 600m.

STOCKED AND LOADED (NZ) (H. Yuen) - began awkwardly and lost ground. Commenced to lay out from the 600m and laid out for the remainder of the event.

SIRMAZE (B. Wong) - required to be resaddled on arrival at the barriers. Lost its off fore plate and required farrier attention. Underwent a pre-race veterinary examination and was deemed suitable to start. Over-raced in the early and middle stages of the event. Rider could explained that the gelding was disappointing and did not respond to her riding when placed under pressure but could offer no further explanation for the geldings poor performance. A post-race veterinary examination revealed no visible abnormalities.

MYSTIC KNOT (R. Milnes) - rider reported that the gelding laid out under pressure in the straight.

RACE 8: NORTHPOINT MURRAYLANDS RATING 0-58 HANDICAP - 1400 Metres

CHARTIN (NZ) (L. Neindorf) - over-raced in the early stages of the event.

MAVETTE (J. Holder) - held up from near the 500m until near the 400m.

DANCING STREAM (H. Yuen) - raced keenly in the early and middle stages of the event.

DON'T DISMISS (C. Jordan) - hampered near the 300m when brushed by CHARTIN (NZ), which shifted out.



RACE 8: NORTHPOINT MURRAYLANDS RATING 0-58 HANDICAP - 1400 Metres (cont'd)

ICE GHOST (F. Atkinson) - near the 200m had to be eased to avoid the heels of CHARTIN (NZ), which had commenced to give ground. A post-race veterinary examination revealed no visible abnormalities.

FIAMETTE (R. Hurdle) - Stewards permitted R. Hurdle 0.5kg over its allocated weight as there was no other senior rider available. R. Hurdle was severely reprimanded under AR190(3). Slow to begin. Rider explained that he was satisfied with the mare's performance today. He added that rounding the home turn he was taken wider by SIPSMITH, which was detrimental to its chances today. A post-race veterinary examination revealed no visible abnormalities.

ALPINE FUN (E. Finnegan) - rider explained that the mare gave ground quickly over the concluding stages of the event, was disappointing and did not respond to her riding as she had anticipated.

SPEARS (D. Caboche) - near the 300m was hampered and raced in restricted room between DON'T DISMISS and JUSTAKIDD for a short distance.

VICTORY TIME (K. Crowther) - slow to begin.

GADIDAE (T. Voorham) - raced keenly in the early stages of the event. Rider reported that the mare hung out for the majority of the straight and as a result proved difficult for her to ride out in her normal manner.

ZERO INN (A. Jordsjo) - raced very keenly in the early stages of the event. Laid out under pressure in the straight.
