Report on Race Meeting held at Morphettville Parks
Racecourse by the South Australian Jockey Club on
Saturday, 28 October 2023

RACE 1: MELBOURNE CUP DAY AT MORPHETTVILLE MAIDEN PLATE- 1250 Metres

KARAKA KIWI (NZ) (W. Price) - inside the 300m was disappointed when attempting a run between DODD and GIVE SOME LIP and was obliged to alter course to obtain clear ground.

DODD (K. Crowther) - near the 1000m was inconvenienced when taken wider by GIVE SOME LIP.

GIVE SOME LIP (B. Price) - made the turn near the 1000m awkwardly and shifted wider on the track. Laid in under pressure in the straight. Rider reported that the gelding raced greenly throughout the event.

SUNDOGG (A. Livesey) - raced fiercely in the early and middle stages of the event. Near the 1000m made the turn awkwardly, shifted out and contacted INTACTO. A post-race veterinary examination revealed no visible abnormalities.

INTACTO (T. Voorham) - near the 1000m was inconvenienced when contacted and taken wider by SUNDOGG.

RACE 2: AIG SECURITY HANDICAP - 1400 Metres

MY MALOO (J. Toeroek) - held up from near the 400m until inside the 200m.

KATIM'S CLUB (T. Pannell) - near 900m shifted into the running line of BASE OF FIRE, which had to be eased. Rider was severely reprimanded under AR131(a) and advised in future to ensure his mounts are clear when shifting ground.



RACE 2: AIG SECURITY HANDICAP - 1400 Metres (cont'd)

BASE OF FIRE (W. Price) - near the 900m had to be eased to avoid the heels of KATIM'S CLUB, which shifted in. In being eased shifted out onto THE LADIES MAN. A post-race veterinary examination revealed no visible abnormalities.

THE LADIES MAN (S. Metcalfe) - near the 900m was inconvenienced when taken wider by BASE OF FIRE. Inclined to shift about under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ENTERPRISE JEWEL (J. Potter) - jumped away awkwardly. Near the 600m shifted out to improve and in doing so tightened CHARM SLINGA (NZ) onto FREE VINO. Rider was reminded of his obligations when shifting ground.

CHARM SLINGA (NZ) (A. Livesey) - slow to begin. Raced keenly in the early and middle stages of the event. Near the 600m had to be steadied for a number of strides when forced to race in restricted room between FREE VINO, which shifted in slightly and ENTERPRISE JEWEL, which commenced to shift out to improve into the event. Laid in under pressure in the straight.

RED SEQUOIA (T. Voorham) - had difficulty obtaining clear ground from the entrance to the straight until inside the 200m when it was able to ease out across the heels of other runners.

RACE 3: TWILIGHT RACES AT MORPHETTVILLE DECEMBER 15TH HANDICAP - 1550 Metres

HOPON HARRY (S. Tomlinson) - fractious en route to course. Underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

PRINCE JOFRA (A. Livesey) - laid in under pressure in the straight.

NEODIUM (E. Finnegan) - shifted in on jumping away onto PLATINUM WOLF.

ALPINE FLYER (B. Price) - laid in under pressure in the straight. Rider reported that the mare raced flat. A post-race veterinary examination revealed no visible abnormalities.

AITCH D'AMICO (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

PLATINUM WOLF (K. Crowther) - contacted by NEODIUM shortly after the start and was taken in onto the heels of HOPON HARRY resulting in the gelding losing ground.

RACE 4: THE FOTOBASE GROUP HANDICAP - 1950 Metres

BERRY FOXIE (W. Price) - laid out rounding the home turn.

MANZALA (B. Price) - rider pleaded guilty to a charge under AR132(6)(b) for using his whip in an action that raised his arm above shoulder height and was fined \$300.

CROWN HARMONIUM (S. Clarke) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

THAT'S UNFORTUNATE (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

PROJECT GUTENBERG (NZ) (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

NIGHT CRUISER (A. Livesey) - hung out throughout the event.

HI BABY FACE (A. Lindsay) - approaching the 400m improved onto the heels of PROJECT GUTENBERG (NZ), which commenced to give ground, and had to be steadied.





RACE 5: SKYCITY HANDICAP - 1250 Metres

RUN AND TELL (B. Price) - laid out under pressure in the straight.

ANJOPIN (M. Collett) - jumped away awkwardly. At the entrance to the straight was disappointed for a run between ORNAMENTAL LADY and RUN AND TELL and was obliged to alter course back to the inside to obtain clear ground. Laid out over the concluding 100m.

ORNAMENTAL LADY (C. Murray) - raced keenly in the early and middle stages of the event.

RACE 6: THOMAS FARMS HANDICAP - 1400 Metres

APACHE STAR (K. Crowther) - raced keenly in the early and middle stages of the event.

HEADPHONES (J. Holder) - jumped away awkwardly. Held up at the entrance to the straight until approaching the 200m and then shifted to the inside of TAPINFORPAR to obtain clear ground.

KYOKUSHIN (W. Price) - shifted in on jumping away and contacted TAPINFORPAR. A post-race veterinary examination revealed no visible abnormalities.

BOLD FEELING (D. Tourneur) - a post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Trainer, Mr J. Warren was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 7: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1950 Metres

SILENT COMMAND (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

DISAGREEABLE MISS (J. Opperman) - had difficulty obtaining clear ground approaching the 200m when TIGRE ROYALE (NZ) shifted in and was obliged to alter course to the outside of that runner to obtain clear ground. A post-race veterinary examination revealed no visible abnormalities.

DR DEE DEE (K. Crowther) - the blindfold was removed simultaneously as the start was effected and as a result was slightly slow to begin. Raced keenly in the early and middle stages of the event. Near the 1200m allowed the gelding to stride forward to obtain the lead.

WHEELS (NZ) (J. Holder) - a post-race veterinary examination revealed the mare to be lame in the near hind leg (2/5). Trainer, Mr A. Gluyas was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

TRUMPSTA (S. Clarke) - held up at the entrance to the straight and was obliged to alter course to the inside of DR DEE DEE to obtain clear ground.

WHITCHETY GRUB (S. Logan) - hung out rounding the home turn.

RACE 8: DRINK WISE HANDICAP - 1000 Metres

The start of this event was delayed approximately four minutes owing to SPANISH HEIRLOOM having to be re-shod.

SPANISH HEIRLOOM (A. Livesey) - lost its off hind plate in the mounting yard and had to be re-shod. Underwent a pre-race veterinary examination and was deemed suitable to race. Lost its near hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

MAGIC MAX (J. Toeroek) - inconvenienced shortly after the start when tightened between DARING MOVE, which shifted out at the same time ALPHA FLIGHT shifted in.

DARING MOVE (J. Holder) - laid out rounding the home turn and under pressure in the straight.

MOUSE ALMIGHTY (S. Metcalfe) - laid out under pressure in the straight.





RACE 8: DRINK WISE HANDICAP - 1000 Metres (cont'd)

ALPHA FLIGHT (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

RACE 9: GRAND SYNDICATES HANDICAP - 1000 Metres

The start of this event was delayed approximately two minutes owing to FLY THE LINE being reluctant to exit the mounting yard.

LAKE AGAWAM (H. Edgley) - a post-race veterinary examination revealed the gelding to have cardiac arrhythmia (1st occurrence). Trainer Mr D. Jolly was advised that he was required to comply with the Racing Australia Code of Practice in order for the gelding to be reinstated to race.

NOSTRYIA (W. Price) - a post-race veterinary examination revealed no visible abnormalities.

LEFT TURN CLYDE (J. Holder) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

FOSTER STREET (R. Hurdle) - slow into stride.

LA DEFENSE (B. Price) - late scratching by order of the Stewards at 7:45am owing to the stable failing to scratch by the required time. Co-trainers, Mr. W. Clarken and Mr N. O'shea were reprimanded under LR19.1.

ROXY BLUE (J. Potter) - raced wide without cover throughout the event.

ELSA'S PRIDE (J. Opperman) - lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

FLY THE LINE (A. Jordsjo) - reluctant to exit the mounting yard. Made the home turn awkwardly and shifted wider on the track.
