Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 4 November 2023

RACE 1: DRINK WISE HANDICAP - 1600 Metres

QUANG TRI (T. Pannell) – a post-race veterinary examination revealed the mare to be lame in the off hind leg (2/5). Trainer, Mr P. Payne, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

THIRSTY GUEST (J. Opperman) – slow to begin. Hung out rounding the home turn and under pressure in the straight. Rider reported that the gelding travelled well in the early and middle stages of the event; however, commenced to hang out rounding the home turn and under pressure in the straight, however, had finished the event off well over the concluding stages. A post-race veterinary examination revealed a slower than expected recovery.

MAGNETIC EDGE (B. Price) - had difficulty obtaining clear ground from near the 300m until near the 200m when it became held up until approaching the 100m.

MOUNT MADEIRA (NZ) (R. Milnes) - raced keenly in the early and middle stages of the event.

RACE 2: CROSER HANDICAP- 1100 Metres

DUBENENKO (S. Tomlinson) – reared on jumping away and was slow to begin. Near the 500m had to be momentarily steadied when it commenced to lay out at the same time as ANOTHERHOUSE (NZ) shifted in slightly. Laid out under pressure in the straight. Rider reported that the filly hung out in the straight and felt awkward in its action. A post-race veterinary examination revealed the filly to be lame in the near hind leg (3/5). Trainer, Mr C. Bieg, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.



DEEPFLOAT DIVA (J. Toeroek) - slow into stride. Rider reported that the gelding never travelled and in his opinion was reluctant racing to the inside of other runners. A post-race veterinary examination revealed the gelding to be lame in the near hind leg (2/5). Co-trainers, Mr R. Jolly and Miss C. Jolly, were advised that a Veterinary Clearance would be required prior to a future jumpout, trial or race start.

RACE 2: CROSER HANDICAP- 1100 Metres (cont'd)

KALASEC (C. Murray) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

ANOTHERHOUSE (NZ) (L. Neindorf) - raced wide without cover throughout the event. Near the 500m shifted in slightly onto DUBENENKO.

RACE 3: GORDON'S PINK HANDICAP - 1200 Metres

MISS REMSKI (C. Murray) - hampered on jumping away when tightened onto PIVOTAL FORCE by WILLYBEAFACTOR.

PIVOTAL FORCE (J. Toeroek) – hampered on jumping away when taken in by MISS REMSKI. Rider reported that his mount felt short in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

TOSEN WATER (J. Opperman) - near the 900m shifted into the running line of WILLYBEAFACTOR, which had to be steadied and alter course. Rider was severely reprimanded and advised in future to ensure he was sufficiently clear prior to commencing to shift ground. Laid in under pressure in the straight.

WILLYBEAFACTOR (S. Metcalfe) - jumped away awkwardly and shifted in onto MISS REMSKI. Raced keenly in the early and middle stages, and near the 900m had to be steadied for a number of strides when TOSEN WATER shifted in, and then was obliged to alter course to that gelding's outside. Inclined to lay in under pressure in the straight.

MYOCEAN WARRIOR (K. Crowther) - fractious in the horse transport en route to the course. Underwent pre-race veterinary examination on arrival on course, was found to have minor abrasions to the off hind leg, and was deemed suitable to race.

SUGGESTIVE MISS (A. Livesey) - laid out under pressure in the straight.

RACE 4: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 2028 Metres

DARLAMAX (B. Price) - reared over in the mounting yard dislodging its rider. Underwent a prerace veterinary examination and was deemed unsuitable to race. Acting on this advice Stewards declared DARLAMAX a late scratching at 1.19pm. Trainer, Mr A. Homann, was advised that a warning had been placed on the gelding in relation to its pre-race manners. Mr Homann was further advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

AMMO AMOR (A. Livesey) - slow to begin. Raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

CROWN MINT (L. Neindorf) - raced keenly in the middle stages of the event.

MARYMOUNT LASS (D. Tourneur) – dislodged its rider en route to the barrier and galloped for a short distance prior to being recaptured. Underwent a pre-race veterinary examination and was deemed suitable to start. Trainer, Mr T. Day, was advised that a warning had been placed on the mare in relation to its pre-race manners. Performed poorly. A post-race veterinary examination revealed the mare to be lame in the off hind leg (1/5). Mr Day was advised that a Veterinary Certificate of Fitness would be required prior to a future jump-out, trial or race start. Mr Day advised that the mare would now be retired.

RACE 5: TAB HANDICAP - 1050 Metres

SGHIRRIPA (K. Crowther) - laid in under pressure in the straight.

BRISTLER (L. Neindorf) - rider reported that the gelding was not comfortable in its action over the concluding 100m. A post-race veterinary examination revealed no visible abnormalities.

HOPE AT HAND (J. Holder) - reared on jumping away and was slow to begin.

RACE 5: TAB HANDICAP - 1050 Metres (cont'd)

SEA WITNESS (A. Livesey) - jumped away awkwardly and was slow into stride.

STARLITE VALLEY (R. Hurdle) - shifted in shortly after the start and brushed BRISTLER, and as a result dipped. Rider reported that as a result of its dipping shortly after the start he was obliged to settle further back than he had hoped.

RACE 6: GRAND SYNDICATES HANDICAP - 1800 Metres

POINTLESS PRAISE (J. Toeroek) - rider explained that the pace of the race was not suited to the gelding, and as a result POINTLESS PRAISE had not let down in its normal manner.

PRICILLA'S CHOICE (S. Payne) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Ms R. Day, advised that the mare would now be spelled.

SALUTE THE STARS (A. Jordsjo) - raced wide without cover throughout the event.

CALL ME VEXATIOUS (C. Murray) - laid out rounding the home turn.

ENTERPRISE JEWEL (J. Holder) - laid in under pressure in the straight. Lost its near fore plate during the event.

SEAFARING (NZ) (H. Grace) - laid out rounding the home turn and under pressure in the straight.

DIVINE BREW (A. Livesey) - change of tactics - attempt to settle further back - settled last. Restrained on jumping away to comply with the instructions. Lost its off hind plate during the event.

RACE 7: TRIPLE M RUSH HOUR AT MORPHETTVILLE HANDICAP - 1050 Metres

IRISH MIST (S. Tomlinson) - had difficulty obtaining clear ground from the entrance to the straight until near the 100m when racing in restricted room between the heels of JUNGLE SENSATION and RICH MEMORIES.

JUNGLE SENSATION (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

ALL BEANS (M. Collett) - raced wide without cover throughout the event.

LANCELOTTO (B. Wong) - jumped away awkwardly and shifted in onto L'IL PIPER. Raced wide without cover throughout the event. Laid in under pressure in the straight.

RICH MEMORIES (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

ROCK HARD (A. Livesey) - jumped away awkwardly.

CHOSEN MISS (K. Crowther) – rider explained that the mare was under pressure in the early stages to maintain its position, and in her opinion would derive benefit from the run and would be better suited in a race over a longer distance. A post-race veterinary examination revealed no visible abnormalities.

L'IL PIPER (D. Caboche) - inconvenienced on jumping away when tightened onto CHOSEN MISS by LANCELOTTO.

CORK HARBOUR (T. Voorham) - laid out rounding the home turn and under pressure in the straight.

Following the running of this event B. Price was examined by the First Care Medical personnel and passed fit to fulfil his remaining engagements.

RACE 8: DAVE LOY HANDICAP - 1522 Metres

JENKINS (H. Edgley) - inconvenienced when contacted on jumping away.

FLEURIEU FLIPPER (S. Payne) - jumped away awkwardly and shifted in onto JENKINS. Inclined to shift about under pressure in the straight.

TEST THE LAW (R. Hurdle) - contacted on jumping away and taken out onto IMPOSING SUSPECT (NZ). Rider accidentally dropped his whip near the 200m. Rider reported that it was not his intention to lead the event; however, after jumping away well the gelding commenced to race keenly and improved to the front of its own accord.

WHISKEY HANGOVER (K. Crowther) - raced keenly in the early and middle stages of the event. Hung out over the concluding 600m. A post-race veterinary examination revealed no visible abnormalities.

SUGAR AND SWEET (B. Price) - rider reported that the gelding was under pressure from near the 600m and had not stretched out when asked for an effort. A post-race veterinary examination revealed no visible abnormalities.

FREE VINO (J. Holder) – jumped away awkwardly and shifted out onto TEST THE LAW. Rider reported that in his opinion the gelding had not backed up from its run last Saturday. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Co-trainers, Mr G. Richards and Mr D. Moyle, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

IMPOSING SUSPECT (NZ) (C. Murray) - contacted on jumping away by TEST THE LAW, which had been taken out. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

EM BRYAN (H. Grace) - a post-race veterinary examination revealed no visible abnormalities.

RACE 9: JOHN LETTS CUP - 1800 Metres

NOT USUAL GLORIOUS (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

CAPTAIN ENVIOUS (NZ) (C. Murray) - inside the 1300m was forced to race in restricted room for a number of strides when PARTY PRINCESS shifted in slightly. Near the 1200m lost its position when the rider was forced to check to avoid the heels of PARTY PRINCESS, which shifted in when insufficiently clear.

ARRAN BAY (L. Neindorf) - change of tactics - attempt to lead - settled behind the leaders. Shifted about under pressure in the straight. Rider advised that despite his efforts in the early stages to obtain the lead he felt that due to the pace to his outside he would be better suited to allow runners to cross and take up a position where comfortable behind the speed.

MONTEPULCIANO (K. Crowther) - raced keenly in the early and middle stages of the event.

THOUGHT PROVOKING (NZ) (J. Opperman) – a post-race veterinary examination revealed the mare to be lame in the off hind leg (2/5). Co-trainers, Mr M. Price and Mr M. Kent (Jnr) were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

PARTY PRINCESS (J. Holder) - which was racing wide without cover, shifted in slightly near the 1300m onto CAPTAIN ENVIOUS (NZ), which was forced to race in restricted room for a short distance. Near the 1200m shifted in to obtain a position with cover when insufficiently clear of CAPTAIN ENVIOUS (NZ), forcing that rider to check his mount to avoid the heels of PARTY PRINCESS. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 11 November 2023 to conclude midnight Sunday, 19 November 2023, a period of four meetings.



RACE 9: JOHN LETTS CUP - 1800 Metres (cont'd)

SILENT SURRENTE (B. Price) - had swelling to its near foreleg on arrival on course. Was examined by the Industry Veterinary Surgeon, and in consultation with the stable a decision was made to declare the mare a late scratching at 3.57pm. Co-trainers, Mr W. Clarken and Mr N. O'Shea, were advised that a Veterinary Clearance, including the results of an ultrasound, would be required prior to accepting for a future event.

Correct weight for this event was delayed to allow C. Murray (CAPTAIN ENVIOUS (NZ)), placed third, to view the Official Vision from approaching the 1200m. After doing so C. Murray lodged an objection against NOT USUAL GLORIOUS (J. Holder) being declared the second placegetter on the grounds of alleged interference near the 1200m. After considering the evidence, viewing the vision and acting on their own observations Stewards *upheld* the protest and amended the result to:

First No. 5 PUDDING (NZ)

Second No. 3 CAPTAIN ENVIOUS (NZ)

Third No. 10 PARTY PRINCESS

Fourth No. 4 ARRAN BAY

RACE 10: PETER ELBERG FUNERALS HANDICAP (HEAT OF TAB GYTRASH SERIES) - 1200 Metres

MY KHALIFA (L. Neindorf) - laid in under pressure in the straight.

RIVER TWAIN (B. Price) - rider reported that he had become concerned with the gelding's action over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities. Lost its near fore and near hind plates during the event.

KENTUCKY CASANOVA (J. Toeroek) - inclined to lay out under pressure in the straight.

OH MO (T. Voorham) - slow to begin.

RICH GINA (D. Tourneur) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

WONDERWOMEN (J. Opperman) - a post-race veterinary examination revealed no visible abnormalities.

CLASSY KENNY (D. Caboche) - raced keenly in the early and middle stages of the event.

OUTPOST (B. Wong) - raced wide without cover throughout the event.
