RACE 1: DIGIORGIO WINES MAIDEN PLATE - 1000 Metres

ALCOSHARE (L. Williams) - jumped away awkwardly, shifted out and bumped NANKEEN. From the 700m laid out and became awkwardly placed on the hind quarters of NANKEEN for a short distance. Rider explained that in the vicinity of the 700m the colt resented racing inside of other runners, hung out and placed him onto the hind quarters of NANKEEN.

NANKEEN (D. Tourneur) - bumped on jumping away by ALCOSHARE, which shifted out.

AMELIA VALENTINA (H. Yuen) - held up from the entrance to the straight until the 100m when she was able to switch to the outside of runners to obtain clear running to the finish.

EL PASO CITIE (C. Puls) - jumped away awkwardly.

RACE 2: TRANS AUSTRALIA LIVESTOCK MAIDEN PLATE - 1430 Metres

CHIQ MAGNET (J. Opperman) - laid out under pressure approaching the finish.

COLD TRAIN (D. Caboche) - approaching the 400m shifted out and inconvenienced SHE'LL BE RIGHT. Rider was reprimanded under AR131(a) and advised, in future, to only shifted ground when entitled to do so.

MR FERRARI (M. Collett) - raced wide without cover throughout the event.



RACE 2: TRANS AUSTRALIA LIVESTOCK MAIDEN PLATE - 1430 Metres (cont'd)

GILDED AGE (D. Tourneur) - rider explained that the gelding travelled well throughout; however, when placed under pressure at the entrance to the straight did not quicken as anticipated and raced greenly in the straight. A post-race veterinary examination revealed no visible abnormalities.

RHINESTONE RORY (J. Potter) - raced keenly in the early and middle stages of the event.

SHE'LL BE RIGHT (S. Fawke) - Change of tactics - attempt to take up a forward position in the event if possible. Settled on pace, three wide without cover. Near the 400m was inconvenienced when COLD TRAIN shifted out.

COMANCHE QUEEN (L. Grace) - underwent a pre-race veterinary examination on arrival on course as it raced at Murray Bridge on Wednesday, 7 February 2024 and was deemed suitable to race. Unable to be fully tested over the concluding stages when the mare was disappointed when attempting a run between MISSY WINKLE (NZ) and HASTA LA WIZARD, which rolled in.

HASTA LA WIZARD (C. Puls) - raced keenly in the early and middle stages of the event. Laid in, in the straight.

Correct weight was delayed to allow H. Grace (THE PARTING GLASS (NZ)), placed second to view the vision of the straight.

RACE 3: MIDFIELD GROUP CLASS ONE PLATE - 2000 Metres

FULL OF DASH (NZ) (C. Puls) - in the vicinity of the 300m was taken out onto ARCTIC PRINCESS by INTERFERING, which shifted out abruptly.

REALITY CHECK (S. Metcalfe) - as the start was effected the inside gate did not fully open. After reviewing the footage, Stewards determined that REALITY CHECK was not disadvantaged on jumping away as a result of the gate not fully opening.

SHAKIB (NZ) (N. Farley) - as the start was effected the outside gate did not fully open. After reviewing the footage, Stewards determined that SHAKIB (NZ) was not disadvantaged on jumping away as a result of the gate not fully opening.

ARCTIC PRINCESS (J. Weatherley) - in the vicinity of the 300m was hampered when taken wider by FULL OF DASH (NZ).

INTERFERING (J. Maund) - near the 300m shifted out abruptly and took FULL OF DASH (NZ) wider on the track.

KHARCHIN (NZ) (L. Williams) - as the start was effected the inside gate did not fully open. After reviewing the footage, Stewards determined that KHARCHIN (NZ) was not disadvantaged on jumping away as a result of the gate not fully opening. Rider explained after getting its head up on jumping away he had to encourage the gelding along to maintain contact with the field throughout the event. A post-race veterinary examination revealed no visible abnormalities.

PENSLEY (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4: TASCO PETROLEUM FILLIES & MARES RATING 0 - 58 HANDICAP - 1100 Metres

JUSTA JILLAROO (J. Weatherley) - approaching the finish rider was unable to ride her mount out to the line when EMERALD COURT shifted out.

AMANI FARASI (Z. Lloyd) - jumped away awkwardly, shifted out and bumped WENTHEDEELINGSDUN. Laid in, in the straight. Near the 100m was steadied away from the heels of ZEYDANA.

EMERALD COURT (S. Logan) - laid out in the straight. Approaching the finish shifted out and inconvenienced JUSTA JILLAROO. Rider was reprimanded under AR131(a) and advised, in future, to stop and straighten her mounts when they commence to shift ground.



RACE 4: TASCO PETROLEUM FILLIES & MARES RATING 0 - 58 HANDICAP - 1100 Metres (cont'd)

ZEYDANA (E. Finnegan) - slow to begin (approximately two lengths). Rider explained that her instructions were to settle forward of midfield in today's event; however, after beginning slow she was able to travel the mare up onto the back of the field in the early stages and improved inside of other runners throughout the event. She added that from the 400m she elected to work her way off the fence and around runners forward of her. She further added that given the formation of field from the 400m, she took until the entrance to the straight to obtain clear ground where she was reluctant to attempt a tight run between ORPHELINE and IN THE SUN given the racing manners of both runners, so she elected to come to the outside of ORPHELINE to improve over the final 150m. A post-race veterinary examination revealed no visible abnormalities.

WHENTHEDEELINGS DUN (A. Lindsay) - bumped on jumping away by AMANI FARASI.

RACE 5: SOUTHEAST MOTOR COMPANY COLTS, GELDINGS & ENTIRES RATING 0 - 58 HANDICAP - 1100 Metres

LOAD AND GO (J. Eaton) - jumped away awkwardly. Shortly after the start raced in restricted room between EAGLES FOREVER and LIBERTY POWER for a number of strides.

CANIDAE (N. Seymour) - jumped away awkwardly and as a result was slow to begin. Rider explained that the gelding never travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

BLUE PAWSOM (D. Caboche) - underwent a pre-race veterinary examination on arrival on course as it had not raced since March 2023 and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

ALLGO (D. Tourneur) - slow to begin.

SQUADRON LEADER (J. Potter) - slow to begin.

RACE 6: PPHS RATING 0 - 58 HANDICAP - 1430 Metres

THANASI (H. Yuen) - raced keenly in the early stages of the event. Held up from the 400m until the entrance to the straight. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

EARL OF BANTRY (J. Opperman) - raced keenly in the middle stages of the event.

FINAL CHANCE (C. Tootell) - held up from approaching the 300m until the entrance to the straight.

TALES OF CONFLICT (J. Doyle) - jumped away awkwardly. Held up from approaching the 300m until the entrance to the straight. Had difficulty obtaining clear ground approaching the 100m for a short distance.

HOT ROD BOY (D. Caboche) - underwent a pre-race veterinary examination on arrival on course as it raced at Oakbank on Friday, 9 February 2024 and was deemed suitable to race.

GRUELLING (K. Crowther) - raced wide without cover throughout the event. Rider explained that the gelding travelled well in the early and middle stages of the event; however, when placed under pressure inside the 600m did not respond to her efforts. A post-race veterinary examination revealed no visible abnormalities.

MYLITLSTAR THAT CAN (B. Wong) - rider explained that the gelding travelled well until placed under pressure approaching the 400m and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr J. Barry advised Stewards that it would be his recommendation to the owners that the gelding be spelled.



RACE 7: MINIJUMBUK NARACOORTE CUP - 2000 Metres

CLEVER MAN (J. Weatherley) - passing the winning post on the first occasion had to be steadied away from the heels of MUG'S GAME. Inside the 600m became held up on the heels of TAMETOMO (NZ), which commenced to give ground. In the vicinity of the 200m rider accidentally dropped her whip. Laid out in the straight. Approaching the finish had to be steadied when it rolled out onto the heels BRUNGLE RAIDER. Rider explained that her instructions were to settle where comfortable and she found herself behind the pace in the early stages; however, approaching the turn out of the straight had to be eased to avoid the heels of MUG'S GAME. She added that approaching the 600m she elected to ride for luck and follow TAMETOMO (NZ) until the entrance to the straight; however, when that gelding commenced to give ground inside the 600m she was unable to shift away from its heels and lost considerable ground. She further added that she was able to gain clear ground at the entrance to the straight where she had dropped her whip and CLEVER MAN commenced to lay out under pressure.

FRANKEL STAR (K. Crowther) - raced wide without cover throughout the event.

MUG'S GAME (S. Logan) - passing the winning post on the first occasion was hampered by TAMETOMO (NZ).

SCENIC HOST (D. Tourneur) - fractious in its barrier stall and had to be backed out. Underwent a pre-race veterinary examination and was deemed suitable to race.

TAMETOMO (NZ) (S. Fawke) - passing the winning post on the first occasion jumped the shadow of the winning post, became unbalanced, shifted in and hampered MUG'S GAME. Inside the 600m commenced to give ground. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: COOPERS BREWERY BENCHMARK 66 HANDICAP - 1200 Metres

RIVER TWAIN (J. Weatherley) - jumped away awkwardly.

ROHLON DRUNK (B. Wong) - lost its near fore plate during the event.

RAVNIKAR (J. Maund) - rider explained that the gelding travelled well throughout the event; however, in his opinion, would appreciate a race over a longer distance.

LASTAR (A. Lindsay) - jumped away awkwardly.

PEWTER (C. Puls) - slow to begin.

ENTERPRISE JEWEL (H. Grace) - underwent a pre-race veterinary examination on arrival on course as it raced at Murray Bridge on Wednesday, 7 February 2024 and was deemed suitable to race. Slow to begin.
