RACE 1: PFD FOOD SERVICES MAIDEN PLATE - 1000 Metres

STACK OUR REWARD (A. Livesey) - shortly after passing the 200m raced in restricted room between BULLEYES and EMMOOKI MAGIC.

THE PHARMACIST (K. Crowther) - raced keen in the early and middle stages of the event.

EMMOOKI MAGIC (S. Fawke) - raced keen in the early and middle stages of the event and got its head up when being restrained.

ENDLESS FAITH (S. Payne) - rider reported the mare laid out when placed under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$300. In determining penalty Stewards had regard for the totality of the use of the whip by S. Payne and noted that he used it on thirteen occasions over the final 100m of the event.

INNOCENT SIPS (R. Milnes) - slipped behind at the start and lost ground. A post-race veterinary examination revealed no visible abnormalities.



RACE 2: FLEURIEU MILK COMPANY HANDICAP - 2250 Metres

DUAL FUEL (NZ) (M. Collett) - slow to begin. Laid in under pressure in the straight.

OATH OF OMERTA (J. Eaton) - raced keen in the early stages of the event.

MAKBEEL (NZ) (B. Price) - rider reported he was uncomfortable with the gelding's action in the straight and therefore did not ride MAKBEEL (NZ) out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

MASTER OF ZERPRISE (S. Metcalfe) - held up from the 350m until near the 250m and shifted out across the heels of KENTUCKY NICK to improve. Rider pleaded guilty to a charge under AR132(6)(b) for using her whip in an action that raised her arm above shoulder height and was reprimanded.

MR COYNE (A. Livesey) - when questioned in relation to the tactics adopted in today's event, rider explained that the blinkers had come off the gelding's gear and she was instructed to ride the MR COYNE in a midfield position, which she was able to obtain. She added the gelding travelled well for the majority of the event and was fair getting to the line.

RACE 3: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1550 Metres

NEODIUM (E. Finnegan) - rider reported that from the wider barrier she was obliged to work hard on the gelding to obtain the lead and thereafter raced keen whilst in the lead. She added that as a result NEODIUM raced at a faster tempo than she would have liked. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (3/5). Trainer, Mr P. Stokes was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

DR DEE DEE (K. Crowther) - began awkwardly and lost ground.

BOLT BY (S. Payne) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$1,500. In determining penalty Stewards had regard for the totality of the use of the whip by S. Payne and noted that he used it on thirteen occasions over the final 100m of the event.

MASTER AT ARMS (NZ) (J. Holder) - rider reported the gelding laid in when placed under pressure and approaching the winning post became awkward when racing close to the heels of MARACOURT.

RACE 4: AUTUMN RACING CARNIVAL AT MORPHETTVILLE (APRIL 27TH - MAY 11TH) HANDICAP - 1250 Metres

ANOTHERHOUSE (NZ) (J. Holder) - raced wide without cover for the majority of the event. Rider reported that the gelding was disappointing and, in his opinion, had not backed up from its last start on at Morphettville on Monday, 11 March 2024. A post-race veterinary examination revealed no visible abnormalities.

STOKOMO (J. Toeroek) - laid in under pressure in the straight.

VOLTAGE POINT (C. Jones) - had difficulty obtaining a clear run from the 300m until approaching the 200m.

FREE BEER (S. Fawke) - at the start was bumped by ARTFUL TAWNY. Became awkwardly placed and was steadied near the 600m when the gelding improved into a narrow run between KRISTOBEL and VOLTAGE POINT.

ARTFUL TAWNY (D. Tourneur) - began awkwardly, shifted out and bumped FREE BEER.

KRISTOBEL (M. Collett) - raced very keen in the early stages of the event. Passing the 950m got its head up when being steadied away from the heels of STOKOMO. Continued to race keen until near the 600m. A post-race veterinary examination revealed no visible abnormalities.

MADAM MILLY (J. Opperman) - laid in rounding the home turn and in the straight. Near the 300m became awkwardly placed close to the heels of ARTFUL TAWNY.



RACE 5: TRIPLE M HANDICAP - 1250 Metres

HUMBOLDT (NZ) (J. Eaton) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

DUTHY STREET (S. Payne) - rider reported the gelding raced keen in the early stages.

BYWATERS ROAD (S. Clarke) - approaching the 200m was obliged to shift out when improving onto the heels of DUTHY STREET, which had commenced to weaken.

CARARADA (J. Holder) - laid in under pressure over the concluding 100m.

BABY ALEX (T. Pannell) - shifted wider in the straight to obtain a clear run.

CALL IT A HUNCH (H. Yuen) - a post-race veterinary examination revealed no visible abnormalities.

EXALTED KATE (R. Milnes) - raced wide without cover for the majority of the event.

SEAFARING (NZ) (D. Tournour) - began awkwardly and lost ground.

MISS VIGNETTE (E. Finnegan) - rider reported over the concluding stages the mare was momentarily placed in restricted room and as a result was reluctant to maintain its position.

TOBIWASHI (A. Livesey) - laid out under pressure over the concluding 100m.

RACE 6: PIPER HEIDSIECK HANDICAP - 1000 Metres

LUNAR HERO (S. Clarke) - a post-race veterinary examination revealed no visible abnormalities.

ALL BEANS (S. Fawke) - began awkwardly, shifted in and contacted OUTPOST. Laid out rounding the turn near the 600m.

LONRODEX (J. Toeroek) - began awkwardly, shifted out and tightened LEFT TURN CLYDE onto OUTPOST.

MOUSE ALMIGHTY (H. Yuen) - laid out rounding the turn near the 600m.

QEYAADY (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

SHOOTOOSE (J. Opperman) - between the 300m and the 200m had difficulty obtaining a clear run between QEYAADY and MESSERSCHMITT, when both runners shifted ground slightly.


OUTPOST (A. Livesey) - tightened at the start between LEFT TURN CLYDE and ALL BEANS. Held up for clear running from the 350m until near the 200m behind MOUSE ALMIGHTY and to the outside of ALL BEANS.

WINNING REVOLUTION (B. Wong) - held up from the 300m until shortly after the 200m where the gelding was shifted out across the heels of LONRODEX to obtain a clear run.

LEFT TURN CLYDE (J. Holder) - tightened at the start between OUTPOST and LONRODEX, which shifted out. Hung out over the concluding 100m and became awkwardly placed close to the heels of QEYAADY. A post-race veterinary examination revealed no visible abnormalities.

Correct weight was delayed to allow Mr J O'Connor, trainer of WINNING REVOLUTION (placed second) to view the vision in the straight.

RACE 7: GRAND SYNDICATES HANDICAP - 1000 Metres



LITTLE BIT CHAI (A. Lindsay) - began awkwardly, shifted in and brushed the running rail. A post-race veterinary examination revealed the mare to be lame in the near foreleg (3/5). Trainer, Ms N. Irwin was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.



RACE 7: GRAND SYNDICATES HANDICAP - 1000 Metres (cont'd)

MY HARUCONI (K. Crowther) - held up and lost ground from the 400m behind LITTLE BIT CHAI, which commenced to weaken. Approaching the 200m shifted out and became awkwardly placed close to the heels of LADYMEANSBUSINESS. The mare was then taken wider on the track and was not able to obtain a clear run until inside the final 100m.

CHOSEN BLONDE (S. Clarke) - hung out over the concluding 200m.

ISA SECRET (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

JAZZ AFFAIR (J. Toeroek) - began awkwardly and was bumped by NO ENTITLEMENT. Held up from the 350m until near the 200m, was then steadied to avoid the heels of MAY'S WEST, which was weakening and had to shift wider on the track to obtain a clear run.

SHARENDIPITY (E. Finnegan) - fractious behind the barriers. Trainer, Mr C. Reardon was advised that a warning had been placed on the filly in relation to its pre-race manners. Raced keen in the middle stages of the event and got its head up. Shifted in under pressure over the concluding 200m. Lost its off hind plate during the event.

MAY'S WEST (S. Payne) - weakened quickly from the 200m. A post-race veterinary examination revealed no visible abnormalities.

NO ENTITLEMENT (A. Livesey) - shifted out shortly after the start and bumped JAZZ AFFAIR. Held up for a short distance approaching the 200m when awkwardly placed close to the heels of MADDISON MISS.

RACE 8: PETALUMA HANDICAP - 1000 Metres

LARKHAM (A. Livesey) - shifted in near the 100m and tightened ZUFASTA onto THEBIGSOSSO. Rider was severely reprimanded under AR131(a) for careless riding and advised to take greater care when shifting ground, in future.

LIMITED RISK (K. Crowther) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg (2/5). Trainer, Mr D. Jolly was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

STORYTELLER (T. Pannell) - slow to begin. Held up and unable to improve from the 400m until near the 150m.

ZUFASTA (H. Yuen) - slow to begin. Near the 100m was steadied when tightened between LARKHAM and THEBIGSOSSO, when both runners shifted ground.

FOSTER STREET (D. Tourneur) - slow to begin. Approaching the winning post had to be steadied when held up behind THEBIGSOSSO.

KUBLAI (R. Milnes) - began awkwardly and shifted out.

PRINCE REICHWEITE (C. Jones) - slow to begin and was then hampered by THEBIGSOSSO, which shifted in. Held up from the 350m and was unable to improve until shortly after the 100m.

THEBIGSOSSO (C. Murray) - began awkwardly, shifted in and hampered PRINCE REICHWEITE. Shifted out slightly near the 100m and tightened ZUFASTA.

LITTLE RICH BOY (J. Holder) - laid out rounding the home turn and raced close to the heels of BABAYKA.

RACE 9: HAHN HANDICAP - 1400 Metres

BADONKIDONK (B. Price) - slow to begin.

CARBONE (S. Metcalfe) - shortly after the start was bumped by MUG'S GAME and became unbalanced.





RACE 9: HAHN HANDICAP - 1400 Metres (cont'd)

STAR OF MONSOON (S. Logan) - bumped at the start by RUBINI. Shortly after the start was tightened by JUST LIKE LISA on its outside and in turn bumped RUBINI.

JUST LIKE LISA (M. Collett) - shortly after the start shifted in and bumped STAR OF MONSOON. Raced very keen in the early and middle stages of the event and got its head up on a number of occasions. Rider reported the mare laid in, in the straight.

IMBIBE (C. Murray) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. Began awkwardly, shifted out and hampered MUG'S GAME.

SMILING FROM ABOVE (A. Livesey) - held up and was unable to improve behind STELLA NOTATION from the 400m until near the 250m and then laid in when placed under pressure.

CAPTAIN JOOLIAN (C. Jones) - raced wide without cover for the majority of the event.

MUG'S GAME (D. Tourneur) - tightened and lost ground at the start between CARBONE and IMBIBE, which shifted out. Raced keen in the early stages of the event.

FIELD THE MOMENT (S. Clarke) - shifted out shortly after the start and bumped RUBINI. Held up behind SMILING FROM ABOVE from the 350m until near the 200m and then shifted wider to improve.

RUBINI (T. Voorham) - began awkwardly, shifted out and bumped STAR OF MONSOON. Shortly after the start was buffeted between FIELD THE MOMENT, which shifted out and STAR OF MONSOON, which was tightened and taken in by JUST LIKE LISA. Near the 900m when racing keenly shifted out and carried CARBONE wider. Raced wide without cover for the majority of the event.

STELLA NOTATION (B. Wong) - difficult to load. Trainer, Mr R. Balfour was advised that a warning had been placed on the mare in relation to its barrier manners. Raced keen in front in the early and middle stages of the event.
