RACE 1: THE JUNCTION MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately two minutes.

GOONSUN (K. Crowther) - fractious in the barrier after being loaded. Underwent a pre-race veterinary examination and was deemed suitable to start. Slow to begin. Inside the 400m shifted out slightly onto MONTANA STATE, which clipped the heels of HURRY LOVE.

IRISH THORN (NZ) (R. Milnes) - contacted on jumping away.

KNIGHT DANCER (M. Nunes) - near the 400m was momentarily inconvenienced by PAINTED PONY.

MONTANA STATE (T. Johnstone) - inside the 400m raced in restricted room and shortly after was taken out slightly, clipping the heels of HURRY LOVE, knuckling and losing ground.

ULTRON (NZ) (C. Murray) - jumped away awkwardly, shifted out and brushed IRISH THORN (NZ). Raced keenly in the early and middle stages of the event.

ALPINE JOY (F. Atkinson) - raced greenly throughout the event and near the 700m shifted out taking LADY SKYLLA wider on the track.

HURRY LOVE (T. Bull) - raced keenly in the early and middle stages of the event. Rider reported that the mare hung out throughout the event and proved difficult to ride. Lost its near hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

LADY SKYLLA (J. Potter) - near the 700m was taken wider by ALPINE JOY.

PAINTED PONY (T. Voorham) - near the 400m shifted out to improve and in doing so contacted KNIGHT DANCER.

SPURIER (A. Livesey) - raced keenly in the early and middle stages of the event.



RACE 1: THE JUNCTION MAIDEN PLATE - 1200 Metres (cont'd)

TOOWANDA (D. Tourneur) - hung in throughout the event.

Correct weight for this event was delayed to allow T. Voorham (PAINTED PONY), placed third, and that mare's trainer, Mr T. Doudle, to view the vision in the straight.

RACE 2: SPORTSBET HANDICAP - 1200 Metres

COLMAR (T. Bull) - inside the 300m shifted into the running line of DREAMS FULFILLED, which had improved to its inside, resulting in that gelding having to be checked. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Friday, 25 October 2024 to conclude midnight Wednesday, 30 October 2024, a period of three meetings. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (1/5). Co-trainers, Mr R. Daniel and Ms T. Stanbury, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

DREAMS FULFILLED (A. Lai) - dislodged its rider leaving the mounting yard and cantered riderless prior to being recaptured. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to start. A. Lai was examined by the First Care Medical personnel and passed fit to ride. Near the 300m shifted in to attempt a run to the inside of COLMAR and shortly after was hampered and had to be checked when that gelding shifted in. Hung in severely for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

SNORE ROOM (T. Pannell) - raced keenly in the early and middle stages of the event.

ENUFF SEDUCTION (J. Potter) - dipped shortly after the start. At the entrance to the straight shifted out to improve and in doing so brushed OUT OF THE SQUARE.

ROYAL MAJESTY (J. Holder) - lost its near hind plate during the event.

OUT OF SQUARE (M. Nunes) - at the entrance to the straight was inconvenienced when contacted and taken wider by ENUFF SEDUCTION.

RACE 3: SPORTSBET HILL SMITH STAKES - 1800 Metres

GOLDRUSH GURU (J. Holder) - reared on jumping away. Laid in under pressure in the straight.

THE DAILY PLANET (L. Neindorf) - rider explained that he was obliged to work hard from a wide barrier and this was a detriment to its changes. A post-race veterinary examination revealed no visible abnormalities.

DARKNCONFIDENTIAL (J. Toeroek) - laid in under pressure in the straight and near the 200m shifted out when being corrected into the running line of CECCHETTI. Rider reprimanded.

RECIPROCAL (S. Payne) - slow into stride. Raced keenly in the early and middle stages of the event.

DISCREETLY BLUE (T. Pannell) - rider reported that the gelding may have come to the end of its preparation. He added that he settled further forward in the event as the gelding had commenced extremely well. A post-race veterinary examination revealed no visible abnormalities. Co-trainer, Mr D. Clarken, advised that the gelding would now be spelled.

CECCHETTI (E. Walsh) - near the 200m rider was forced to take hold when tightened between DARKNCONFIDENTIAL, which shifted out, and CAVITY BAY, which shifted in, and as a result was obliged to alter course to obtain clear ground.

CAVITY BAY (M. Nunes) - laid in under pressure in the straight and near the 200m shifted in into the running line of CECCHETTI. Rider reprimanded.

WILD WINNER (T. Voorham) - difficult to load. Trainer, Mr A. Gluyas, was advised that the filly would be required to load without delay in either an Official Barrier Trial or Approval to Race Jump-out prior to a future race start. Laid in under pressure in the straight.



RACE 4: SPORTSBET HANDICAP - 1600 Metres

BIT OF A REBEL (K. Crowther) - laid in at the entrance to the straight and near the 300m shifted in and brushed CULLEN SKINK.

CULLEN SKINK (R. Milnes) - near the 300m was inconvenienced when contacted by BIT OF A REBEL. Laid in under pressure over the concluding 200m of the event.

MERCHANT BOSS (T. Voorham) - slow to begin.

HANGYOURHAT (NZ) (L. Neindorf) - held up from the 400m until inside the 300m. Rider explained that the gelding was a touch slow to begin resulting in him settling further back than he had hoped. He added that he was unable to obtain clear ground at the entrance to the straight; however, after commencing to improve into the race inside the 300m he had again had difficulty obtaining clear ground over the final 100m of the event. After considering his explanation Stewards advised L. Neindorf to ride in a manner that did not invite question in future as in their opinion there was sufficient room to continue to test his mount over the concluding 100m between BIT OF A REBEL and BLUE SPECIAL. A post-race veterinary examination revealed no visible abnormalities.

SUBMERGE (S. Fawke) - underwent a pre-race veterinary examination as it had not raced in over twelve months and was deemed suitable to start. Stood flat-footed and was left at the post. Trainer, Mr G. Lynch, was advised that the gelding would now be required to jump away to the satisfaction of Stewards in two consecutive Official Barrier Trials or Approval to Race Jump-outs prior to a future race start.

FRANCE'S BOY (Z. Lloyd) - When questioned in relation to the gelding's improve performance co-trainer, Mr J. Hickmott, explained that they have been doing additional work with the gelding on the uphill track at Murray Bridge; however, he felt that the easy lead it had in today's event was the main reason for its improved performance. He added that most of the gelding's wins had occurred when it had an easy run in front.

DRAGONFACE (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

NEW YORK SCANDAL (T. Bull) - rider reported that the mare did not feel comfortable in its action when rounding the turns and was inclined to lay in under pressure in the straight. She added that in her opinion the mare may have come to the end of its preparation.

RACE 5: CANADIAN CLUB HANDICAP - 1050 Metres

The start of this event was delayed approximately twelve minutes.

RUSSIAN BOBSHARK (B. Price) - near the 600m was forced to race in restricted room for a number of strides between BEAUTY BOUND and HYPERNOVA. Rider reported that the gelding travelled well in the early and middle stages of the event; however, it did not let down as he had anticipated. A post-race veterinary examination revealed no visible abnormalities.

FASHION DOG (J. Toeroek) - slow to begin. Made the turn near the 600m awkwardly. Had difficulty obtaining clear ground from the entrance to the straight until inside the 200m. Lost its off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

THE JOURNO (J. Opperman) - near the 600m had to be momentarily steadied when HYPERNOVA was taken in.

HYPERNOVA (K. Crowther) - near the 600m was inconvenienced when taken in onto THE JOURNO by MANUKA BAY (NZ).

MERCURY EIGHT (A. Lai) - jumped away awkwardly. Laid out under pressure in the straight. Rider was advised to make a greater effort to keep his mounts straight when they commence to shift ground.

ROYAL TRAPEZE (S. Fawke) - severely hampered and became unbalanced on jumping away when contacted by MANUKA BAY (NZ). Near the 600m shifted in and away from MERCURY EIGHT onto MANUKA BAY (NZ). Lost its near hind plate during the event.



RACE 5: CANADIAN CLUB HANDICAP - 1050 Metres (cont'd)

SERENE MOON (M. Nunes) - underwent a pre-race veterinary examination as it had not raced in over twelve months and was deemed suitable to start.

SHARENDIPITY (T. Johnstone) - lost its off hind plate behind the barriers and required farrier attention. Underwent a pre-race veterinary examination and was deemed suitable to start.

BEAUTY BOUND (L. Neindorf) - near the 700m shifted out slightly at the same time as SHARENDIPITY shifted in, resulting in it having to be momentarily steadied. Rider reported that the mare was awkward in its action in the early stages of the event.

TOGETHERFOREVER (J. Potter) - change of tactics - attempt to be more forward and lead if possible - settled on-pace. Rider reported that the mare hung out severely throughout the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Ms L. Treloar, was advised that a warning had been placed on the mare, and an embargo against apprentice riders being engaged on the horse until further notice.

SWISS WISH (S. Metcalfe) - rider reported that her mount hung out throughout the event.

THE STING (D. Caboche) - jumped away awkwardly. Near the 600m became awkwardly placed on the heels of BEAUTY BOUND and was obliged to shift wider on the track.

MANUKA BAY (NZ) (J. Doyle) - shifted out on jumping away and bumped ROYAL TRAPEZE. Near the 600m was taken in onto HYPERNOVA.

RACE 6: CROSER HANDICAP - 1050 Metres

SIXTEEN REASONS (R. Milnes) - near the 400m improved into restricted room between THE GREAT BABY and HOWL, and was obliged to alter course to the inside of THE GREAT BABY to obtain clear ground when that gelding shifted out.

THE GREAT BABY (K. Crowther) - inside the 400m shifted out inconveniencing SIXTEEN REASONS, which was obliged to alter course, and HOWL, which was taken wider.

DEEPFLOAT DIVA (J. Toeroek) - held up from the 400m to the 300m.

HOWL (J. Holder) - awkward and slow to begin. Inside the 400m was inconvenienced when taken wider by THE GREAT BABY. Rider reported that the gelding laid in under pressure in the straight and was disappointing.

LOVELY LOOKIN' (L. Neindorf) - rider explained that the mare travelled well in the early and middle stages of the event; however, when asked for an effort in the straight did not respond to his riding and commenced to weaken of its own accord. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: ANTONIO AND ELISABETH ROMEO HANDICAP - 1100 Metres

VINTAGE STAR (J. Toeroek) - laid out under pressure over the concluding 100m of the event.

OVERSTATED (J. Holder) - raced greenly. Held up from approaching the 400m until near the 300m and then had difficulty obtaining clear ground until near the 200m. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (1/5). Trainer, Mr J. O'Connor, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

MAGIC FIELD (T. Bull) - a post-race veterinary examination revealed no visible abnormalities.

FREE BEER (M. Collett) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout. Shifted in inside the 100m onto AZTEC DANCER.

KOVA (J. Potter) - inclined to rear and was slow into stride.

SABERMETRIC (D. Tourneur) - slow to begin.



RACE 7: ANTONIO AND ELISABETH ROMEO HANDICAP - 1100 Metres (cont'd)

AZTEC DANCER (T. Voorham) - inside the 100m had to be steadied for a short distance when FREE BEER shifted in.

Correct weight for this event was delayed to allow T. Voorham (AZTEC DANCER), placed fifth, and co-trainer, Mrs N. Searle, to view the vision in the straight.

RACE 8: ACCESS HARDWARE HANDICAP - 1200 Metres

SURPRISE COMING (R. Milnes) - held up and had difficulty obtaining clear ground for the majority of the straight.

WIGGUM (D. Tourneur) - held up from the 500m to the 300m.

VOLTAGE POINT (M. Nunes) - rider explained that he was caught wide without cover from a wide barrier and was of the opinion that this was detrimental to the gelding's performance. A post-race veterinary examination revealed no visible abnormalities.

BUBBLE OVER (C. Murray) - laid in under pressure in the straight and approaching the 100m attempted to improve to the outside of KONG, and in doing so shifted out and contacted DEEVINE.

NURYS (T. Bull) - rider explained that the mare never fully travelled and was uncomfortable in its action; however, had finished its race off fairly. She added that she was of the opinion that NURYS would be better suited over further distance. A post-race veterinary examination revealed no visible abnormalities.

KONG (A. Livesey) - raced keenly in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

DEEVINE (A. Lai) - inconvenienced near the 100m when contacted by BUBBLE OVER.

RACE 9: GRAND SYNDICATES HANDICAP - 2014 Metres

TIPPA (R. Milnes) - inconvenienced on jumping away when its hindquarters were contacted by NISHINO CRESCENT (JPN).

CRIMSON VINE (NZ) (J. Opperman) - jumped away awkwardly and shifted out onto CROWN MINT. Raced keenly in the early and middle stages of the event whilst being restrained.

NISHINO CRESCENT (JPN) (D. Tourneur) - jumped away awkwardly and shifted out onto TIPPA.

BIG STORY (NZ) (M. Nunes) - laid in under pressure in the straight.

CROWN MINT (A. Livesey) - inconvenienced on jumping away when taken out onto DUAL FUEL (NZ). Rider reported that the gelding raced keenly in the early and middle stages of the event and obtained the lead of its own accord. A post-race veterinary examination revealed no visible abnormalities.

DUAL FUEL (NZ) (M. Collett) - slow to begin and shortly after was inconvenienced when CROWN MINT (NZ) was taken out. Rider reported that the mare did not travel during the event and in her opinion this was due to the removal of blinkers from its gear.

ON THE SCENT (B. Price) - rider reported that the gelding did not see out the 2000m of the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg (1/5). Co-trainers, Mr D. Clarken and Ms O. MacGillivray, were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

EISHAA (L. Neindorf) - laid in under pressure in the straight.
