Report on Race Meeting held at Port Lincoln Racecourse by the Port Lincoln Racing Club on Wednesday, 6 November 2024

RACE 1: CEDUNA FORESHORE HOTEL MAIDEN PLATE - 1350 Metres

DEE MAC (A. Lai) – jumped away awkwardly. Laid in, in the straight. Near the 200m rider accidentally dropped his whip and when laying in, shifted in onto AM I LACY (NZ).

HOPEFUL HEART (F. Atkinson) – difficult to load. Trainer, Mr J. McMahon was advised the gelding was now required to load without delay in an Official Barrier Trial prior to a future race. Raced keenly in the early and middle stages of the event. Raced greenly under pressure in the straight.

THE REAL PRINCE (K. Crowther) - laid in, in the straight.

TUFF OPERATOR (J. Potter) - slow to begin.

COLIN'S LAST – as no rider was available to ride the gelding, COLIN'S LAST was declared a late scratching by order of the Steward's at 11:53am.

AM I LACY (NZ) (B. Price) – near the 200m was steadied to avoid the heels of DEE MAC, which shifted in.

JETT ROCKIN' (M. Wolanin) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: HOTEL BOSTON MAIDEN PLATE - 1000 Metres

The start of this event was delayed approximately two minutes.

SURVEY LANE (M. Wolanin) – jumped away awkwardly. Held up for clear running rounding the home turn. On pulling up shied and dislodged its rider. M. Wolanin was examined by First Care Medical personnel and was passed fit to fulfil his remaining engagements.

DABBLE (A. Jordsjo) - slow to begin (approximately five lengths). Co-trainers, Ms J. Branford & Ms H. Dorward were advised that a warning had been placed on the gelding in relation to its starting manners. Near the 800m was brushed and then shifted out and away from MALLY'S GIRL, which shifted out abruptly and raced greenly for the remainder of the event.

MALLY'S GIRL (C. Tootell) - raced greenly throughout the event. Near the 800m when racing greenly shifted out abruptly and brushed with DABBLE before being straightened by its rider.

FEATHERED MAIDEN (M. Collett) – jumped away awkwardly and as a result was slow to begin. Beaten by 36.9 lengths. Trainer, Mr J. Allen was advised that a warning had been placed on the filly in relation to its competitiveness. A post-race veterinary examination revealed no visible abnormalities.

HONEYCRISP (S. Metcalfe) - raced greenly throughout the event.

LITTLE PRINCESS (K. Crowther) - shortly after being loaded became fractious in its barrier. Underwent a pre-race veterinary examination and was deemed suitable to race. Trainer, Ms J. Stoetzer was advised that a warning had been placed on the filly in relation to its barrier manners.

RACE 3: COFFIN BAY CELLARS FILLIES & MARES RATING 0-56 HANDICAP - 1210 Metres

ANDAMOOKA (S. Metcalfe) - contacted on jumping away by OPAL BEACH, which shifted in.

OPAL BEACH (K. Crowther) - shifted in on jumping away and contacted ANDAMOOKA.

ROCKSTAR DANCES (J. Potter) – laid out rounding the home turn.

RACE 4: STREAKY BAY HOTEL RATING 0-54 HANDICAP - 1000 Metres

HARLEEN (R. Milnes) - rider reported that the mare over raced in the early stages of the event.

SHIPWRECK (A. Jordsjo) – rider reported that inside the 200m the gelding knuckled and became awkward in its action for a short distance. She added that SHIPWRECK pulled up in a normal manner.

ALL STARDOM (A. Lai) - near the 800m became awkwardly placed on the heels of BITE YOUR TONGUE, got its head up and raced ungenerously for a short distance.


VON GEORGE (J. Potter) - Stewards permitted VON GEORGE to race without a tongue tie as it became undone in the mounting yard and was unable to be re-applied behind the barriers.

CELESTIAL ILLUSION (M. Wolanin) - slow to begin.

RACE 5: TUMBY BAY HOTEL BENCHMARK 74 HANDICAP - 1000 Metres

ARTFUL AMBITION (A. Jordsjo) - near the 150m shifted out under pressure onto THE HASS.

MESSERSCHMITT (R. Milnes) - near the 300m altered course when disappointed for a run between TYDEUS and THE HASS.



EVENING BRIDE (A. Livesey) - rider reported that the mare raced keenly in the middle stages.

RACE 5: TUMBY BAY HOTEL BENCHMARK 74 HANDICAP - 1000 Metres (cont'd)

STRAWBERRY SWING (J. Potter) - jumped away awkwardly.

TYDEUS (F. Atkinson) - slow to begin. Raced keenly in the middle stages of the event.

PARACHUTER (B. Price) - slow into stride.

RACE 6: GREAT NORTHERN HOTEL BENCHMARK 64 HANDICAP - 1350 Metres

TOAST THE DEEL (B. Price) - near the 300m brushed with SIR PANAMA and as result its rider became momentarily unbalanced.

PALE FACE (NZ) (A. Lai) - rider was dislodged en route to barrier and the gelding galloped riderless for some distance before being captured by the Clerk of the Course. Underwent a prerace veterinary examination and was deemed suitable to race. A. Lai was examined by First Care Medical personnel and was passed fit to fulfil his remaining engagements. Jumped away awkwardly and shortly after commenced to buck for a considerable distance. Co-trainers, Mr J. Dunn and Ms K. Bishop were advised the gelding must perform to the Stewards' satisfaction in an Official Barrier Trial prior to a future race. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (1/5). Co-trainers, Mr J. Dunn and Ms K. Bishop were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

SUTADAMU (M. Wolanin) - jumped away awkwardly.

SIR PANAMA (J. Potter) - near the 300m brushed with TOAST THE DEEL when attempting a tight run between that mare and MISTA RAZZLEDAZZLE.

MISTA RAZZLEDAZZLE (F. Atkinson) - held up rounding the home turn and laid in, in the straight.

ABLE WARRIOR (C. Tootell) – jumped away awkwardly. Rider reported that the gelding never travelled in today's event. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: THE MARINA HOTEL BENCHMARK 64 HANDICAP - 1350 Metres

MOUNT MADEIRA (NZ) (R. Milnes) - jumped away awkwardly. Held up for clear running from the 400m until the 250m.

DIAMONDS ARE (K. Crowther) - slow to begin.

STREET CULTURE (F. Atkinson) - laid in, in the straight.

LEBANESE TRADER (C. Tootell) – near the 600m became awkwardly placed on the heels of AXECAPITAL (NZ) for a short distance.

RACE 8: WUDINNA HOTEL COLTS, GELDINGS & ENTIRES RATING 0-56 HANDICAP - 1210 Metres

TOORAK BLAZE (C. Tootell) - contacted CHEF DE MISSION on jumping away when taken in and contacted by A THOUSAND DEGREES.

CHEF DE MISSION (F. Atkinson) - inconvenienced on jumping away when contacted by TOORAK BLAZE.

HE'S ABEL (K. Crowther) - slow to begin. Approaching the 100m became held up and altered course when disappointed for a run between CALL ME HERBIE, which rolled in and A THOUSAND DEGREES, which rolled out marginally.



A THOUSAND DEGREES (J. Potter) - on jumping away contacted TOORAK BLAZE.

FOX DUNNETT (M. Wolanin) - jumped away awkwardly. Held up for clear running from the 300m for the remainder of the event and as a result was not fully tested.

RACE 8: WUDINNA HOTEL COLTS, GELDINGS & ENTIRES RATING 0-56 HANDICAP - 1210 Metres (cont'd)

DAY FOR IT (NZ) (R. Milnes) – held up from the 300m for the remainder of the event and as a result was not fully tested.

SWIFT TERCEL (A. Lai) - laid in over the concluding stages of the event.

ADDITIONAL REPORT

MORPHETTVILLE - SATURDAY, 2 NOVEMBER 2024 RACE 5 - MM ELECTRICAL - 1100 Metres

THUNDER SHOC – Trainer, Mr W. Clarken reported the filly, on return to his stable, was bilaterally lame in front. On further examination by his stable veterinary an x-ray revealed a bone chip to the near fore knee. THUNDER SHOC will undergo a minor operation to remove the bone chip prior to racing again.
