Report on Race Meeting held at Murray Bridge Racecourse by the Murray Bridge Racing Club on Wednesday, 13 November 2024

RACE 1: AAP INDUSTRIES MAIDEN PLATE - 900 Metres

The start of this event was delayed approximately five minutes.

CROWN RICHES (A. Livesey) - fractious in its barrier after being loaded. Trainer, Ms K. Charles, was advised that a warning had been placed on the gelding. Laid in under pressure in the straight.

LUDO (NZ) (C. Murray) – near the 150m became held up when forced in restricted room to the inside of ILLUSTRATES (NZ), which was racing greenly and shifted in.

THE SILENT DEVIL (A. Lai) – jumped away awkwardly and shifted in onto ALLOY. Inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

LITTLE ROCKET (A. Jordsjo) – fractious behind the barriers on arrival at the start. Trainer, Mr D. Hewitt, was advised that a warning had been placed on the gelding in relation to its pre-race behaviour. Slow to begin. Raced greenly throughout the event.



OUT ONTARIO (J. Eaton) – hampered shortly after the start when tightened by ALLOY, which had been taken in.

RACE 1: AAP INDUSTRIES MAIDEN PLATE - 900 Metres (cont'd)

ALLOY (K. Crowther) - shortly after the start was hampered when tightened onto OUT ONTARIO by THE SILENT DEVIL.

COSMIC RIDE (M. Nunes) - hung out under pressure in the straight and proved difficult to ride.

FRENCH DELICACY (D. Tourneur) – near the 700m had to be checked when ILLUSTRATES (NZ) hung out into its running line.

ILLUSTRATES (NZ) (B. King) – fractious behind the barriers on arrival at the start. Trainer, Ms E. Hubbard, was advised that a warning had been placed on the filly in relation to its pre-race behaviour. Hung out severely in the early stages of the event and near the 700m shifted out into the running line of FRENCH DELCIACY, which had to be checked. Raced greenly in the straight and near the 150m shifted in onto LUDO (NZ). Trainer, Ms E. Hubbard, was advised that a warning had been placed on the filly in relation to its racing manners.

LIKE A DIAMOND (C. Tootell) – following the declaration of acceptances trainer, Mr J. Searle, made a gear application to add a cross-over noseband to the filly's race gear. Stewards acceded to this request and acting under AR206(2) fined Mr Searle \$200. Slow to begin. Raced greenly during the event. Near the 100m had to be momentarily steadied when OUT ONTARIO rolled in slightly.

ROCKTAGON (B. Price) - fractious in its barrier after being loaded and reared over. Underwent a pre-race veterinary examination and was deemed unsuitable to start. Acting on this advice Stewards declared ROCKTAGON a late scratching at 1.23pm. Trainer, Mr D. Jolly, was advised that the gelding would now be required to prove tractable in the barriers at an Official Barrier Trial prior to a future race start.

RACE 2: TEAM POLY TANKS MAIDEN PLATE - 1400 Metres

The start of this event was delayed approximately five minutes.

NAVAL ENSIGN (NZ) (C. Murray) – jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

SAKASU (S. Payne) – jumped away awkwardly. Laid in under pressure in the straight and near the 300m shifted in onto THAVMA, forcing the rider of that gelding to take hold when tightened onto SAINT BOOM, which was inconvenienced. Rider was severely reprimanded under AR131(a) and advised to make a greater effort to straighten his mounts when they commence to shift ground in future.

THAVMA (S. Metcalfe) – near the 300m rider was forced to take hold when tightened onto SAINT BOOM by SAKASU.

GREY SILVERADO (J. Holder) – in the vicinity of the 150m was forced to race in restricted room for a short distance when THE TANK shifted in, and as a result was steadied and altered course to the outside of that gelding. A post-race veterinary examination revealed no visible abnormalities.

STOLEN (J. Toeroek) – kicked by SAINT BOOM behind the barriers. Underwent a pre-race veterinary examination and was found to be lame in the off hindleg (2/5) and therefore was deemed unsuitable to start. Acting on this advice Stewards declared STOLEN a late scratching at 1.57pm. First aid administered. Trainer, Mr M. Hickmott, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start. Mr Hickmott was also advised that a warning had been placed on the mare in relation to its pre-race behaviour.

SAINT BOOM (M. Nunes) – kicked by STOLEN behind the barriers. Underwent a pre-race veterinary examination and was deemed suitable to start. Trainer, Mr P. Hardacre, was advised that a warning had been placed on the filly in relation to its pre-race behaviour. Near the 300m was momentarily inconvenienced when tightened onto I AM RALPH by THAVMA, which had been taken in.



THE TANK (B. Price) - near the 150m shifted in onto GREY SILVERADO.

RACE 2: TEAM POLY TANKS MAIDEN PLATE - 1400 Metres (cont'd)

MISS NARRANGA (Z. Lloyd) – fractious behind the barriers dislodging its rider and galloping free for a short distance prior to being recaptured. Returned to the barriers and shortly after dislodged its rider again, broke free and galloped for some distance. Stewards declared MISS NARRANGA on Veterinary advice at 1.57pm. Z. Lloyd was examined by the First Care Medical personnel and ruled unfit to fulfil her remaining riding engagements. Trainer, Ms S. Norton, was advised that the mare would now be required to prove tractable en route to and behind the barriers at an Official Barrier Trial prior to a future race start.

RACE 3: COONARA MAIDEN PLATE - 1800 Metres

HOLPIN (S. Metcalfe) - raced keenly in the early and middle stages of the event.

I AIN'T CHICKEN (J. Doyle) - laid out under pressure in the straight.

UNISPHERE (J. Opperman) - slow to begin.

AMBER NOOK (J. Holder) - laid in under pressure in the straight.

CUT NO ICE (NZ) (K. Crowther) - raced keenly in the early and middle stages of the event.

FOXY EAGLE (D. Tourneur) - slow to begin.

RACE 4: DAVEY WATER RATING 0 - 56 HANDICAP - 2500 Metres

GOT AN INSPIRATION (NZ) (C. Tootell) – inconvenienced on jumping away when contacted by HOSTESS SUSIE and taken out onto SHARMA PRINCESS (NZ).

SHEARMAN DYER (J. Holder) – acting on confirmed advice from trainer, Ms P. Trenwith, that the gelding had swelling to its off foreleg and would be unfit to start Stewards declared SHEARMAN DYER a late scratching at 10.18am. Ms Trenwith was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

THINK TANK (S. Payne) - laid in under pressure in the straight.

WARRANDYTE ROAD (D. Tourneur) - raced keenly in the middle stages of the event.

SPEC RAIDER (A. Jordsjo) - raced keenly in the early and middle stages of the event.

BENZ BARON (B. Price) - a post-race veterinary examination revealed no visible abnormalities.

HOSTESS SUSIE (L. Neindorf) – jumped away awkwardly and shifted out onto GOT AN INSPIRATION (NZ). A post-race veterinary examination revealed no visible abnormalities.

SHARMA PRINCESS (NZ) (B. King) – reared on jumping away and shortly after was contacted by GOT AN INSPIRIATION (NZ), which had been taken out. In the early stages got its head up, became intractable and refused to race dislodging its rider in the vicinity of the winning post on the first occasion. Rider reported that she had been instructed to take up a forward position; however, after the mare was slow to begin and then received some interference she had found herself further back than she had hoped. She added that when the pace in the race slowed she attempted to take hold of the mare to avoid heels in front and SHARMA PRINCESS (NZ) got its head up, became extremely awkward in its action and refused to get back into stride despite her efforts. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr L. Cadzow, was advised that the mare would now be required to prove tractable in an Official Barrier Trial prior to a future race start.

HOGAN (S. Metcalfe) - rider reported that it was not her intention to settle on pace in today's event; however, after jumping away well there was no pace in the early stages of the event and the gelding found itself in that position of its own accord.



RACE 5: VINIDEX & PHILMAC NMW-LY HANDICAP - 1800 Metres

ESKY (NZ) (J. Holder) - rider reported that the gelding was not suited by the slow tempo in the race, and for this reason had not finished the event off as he had anticipated. A post-race veterinary examination revealed no visible abnormalities.

DAZZLING PROSPECT (A. Lai) – reared over in its raceday stall. Underwent a pre-race veterinary examination and found to be lame in the near hind leg (1/5) and therefore was deemed unsuitable to start. Acting on this advice Stewards declared DAZZLING PROSPECT a late scratching at 3.17pm. Trainer, Mr B. Campbell, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

MR TRAFFICANTI (NZ) (B. Price) – inconvenienced on jumping away when taken in onto APPLIED by EVENTUALLY. Raced wide without cover throughout the event.

MANDINO (L. Neindorf) - laid in under pressure in the straight.

A TOUCH FROSTY (M. Nunes) - over-raced in the early and middle stages of the event.

EVENTUALLY (K. Crowther) - shifted in on jumping away onto MR TRAFFICANTI (NZ). Raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

JAYWICK (B. King) – raced wide without cover throughout the event.

HIT THE SLOPES (J. Eaton) – slow to begin. Rider explained that it was not her intention to settle as far forward as she had; however, after being slow to begin she had encouraged her mount to maintain contact with the field, but it had raced forward of its own accord and then no other runners pushed forward to provide her cover. Lost its near fore plate during the event.

APPLIED (S. Metcalfe) - lost its position shortly after the start when tightened by MR TRAFFICANTI (NZ), which had been taken in by EVENTUALLY.

RACE 6: BIANCO NXT BENCHMARK 56 HANDICAP - 900 Metres

VOLCANIC EXPRESS (B. King) – raced keenly in the early and middle stages of the event and near the 500m shifted out onto BIG MAV, forcing that rider to check when taken out onto the heels of PUTANOTHERCOININ. Rider was severely reprimanded and advised in future to ensure there was sufficient room prior to commencing to shift ground. Became held up from the entrance to the straight until inside the 400m.

BIG MAV (M. Nunes) – near the 500m rider was forced to check and lose his position when taken out onto the heels of PUTANOTHERCOININ by VOLCANIC EXPRESS.

IN LOVE (A. Jordsjo) - rider reported that in her opinion the filly was disappointing and may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

MY HARUCONI (L. Neindorf) – slow into stride. Held up from the entrance to the straight until inside the 100m and was not fully tested.

RIVER CLYDE (A. Lai) - lost its near fore plate during the event.

OUR GODDESS (F. Atkinson) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 200m, and then became held up for a short distance prior to obtaining clear ground.

REINE OF NINE (K. Crowther) - slow to begin.

WEE DRAM (J. Toeroek) - laid out rounding the home turn.

JIMMYS EDGE (D. Tourneur) - held up from the entrance to the straight until near the 300m.

MADAM FURPHY (S. Payne) - held up from the entrance to the straight until inside the 200m.

MAY'S WEST (S. Mitchell) - raced wide without cover throughout the event.



RACE 7: ORANGE PUMPS RATING 0 - 56 HANDICAP - 1600 Metres

DOCTOR ROBERT (NZ) (J. Opperman) - jumped away awkwardly.

ENLIST (A. Jordsjo) - inside the 400m shifted out and contacted THE GREY KING.

MYSTERY DEEL (F. Atkinson) – change of tactics – attempt to settle more forward – settled on pace.

ALPINE BEAU (E. Finnegan) – jumped away awkwardly. Near the 250m had to be checked to avoid the heels of OUR SELECTION (NZ), which had been taken out into its running line.

SUGGESTIVE MISS (C. Tootell) – near the 250m shifted out onto OUR SELECTION (NZ) taking that gelding out into the running line of ALPINE BEAU, which was forced to be checked. Rider pleaded guilty to a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Saturday, 16 November 2024 and to conclude midnight Saturday, 23 November 2024, a period of three meetings.

THE GREY KING (S. Payne) – stood flat-footed and was slow to begin. Inside the 400m shifted in and contacted ENLIST. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr J. Pickering, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

RUE BUNGAN (D. Tourneur) - slow to begin.

PIWHANE (B. Price) - raced keenly in the early and middle stages of the event.

ARCHDEACON (S. Metcalfe) – inside the 400m became awkwardly placed between the heels of THE GREY KING and ENLIST, which both shifted ground, and was obliged to alter course to obtain clear running.
