**Report on Race Meeting held at Morphettville Racecourse**  
**by the South Australian Jockey Club on Saturday, 8 August 2015**

**RACE 1 : MILL PARK STUD HANDICAP - 2000 metres**

TRY FOUR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

**RACE 2 : ZEBEDEE AT CORNERSTONE STUD MAIDEN PLATE - 1050 metres**

The start of this event was delayed approximately one minute owing to BEDROCK DREAMS becoming fractious after being loaded into its barrier stall. BEDROCK DREAMS was examined by the Club's Veterinary Surgeon and passed fit to race.

BURST AWAY (J. Holder) jumped away awkwardly, shifted out and contacted ECLAIR GO GO (D. Tourneur).

MISS MURRA (S. Carr) jumped away very awkwardly, shifted out and contacted SAMBUCA SIREN (S. Price).

SOARING HIGH (C. Lindop) was slow to begin. SOARING HIGH was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

LOPE DE CAPIO (Z. Spain) laid out from in the vicinity of the 700 metres until near the entrance to the straight.

BEDROCK DREAMS (M. Payne) laid out under pressure in the straight.

In the vicinity of the 250 metres BURST AWAY (J. Holder) shifted in abruptly of its own accord and became momentarily unbalanced.

Inside the 100 metres SAMBUCA SIREN (S. Price) was momentarily inconvenienced when racing between ECLAIR GO GO (D. Tourneur), which maintained its line and BEDROCK DREAMS (M. Payne), which shifted out.

## **RACE 2 : ZEBEDEE AT CORNERSTONE STUD MAIDEN PLATE - 1050 metres (Cont'd)**

M. Payne, the rider of BEDROCK DREAMS, reported the filly laid out throughout in the straight. BEDROCK DREAMS was examined by the Club's Veterinary Surgeon who reported the filly to be lame in the off foreleg. Trainer Mr W. Hunter was advised a Veterinary Certificate of Fitness would be required prior to presenting BEDROCK DREAMS for a future trial or race.

SAMBUCA SIREN was examined by the Club's Veterinary Surgeon who reported a laceration to its near hind canon. First Aid was administered.

## **RACE 3: AKEED MOFEED AT GOLDIN FARMS HANDICAP - 1800 metres**

THING OF NOTHING (IRE), which lost its near fore plate after arrival on course was attended to by the Farrier, examined by the Club's Veterinary Surgeon and passed fit to race.

MISS WAIROA (E. Finnegan) raced wide without cover in the early stages of the event.

MISS WAIROA lost its near hind plate during the event.

CENTRE DIVIDER (D. Tootell) and CLANDARBHEN (C. Lindop) were held up and unable to improve their positions from in the vicinity of the 600 metres until near the 200 metres and QUAD (C. Jokic) was held up and unable to improve its position from in the vicinity of the 600 metres until in the vicinity of the 100 metres.

Approaching the 100 metres CENTRE DIVIDER (D. Tootell), which had commenced to improve its position between MANNA TRUST (J. Mott), which rolled in and JOURNEY UNKNOWN (D. Tourneur), which maintained its line, was obliged to be steadied and as a consequence rolled in and contacted QUAD (C. Jokic), which had shifted out to improve its position, resulting in both horses being inconvenienced.

J. Holder, the rider of THING OF NOTHING (IRE) explained the gelding travelled well in the early stages but was under pressure in the vicinity of the 600 metres and did not finish the event off in its normal manner. THING OF NOTHING (IRE) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

D. Tootell, the rider of CENTRE DIVIDER, reported he was held up for clear running from in the vicinity of the 800 metres until near the entrance to the straight.

## **RACE 4 : MORPHETTVILLE EQUINE CLINIC HANDICAP - 1050 metres**

BAY ROAD (P. Gatt) which was fractious in its barrier stall began very awkwardly and as a consequence was slow to begin.

CASHED (J. Mott) jumped away very awkwardly and was slow to begin.

WILANDER PRINCESS (E. Finnegan) raced wide without cover in the early stages.

In the vicinity of the 700 metres CASHED (J. Mott), which had raced keenly, got its head up and raced ungenerous when being restrained as IMPULSE BUY (S. Price) shifted in. S. Price was reminded of his obligations when shifting ground in future.

TOM'S LUCK (S. Carr) was held up for clear running from inside the 500 metres when racing behind IMPULSE BUY (S. Price) and SUNSET ROCK (Z. Spain) until in the vicinity of the 200 metres and thereafter was again held up for clear running between the heels of OUR SNIPPY (J. Holder) and BAY ROAD (P. Gatt) and was only able to obtain clear running inside the 100 metres. TOM'S LUCK was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the off hind leg. Mr G. Young was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

#### **RACE 4 : MORPHETTVILLE EQUINE CLINIC HANDICAP - 1050 metres (Cont'd)**

J. Mott, the rider of CASHED explained his intentions were to settle mid-field but owing to the manner in which the gelding began, he was obliged to settle a little further back in the field. He added that in the vicinity of the 800 metres the gelding raced keenly and got its head up and raced ungenerously for a short distance.

S. Price, the rider of IMPULSE BUY, reported the gelding was awkward in its action during the event. IMPULSE BUY was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near hind leg. Mr G. Richards was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

#### **RACE 5 : DALAKHANI AT CORNERSTONE STUD HANDICAP - 1050 metres**

ZANDERCAN (A. Doyle) jumped away awkwardly, was slow to begin and thereafter pulled hard in the early stages and was difficult to restrain.

At the entrance to the straight ZANDERCAN (A. Doyle) improved onto the heels of HURRICANE ANDY (E. Boyd), shifted out to obtain clear ground and became very awkward between HURRICANE ANDY and WILD RUN (K. Bishop). A. Doyle was shown the vision of the incident and advised to take greater care in future when electing runs.

Rounding the home turn COOL HERO (P. Gatt) shifted out to improve and brushed with TRUE SASSO (M. Neilson), which maintained its line.

COOL HERO lost its near fore plate during the event.

J. Frew, the rider of BOLD SENATOR was questioned regarding the use of his whip prior to the 100 metres. He pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip in a forehand manner on more than five occasions prior to the 100 metres and was fined \$200. He also pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and was reprimanded.

COURTSIDE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

***Following this event the track was upgraded to Soft 6 @ 2.58 pm retrospective to Race 5***

#### **RACE 6 : UNITED DISCOUNT CHEMIST HANDICAP - 1600 metres**

In the vicinity of the 700 metres EDGE OF WAR (J. Mott) raced in restricted room for a short distance between ASTRO DAMUS (S. Price) and BRIMMING (Z. Spain) as that horse improved to its outside.

HALAYR JET (S. Cahill) was held up for clear running from the entrance to the straight when racing behind USTINOV'S FURY (M. Payne) and was only able to obtain clear running inside the 200 metres.

DAYDREAM CHARLIE lost its off hind plate during the event.

J. Mott, the rider of EDGE OF WAR explained the gelding travelled well until in the vicinity of the 700 metres but after racing in restricted room between runners, the gelding failed to respond to his riding for the remainder of the event and finished the race of in a disappointing manner. EDGE OF WAR was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 6 : UNITED DISCOUNT CHEMIST HANDICAP - 1600 metres (Cont'd)**

SATURDAY AFFAIR was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Trainers Mr L. Macdonald and Mr A. Gluyas were advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

BIG MAN was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

## **RACE 7 : DAVID COLES AM SPRING STAKES - 1200 metres**

DYLANSON (M. Neilson) was held up for clear running from inside the 600 metres until near the entrance to the straight.

Inside the 200 metres DYLANSON (M. Neilson) was obliged to alter course to obtain clear running to the inside of STIMULATTE (J. Holder) as that gelding commenced to weaken.

ALCOHOL was examined by the Club's Veterinary Surgeon who reported the gelding to be lame in the near foreleg. Trainer Mr R. Jolly was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

PINKY TUSCADERO was examined by the Club's Veterinary Surgeon who reported the mare to be lame in the off hind leg. Trainers Ms K. McNulty and Mr C. Binnie were advised a Veterinary Certificate of Fitness would be required prior to presenting the mare for a future trial or race.

## **RACE 8 : PERKS CHARTERED ACCOUNTANT HANDICAP - 1200 metres**

As Stewards were able to confirm the identity of MOONLIGHT FOREST from records held by them when the Thoroughbred Identification Card was not available for inspection, the gelding was permitted to start. Mr W. Clarken, the Trainer of MOONLIGHT FOREST was fined \$50 under AR59A.

The start of this event was delayed approximately one minute owing to an interstate delay and also owing to CASH IS COMING proving difficult to load.

CASH IS COMING (C. Lindop) began awkwardly.

TRUFFLE (M. Payne) over-raced in the early and middle stages of the event.

Inside the 600 metres BACK ON TARGET (E. Finnegan) commenced to race keenly and became awkward on the heels of THEATREMAN (C. Jokic) for a short distance.

Shortly after the entrance to the straight BACK ON TARGET (E. Finnegan) was disappointed for clear running between HIGHEST NOTE (D. Tourneur) and THEATREMAN (C. Jokic), which rolled out and shifted in to improve resulting in AMICONI ORIGINALE (M. Neilson) being inconvenienced when taken in.

SOL BRILLANTE (C. Jones) was held up for clear running from inside the 400 metres until approaching the 200 metres when racing behind TYCOON QUEEN (J. Maund) and shifted in to obtain clear running and shortly thereafter, inside the 200 metres was again held up for clear running on the heels of HIGHEST NOTE (D. Tourneur) for a short distance.
