STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 12 September 2015

TRACK: Good 4 (*Upgraded to Good 3 at 11.10 am*)

WEATHER: Fine

RAIL: Out 7 metres 1200 metres to Winning Post, 5 metres remainder. Sectional 609 metres

RACE 1 : DAVID & MARY AXON-STOKES HANDICAP - 1050 metres

JEST FOR THE ROAD proved difficult to load. Trainer, Mr J. O'Connor, was advised a warning had been placed on the gelding in relation to its loading manners.

INVINCIBLE HEART (S. King) bucked for several strides shortly after the start and as a consequence lost considerable ground.

S. King, the rider of INVINCIBLE HEART explained, owing to the manner in which the filly began he was unable to settle forward of mid-field as intended. He added from inside the 600 metres, when there appeared to be a lack of pace, he elected to improve his position but was obliged to race wide without cover for some distance and raced wide into the straight and whilst the filly finished the race off in a respectable manner, he was unable to make up the lost ground in the early stages. Mr C. Bieg, representing Mr M. Price, the Trainer of INVINCIBLE HEART was advised that in view of the filly's behaviour shortly after the start, it would be required to compete in an Official Barrier Trial to the satisfaction of the Stewards prior to accepting for a future race. INVINCIBLE HEART was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

In the vicinity of the 300 metres VIDDORA (J. Bowditch), which raced greenly and was inclined to lay in, shifted in and inconvenienced SCHIZLE (T. Pannell).

Inside the 200 metres BACKSTAGE PASS (C. Lindop) was unable to obtain clear running when racing behind ASK ME HOW I KNOW (E. Finnegan) and to the inside of SCHIZLE (T. Pannell), was obliged to be steadied and altered course to the outside of SCHIZLE (T. Pannell) to improve its position.

RACE 2 : HYLAND RACE COLOURS HANDICAP – 1200 metres

The start of this event was delayed approximately two minutes owing to the late arrival of horses at the barriers.

RACE 2 : HYLAND RACE COLOURS HANDICAP – 1200 metres (Cont'd)

ROCK OUT (J. Toeroek) and COME FOLLOW ME (J. Bayliss) over-raced in the early stages of the event.

Shortly after the entrance to the straight MISS ADELE (J. Holder) was disappointed for clear running when attempting a run between ROCK OUT (J. Toeroek) and OKAHU BAY (E. Finnegan) at the same time as TRY YOUR BEST (NZ) (D. Tourneur) attempted the same run. As a consequence MISS ADELE was only able to fully improve its position approaching the 100 metres.

COME FOLLOW ME (J. Bayliss) laid in severely in the straight and as a consequence was unable to improve its position when racing behind CASH IS COMING (S. Carr) and NATURAL DISASTER (J. Childs) until approaching the 100 metres. Thereafter COME FOLLOW ME attempted a run to the outside of CASH IS COMING, however, shortly thereafter had to be steadied to avoid the heels of CASH IS COMING and MOLLY THE SNIP (P. Gatt) when awkwardly placed on the heels of these runners. J. Bayliss, the rider of COME FOLLOW ME, explained that despite his best efforts to attempt to improve outside runners in the straight, the mare failed to respond and as a consequence he found himself awkwardly placed on heels throughout in the straight.

Inside the 100 metres ALERTNESS (E. Boyd) was disappointed and inconvenienced when improving into a tight run inside ROCK OUT (J. Toeroek), which shifted in and away from MISS ADELE (J. Holder).

NATURAL DISASTER was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

COME FOLLOW ME was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 3 : FIRST CARE MEDICAL HANDICAP - 1600 metres

The start of this event was delayed approximately three minutes owing to an interstate delay.

EMMOOKI'S DASH (R. Hurdle) raced keenly in the early stages and in the vicinity of the 1000 metres became awkwardly placed for a number of strides on the heels of ROCKET COMMANDER (P. Gatt).

ROCKET COMMANDER (P. Gatt) was held up for clear running for a short distance shortly after the entrance to the straight when racing behind FROST DODGER (J. Bayliss) and SET ON STONE (J. Potter) and was only able to improve its position in the vicinity of the 300 metres.

J. Toeroek, the rider of LADY HEDERAJ reported owing to the manner in which the mare began, he was unable to take up a more forward position as intended.

RACE 4 : NATIONAL JOCKEYS' TRUST SERIES FINAL HANDICAP - 1200 metres

NORTHERN ZHAR (J. Childs) jumped away awkwardly, shifted out and tightened JUST FOR STARTERS (J. Bayliss) onto the heels of BELFAST BOY (D. Tourneur).

BELFAST BOY (D. Tourneur) raced keenly in the early stages of the event.

In the vicinity of the 800 metres BELFAST BOY (D. Tourneur) had to be steadied and was inconvenienced for several strides when awkwardly placed inside the heels of STRAVINSKY CODE (J. Toeroek) as that horse shifted in to improve. J. Toeroek was severely reprimanded and advised to ensure he was sufficiently clear when shifting ground in future.

RACE 4 : NATIONAL JOCKEYS' TRUST SERIES FINAL HANDICAP - 1200 metres

BELFAST BOY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

J. Toeroek, the rider of STRAVINSKY CODE, reported in his opinion, the gelding may have jarred up in running. STRAVINSKY CODE was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 5 : UBET HANDICAP - 2600 metres

I AM GYPSY (J. Toeroek) reared, was very awkward as a consequence was slow to begin.

I AM GYPSY (J. Toeroek) over-raced in the early stages of the event.

QUICK LOVER (P. Gatt) was held up for clear running from the entrance to the straight when racing behind PERIDUKI (E. Boyd) and inside SPARTAN WARRIOR (C. Lindop) and was only able to obtain clear running inside the 100 metres. PERIDUKI was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

CLASSY JACK was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 6 : MARKEYSADDLERY.COM.AU HANDICAP - 1200 metres

In the vicinity of the 900 metres OUTLANDISH LAD (E. Finnegan), which had commenced to race keenly became awkwardly placed on the heels of EXCITES ZELADY (P. Gatt) and when being restrained shifted abruptly onto DAYTONA GREY (J. Bayliss), which was tightened onto and contacted the inside running rail. Thereafter OUTLANDISH LAD continued to race keenly for some distance.

KING BUDDY (H. Coffey) was momentarily held up for clear running at the entrance to the straight.

Approaching the 200 metres DAYTONA GREY (J. Bayliss) improved onto the heels of HANK'S NEPHEW (D. Gauci) and was obliged to shift in and thereafter in the vicinity of the 100 metres, was held up for clear running and unable to improve his position.

OUTLANDISH LAD (E. Finnegan) was held up for clear running from in the vicinity of the 400 metres until the finish and was untested to the line. E. Finnegan, the rider of OUTLANDISH LAD reported that owing to the composition of the field in the straight she was unable to ride her mount out fully to the finish.

DAYTONA GREY was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.

RACE 7 : GOLDIN FARMS MORPHETTVILLE GUINEAS - 1600 metres

CELTIC TIGER (NZ) (S. King) was slow to begin.

In the vicinity of the 1100 metres BELUGA BLUE (T. Pannell) became awkward inside the heels of C'EST BEAU LA VIE (C. Lindop) and had to be steadied. At the same time NURBURGRING (J. Beriman) was obliged to be steadied when racing in restricted room when the pace slackened and as a result CELESTIAL STORY (J. Toeroek), which was following, became awkwardly placed on the heels of NURBURGRING for a short distance.

RACE 7 : GOLDIN FARMS MORPHETTVILLE GUINEAS - 1600 metres (Cont'd)

NURBURGRING was examined by the Club's Veterinary Surgeon who reported abrasions to the off hind canon and to the near hind hock. First aid was administered.

PRINCE OF PAGODA (NZ) (M. Neilson), which commenced to weaken approaching the entrance to the straight, was eased out of the event in the vicinity of the 200 metres. M. Neilson, the rider of PRINCE OF PAGODA (NZ) reported he had become concerned with the manner in which the gelding weakened in the straight and for that reason he eased his mount out of the event.

RACE 8 : THE HIGHWAY AFTER PARTY HANDICAP - 1600 metres

In the vicinity of the 1500 metres MIDSOMER BARNABY (T. Zanker) shifted in and crossed the running of LONCAVA (NZ) (J. Bayliss), which was obliged to check his mount for several strides to avoid the heels of MIDSOMER BARNABY (T. Zanker). T. Zanker, the rider of MIDSOMER BARNABY pleaded guilty to a charge under AR137(a) (Careless Riding) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight Sunday, 13 September and to conclude at midnight on Sunday, 20 September 2015: a period of three (3) meetings.

CYCLONE THOMAS (P. Gatt) raced keenly in the early and middle stages of the event.

Approaching the 200 metres HAVE PLENTY (J. Bowditch) improved into a tight run between BUYMEBYCHANCE (M. Neilson) and CYCLONE THOMAS (P. Gatt) and brushed CYCLONE THOMAS, which was taken a little wider.

FIVE TO MIDNIGHT (C. Lindop) was held up for clear running from in the vicinity of the 300 metres when racing behind CYCLONE THOMAS (P. Gatt) and HAVE PLENTY (J. Bowditch) until in the vicinity of the 200 metres and was obliged to shift in to obtain clear running and thereafter was again held up over the concluding stages and was untested to the line.

DIVAN (NZ) was examined by the Club's Veterinary Surgeon who reported no visible abnormalities.
