RACE 1 : VAL HANCHANT MEMORIAL / SABOIS MAIDEN PLATE - 1390 metres

SWING ALONG (B. Griffiths) – slow into stride in the early stages. A post-race veterinary examination revealed no visible abnormalities.

WILLIS (M. Poon) - slow to begin.

ECHINACEA (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2 : MGA INSURANCE /SABOIS THREE-YEAR-OLD BENCHMARK 60 HANDICAP
- 1210 metres

MOONSHAFT (S. Cahill) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

POINT DRUMMOND - late scratching on veterinary advice at 10.49 am. Veterinary Certificate of Fitness required prior to trial or race.

RACE 3 : ACTIVE FINANCIAL MANAGEMENT BENCHMARK 80 HANDICAP - 1390 metres

PROPSHAFT (G. Willoughby) – rider reminded of her obligations to ride her mounts out over the concluding stages. A post-race veterinary examination revealed no visible abnormalities. Trainer advised the gelding would now be spelled.

RACE 4 : K & K COOLING / SABOIS MAIDEN PLATE - 1000 metres

AL ZAFIR (A. Doyle) – slow to begin. Raced greenly when placed under pressure over the concluding stages.

ZAHALIDAN (M. Poon) – raced greenly throughout the event. Ran wide on entering the straight. Warning issued. Trainer reported the mare will be ridden by a senior rider at its next race. A post-race veterinary examination revealed no visible abnormalities.

ON DUTY (R. Hurdle) – laid in when placed under pressure over the concluding stages.

RACE 5 : PORT LINCOLN TROPHY & BADGE BENCHMARK 60 HANDICAP - 1390 metres

BOSSA NOVA (NZ) (S. Cahill) – momentarily held up when entering the straight and shifted wider on the track to improve.

ALL KRUPT (Z. Spain) – hung in when placed under pressure in the straight.

IN HIS DREAMS (T. Zanker) – began awkwardly, shifted in and bumped TRESETTE. A post-race veterinary examination revealed no visible abnormalities.

LATIN HERO (L. Stojakovic) – began awkwardly.

BOLD JAZZ (R. Hurdle) – over-raced in the middle stages of the event.

TRESETTE (J. Potter) - began awkwardly, shifted out and bumped IN HIS DREAMS. A post-race veterinary examination revealed no visible abnormalities.

FACE LEICA STAR (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6 : MORPHETTVILLE EQUINE BENCHMARK 60 HANDICAP - 1390 metres

HEZA HUSSLER (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

CINCINNATI (S. Cahill) – held up for clear running at the entrance to the straight.

FRAAR MANDY (C. Jones) - began awkwardly, shifted out and bumped MINDSTORMS. Rider reminded of her obligations to be two lengths clear when shifting ground in future.

PERUVIAN POWER (R. Hurdle) – over-raced in the early stages after being crossed by FRAAR MANDY. Continued to over-race in the middle stages of the event. Shifted in when placed under pressure over the concluding stages. Rider reminded of his obligations to stop and straighten his mounts when shifting ground. A post-race veterinary examination revealed no visible abnormalities.

ATOMIC HERO (Z. Spain) – over-raced in the middle stages of the event.

DIVADEBEER (J. Kah) – held up for clear running at the entrance to the straight.

HAPPYENDO (L. Stojakovic) - a post-race veterinary examination revealed no visible abnormalities.

MINDSTORMS (A. Doyle) – bumped at the start. Raced in restricted room over the concluding stages.

WAADOO (E. Boyd) - underwent a pre-race veterinary examination and passed fit to race.

RACE 7 : AIT SPECIALISTS PTY LTD BENCHMARK 72 HANDICAP - 1000 metres

DESTONY HAWK (M. Poon) – held up for clear running in the home straight and found difficulty in obtaining clear ground due to the mare hanging out over the concluding stages. A post-race veterinary examination revealed small laceration inside the off side corner of the mouth.

IMPERIAL FURY (A. Doyle) – hampered shortly after the start.

GOOD CONDUCT (R. Hurdle) – raced wide without cover throughout the event.

SLIDE OF HAND (B. Griffiths) - a post-race veterinary examination revealed no visible abnormalities.

RIGHT BUZZ (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8 : LINCOLN RURAL SUPPLIES BENCHMARK 80 HANDICAP - 1750 metres

MOON DEVIL (A. Doyle) – reared as the start was affected.

RACE 8 : LINCOLN RURAL SUPPLIES BENCHMARK 80 HANDICAP - 1750 metres (Cont'd)

MONTALTO (J. Potter) – in the vicinity of the 100 metres improved into a narrow run and in doing so carried ROOBOY in onto NEW WAVE. Rider reminded of his obligations to be clear when shifting ground in future.

ROOBOY (L. Stojakovic) – in the vicinity of the 100 metres was crowded for room. Lost both hind plates during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 9 : PORT LINCOLN GOURMET MEATS BENCMATK 60 HANDICAP - 1210 metres

NIPEX (J. Kah) – bucked shortly after the start causing its rider’s saddle to slip backwards, placing the rider at a disadvantage throughout the event. In the incident the rider lost two pieces of packing and on return to scale J. Kah weighed in 1.1kg under the gelding’s advertised weight. As a result under AR143(a) NIPEX was disqualified and the placing’s were amended. Trainer was advised that the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.
