RACE 1 : XXXX GOLD/SABOIS MAIDEN PLATE - 1550 metres

AL SLAMMER (M. Poon) – in the vicinity of the 1400 metres shifted in when insufficiently clear. Rider severely reprimanded. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

GRAND ARROW (J. Kah) – in the vicinity of the 1400 metres was inconvenienced when taken wider on the track.

WHITE FACE WOMBAT (P. Denton) – in the vicinity of the 1400 metres was inconvenienced when taken wider on the track.

ALPHA CASH (K. Brooks) – in the vicinity of the 1400 metres had to be steadied and lost its position.

DANCER'S DREAM (E. Boyd) – rider reported the mare felt awkward in its action. A post-race veterinary examination revealed no visible abnormalities.

SET TO SURPRISE (W. Kerford) - in the vicinity of the 1400 metres had to momentarily steady and lost its position.

RACE 2 : BORDERTOWN HAULAGE & TRADING / SABOIS MAIDEN PLATE - 1300 metres

MAD COMMAND (J. Potter) – bumped at the entrance to the straight for a short distance.

RED JIAN (M. Neilson) – bumped at the entrance to the straight for a short distance.

RACE 3 : D & M RURAL / SABOIS MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately two minutes due to an international delay.

JUST A SINGER (C. Hall) - jumped away awkwardly and shifted in bumping another runner.

SPIN FOR LUCK (H. McKechnie) - was slow to begin.

IN CLOVER (J. Kah) - jumped away awkwardly and shifted out bumping another runner.

RACE 3 : D & M RURAL / SABOIS MAIDEN PLATE - 1100 metres (Cont'd)

MICKY'S DIAMONDS (J. Maund) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

ALPHA MINT (K. Brooks) – rider reported the filly raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : BARRETT PETROLEUM RATING 0-58 HANDICAP - 1100 metres

JIMASSI (M. Neilson) – approaching the 900 metres had to momentarily steady. Hung in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SCROLL (J. Frew) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

ALREADY LEICA (J. Kah) – in the vicinity of the 900 metres was inconvenienced when taken wider on the track. Rider explained the mare did not feel comfortable in its action. A post-race veterinary examination revealed no visible abnormalities.

RUBILAD (P. Denton) – approaching the 900 metres shifted in when insufficiently clear. Rider severely reprimanded.

SPARKLING VIXEN (K. Brooks) – in the vicinity of the 900 metres was inconvenienced when taken wider on the track.

LITTLE PEARLA (J. Potter) – laid out for a short distance in the vicinity of the 900 metres.

RACE 5 : BORDERTOWN BAKERY RATING 0-58 HANDICAP - 1550 metres

NEHRU (Jemma Frew) – approaching the 900 metres shifted in marginally when insufficiently clear. Rider reprimanded. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200. Performed below expectations. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

ODYSSEO (C. Jones) – approaching the 900 metres had to momentarily steady.

NIGHT BREEZE (M. Neilson) – rider could offer no explanation into the poor performance of the gelding. A post-race veterinary examination revealed no visible abnormalities.

ADIOS ATLANTIS (P. Marks) - was slow to begin.

SIX OF HEARTS (H. Mckechnie) - was slow to begin.

MARVEDO (M. Poon) – laid in under pressure in the straight.

RACE 6 : WILLOW GROVE STUD BENCHMARK 64 HANDICAP - 2000 metres

NOMIS (NZ) (M. Neilson) – rider explained he was of the opinion that the gelding felt the track in today's event. A post-race veterinary examination revealed no visible abnormalities.

KHAZNEH (M. Poon) – at the entrance to the straight was inconvenienced when taken wider on the track.

INDIGO SUN (J. Potter) – entrance to the straight laid out under pressure. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SPRAY TAN (W. Kerford) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 6 : WILLOW GROVE STUD BENCHMARK 64 HANDICAP - 2000 metres (Cont'd)

MR LOWNDES (NZ) (E. Finnegan) - at the entrance to the straight was inconvenienced when taken wider on the track.

SURPRISE US (A Doyle) - jumped away awkwardly. At the entrance to the straight was inconvenienced when taken wider on the track.

BEGOR I'M SURE (E. Boyd) – raced keenly in the middle stages. In the vicinity 1800 metres, when continuing to race keenly, had to momentarily steady off heels when improving.

FLYING SKIPPER (K. Brooks) - in the vicinity 1800 metres shifted in marginally. Rider reminded of obligations when shifting ground in future.

Following the running of this event E. Boyd was examined by the First Care Medical Personnel and ruled unfit to fulfil her remaining engagements.

RACE 7 : LOCAL TRAINERS BENCHMARK 64 HANDICAP - 1300 metres

The start of this event was delayed approximately two minutes.

AKBAR MAHAL (K. Brooks) - jumped away awkwardly and shifted in bumping another runner. A post-race veterinary examination revealed no visible abnormalities.

STATUE OF GLORY (H. McKechnie) - in the vicinity of the 1100 metres shifted in when insufficiently clear. Rider was reprimanded.

HUSTLER LA LOPE (J. Kah) – bumped on jumping away. A post-race veterinary examination revealed no visible abnormalities.

DULCIE JANE (C. Hall) – in the vicinity of the 1100 metres was momentarily inconvenienced.

ORBITAL MOTION (Jemma Frew) - was slow to begin.

ONWARD (A. Doyle) – dislodged its rider en route to the barriers, galloped for a short distance before being recaptured. Underwent a pre-race veterinary examination and passed fit to race. Rider examined by the First Care Medical Personnel and passed fit to fulfil his riding engagement. In the vicinity of the 1100 metres was momentarily inconvenienced. From the entrance to the straight and for the remainder of the event was disappointed for clear running when racing tight inside **STATUE OF GLORY**. Rider reminded of his obligations when attempting to take a tight run when cleared to do so.
