Report on Race Meeting held at Morphettville Racecourse

RACE 1 : ADELAIDE'S FESTIVAL OF RACING HANDICAP - 1200 metres

The start of this event was delayed approximately three minutes.

RED BEGONIA (J. Bowditch) – inconvenienced inside the 200 metres.

FREEDOM ROAD (J. Kah) – became cast in its barrier stall and had to be removed and examined by the Club's Veterinary Surgeon who passed the mare fit to race. Inside the 200 metres shifted out to improve and inconvenienced RED BEGONIA. J. Kah was reminded of her obligations when shifting ground and advised to take greater care in future.

SALTARELLO (C. Jones) – proved very difficult to load, refused to load and was a late scratching by order of Stewards at 12.06 pm. Trainer, Mr R. Jolly was advised that the filly would be required to load without delay in an Official Barrier Trial prior to accepting for a future race.

TORI'S GIFT (E. Finnegan) – stood flat-footed, was slow to begin and lost many lengths. In the vicinity of the 400 metres became awkward on the heels BAKER'S DOZEN. E. Finnegan reported the mare felt sore behind and for that reason she did not persevere with her riding from in the vicinity of the 400 metres. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Veterinary Certificate of Fitness required prior to trial or race.

RACE 2 : UBET HANDICAP - 1050 metres

MISS GUNPOWDER (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

COUNTER PULSE (J. Childs) – lost its off fore plate during the event.

BURST AWAY (J. Holder) - jumped away awkwardly.

AMERICAN STAR (D. Tourneur) – approaching the 800 metres became very awkward inside the heels of VIDDORA, which initially shifted in of its own accord and was then taken in slightly by MYSTIC MOON. As a consequence D. Tourneur was obliged to restrain his mount for several strides to avoid the heels of VIDDORA.

VIDDORA (J. Bowditch) – approaching the 800 metres shifted in initially of its own accord tightening AMERICAN STAR and thereafter was taken in slightly by MYSTIC MOON. J. Bowditch was severely reprimanded and advised to take greater care when shifting ground in future.

RACE 2 : UBET HANDICAP - 1050 metres (cont'd)

MYSTIC MOON (M. Neilson) – inside the 800 metres shifted in taking VIDDORA inwards for several strides. M. Neilson reminded of his obligations when shifting ground in future.

MAGNUS KNIGHT (J. Toeroek) – held up for clear running from in the vicinity of the 400 metres until the entrance to the straight and again inside the 100 metres for a number of strides.

RACE 3 : QUAYCLEAN HANDICAP - 1200 metres

COACHELLA (NZ) (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

SHEEZ ON TOP (J. Childs) – raced wide without cover throughout the event.

TRUPT (T. Pannell) – in the vicinity of the 500 metres became awkward on the heels of TAHNI DANCER for several strides and had to be restrained. A post-race veterinary examination revealed signs of colic. First aid administered.

CHATEAU CHEVAL (M. Neilson) – over-raced in the early stages of the event.

PINKY TUSCADERO (P. Gatt) – jumped away very awkwardly and as a consequence was slow to begin.

RACE 4 : SCHWEPPE HANDICAP - 1100 metres

LAST DAY (NZ) (C. Jones) – contacted at the start.

TENERE (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

CALIANCO (R. Hurdle) – inconvenienced in the vicinity of the 800 metres when contacted by REGAL SPUR, which shifted out.

EL PRADO GOLD (J. Childs) - jumped away awkwardly, shifted out and contacted LAST DAY (NZ).

JUST KAPPY (P. Gatt) - jumped away awkwardly, shifted out and inconvenienced CASH IS COMING. A post-race veterinary examination revealed no visible abnormalities.

REGAL SPUR (T. Pannell) – raced very keenly in the early stages, shifted out approaching the 800 metres and contacted CALIANCO. T. Pannell explained the gelding raced very fresh, pulled very hard, was difficult to restrain and in an attempt to position himself towards the outside of the field in the vicinity of the 800 metres, he shifted out but the gelding over-reacted and shifted out abruptly contacting CALIANCO. A post-race veterinary examination revealed no visible abnormalities.

CASH IS COMING (C. Lindop) – inconvenienced at the start.

RACE 5 : ADELAIDE GALVANISING HANDICAP - 2000 metres

GLADSTONE (D. Pires) - underwent a pre-race veterinary examination and was passed fit to race. D. Pires explained the gelding was able to settle forward as it did in its previous start, travelled well but in the vicinity of the 400 metres was off the bridle, did not finish the event off and was disappointing in its performance. A post-race veterinary examination revealed no visible abnormalities.

STIMULATTE (J. Kah) - a post-race veterinary examination revealed no visible abnormalities. In the vicinity of the 500 metres the gelding attempted to savage TENACITUS (USA) on two separate occasions. Trainer, Mr G. Richards was advised a warning had been placed on the gelding in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

MISS WYNETTE (P. Gatt) – P. Gatt pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

MR LAMBORGHINI (A. Doyle) – A. Doyle accidentally dropped his whip in the vicinity of the 300 metres and was reprimanded.

RACE 6 : FARMERS UNION ICED COFFEE MANIHI CLASSIC - 1100 metres

RIZIZ (C. Jones) – awkward to begin, shifted out and inconvenienced OKAHU BAY.

EXCLUSIVE LASS (L. Meech) – shifted out approaching the 500 metres and tightened COULDN'T AGREEMORE onto THE MESSINA NYMPH resulting in M. Neilson having to restrain his mount for several strides to avoid the heels of EXCLUSIVE LASS and losing his position. Shortly after the entrance to the straight, was eased out of the event. L. Meech reported she became concerned with the mare's action and for that reason did not persist with her riding in the straight. L. Meech pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Monday, 11 April, and to conclude at midnight on Wednesday, 20 April 2016: a period of four (4) meetings. A post-race veterinary examination revealed no visible abnormalities.

COULDN'T AGREEMORE (M. Neilson) – tightened by EXCLUSIVE LASS onto THE MESSINA NYMPH approaching the 500 metres, had to be restrained and lost its position.

OKAHU BAY (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

TARCO (J. Holder) - jumped away awkwardly, shifted out and tightened DAYTONA GREY onto I AM GYPSY, which was tightened onto NOSTRADAMUS, resulting in all three runners being inconvenienced.

NORTHERN ZHAR (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

SOOBOOG (J. Noonan) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7 : LAELIA STAKES - 1600 metres

THAMES COURT (L. Meech) – L. Meech reported in her opinion the filly jarred up during the event. Obligated to be checked approaching the 400 metres to avoid the heels of OPTIMIZE, which shifted out and lost its position. A post-race veterinary examination revealed no visible abnormalities.

BELUGA BLUE (C. Lindop) – over-raced in the early stages of the event.

SAILING BY (J. Noonan) – shifted in approaching the 1200 metres and inconvenienced BALLYBRIT, which had to be steadied. J. Noonan was reprimanded and advised to take greater care when shifting ground in future.

C'EST BEAU LA VIE (J. Holder) – lost its near fore plate during the event.

COERCED WITNESS (E. Finnegan) - jumped away awkwardly.

BALLYBRIT (J. Bowditch) – approaching the 1200 metres was obliged to be steadied when SAILING BY shifted in. J. Bowditch reported in his opinion the filly got galloped on behind during the event. A post-race veterinary examination revealed no visible abnormalities.

SCRUM (P. Gatt) - jumped away awkwardly, shifted in and contacted THAMES COURT, which was tightened onto CONCUBINE.

STREET SPUN (J. Payne) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

OPTIMIZE (J. Toeroek) – J. Toeroek reported the filly hung in throughout the event. Approaching the 400 metres shifted out to improve across the running of THAMES COURT, which had to be checked. A post-race veterinary examination revealed no visible abnormalities. J. Toeroek was found guilty of a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 13 April and to conclude at midnight on Wednesday, 20 April 2016: a period of three (3) meetings.

RACE 8 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1600 metres

EMMOOKI'S DASH (J. Toeroek) – rolled out approaching the 1200 metres and contacted ILOVEWHATSEBRINGS, which had its hindquarters turned.

RACE 8 : HUGHES CHAUFFEURS LIMOUSINES HANDICAP - 1600 metres (Cont'd)

ILOVEWHATSEBRINGS (T. Pannell) – approaching the 1200 metres was contacted by EMMOOKI'S DASH, which rolled out, had its hindquarters turned, became unbalanced and thereafter raced wide without cover in the middle stages of the event. Lost its off fore plate during the event. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race. First aid administered.

KINGSGROVE (E. Finnegan) – E. Finnegan reported her mount felt awkward in its action during the event.
