RACE 1 : REQUEST RECRUITMENT / SABOIS MAIDEN PLATE - 906 metres

The start of this event was delayed approximately five minutes.

NEVER WITHOUT YOU (S. Cahill) - A post-race veterinary examination revealed lacerations to the near hind leg.

BRIMARVI EQUIADA (J. Toeroek) – shifted out and away from the semaphore board approaching the finish of the event.

CLEVER TOMMY (R. Hurdle) - jumped away awkwardly.

ALEXIS JET (K. Brooks) - slow to begin.

REYIA (T. Pannell) – became cast in its barrier after being loaded. Underwent a pre-race veterinary examination which ruled the filly unfit to race. Acting on this advice Stewards withdrew REYIA AT 1.08 pm. Trainer advised that the filly would be required to perform tractably in an Official Barrier Trial prior to accepting for a future race.

RACE 2 : RSL / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1206 metres

DAPPER AFTER DARK (J. Toeroek) – raced greenly throughout the event.

JUST LIVE ON (S. Cahill) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

LONDOSTAR (J. Kah) – laid out under pressure in the straight.

AZTEC PRIESTESS (J. Bowditch) - slow to begin. Held up from the vicinity of the 500 to the vicinity of the 300 metres.

KEMERI (M. Neilson) – rider reported he had become concerned with that filly's action in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 2 : RSL / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1206 metres (Cont'd)

MAGNUS MAGIC (J. Holder) – rider explained the filly travelled well in the early and middle stages of the event, however, when placed under pressure had failed to respond to his riding and in his opinion had raced flat. A post-race veterinary examination revealed no visible abnormalities.

RACE 3 : SAMBEC SHEDS / SABOIS MAIDEN PLATE - 1406 metres

PLATINUM SET (R. Hurdle) - jumped away awkwardly and shifted in onto SIXTEEN AGAIN. Raced greenly and was inclined to shift about throughout the event and in the vicinity of the 1200 metres shifted in and made contact with the running rail. A post-race veterinary examination revealed no visible abnormalities.

SAVANETA (D. Tootell) - slow to begin.

SIXTEEN AGAIN (C. Lindop) – hampered on jumping away.

RACE 4 : CLARKE GRAIN / RURALCO PROPERTY BENCHMARK 60 HANDICAP - 2210 metres

DUMOSA (B. Griffiths) – wide without cover throughout the event. Taken wider approaching the 500 metres by POWER GLEN. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. First aid administered. Veterinary Certificate of Fitness required prior to trial or race.

POWER GLEN (C. Jones) – laid out approaching the 500 metres onto DUMOSA, which was taken wider.

GOT THE EDGE (J. Toeroek) - slow to begin. Rolled in marginally approaching the 500 metres. A post-race veterinary examination revealed a laceration to the near hind fetlock consistent with being galloped on. First aid administered.

BUYMEBYCHANCE (J. Bowditch) – over-raced in the early and middle staged of the event.

LOUISIANA (R. hurdle) –in the vicinity of the 500 metres had to be checked off the heels of GOT THE EDGE, which rolled in marginally at the same time as POWER GLEN laid out onto DUMOSA, taking that gelding wider. A post-race veterinary examination revealed no visible abnormalities.

RACE 5 : GUILIO & CARMELA GRANDE MEMORIAL CLASS ONE HANDICAP - 1406 metres

RITZY (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

MAPPINGA PRINCE (M. Neison) – rider became concerned with the gelding's action in the vicinity of the 600 metres and for this reason eased the gelding from the event. A post-race veterinary examination revealed no visible abnormalities. Trainer advised that the gelding would be required to trial competitively in an Official Barrier Trial prior to accepting for a future race.

RED FAIRARIE (S. Cahill) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

SHARK MIRAGE (D. Tootell) - jumped away awkwardly.

ARWA (D. Tourneur) – laid in under pressure in the straight.

EMCEECEE (R. Hurdle) – commenced to buck shortly after the start dislodging R. Hurdle. Trainer advised the gelding would be required to perform tractably in two Official Barrier Trials prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

RACE 6 : REMEMBERING BEERSHEBA DAY BENCHMARK 70 HANDICAP - 1406 metres

The start of this event was delayed approximately four minutes owing to D. Tourneur being unable to conform to standards required under AR87 in relation to his helmet and was replaced by B. Griffiths.

WISE JOURNEY (Z. Spain) – inconvenienced on jumping away. Raced keenly in the early and middle stages of the event.

EDGEWOOD (J. Kah) - jumped away awkwardly and shifted in inconveniencing WISE JOURNEY.

SVETSKI (S. Cahill) – rider reported he became concerned with that gelding's action in the early stages of the straight and for that reason had not ridden out in his normal manner. A post-race veterinary examination revealed a small skin laceration to the medial heel on near foreleg.

FLASK (A. Doyle) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7 : NEIL TANNER MEMORIAL BENCHMARK 64 HANDICAP - 1606 metres

BIANMAGIC (M. Poon) – rolled in slightly in the vicinity of the 500 metres. A post-race veterinary examination revealed a slow recovery rate and abnormal respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

SUPER HAZE (IRE) (P. Gatt) – raced in restricted room for a short distance in the vicinity of the 300 metres to the outside of MAGGIE'S CALL, which had been taken out slightly by SOME DO, which rolled out. A post-race veterinary examination revealed no visible abnormalities.

BEAU ACRE (Z. Spain) - slow to begin. Raced keenly in the early and middle stages of the event.

RIGHT AND READY (J. Holder) – reared on jumping away.

CLAY PAVER (T. Zanker) – raced wide without cover throughout the event. In the vicinity of the 500 metres had to steady when BIANMAGIC rolled in slightly.

ZABROCK (NZ) (B. Griffiths) - a post-race veterinary examination revealed a slower than expected recovery rate.

RACE 8 : CAWTE INDUSTRIES JOHN STOCKER MEMORIAL BENCHMARK 64 HANDICAP
- 1206 metres

MISS MARGARITA (D. Tourneur) - jumped away awkwardly.

LADY HEDERAJ (J. Kah) – raced wide without cover throughout the event.

NIMASAEL (P. Gatt) – rider became concerned with the mare's action in the straight. A post-race veterinary examination revealed no visible abnormalities.

EXALTED APPEAL (A. Doyle) - jumped away awkwardly and was slow into stride.

DAMAGE CONTROL (D. Tootell) – inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.
