**RACE 1 : SPORTSBET STEEPLECHASE - 3340 metres**

**NISHIAZABU** (P. Hamblin) – momentarily inconvenienced in the vicinity of the 800 metres. A post-race veterinary examination revealed no visible abnormalities.

**BOLD ZAMOUR (NZ)** (S. Jackson) - in the vicinity of the 800 metres shifted out to improve and in doing so inconvenienced NISHIAZABU.

Following this race, all horses were inspected by the Club's Veterinary Surgeons who reported no visible abnormalities.

**RACE 2 : SCHWEPPE'S BENCHMARK 120 HURDLE – 3340 metres**

**BAKLAVA BOY (NZ)** (T. Ryan) – jumped the fourth hurdle awkwardly, shifted out and bumped DIVI FILIUS. A post-race veterinary examination revealed the gelding to be lame in both forelegs. Veterinary Certificate of Fitness required prior to trial or race.

**BLAKELEY** (N. O'Shea) - slow to begin.

**CELTIC PRINCE (NZ)** (R. Cully) – jumped the fifth hurdle awkwardly.

**DIVI FILLIUS** (S. Jackson) – when jumping the fourth hurdle was hampered after BAKLAVA BOY (NZ) shifted out. A post-race veterinary examination revealed no visible abnormalities.

Following this race, all horses were inspected by the Club's Veterinary Surgeons who reported no visible abnormalities.

**RACE 3 : ANZAC APPEAL / SABOIS DISTANCE MAIDEN PLATE – 2100 metres**

**BUDJIROO** (B. Griffiths) – severely hampered when making the crossing at the 1800 metres. Rider was reprimanded under AR37A(4)(c) in that he used his whip when his horse was out of contention. A post-race veterinary examination revealed no visible abnormalities.

**KING OF SIAM (NZ)** (K. Brooks) - hampered on jumping away.

**PRINCE OF PAGODA (NZ)** (D. Tourneur) – began awkwardly, shifted out and hampered KING OF SIAM (NZ).

### **RACE 3 : ANZAC APPEAL / SABOIS DISTANCE MAIDEN PLATE – 2100 metres (Cont'd)**

**DE LA CRUZ** (J. Bowditch) – Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. A post-race veterinary examination revealed no visible abnormalities.

**AALI MIA** (Z. Spain) - a post-race veterinary examination revealed lacerations to the near hind cannon. First aid administered.

**OCTOBER DAWN** (E. Finnegan) – over-raced in the early stages of the event. Became awkward when making the crossing at the 1800 metres, shifted in and severely hampered BUDJIROO.

### **RACE 4 : 50<sup>TH</sup> ANNIVERSARY OF THE BATTLE OF LONG TAN / SABOIS MAIDEN PLATE** **- 1200 metres**

**BOOST THE MOOSE** (C. Jones) - underwent a pre-race veterinary examination as the gelding had not raced for twelve months and passed fit to race. Slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**HOLY TRILOGEY** (J. Toeroek) – over-raced in the early stages of the event.

**RUFINSON** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

**MINTINI** (T. Pannell) - trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards.

**COMPELTE CLASS** (C. Lindop) – laid in when placed under pressure over the concluding stages.

**FIRSTEE** (R. Hurdle) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300

**SEATTLE FLIGHT** (E. Finnegan) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 5 : OPERATION K9 / CRABB SHELLGRIT BENCHMARK 60 HANDICAP - 1100 metres**

**KARADOC KID** (J. Bowditch) – laid out when placed under pressure over the concluding stages.

**LEXGETREDDY** (J. Kah) - Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards.

**SOCIAL MEDIA** (K. Brooks) – reared on jumping away and raced fiercely in the early stages of the event.

**SPARTAN WARRIOR** (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities. Stewards opened an enquiry into the riding and tactics adopted in the race. Evidence was taken from rider D. Tourneur and Trainer Mr G. Young before Stewards adjourned the enquiry for a date and time to be advised.

### **RACE 6 : RSL CENTENARY / ADELAIDE GALVANISING CLASS ONE HANDICAP - 1200 metres**

**ARAVALLI** (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

**ROYAL MINT (NZ)** (J. Bowditch) – began awkwardly, shifted in and hampered SELANTE.

**GAME BREAKER** – late scratching on veterinary advice at 1.58 pm after found to be lame in both forelegs. Trainer advised Veterinary Certificate of Fitness required prior to trial or race.

**ENCHANTING BEAUTY** (C. Lindop) – began awkwardly, shifted out and hampered SELANTE. Hung out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

**SELANTE** (D. Tourneur) – hampered at the start.

**RACE 7 : GALLIPOLI 1915 PERPETUAL TROPHY - 1700 metres**

**TIDY PROPHET** (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

**AWARD OF MERIT** (D. Tourneur) – held up for clear running in the vicinity of the 400 metres and shifted out to obtain clear running.

**PERPETUAL BLISS** (E. Finnegan) – raced wide without cover throughout the event. In the vicinity of the 400 metres was momentarily hampered when avoiding the heels of AWARD OF MERIT, which shifted out to improve.

**RACE 8 : WESTERN FRONT 1916 / GOLDIN FARMS BENCHMARK 60 HANDICAP - 1500 metres**

**DANOULI** (J. Bowditch) – over-raced in the middle stages of the event.

**MIGHTY MAHER** (P. Gatt) - slow to begin.

**RAIN ATTACK** (B. Griffiths) – held up for clear running in the straight and was not able to be fully tested at any stage over the concluding stages.
