STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 21 May 2016

TRACK: Good 4 (*Upgraded to Good 3 @ 11.18 am*)

WEATHER: Fine

RAIL: Out 4 metres 1200m to 700m, 5 metres 700m to Winning Post, 2 metres remainder.

RACE 1 : QUAYCLEAN NATIONAL STAKES - 1200 metres

RATA TAT TAT (S. Arnold) – raced keenly in the early and middle stages of the event.

DISSOLUTE (C. Williams) – raced wide without cover throughout the event. Rider explained that despite being caught wide without cover, the colt had travelled well in the early and middle stages of the event, however, when placed under pressure at the entrance to the straight, had only responded for a short distance and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

POSH JOURNEY (R. Hurdle) – laid in under pressure in the straight and in the vicinity of the 100m shifted in onto SOMETHING MORE, contacting that filly's hindquarters, turning it out, resulting in both runners being inconvenienced. A post-race veterinary examination revealed mild tying up in the hindquarters.

SOMETHING MORE (J. Cartwright) – jumped away awkwardly and was slow into stride. Inconvenienced in the vicinity of the 100m when its hindquarters were contacted.

RACE 2 : MITTYS PORT ADELAIDE CUP - 2500 metres

The start of this race was delayed approximately two minutes.

SENSE OF OCCASION (N. Hall) – laid in, in the vicinity of the 700m, inconveniencing FALAGO. Unable to maintain its position at the entrance to the straight when racing in restricted room between UNGRATEFUL ELLEN and MASTER ZEPHYR (GB). Laid in under pressure in the straight.

FALAGO (B. Rawiller) – inconvenienced in the vicinity of the 700m. Rounding the home turn had to be checked off the heels of MASTER ZEPHYR (GB), which rolled in marginally, at the same time as SENSE OF OCCASION was taken out slightly by UNGRATEFUL ELLEN.

MASTER ZEPHYR (GB) (D. Yendall) – rolled in marginally rounding the home turn onto FALAGO.

UNGRATEFUL ELLEN (D. Dunn) – rolled out marginally rounding the home turn onto SENSE OF OCCASION.

ADIRONDACK (C. Newitt) – raced keenly in the early and middle stages of the event.

RIVER'S LANE (T. Pannell) – had to be steadied in the vicinity of the 500m when ZAYAK shifted out. Had difficulty obtaining clear ground from the entrance to the straight until approaching the 100m.

SNOW SECRET (NZ) (S. King) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2 : MITTYS PORT ADELAIDE CUP - 2500 metres (Cont'd)

ZAYAK (L. Meech) – raced keenly in the early and middle stages of the event. Held up from the vicinity of the 600m until near the 300m. Shifted out slightly in the vicinity of the 500m onto RIVER'S LANE. L. Meech pleaded guilty to a charge of Careless Riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 22 May and to conclude at midnight on Wednesday, 1 June 2016; a period of four (4) meetings.

RACE 3 : UBET SA FILLIES CLASSIC - 2500 metres

The start of this race was delayed approximately two minutes.

ASHLEE MARIE (C. Newitt) – tightened onto CHABAUD (NZ) on jumping away.

VANDANCER (NZ) (M. Zahra) – obliged to alter course in the vicinity of the 200m when it improved onto the heels of CONCUBINE.

SHE'S GOT SPEED (J. Winks) – kicked out in its barrier after being loaded. A pre-race veterinary examination ruled the filly fit to race. A post-race veterinary examination revealed no visible abnormalities.

TEOFLYTE (S. King) – shifted out on jumping away onto ASHLEE MARIE.

ENSUING (S. Baster) – fractious in barriers after being loaded, opening front panel of gate. A pre-race veterinary examination ruled the filly fit to race. Raced keenly in the early and middle stages of the event.

ALITTLE LOOSE (C. Williams) – raced wide without cover throughout the event.

CONCUBINE (D. Lane) - a post-race veterinary examination revealed no visible abnormalities.

DASHEBO (T. Pannell) – jumped away awkwardly.

Correct Weight for this event was delayed to allow C. Lindop (BELUGA BLUE) placed fourth, and Co-Trainers Messrs. L. Macdonald and A. Gluyas, to view the official footage in the straight.

RACE 4 : MAC DRINK DRIVING? GROW UP CENTAUREA STAKES - 2015 metres

INTO THE MIST (D. Dunn) – rider reported that he had settled closer to the speed than anticipated and when placed under pressure in the vicinity of the 600m, the mare failed to respond to his riding and in his opinion may not have appreciated the step up in distance. A post-race veterinary examination revealed no visible abnormalities.

FELICIENNE (B. Rawiller) – rider reported the mare became awkward in its action in the vicinity of the 1800m and had not been comfortable for the remainder of the event. Lost off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

INISHOWEN (D. Moor) – under pressure in the vicinity of the 700m and weakened from the event. Rider reported he could not fault the mare's action, however, INISHOWEN was unable to maintain contact with the field. The stable advised the mare would now be retired. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Co-Trainer Mr. L. Freedman was advised a Veterinary Certificate of Fitness would be required prior to presenting for a future race.

SURE YOU CAN (NZ) (D. Lane) – shifted out at the entrance to the straight onto JOYFUL JOURNEY. D. Lane was reminded of his obligations when shifting ground in future. Inclined to lay in under pressure in the straight.

COACHELLA (NZ) (D. Tourneur) – lost its near hind plate during the event.

JOYFUL JOURNEY (S. Baster) – had to be momentarily steadied at the entrance to the straight when SURE YOU CAN (NZ) shifted out.

RACE 5 : ROBERT & FAY GERARD R A LEE STAKES - 1600 metres

PRINCE OF PENZANCE (NZ) (M. Payne) – raced wide without cover throughout the event.

ALPINE EAGLE (M. Zahra) - a post-race veterinary examination revealed no visible abnormalities.

KINGDOMS (NZ) (C. Newitt) – Trainer Mr. M. Hickmott advised Stewards he would instruct rider to attempt to ride more positively today. Raced keenly in the early and middle stages of the event. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

FLOW METER (S. King) – raced wide without cover throughout the event.

Following this race D. Yendall was examined by the First Care Medical personnel, who ruled him unfit to fulfil his remaining engagements.

RACE 6 : UBET PROUD MISS STAKES - 1200 metres

The start of this race was delayed approximately two minutes.

I LOVE IT (S. Baster) – had to check in the vicinity of the 200m when PRIVATE SECRETARY shifted out. A post-race veterinary examination revealed no visible abnormalities.

THE MESSINA NYMPH (N. Hall) – unbalanced when contacted by FORGERESS at the entrance to the straight. A post-race veterinary examination revealed an elevated heart rate.

RUNWAY STAR (D. Tourneur) – shifted out shortly after entering the straight and brushed with ANDRASSY for a number of strides.

MY POPPETTE (M. Zahra) – contacted inside the 100m by KAYJAY'S JOY, which laid out.

PRIVATE SECRETARY (C. Williams) – held up from the vicinity of the 500m until near the 300m. Shifted out in the vicinity of the 200m into the running line of I LOVE IT, which had to check. C. Williams pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 22 May and to conclude at midnight on Wednesday, 1 June 2016; a period of four (4) meetings. Shifted out approaching the finish into the running line of KAYJAY'S JOY, which had to be checked. C. Williams pleaded guilty to a charge of Careless Riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 22 May and to conclude at midnight on Sunday, 5 June 2016; a period of six (6) meetings. Acting under AR196(3), Stewards deemed the suspensions be served concurrently. Rider reported the mare was inclined to hang out in the straight. A post-race veterinary examination revealed no visible abnormalities.

KAYJAY'S JOY (D. Lane) – laid out inside the 100m and brushed with MY POPPETTE. Shortly after had to be checked to avoid the heels of PRIVATE SECRETARY.

FORGERESS (J. Berriman) – shortly after entering the straight shifted out to improve and bumped THE MESSINA NYMPH.

RATIONALITY (J. Winks) - a post-race veterinary examination revealed no visible abnormalities.

CASH IS COMING (C. Lindop) – refused to load. Withdrawn by Stewards at 3.47 pm. Trainer Mr. K. Sweeney was advised the mare would be required to prove it can load without delay in an Official Barrier Trial prior to accepting for a future trial.

RACE 7 : DARLEY GOODWOOD - 1200 metres

The start of this race was delayed approximately three minutes.

FLAMBERGE (D. Lane) - a post-race veterinary examination revealed no visible abnormalities.

BLACK HEART BART (B. Rawiller) – laid out under pressure in the straight.

RACE 7 : DARLEY GOODWOOD - 1200 metres (Cont'd)

CHURCHILL DANCER (N. Hall) – shifted in on jumping away. A post-race veterinary examination revealed no visible abnormalities.

BIG MONEY (R. Thompson) – hampered on jumping away when tightened between SUPER ONE and CHURCHILL DANCER.

SMOKIN' JOEY (C. Newitt) – inclined to rear on jumping away and slow into stride.

NOSTRADAMUS (D. Tourneur) – raced wide without cover throughout the event.

SUPER ONE (D. Moor) – shifted out on jumping away.

SOOBOOG (C. Williams) – raced keenly in the early and middle stages of the event.

RACE 8 : STAMFORD HOTELS HANDICAP - 1200 metres

The start of this race was delayed approximately four minutes.

ILGATTINO (M. Zahra) – shifted out on jumping away onto TELOPEA (GB). Raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground in the straight.

TIPPERARY LIL (S. Cahill) – inclined to lay in under pressure in the straight.

CALIANCO (J. Cartwright) – tongue tie had to be re-fitted on arrival at the barriers. From the vicinity of the 300m was reluctant to improve into a tight run between MUBAKKIR and MR LIBERTY and in the vicinity of the 100m had to be steadied momentarily when MUBAKKIR rolled out under pressure.

COUNTER PULSE (C. Lindop) - a post-race veterinary examination revealed mild heat stress and a poor recovery.

TELOPEA (GB) (B. Rawiller) – lost its position on jumping away when tightened onto MANHATTAN BLUES by ILGATTINO.

LYRIC (S. Arnold) – rider reported he was concerned with the gelding's action and for that reason did not ride it out to the finish. A post-race veterinary examination revealed no visible abnormalities. Trainer Mr. G. Hickman was advised a warning had been placed on the gelding in relation to it being uncompetitive.

SHACARDE (D. Dunn) – jumped away awkwardly and shifted in.

TRUPT (T. Pannell) – hampered on jumping away by SHACARDE.

GENERAL:

Stewards questioned Apprentice J. Cartwright regarding him leaving the course without seeking permission from the Stewards. He pleaded guilty to a charge under AR91 and was fined \$200.

RACE 3 : UBET SA FILLIES CLASSIC - 2500 metres

Trainer Mr. M. Kent was fined \$400 under AR140B(3) for failing to advise a gear change for ALITTLE LOOSE by acceptance time, being the addition of visors.

RACE 5 : ROBERT & FAY GERARD R A LEE STAKES - 1600 metres

Trainer Mr. T. McEvoy was fined \$200 under AR140B(3) for failing to advise a gear change for ALPINE EAGLE by acceptance time, being the addition of hoof pads to the front feet only.
