Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 18 June 2016

RACE 1 : UBET HANDICAP - 2500 metres

SPANISH HALO (NZ) (J. Holder) - underwent a pre-race veterinary examination on arrival on course and again at the barriers and passed fit to race.

YOUL DASH FOR CASH (M. Neilson) – shifted in approaching the 2000 metres when insufficiently clear of **BABY BOY** resulting in that horse having to be checked to avoid the heels of **YOUL DASH FOR CASH**. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 29 June, and to conclude at midnight on Wednesday, 6 July 2016: a period of three (3) meetings.

BABY BOY (C. Lindop) – forced to check approaching the 2000 metres to avoid the heels of **YOUL DASH FOR CASH**, which shifted in. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

RACE 2 : PETER ELBERG FUNERALS HANDICAP - 1050 metres

PRINCE GOBLET (J. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

TEQUILA FLYER (P. Gatt) – began awkwardly and was slow into stride. Raced greenly and commenced to hang out from the 600 metres. Shifted out rounding the home turn taking **ARTFUL JACK** wider. A post-race veterinary examination revealed no visible abnormalities.

ARTFUL JACK (R. Hurdle) – hampered and taken wider rounding the home turn by **TEQUILA FLYER**. Laid in, in the straight.

NEVER BE DISCREET (D. Tourneur) – raced greenly from inside the 800 metres, laid in and became awkward on the heels of **AENGUS** for a number of strides. Thereafter shifted in and as a consequence hampered **WILLOCHRA**, which had to be steadied.

WILLOCHRA (T. Pannell) – hampered inside the 800 metres and obliged to be steadied.

RACE 3 : JAMES BOAG'S PREMIUM HANDICAP - 2038 metres

GALLATIN (Z. Spain) – Change of tactics - Trainer Mr J. Macmillan advised he would instruct his rider to attempt to settle forward of mid-field if possible. Rider reported that despite his efforts in the early stages of the event was unable to take up a more forward position as intended. Laid out in the straight from shortly after the entrance to the straight until near the 100 metres and shifted ground approaching the 200 metres. A post-race veterinary examination revealed an elevated heart rate.

SOHOOL (M. Neilson) – rider explained he was comfortable with the position he obtained in running and had cover behind CHU CHU CHARLIE in the early and middle stages of the event. He added the colt was on and off the bridle throughout the event, failed to respond to his riding in the straight and finished the race off in a very disappointing manner. A post-race veterinary examination revealed a slow recovery.

CHU CHU CHARLIE (C. Lindop) – Change of Tactics – Trainer Mr R. Daniel advised he would instruct his rider to attempt to settle forward of mid-field with cover if possible and not lead.

MAGNAZONE (H. McKechnie) - rider reported after being a little slow to begin the gelding pulled hard in the early stages of the event.

IN TAIPEI (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4 : CHAIRMAN BOB'S 70TH BIRTHDAY BASH HANDICAP - 1600 metres

KEMERI (C. Lindop) – eased out in the vicinity of the 500 metres. Rider explained she felt something amiss with the filly and for that reason did not persevere with her ride in the vicinity of the 500 metres. A post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the filly performing satisfactorily in an Official Barrier Trial.

OCTOMINT – a late scratching at 8.08 pm by order of Stewards acting on confirmed advice from Trainer Mr K. Sweeney that the gelding was lame in the near foreleg.

RACE 5 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1100 metres

HEARTZ ABALZE (M. Poon) - jumped away awkwardly, shifted out and contacted BIG EFFORT. Rider explained his instructions were to allow the filly to settle where comfortable but added HEARTZ ABLAZE never travelled during the event and finished the race off in a disappointing manner. A post-race veterinary examination revealed no visible abnormalities.

BIG EFFORT (P. Gatt) – contacted at the start and obliged to steady in the vicinity of the 1000 metres. Lost its near fore plate during the event.

KIFAAH (M. Neilson) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

MAGNUS KNIGHT (T. Pannell) – shifted in, in the vicinity of the 1000 metres and inconvenienced BIG EFFORT, which had to be steadied. As a consequence MYSTICANO, which was following became awkward on the heels of BIG EFFORT for a number of strides. Rider reprimanded and advised to take greater care when shifting ground in future.

MYSTICANO (J. Maund) – shifted out at the start and contacted ROTHMOORE. In the vicinity of the 1000 metres became awkward on the heels of BIG EFFORT for a number of strides.

ROTHMOORE (R. Hurdle) – contacted at the start. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

MAGNUS MAGIC (E. Finnegan) – rider reported the filly felt lame in both forelegs. A post-race veterinary examination revealed a lower than expected heart rate.

RACE 6 : SCHWEPES HANDICAP - 1200 metres

TILDY LAD (J. Maund) – hampered for a number of strides in the vicinity of the 1000 metres.

SPINNING DIAMOND (J. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

BREATHE FREE (J. Toeroek) - jumped away awkwardly and contacted SULLIVAN BAY.

SULLIVAN BAY (M. Neilson) – contacted at the start. Approaching the 800 metres shifted in and hampered TILDY LAD for a number of strides, which had to be steadied. Rider reprimanded and advised to take greater care when shifting ground in future.

RACE 7 : IRISH RACE DAY 27 AUGUST HANDICAP - 1600 metres

ARCTIC SONG (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

MULLINGER LANE (D. Caboche) – hampered approaching the 200 metres.

WICKED TYCOON (J. Cartwright) - hampered approaching the 200 metres and contacted the hindquarters of THE NIGHT SKY and shortly thereafter contacted TRUPT.

BRIMMING (P. Gatt) – taken in, inside the 300 metres then commenced to lay in and shifted in onto DANOULI taking that horse inwards.

TRUPT (M. Poon) – held up for clear running shortly after entering the straight and approaching the 200 metres was contacted by WICKED TYCOON, was hampered and had to be steadied.

THE NIGHT SKY (T. Pannell) – Trainer reprimanded under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Hindquarters contacted and turned approaching the 200 metres. Lost its off fore plate during the event.

MONOPOLE (J. Holder) – shifted in, in the vicinity of the 300 metres taking BRIMMING inwards which was tightened onto other runners. Rider was severely reprimanded.

DANOULI (R. Hurdle) – held up for clear ground from the 500 metres until near the 300 metres when being taken in by BRIMMING making contact with MULLINGER LANE.

RACE 8 : HOLDFAST INSURANCE HANDICAP - 1100 metres

The start of this event was delayed approximately three minutes owing to the delay of the horses leaving the mounting yard.

REGAL SPUR (D. Caboche) – approaching the 200 metres attempted a run to the outside of SHAHQU, which rolled out. As a consequence REGAL SPUR was obliged to shift out and in doing so contacted CONCENTRATE, which was hampered when tightened onto GOLDEN CENTURY, which rolled in.

VICEROY (R. Hurdle) – held up for clear running from approximately the 150 to the 100 metres.

WAPPING – a late scratching by order of Stewards at 3.21 pm acting on Veterinary advice that the gelding had struck its head in the float en route to the course and had blood present in its near side nostril.

IDATWO (T. Pannell) – lost its off fore plate during the event.

MISTER ROCKSTAR (M. Poon) - a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Veterinary Certificate of Fitness required prior to trial or race.

CONCENTRATE (Z. Spain) – contacted in the vicinity of the 200 metres.

DOWNS AFTER DARK – a late scratching at 7.40 am by order of Stewards, explanation accepted.
