RACE 1 : AUSTRALIAN RAIL TRACK CORPORATION & JACK FULLERTON MEMORIAL
BENCHMARK 72 HANDICAP - 1200 metres

BAITON (K. Brooks) – inclined to lay out under pressure in the straight. A post-race veterinary examination revealed thumps. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

RACE 2 : CENTURY 21 PORT AUGUSTA / SABOIS MAIDEN PLATE - 1200 metres

The start of this event was delayed approximately thirteen minutes owing to a power outage.

BONSTAR EXPRESS (L. Stojakovic) – shifted in on jumping away onto MISS SEAL LINE.

MONICA'S MACHINE (T. Pannell) – taken out on jumping away onto MISS SEAL LINE.

RONDAFERRO (Jemma Frew) – shifted out on jumping away onto MONICA'S MACHINE.

MISS SEA LINE (K. Brooks) – rider was permitted to ride this filly at its weight rather than her minimum riding weight as there was no other rider available on course. Jumped away awkwardly was buffeted between BONSTAR EXPRESS and MONICA'S MACHINE for a number of strides and lost its position. Raced keenly in the early and middle stages of the event.

ZARINGAL – a late scratching at 12.05 pm as there was no available rider.

RACE 3 : ADELAIDE GALVANISING BENCHMARK 60 HANDICAP - 1867 metres

KIWI COLLEEN (NZ) (T. Pannell) – rider reported the mare was not comfortable in its action throughout the event. A post-race veterinary examination revealed no visible abnormalities.

LITTLE AUDREY (K. Brooks) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100.

DESDANE (Jemma Frew) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : MILHINCH HOURGLASS JEWELLERS BENCHMARK 72 HANDICAP
- 1498 metres

LIBERTY HILL (K. Brooks) – raced keenly in the early and middle stages of the event.

RACE 5 : MAX CRANES BENCHMARK 56 HANDICAP – 1600 metres

SELDOM HOME (J. Potter) - slow to begin.

MORE PLEASE (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

MAGGIE'S CALL (A. Doyle) - slow to begin. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

PILOT'S LANE (T. Pannell) - slow to begin.

TICKLE ME ERNIE (Z. Spain) - slow to begin.

RACE 6 : AUGUSTA AUTOMALL BENCHMARK 56 HANDICAP - 1396 metres

TALE BLAZER (L. Stojakovic) - jumped away awkwardly.

DECOMPRESSION (Jemma Frew) - jumped away awkwardly.

RACE 7 : CITY OF PORT AUGUSTA CUP - 2300 metres

The start of this event was delayed approximately two minutes.

MILKWOOD (J. Frew) – rider reported in his opinion the mare had not handled the track. A post-race veterinary examination revealed no visible abnormalities.

NOT A ZEPRISE (T. Pannell) - rider reported the gelding had not stretched out at any stage throughout the event and was under pressure in the vicinity of the 1200 metres. A post-race veterinary examination revealed no visible abnormalities.

DEVON (B. Griffiths) - laid out rounding the home turn and under pressure in the straight. In the vicinity of the 200 metres shifted out onto BUYMEBYCHANCE, which was inconvenienced when tightened onto NEW EMPIRE. A post-race veterinary examination revealed no visible abnormalities.

BUYMEBYCHANCE (B. Claridge) – inconvenienced near the 200 metres.

RACE 8 : P A & C I MARTIN BENCHMARK 60 HANDICAP - 1100 metres

OVERSTREET (M. Poon) – contacted on jumping away.

ARTIE'S ANGEL (K. Brooks) - a post-race veterinary examination revealed no visible abnormalities.

DOUBLE FIVE (T. Zanker) – inclined to lay in under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was \$100.

STRAVINSKA (J. Potter) – shifted out on jumping away onto OVERSTREET.

REALLY EDGY (A. Doyle) - a post-race veterinary examination revealed no visible abnormalities.
