**RACE 1 : SAVE THE DATE NARACOORTE RACES 26 MARCH / SABOIS MAIDEN PLATE**  
**- 2000 metres**

**ASELLUS** (E. Finnegan) – in the vicinity of the 1800 metres had to be restrained to avoid the heels of EXTRA COVER, which shifted in when insufficiently clear. Laid in when placed under pressure in the straight.

**EXTRA COVER** (M. Julius) - in the vicinity of the 1800 metres shifted in when insufficiently clear of ASELLUS. Rider severely reprimanded for shifting ground when insufficiently clear. Laid out rounding the home turn and made the corner awkwardly.

**TIGER EXPRESS** (D. Tootell) – Trainer was advised that the gelding would be required to perform competitively to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

**MATALISTIC** (Z. Spain) - in the vicinity of the 1800 metres had to be restrained after improving onto the heels of TIGER EXPRESS and in doing so made heavy contact with the running rail. Rider reported his mount laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities. Trainer advised that the gelding would be required to perform competitively to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

**VINTAGE DISH** (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 2 : SAVE THE DATE NARACOORTE CUP 12 FEBRUARY BENCHMARK 72 HANDICAP**  
**- 1200 metres**

**BACK ON TRACK** (J. Mamat) – held up for clear running from the 200 metres to until inside the 100 metres.

**WOOLSTHORPE STORE** (R. Hurdle) – rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear in the vicinity of the 300 metres in onto SON OF COCOA (NZ) and was suspended from riding in races for a period to commence at midnight on Wednesday, 20 July, and to conclude at midnight on Wednesday, 27 July 2016: a period of three (3) meetings. Approaching the 50 metres shifted in when insufficiently clear of GAV'S GIFT. Rider severely reprimanded and advised to only shift ground when clear in future.

**GAV'S GIFT** (J. Potter) – in the vicinity of the 50 metres had to be restrained to avoid the heels of WOOLSTHORPE STORE, which shifted in when insufficiently clear and ONE FOR MAX, which shifted out.

**SON OF COCO (NZ)** (Z. Spain) - in the vicinity of the 300 metres was severely hampered when having to check to avoid the heels of WOOLSTHORPE STORE, which shifted in when insufficiently clear.

**RACE 2 : SAVE THE DATE NARACORTE CUP 12 FEBRUARY BENCHMARK 72 HANDICAP**  
**- 1200 metres (Cont'd)**

**ONE FOR MAX** (D. Tourneur) - in the vicinity of the 50 metres shifted out crowding GAV'S GIFT. Rider reminded of his obligations to keep his mount straight and to be clear when shifting ground in future.

**RACE 3 : JIM & MAUREEN BIGGINS / SABOIS MAIDEN PLATE - 1100 metres**

**PAARTAPAE** (Z. Spain) - slow to begin.

**PLAYTHESPOONS** (D. Caboche) - a post-race veterinary examination, after being beaten 27 lengths, revealed no visible abnormalities. Warning issued.

**DOUBLE BURNER** (C. Puls) - slow to begin.

**MANNION** (E. Finnegan) - underwent a pre-race veterinary examination after dislodging its rider en route to the barriers and passed fit to race.

**RINEHART** (D. Tourneur) – raced wide without cover throughout the event.

**PERCANO (NZ)** (J. Cartwright) – slow into stride. Hung in when placed under pressure in the straight.

**RACE 4 : PETER & ROBYN WALTERS / SABOIS MAIDEN PLATE - 1430 metres**

**BEARDED ESAM** (J. Potter) - slow to begin. Raced wide throughout the event.

**FREECLOUD** (M. Julius) – laid in when placed under pressure in the straight.

**SPARKLING SON** (Z. Spain) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities. Trainer was advised that the gelding would be required to perform competitively to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

**BRAEVIEW MISS** (D. Tourneur) – raced keenly in the early stages of the event. Held up for clear running in the vicinity of the 300 metres to inside the 200 metres.

**CRYSTAL GLASS** (E. Finnegan) - slow to begin. Raced wide throughout the event.

**GRECIAN SPY** (J. Cartwright) – laid in rounding in the home turn.

**SILENT SINNER** (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 5 : SAVE THE DATE WRATTONBULLY RACE DAY 18 NOVEMBER BENCHMARK 60**  
**HANDICAP - 2000 metres**

**CHU CHU CHARLIE** (J. Cartwright) – Rider explained when he placed his mount under pressure in the vicinity of the 600 metres, the gelding failed to respond to his riding and he became concerned with the gelding's action. A post-race veterinary examination revealed no visible abnormalities.

**MAJESTIC RIDGE** (Z. Spain) – rider reported that in his opinion the mare failed to handle today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

**ONE PERCENTA** (D. Tootell) - underwent a pre-race veterinary examination and passed fit to race.

**RACE 6 : SAVE THE DATE FAMILY RACE DAY 2 JANUARY BENCHMARK 60 HANDICAP**  
**- 1100 metres**

**OGUNDE** (Jemma Frew) - in the vicinity of the 100 metres shifted in when insufficiently clear of CLONMEL. Rider reminded of her obligations to be clear when shifting ground.

**RACE 6 : SAVE THE DATE FAMILY RACE DAY 2 JANUARY BENCHMARK 60 HANDICAP**  
**- 1100 metres (Cont'd)**

**NORTH BEACH** (B. Griffiths) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$400.

**CLONMEL** (R. Hurdle) – rider reported his mount failed to travel in the early stages, however, when he placed the gelding under pressure in the vicinity of the 600 metres CLONMEL responded to his vigorous riding and was pleased with the gelding's finishing effort. In the vicinity of the 100 metres had to be retrained when racing in restricted room after OGUNDE shifted in when insufficiently clear.

**SHE'S ALL POWER** (J. Mamat) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 7: SAVE THE DATE NARACORTE RACES 18 SEPTEMBER BENCHMARK 56 HANDICAP-**  
**1430 metres**

**AMBER ALERT** (J. Frew) – rider report his mount was on the wrong leg throughout the event and laid out when placed under pressure in the straight.

**CHRISTOPHERSON** (M. Julius) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**PRIME FOCUS** (Jemma Frew) – raced wide without cover throughout the event. Rider reported in her opinion the gelding failed to handle today's track conditions.

**HASTA LA GORBY** (J. Mamat) – over-raced keenly in the early and middle stages of the event. In the vicinity of the 300 metres accidentally dropped his whip. Rider reprimanded.

**TROUBLED GLASS** (E. Finnegan) – raced wide without cover throughout the event.
