RACE 1 : IAN'S WESTERN HOTEL / SABOIS MAIDEN PLATE - 1100 metres

ZIGZAG STREET (B. Griffiths) - underwent a pre-race veterinary examination as it had not raced since May 2014 and passed fit to race. Inclined to lay in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

HASHIBA (J. Maund) - slow to begin.

TIME TO ORDER (L. Stojakovic) - a post-race veterinary examination revealed no visible abnormalities.

COCOA LABELLE (M. Poon) - jumped away awkwardly. Inclined to hang out throughout the event. A post-race veterinary examination revealed a small laceration to the near hind fetlock and a small ulcer to the off side of the mouth.

MAPPINGA MELODY (K. Bishop) - slow to begin.

RACE 2 : AUGUSTA BOTTLE & CAN RECYCLERS BENCHMARK 64 HANDICAP - 1867 metres

POLLYWAGON (M. Poon) – slow into stride. Rider reported in his opinion the mare was not suited to the dirt track. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness required prior to trial or race. Trainer advised the mare would now be spelled.

RACE 3 : AUGUSTA AUTOMALL BENCHMARK 54 HANDICAP - 1600 metres

BENJIDDAH (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

FINAL TABLE (K. Brooks) - a post-race veterinary examination revealed no visible abnormalities.

NICCOROSSA (M. Poon) - jumped away awkwardly and shifted in. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

RACE 3 : AUGUSTA AUTOMALL BENCHMARK 54 HANDICAP - 1600 metres (Cont'd)

DAL ROMMEL (NZ) (J. Potter) – hung out for a short distance rounding the home turn.

Correct weight for this event was delayed to allow Mr D. Jolly, Trainer of NICCOROSSA placed second to view the official photo for first place.

RACE 4 : PORT AUGUSTA BUS SERVICE / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE
- 1396 metres

I'M OUT (Jemma Frew) - in the vicinity of the 500 metres dipped for no apparent reason.

OUTLAW (J. Potter) – shifted in approaching the finish onto TICKLE ME ERNIE, which was obliged to be steadied when tightened onto KASMARLAINE, which rolled out. Rider severely reprimanded.

TICKLE ME ERNIE (K. Brooks) - slow to begin. In the vicinity of the 1200 metres improved onto the heels of I'M OUT and OUTLAW and was obliged to be restrained. Inclined to lay in under pressure in the straight. From in the vicinity of the 150 metres until in the vicinity of the 50 metres contacted KASMARLAINE on a number of occasions. Approaching the finish became tight for room and was obliged to be steadied as OUTLAW shifted in and KASMARLAINE rolled out.

WALKABOUTCREEK (J. Mamat) – rider reported the gelding was inclined to hang out throughout the event.

WILLIS (J. Frew) - jumped away awkwardly, shifted in and bumped DANCER'S DREAM.

BUTTERBEER (L. Stojakovic) - a post-race veterinary examination revealed no visible abnormalities.

KASMARLAINE (M. Poon) – inside the 150 metres until in the vicinity of the 50 metres contacted TICKLE ME ERNIE on a number of occasions. Rolled out approaching the finish.

FLYING RHYTHM (T. Pannell) - jumped away awkwardly and shifted out.

LEMON ZEST (T. Zanker) - jumped away awkwardly and shifted out.

DANCER'S DREAM (B. Griffiths) – bumped on jumping away as WILLIS shifted in.

Correct weight for this event was delayed to allow K. Brooks (TICKLE ME ERNIE) placed fourth to view the vision in the straight.

RACE 5 : CINEMA AUGUSTA BENCHMARK 64 HANDICAP – 1200 metres

LIBERTY HILL (K. Brooks) - jumped away awkwardly and shifted out

OVERSTREET (J. Maund) – on jumping away was tightened onto KUNGSLEDEN as LIBERTY HILL jumped away awkwardly and shifted out.

INNOVATE (NZ) (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6 : KEITH MCINNIS MEMORIAL BENCHMARK 60 HANDICAP - 1396 metres

TRIUMPHANT ONE (B. Griffiths) – contacted at the start as FINNISS MOMENT jumped away awkwardly and shifted out.

MIXOLOGIST (M. Poon) - a post-race veterinary examination revealed the gelding was wind sucking from behind.

SAVANERO (NZ) (T. Pannell) – inclined to rear on jumping away.

LITTLE AUDREY (K. Brooks) – slow into stride. Raced keenly in the early and middle stages of the event.

RACE 6 : KEITH MCINNIS MEMORIAL BENCHMARK 60 HANDICAP - 1396 metres (Cont'd)

FINNISS MOMENT (Jemma Frew) - jumped away awkwardly and shifted out contacting TRIUMPHANT ONE.

TRAFALGAR BELLE (L. Stojakovic) - jumped away awkwardly and as a result was slow into stride.

MAPPINGA PRINCE (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7 : PKB ELECTRICAL SERVICES BENCHMARK 54 HANDICAP - 1100 metres

The start of this event was delayed approximately three minutes to avoid a clash with an interstate race (Moe).

MUCKATAH LAD (T. Zanker) – difficulty obtaining clear ground from approaching the 200 metres until in the vicinity of the 50 metres.

MUNDO NOVA (K. Brooks) - a post-race veterinary examination revealed the gelding had suffered a bi-lateral bleeding attack. Trainer advised as this was the gelding's first bleeding attack, MUNDO NOVA would now be suspended from racing for a period of three months in accordance with AR59A.

FULL SWING (J. Maund) – required to be re-saddled on arrival at the start.

BLOOMIN' ELUSIVE (NZ) – a late scratching at 11.26 am by order of Stewards as there was no rider available at the weight.

TILLY GIRL (Jemma Frew) – marginally slow to begin.
