STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 30 July 2016

RACE 1 : ADELAIDE GALVANISING HANDICAP – 2000 metres

SUBIASO (B Claridge) – hampered inside the 300 metres. A post-race veterinary examination revealed a lower than expected heart rate.

EIGELSTEIN (GB) (P Gatt) – inside the 200 metres, was forced to take hold and lost it's position.

DANOULI (J Holder) – inclined to lay in under pressure in the straight and in the vicinity of the 300 metres shifted in onto SUBIASO. Rider severely reprimanded. Inside the 200 metres, shifted in onto EIGELSTEIN (GB), which was forced to check and lost it's position. J. Holder pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 6 August and to conclude at midnight on Wednesday, 17 August, a period of five (5) meetings.

Correct weight was delayed to allow P. Gatt, rider of the third place-getter EIGELSTEIN (GB), and that gelding's trainer, Mr. G. Young, to view the official vision in the straight.

RACE 2 : ABSOLUTELY FABULOUS: THE MOVIE HANDICAP - 1600 metres

SPREADEAGLED (NZ) (D Moor) – a post-race veterinary examination revealed no visible abnormalities.

RACE 3 : KEVIN WOODS RETIREMENT HANDICAP - 1600 metres

VEGA DE LAGO (J Holder) – rider explained that the gelding had travelled well in the early and middle stages of the event, however, when placed under pressure at the entrance to the straight failed to respond to his riding and commenced to lay in severely. A post-race veterinary examination revealed the gelding to have a cardiac arrhythmia. Results of an ECG to be forwarded to TRSA Vet and a Vet Cert of Fitness required prior to presenting to a trial.

KESAN (J Toeroek) – slow to begin.

ROTHMOORE (T Pannell) – Stewards questioned rider T. Pannell in relation to the instructions provided in today's event. T. Pannell explained that he had been instructed to take up a position mid-field with cover; however, due to the formation of the field and the pace early in the event he had elected to use his initiative and push forward to obtain an easy lead. Trainer Mr. R. Moore confirmed the instructions to be midfield.

CREAM OF THE CROP (D Thornton) – was fractious in the float en-route to the course. Examined by the Club's Veterinary Surgeon on arrival and passed fit to race.

RACE 3 : KEVIN WOODS RETIREMENT HANDICAP - 1600 metres (Cont'd)

SUPERCHIC (J Kah) – rider accidentally dropped her whip in the vicinity of the 300 metres. Reprimanded under AR137(a) for carelessness. Rider explained that the filly had not travelled throughout the event and had performed below expectation. A post-race veterinary examination revealed a mildly elevated heart rate.

REYIA (D Tootell) – Stewards questioned rider D. Tootell in relation to his whip use in the straight. Reprimanded under AR137A(4)(c) for using his whip when his mount was out of contention.

RACE 4 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1050 metres

TIME OUT (M Poon) – jumped away awkwardly.

ASHERO (R Hurdle) – jumped away awkwardly. A post-race veterinary inspection revealed no visible abnormalities.

YULONG YONGXING (J Allen) – raced keenly in the early and middle stages.

MANUEL (D Thornton) - raced keenly in the early and middle stages.

ARIZONA WILDCAT – a late scratching by order of Stewards on veterinary advice at 7.44 am as the filly had inflammation in the off fore foot.

GOT THAT SWING (J Kah) – inclined to lay in under pressure in the straight.

RACE 5 : SCHWEPPE HANDICAP - 1200 metres

OUTLANDISH LAD (E Finnegan) – jumped away awkwardly and shortly after was hampered by COUNTER SPIN, which was taken out. Had difficulty obtaining clear ground at the entrance to the straight and approaching the 100 metres was disappointed when attempting a run between MOLLY THE SNIP, which shifted out slightly, and MUBAKKIR, which shifted in under riding, and was untested to the line.

MUBAKKIR (D Caboche) – shifted in under riding over the concluding 100 metres onto OUTLANDISH LAD. Rider reprimanded.

REDEEM BOUNTY (M Poon) – shifted out on jumping away onto MUBAKKIR.

COUNTER SPIN (C Lindop) – taken out on jumping away by MUBAKKIR. Raced in restricted room for a number strides inside the 700 metres. Momentarily held up in the vicinity of the 200 metres.

LIMINAL (D Moor) – rider reported that the gelding was inclined to lay out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

BRAVE JOURNEY (J Maund) – commenced to weaken from the event in the vicinity of the 600 metres. Rider reported that he had become concerned with the mare's action at this point of the race, in particular it's off fore leg. A post-race veterinary inspection revealed no visible abnormalities.

MOLLY THE SNIP (J Toeroek) – shifted out slightly in the vicinity of the 100 metres onto OUTLANDISH LAD.

RACE 6 : BEN & STRECKY'S DAY OUT HANDICAP - 1600 metres

ALLEZ TARA (M Neilson) – rider explained that the gelding had travelled well in the early and middle stages, however when placed under pressure failed to let down as he had anticipated and was one paced to the line. A post-race veterinary examination revealed no visible abnormalities.

TABLEAUX (C. Lindop) – post-race veterinary examination revealed a poor recovery. First aid administered.

RACE 6 : BEN & STRECKY'S DAY OUT HANDICAP - 1600 metres (Cont'd)

BLUE VIPER (D Thornton) – held up from the entrance to the straight until approaching the 200 metres. Laid in approaching the 100 metres and bumped HELL ON EARTH.

JOCKS GLEN (M Poon) – rider reported that the gelding had not travelled well during the event and was under pressure from the vicinity of the 1000 metres and in his opinion had not handled the track. A post-race veterinary inspection revealed an elevated heart rate.

GRAND ARMADA (D Tootell) – over-raced in the early and middle stages.

ALL EIGHTS (P Gatt) – rider explained that it was his intention to take up a forward position and possibly lead in the event, however the gelding was unable to obtain that position despite his efforts. He added that the gelding was reluctant when racing amongst other runners and in his opinion may not have backed up from it's race last Saturday. A post-race veterinary inspection revealed no visible abnormalities

RACE 7 : UBET LIGHTNING STAKES - 1050 metres

LOPE DE CAPIO (K Chiong) – had to be momentarily steadied approaching the 800 metres and was taken in slightly onto SHOWPERO.

VIDDORA (M Neilson) – laid in under pressure over the concluding stages.

COOL SNITZEL (J Allen) – shifted out slightly in the vicinity of the 200 metres. Rider reminded of his obligations. A post-race veterinary examination revealed no visible abnormalities.

HEARTZ ABLAZE (J Toeroek) – jumped away awkwardly and was slow into stride.

COCOA DOLL (J Holder) – which performed poorly, made excess respiratory noise on pulling up. A post-race veterinary examination revealed that it had tied up in its hindquarters. Veterinary Certificate of Fitness required prior to trial or race.

LIFE'S REWARD (Z Spain) – shifted in approaching the 800 metres onto LOPE DE CAPIO. Rider severely reprimanded.

SHOWPERO (J Kah) – slow to begin. Inconvenienced approaching the 800 metres when LOPE DE CAPIO was taken in slightly.

MOTOWN LIL (D Moor) – had to be steadied momentarily in the vicinity of the 200 metres when COOL SNITZEL shifted out slightly.

RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1050 metres

EL PRADO GOLD (D Caboche) – lost it's off fore plate during the event.

BABITZIN (E Finnegan) – slow to begin. Raced in restricted room for a short distance near the 700 metres when inside CERTAIN ELLIE. Had difficulty obtaining clear ground in the straight.

ASCENDANCE (D Thornton) – slow to begin.

IXCATAN (P Gatt) – laid in approaching the 200 metres onto MAGNUSIFICENT.

BOLDACIOUS GIRL (C Parish) – lost it's off hind plate during the event.

CERTAIN ELLIE (C Lindop) – improved onto the heels of MAGNUSIFICENT approaching the finish and had to be steadied. A post-race veterinary examination revealed no visible abnormalities.
