**RACE 1 : SCHWEPPE MIXERS / SABOIS PLUS MAIDEN / CLASS 1 PLATE - 2100 metres**

**FINAL TABLE** (R. Hurdle) - in the vicinity of the 1800 metres had to be restrained to avoid the heels of THE BRIGHTONIAN, which shifted in when insufficiently clear, as a result was carried in onto AUDEAMUS.

**LYDIARD** (B. Griffiths) – raced wide without cover throughout the event.

**RICCONE** (D. Thornton) – RICCONE was declared a non-runner under AR134A, when it was established that the blindfold that was part of the geldings gear was not removed prior to the gates being opened resulting in the gelding, which is an on pace runner, being disadvantaged and losing ground on jumping in the order of a length. A post-race veterinary examination revealed no visible abnormalities.

**THE BRIGHTONIAN** (J. Maund) – in the vicinity of the 1800 metres shifted in when insufficiently clear of FINAL TABLE carrying that gelding in onto AUDEAMUS, which was carried in onto VIEWPOINT ESTATE, which had to be checked. Rider severely reprimanded.

**VIEWPOINT ESTATE** (L. Stojakovic) - in the vicinity of the 1800 metres had to be checked to avoid the heels of FINAL TABLE.

**AUDEAMUS** (D. Tourneur) - in the vicinity of the 1800 metres was carried in by FINAL TABLE in onto VIEWPOINT ESTATE, which had to be checked.

**SWING ALONG** (K. Bishop) - slow to begin.

**RACE 2 : GOLDIN FARMS / AKEED MOFEED / SABOIS MAIDEN PLATE – 1100 metres**

**ITS OUR LIFE** (K. Bishop) - a post-race veterinary examination revealed the filly to be lame in the near hind leg. Veterinary Certificate of Fitness required prior to trial or race.

### **RACE 2 : GOLDIN FARMS / AKEED MOFEED / SABOIS MAIDEN PLATE – 1100 metres (Cont'd)**

**NIL RHYTHM** (J. Potter) – held up for clear running in the vicinity of the 400 metres until inside the 300 metres and laid out when placed under pressure in the straight.

**PARLIAMENT MISS** (J. Kah) – bumped on jumping away.

**STONE COLD FOX** (J. Holder) - slow to begin. Held up for clear running from in the vicinity of the 400 metres until inside the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

**SUPER SHOPPER** (D. Tootell) – underwent a pre-race veterinary examination and passed fit to race. Over-raced in the early stages of the event.

**TOFF I AM** (J. Toeroek) – began awkwardly.

**TUSCAN MARIE** (J. Mamat) – hung out throughout the event. A post-race veterinary examination revealed an elevated heart rate.

**FAMILJA** (K. Chiong) – began awkwardly.

**LA PRENEUSE** (T. Pannell) – began awkwardly.

### **RACE 3 : SPORTSBET CASH CARD / SABOIS TWO-YEAR-OLD MAIDEN PLATE – 1200 metres**

**ARTFUL JACK** (R. Hurdle) – bumped on jumping away.

**HERO'S HONOR** (M. Poon) – rider reported the gelding failed to handle the heavy track conditions. A post-race veterinary examination revealed no visible abnormalities.

**BATTLE HARDENED** (D. Tourneur) – in the vicinity of the 1000 metres was momentarily hampered after PUJOLS shifted out. A post-race veterinary examination revealed no visible abnormalities.

**CASINO CLUB** (B. Claridge) – over-raced in the middle stages of the event.

**FEDEROSA (NZ)** (J. Toeroek) – began awkwardly, shifted in and bumped ARTFUL JACK. Rider reported that the filly failed to handle the heavy track conditions.

**LENI MAE** (K. Bishop) - slow to begin.

**PULOLS** (C. Lindop) - in the vicinity of the 1000 metres shifted out hampering BATTLE HARDENED.

**ARLEIGH** (K. Chiong) – began awkwardly. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 4 : COOPERS CARLSBERG PREMIUM BEER BENCHMARK 56 HANDICAP - 1500 metres**

**WICKED PROMISE** (M. Neilson) – held up for clear running from in the vicinity of the 600 metres until inside the 400 metres.

**THE FASTNET** (M. Poon) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**BON ELISE** (J. Kah) - rider reported the mare failed to travel in the early stages of the event and in her opinion did not handle the heavy track conditions. A post-race veterinary examination revealed no visible abnormalities.

**ALWAYS MAGIC** (R. Hurdle) – over-raced in the early stages. Laid out when placed under pressure over the concluding stages of the event.

**RACE 4 : COOPERS CARLSBERG PREMIUM BEER BENCHMARK 56 HANDICAP - 1500 metres**  
(cont'd)

**LIMBO QUEEN** (K. Chiong) – rider reported the mare failed to handle the heavy track conditions. A post-race veterinary examination revealed no visible abnormalities.

**RACE 5 : COOPERS VINTAGE BEER BENCHMARK 56 HANDICAP - 1500 metres**

**UNSPUN** (P. Gatt) – dropped his whip in the vicinity of the 300 metres and was reprimanded.

**SELDOM HOME** (J. Potter) - in the vicinity of the 1000 metres dipped on a number of occasions.

**VALARCH** – a late scratching by order of Stewards at 10.48 am as the Trainer failed to scratch the gelding by the prescribed time. Trainer was reprimanded under AR114(a).

**FRIENDWITHBENEFITS** (J. Holder) – rider reported in his opinion the mare failed to handle the heavy track conditions. A post-race veterinary examination revealed no visible abnormalities.

**SHADOWS ABOVE** (J. Kah) - slow to begin. Shifted out abruptly when passing the winning post.

**SILENT SINNER** (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 6 : CRABB SHELLGRIT CLASS ONE HANDICAP - 1200 metres**

**DAPPER AFTER DARK** (C. Lindop) - in the vicinity of the 800 metres had to be restrained whilst over-racing to avoid the heels of CRYSTAL MOMENT, which shifted in.

**BACKSTAGE PASS** (T. Pannell) – began awkwardly and shifted out making contact with PULEDRA.

**CRYSTAL MOMENT** (O. Ridge) – over-raced in the early and middle stages of the event. In the vicinity of the 800 metres shifted in when insufficiently clear of DAPPER AFTER DARK. Rider reminded of his obligations to be clear when shifting ground in future.

**LIGHT 'N' FIRE** (J. Maund) – over-raced in the middle stages of the event.

**MOLASMO JET** – a late scratching by order of Stewards at 3.13 pm on veterinary advice after becoming fractious being re-plated behind the barriers.

**SOUVLAKI** (R. Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**PULEDRA** (J. Kah) – began awkwardly, shifted in bumping BACKSTAGE PASS.

**RACE 7 : SANDERS FODDER / SABOIS THREE-YEAR-OLD BENCHMARK 64 HANDICAP**  
- 1200 metres

**ALASKAN JADE** (J. Maund) - in the vicinity of the 900 metres had to be restrained to avoid the heels of CLANDESTINE AFFAIR, which shifted in when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

**SHE'S A STORM** (C. Lindop) – stood flat-footed at the start and was slow to begin by four lengths.

**CLANDESTINE AFFAIR** (M. Poon) - in the vicinity of the 900 metres shifted in when insufficiently clear of ALASKAN JADE. Rider severely reprimanded.

**SEEK TO DESTROY** (B. Claridge) – in the vicinity of the 500 metres had to be restrained after improving onto heels. Hung in when placed under pressure over the concluding stages. Rider was cautioned regarding the use of the whip forward of the shoulder under AR137A(4)(a).

**RACE 8 : GLENRAE STUD BENCHMARK 60 HANDICAP - 1100 metres**

**HOT DEMAND** (M. Poon) - in the vicinity of the 200 metres shifted out when insufficiently clear of PRINCESS COSTA. Rider reprimanded.

**RIGHTEOUS RULER** (L. Stojakovic) – underwent a pre-race veterinary examination and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

**PRINCESS COSTA** (K. Bishop) - in the vicinity of the 200 metres had to be steadied when crowded for room by HOT DEMAND, which shifted out when insufficiently clear.

**LEAHONE** (J. Maund) - in the vicinity of the 200 metres was momentarily hampered when WARRASIDE EDDY shifted out.

**WARRASIDE EDDY** (D. Tootell) - in the vicinity of the 600 metres had to be restrained after improving onto the heels of SILENT SNIPER. Held up for clear running from the 600 metres until inside the 200 metres when the gelding shifted out to improve making contact with LEAHONE.

**SAR SAR** (R. Hurdle) – laid in when placed under pressure over the concluding stages of the event.

**NIGHT BREEZE** – a late scratching by order of Stewards at 3.01 pm on veterinary advice after injuring its near hind leg en route to the course.
