**TRACK** (Morphettville Parks): Soft 6  
(Morphettville): Soft 7

**WEATHER:** Overcast

**RAIL** (Morphettville Parks): True.  
(Morphettville): Out 3 metres 1200 metres to 500 metres.

**RIDER CHANGES:** Nil

**RACE 1 : MILL PARK STUD HANDICAP - 1000 metres**

The start of this race was delayed approximately three minutes initially owing to EL PRADO GOLD having to be re-shod when it lost its off fore plate en-route to the barriers. EL PRADO GOLD was examined by the Club's Veterinary Surgeon and passed fit to race. There was a further delay owing to one of the ambulances on course becoming stuck in an area adjacent to the service road near the 1800 metres.

**BRIMARVI PRINCE** (J Bowditch) – laid in in the straight. A post-race veterinary examination revealed no visible abnormalities.

**ALABAMA MISSILE** (M Poon) – rider explained that the mare was unable to run with the field in the early stages, however, added that the mare finished the race off strongly. A post-race veterinary examination revealed no visible abnormalities.

**EL PRADO GOLD** (T Pannell) – lost its off fore plate en-route to the barriers and was re-shod. Examined by the Club's Veterinary Surgeon and passed fit to start.

**RACE 2 : KEVERN KLEMICH MEMORIAL HURDLE - 3200 metres**  
(Run on Morphettville track)

**ABOUT THE JOURNEY (NZ)** (M Kelly) – was hampered after jumping the first hurdle when avoiding ZABROCK (NZ) which knuckled, fell and dislodged its rider.

**SPYING ON YOU (NZ)** (R Cully) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**MILKWOOD** (Arron Lynch) – jumped the seventh hurdle awkwardly. Knuckled after jumping the final hurdle, became unbalanced and as a consequence A. Lynch was dislodged.

**BUYMEBYCHANCE** (L Horner) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**RACE 2 : KEVERN KLEMICH MEMORIAL HURDLE - 3200 metres**  
**(Run on Morphetville track) (Cont'd)**

**ZABROCK (NZ)** (J Lynch) – made the first hurdle awkwardly, knuckled on landing, fell and dislodged J. Lynch. A post-race veterinary examination revealed a small cut to the gelding's tongue.

Both A. Lynch and J. Lynch were examined by the First Care Medical staff who cleared them of any injury.

All other runners underwent a post-race veterinary examination with no abnormalities detected.

**RACE 3 : MAGIC MILLIONS HANDICAP - 1550 metres**

**FLOW METER** (J Bowditch) – lost its near hind plate during the event.

**TANZEN** (P Gatt) – very awkward to begin. Lost its near fore plate during the event. A post-race veterinary examination revealed the gelding to be lame in the both hind legs. Veterinary Certificate of Fitness required prior to trial or race.

**RACE 4 : MORPHETVILLE EQUINE CLINIC HANDICAP - 1300 metres**

**VIEIRA** (J Potter) – contacted in the vicinity of the 800 metres by MUSTARRID, which shifted out, resulting in the hindquarters of VIEIRA being turned. Hung in in the straight. A post-race veterinary examination revealed no visible abnormalities.

**MUSTARRID** (M Neilson) – began awkwardly. Raced keenly in the early and middle stages of the event. Made the turn near the 800 metres awkwardly, shifted out and contacted VIEIRA turning that gelding's hindquarters. Rider reported the gelding laid out in the straight. A post-race veterinary examination revealed the gelding to have a laceration to its mouth.

**ACE ATTACK** (J Bowditch) – held up for a short distance approaching the entrance to the straight.

**VIENNA MISS** (P Gatt) – tightened at the start between PUJOLS and CASTA. Raced keenly in the early and middle stages of the event. Laid in, in the straight resulting in P. Gatt having to stop riding and straighten his mount on several occasions. A post-race veterinary examination revealed no visible abnormalities.

**PUJOLS** (C Lindop) – raced keenly for a short distance inside the 700 metres and approaching the 500 metres became awkward on the heels of NICOISE and had to be momentarily steadied.

**RACE 5 : PERKS ASSOCIATES HANDICAP - 1950 metres**

**LOTION** (M Neilson) – Mr. B Hayes, representing the training partnership, advised Stewards prior to the event that he would instruct his rider to attempt to settle forward of mid-field with cover. M. Neilson explained that he was unable to comply with his instruction owing to his wide barrier and the composition of the field in the early stages, and was obliged to settle back of mid-field with cover. He added that the gelding was under pressure from in the vicinity of the 600 metres, failed to respond to his riding and finished the race off in a very disappointing manner. A post-race veterinary examination revealed no visible abnormalities.

**OUR POSITIVE MOVE (GB)** (C Lindop) – rider reported the gelding hung in during the event. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 5 : PERKS ASSOCIATES HANDICAP - 1950 metres (Cont'd)**

**SARAH'S WAY** (R Hurdle) - a post-race veterinary examination revealed no visible abnormalities.

**FINAL TABLE** (K Brooks) – rider reported the gelding laid in during the event.

### **RACE 6 : GOLDNERS HORSE TRANSPORT HANDICAP – 1000 metres**

**CLASSY JACK** (D Caboche) – hung out over the concluding stages.

**I AM THE GENERAL** (A Creighton) – a post-race veterinary examination revealed no visible abnormalities.

**DANUKI** (J Allen) – broke through the front of its barrier stall after being loaded, cantered a short distance before being captured by the Clerk of the Course and returned to behind the barriers. Examined by the Club's Veterinary Surgeon and passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

**IXCATAN** (E Finnegan) – rider reported that the gelding slipped behind on jumping away, placing her at a disadvantage and as a consequence she was slow to begin and unable to settle forward as intended, and was obliged to settle back in the field.

**NORDIC ECLIPSE** (M Poon) – rider reminded of his obligations to ride his mounts to the end of the race. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 7 : KADINA LEADING EDGE JEWELLERS HANDICAP - 1300 metres**

**OUTLANDISH LAD** (E Boyd) – trainer Mr. D O'Leary advised Stewards prior to the event that he would instruct his rider to attempt to settle forward of mid-field with cover and if possible improve to the outside of runners. Mr D. O'Leary was reminded of his obligations to report a change of tactics prior to thirty minutes to the start of a race in which he has a runner (AR135A). Approaching the 200 metres raced in restricted for a number of strides inside **LUCKY FLIPPER**, which rolled in.

**COUNTER SPIN** (C Lindop) – over-raced in the early and middle stages of the event.

**LUCKY FLIPPER** (J Potter) – rolled in for a number of strides approaching the 200 metres.

### **RACE 8 : AKEED MOFEED @ GOLDIN FARMS HANDICAP - 1400 metres**

**GOLDEN CENTURY** (M Neilson) – inconvenienced in the vicinity of the 600 metres when awkward inside the heels of **PATCH HERO**, which shifted in. A post-race veterinary examination revealed no visible abnormalities.

**SINGLE BARREL** (Z Spain) – approaching the 600 metres became awkward inside the heels of **TRUPT** and was obliged to be steadied. A post-race veterinary examination revealed no visible abnormalities.

**DREADLOCK** (D Thornton) – began awkwardly, shifted out and inconvenienced **ONE FOR MAX**. A post-race veterinary examination revealed no visible abnormalities.

**PATCH HERO** (J Bowditch) – inside the 700 metres shifted in and inconvenienced **GOLDEN CENTURY**. J. Bowditch was reminded of his obligations when shifting ground.

**RACE 8 : AKEED MOFEED @ GOLDIN FARMS HANDICAP - 1400 metres (Cont'd)**

**ONE FOR MAX** (E Boyd) – inconvenienced at the start.

**UNSPUN** (P Gatt) – race wide without cover throughout the event.

**ROSELLI STING** (R Hurdle) – a post-race veterinary examination revealed no visible abnormalities.
