Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 03 September 2016

TRACK: Soft 5 (*Downgraded to Soft 6 at 11.15 am*)

WEATHER: Fine

RAIL: Out 3 metres 1000 metres to 400 metres, true remainder.

RACE 1 : SCHWEPES HANDICAP - 1950 metres

FLYING CASINO (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

ALLEZ TARA (E. Finnegan) – rider reported that the gelding pulled up short in front. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to future trial or race.

NAME THE DAY (D. Tourneur) – laid in, in the straight. Shifted in, in the vicinity of the 200 metres and inconvenienced DEVON, and thereafter continued to lay in and shifted in approaching the 100 metres and inconvenienced EIGELSTEIN (GB). Rider severely reprimanded in relation to both incidents and advised to stop and straighten his mounts when they commence to shift ground.

DEVON (M. Poon) – shifted in, in the vicinity of the 600 metres and momentarily inconvenienced EIGELSTEIN (GB). Rider reminded of his obligations when shifting ground. Inconvenienced in the vicinity of the 200 metres.

EIGELSTEIN (GB) (D. Thornton) – inconvenienced in the vicinity of the 600 metres, and thereafter in the vicinity of the 100 metres.

GRAND ARMADA (D. Tootell) – over-raced in the early stages of the event and raced wide without cover for some distance.

RACE 2 : UBET HANDICAP - 2400 metres

The start of this event was delayed approximately one minute owing to HENRY THE DOLPHIN proving fractious after being loaded into its barrier stall.

TUNES (Z. Spain) – raced wide without cover in the early stages of the event.

MATERIALISED (P. Gatt) – laid out rounding the home turn. Rider report he felt there may be something amiss with the mare over the concluding stages and it felt sore on pulling up. A post-race veterinary examination revealed no visible abnormalities.

HENRY THE DOLPHIN (L. Stojakovic) – fractious after being loaded into its barrier stall. Examined by the Club's Veterinary Surgeon who reported the gelding to have abrasions and minor lacerations to its near hind leg and ruled it unfit to start. Late scratching by order of stewards on vet's advice at 1.14 pm. Trainer, Mr M. Faust, advised that the gelding would now have to prove tractable in the barriers in an Official Barrier Trial prior to accepting for a future race. First aid administered prior to leaving the course.

DAPPER ROSSA (D. Tourneur) – rider accidentally dropped his whip inside the 200 metres and reprimanded for carelessness.

BIAN LATE (C. Lindop) – a post-race veterinary examination revealed no visible abnormalities.

RACE 3 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1250 metres

RAMPAGE (M. Neilson) – raced keenly in the early stages of the event and was taken wider over the concluding stages.

ARROW LANE (M. Poon) – raced keenly in the early stages. Laid out rounding the home turn and shifted out and away from SERENELY DISCREET over the concluding stages, taking RAMPAGE wider. Rider reminded of his obligations when his mounts commence to shift ground.

SERENELY DISCREET (D. Tourneur) – rider accidentally dropped his whip inside the 200 metres. Fined \$50 under AR137(a) for carelessness in dropping his whip.

WITH A BIT OF DASH (T. Pannell) – shifted out to improve in the vicinity of the 200 metres and brushed with ULTIMATE WEAPON, which was taken wider.

ULTIMATE WEAPON (D. Thornton) – taken wider near the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow M. Neilson (RAMPAGE) to view the vision over the concluding stages.

RACE 4 : KATE DANSIE 50TH BIRTHDAY HANDICAP - 1250 metres

DOUBLE POCKETS (J. Frew) – slow into stride.

MR LIBERTY (M. Poon) – rider reported he felt something amiss with the gelding and for that reason did not persevere with his riding over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

ASCENDANCE (D. Thornton) – rider could offer no explanation for the gelding's performance today. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : KATE DANSIE 50TH BIRTHDAY HANDICAP - 1250 metres (cont'd)

SNAKE CHARMER (E. Finnegan) – rider reported the mare felt short in front during the event. A post-race veterinary examination revealed no visible abnormalities.

TYCOON SOFIE (J. Holder) – rider reported that the mare was reluctant to stretch out during the event. A post-race veterinary examination revealed an old abrasion to its wither.

RACE 5 : FRED VELLA TYRE & CRASH HANDICAP - 1400 metres

DECIRCLES (J. Martin) – rider reported the gelding laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

HAVE PLENTY (J. Bowditch) – a post-race veterinary examination revealed no visible abnormalities.

DANE HUSSLER (E. Finnegan) – tightened at the start and lost its position.

NICCOCO (D. Thornton) – rider explained that in his opinion the gelding may be better suited to firmer tracks.

GUILTY AS CHARGED (E. Boyd) – shifted out at the start and tightened DANE HUSSLER. Rider reported the gelding raced erratically at various stages during the event.

RACE 6 : COVE PRINT HANDICAP – 1000 metres

COUNTER PULSE (M. Poon) – a post-race veterinary examination revealed no visible abnormalities.

FEDERAL COURT (Z. Spain) – reluctant to improve between runners for a short distance shortly after the entrance to the straight.

WINGARD'S MARK (P. Gatt) – rider reported the gelding laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 7 : LEIGH HOEY HANDICAP (LEG OF NATIONAL JOCKEYS' TRUST SERIES) - 1250 metres

LORD TOPPER (R. Hurdle) – tightened at the start.

WIND FORCE (M. Neilson) – jumped away awkwardly, shifted in onto LORD TOPPER. Raced wide without cover in the early stages. A post-race veterinary examination revealed no visible abnormalities.

ONE MORE DAISY (E. Boyd) – co-trainer, Mr W. Francis, pleaded guilty to a charge under AR175(k) in that his negligence in saddling this mare could have led to a breach of AR143(a). The particulars being that when saddling this mare the towel that apprentice E. Boyd weighed out with was inadvertently left off. Stewards were satisfied when weighing apprentice E. Boyd in after this event that the terms of AR143 had not been breached as she was not more than half a kilogram under the weight at which she weighed out at. Mr W. Francis was fined \$200.

ROUGHLY (S. Cahill) – rider reported the mare laid out during the event. A post-race veterinary examination revealed the mare to be lame in near foreleg. Veterinary Certificate of Fitness required prior to future trial or race.

RACE 7 : LEIGH HOEY HANDICAP (LEG OF NATIONAL JOCKEYS' TRUST SERIES) - 1250 metres (cont'd)

SWEDISH BITTERS (Z. Spain) – tightened at the 600 metres and lost its position.

AVOID THE MISSUS (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

DROVER MAD (B. Claridge) – in the vicinity of the 600 metres, shifted out momentarily onto **ALERTNESS**, which was taken out onto **SWEDISH BITTERS**, which was tightened.

ALERTNESS (J. Potter) – taken out near the 600 metres. Hung out in the straight.

RACE 8 : GOLDIN FARMS HANDICAP - 1400 metres

ARCTIC SONG (E. Finnegan) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to future trial or race.

FORCE OF THREE (R. Hurdle) – inclined to lay in and shifted in approaching the 1000 metres onto **ON A DREAM**. A post-race veterinary examination revealed no visible abnormalities.

AMICONI ORIGINALE (J. Bowditch) – trainer, Mr G. Young, fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards.

ON A DREAM (C. Lindop) – inconvenienced approaching the 1000 metres.

PATCH HERO (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

FREE THE WIND (Z. Spain) – hung out throughout in the straight. Raced in restricted room for a short distance approaching the 200 metres to the inside of **PATCH HERO**, which shifted in to improve.

EXALTED JOURNEY (K. Bishop) – over-raced in the early and middle stages of the event.

Race 8 – ARCTIC SONG - Not to race – Vet Cert of Fitness required prior to future trial or race – Lameness near foreleg.
