Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 24 September 2016

WEATHER: Overcast

RAIL: Out 6 metres 1000 metres to 400 metres, 3 metres remainder.

RACE 1 : JAMES BOAG'S PREMIUM HANDICAP - 1950 metres

EMMOOKI'S DASH (Z. Spain) - began awkwardly.

NAME THE DAY (J. Bayliss) – laid in, in the straight and as a consequence J. Bayliss had to stop riding and straighten his mount inside the 100 metres.

DANOULI (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

AAI MIA (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2 : SCHWEPPE'S HANDICAP - 1550 metres

FULLY STOKED (B. Claridge) – laid in, in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(i) for using his whip in consecutive strides prior to the 100 metres and was fined \$200. He also pleaded guilty to a charge under AR137A(5)(a)(ii) for using the whip on more than five occasions prior to the 100 metres and was fined \$600.

MISS IDENTIFIED (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

RACE 3 : AKEED MOFEED @ GOLDIN FARMS HANDICAP - 1250 metres

MAGIC BOY (E. Boyd) – over-raced in the early stages of the event.

MISS ADELE (M. Poon) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : BOB COWPER OAM MEMORIAL THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

BERNIE (J. Kah) – contacted at the start and taken wider at the entrance to the straight. Rider reported in her opinion the gelding raced like a tired horse, was disappointing and failed to finish the event off. A post-race veterinary examination revealed no visible abnormalities.

CRAFTED (J. Holder) – shifted out in the vicinity of the 500 metres and tightened HELMARA. Rider reminded of his obligations when shifting ground in future.

FORGOT MY SOCK (Z. Spain) – jumped away awkwardly, shifted in and contacted BERNIE.

JAGRAP (D. Thornton) – awkward to begin.

RACE 4 : BOB COWPER OAM MEMORIAL THREE-YEAR-OLD MAIDEN PLATE - 1000 metres
(Cont'd)

PRINCESS LEAH (C. Lindop) – inconvenienced and had to be steadied at the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

VOD (B. Claridge) – rolled out at the entrance to the straight and inconvenienced **PRINCESS LEAH**.

WASHERWOMAN (E. Boyd) – rider reported the filly raced greenly during the event.

HELMARA (P. Gatt) - slow to begin. Tightened in the vicinity of the 500 metres, had to be steadied and lost its position.

STREETS OF DUBAI (M. Neilson) – shifted out at the entrance to the straight taking **BERNIE** wider.

RACE 5 : DR TERRY HODGSON HANDICAP (HEAT ONE OF THE SPRING SERIES) - 1400 metres

MISS JOOLIA (M. Poon) - slow to begin.

HAZY LANE (E. Boyd) – rider reported the mare hung out in the straight.

DAISY'S JOY (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6 : DR SAM BARNETT HANDICAP – 1400 metres

DOUBLE POCKETS (E. Finnegan) – inconvenienced at the start. Rider reported the gelding pulled hard in the early stages, made the turn near the 1000 metres wide and as a consequence she was unable to obtain cover and raced wide without cover for some distance. A post-race veterinary examination revealed no visible abnormalities. Lost its near fore plate during the event.

GALAXY GAZER (J. Holder) – a post-race veterinary examination revealed the gelding was galloped on, on the off hind leg. First aid was administered.

BEAU'S MY BOY (Z. Spain) – in the vicinity of the 1100 metres shifted in and tightened **IMPORTANT** for several strides resulting in that gelding being obliged to race in restricted room. Rider reprimanded and advised to take greater care when shifting ground in future. A post-race veterinary examination revealed no visible abnormalities. Sprung its off fore plate during the event.

TABLEAUX (E. Boyd) - a post-race veterinary examination revealed no visible abnormalities.

MIO DIO (J. Bayliss) – inconvenienced near the 1000 metres.

KAZOOM (NZ) (S. Cahill) – inconvenienced at the start. Raced fiercely in the early stages of the event and approaching the 1000 metres became very awkwardly placed on the heels of **GALAXY GAZER**, shifted in slightly when being restrained and inconvenienced **MIO DIO**. Trainer advised a warning had been placed on the gelding in relation to its racing manners.

IMPORTANT (J. Bowditch) – in the vicinity of the 1100 metres raced in restricted room for several strides and thereafter in the vicinity of the 700 metres became awkward on the heels of **MUNICIPALITY** for several strides and raced in restricted room. In the vicinity of the 200 metres was obliged to be steadied to avoid the heels of **SHARKPEACE**, which shifted out to improve.

SILENT ICE (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

SHARKPEACE (R. Hurdle) - jumped away awkwardly, shifted out and tightened **KAZOOM (NZ)**, which was taken out onto **DOUBLE POCKETS** inconveniencing both these runners. Shifted out near the 200 metres to improve and crossed the running of **IMPORTANT**, which had to be steadied. Rider reprimanded and advised to take greater care when shifting ground in future. Rider pleaded guilty to a charge under AR83(a) for misconduct, the particulars being, that after weighing in for this event and after leaving the scales area, he caused damage to one of the walls in the male jockey's room by striking the wall with his riding helmet and was fined \$250. He was also ordered to pay for the cost of the repair to the wall.

RACE 6 : DR SAM BARNETT HANDICAP – 1400 metres (Cont'd)

Correct weight for this event was delayed to allow J. Holder (GALAXY GAZER) placed third and Co-Trainers Mr L. Macdonald & Mr A. Gluyas to view the vision in the vicinity of the 800 metres.

RACE 7 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1400 metres

EXCITES ZELADY (E. Finnegan) – rider reported in her opinion the pace in the early and middle stages of the event did not suit her mount. A post-race veterinary examination revealed no visible abnormalities.

SISTINE DEMON (J. Kah) - a post-race veterinary examination revealed no visible abnormalities.

ROYAL RUMBLE (C. Lindop) – over-raced and was ungenerous for a short distance inside the 800 metres.

OUR EXCHANGE (M. Poon) – Trainer Mr R. Jolly advised Stewards prior to the event he would instruct his rider to attempt to settle back of mid-field with cover.

OUTLANDISH LAD (E. Boyd) – awkward to begin.

ORIENT LINE (J. Bayliss) - over-raced in the early stages of the event and approaching the 800 metres raced ungenerously and became very awkward on the heels of FLOW METER for several strides. A post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow J. Holder (SANDHILL WARRIOR) placed third to view the vision in the straight.

RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres

The start of this event was delayed approximately one minute.

I BOUGHT A HORSE (D. Caboche) – contacted at the start and had its hindquarters turned.

FORCE OF THREE (R. Hurdle) – kicked by another runner on arrival at the barriers. Examined by the Clubs veterinary Surgeon and was declared a late scratching at 5.12 pm by order of Stewards acting on Veterinary advice that the gelding was unfit to start.

ONE MORE DAISY (E. Boyd) – shifted in at the entrance of the straight onto BROWN BEN, which was tightened onto ARKHAM KNIGHT resulting in BROWN BEN having to be checked losing its position. Rider pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 1 October and to conclude at midnight on Saturday, 8 October 2016 : a period of (4) meetings.

BROWN BEN (D. Thornton) – obliged to be checked at the entrance to the straight and lost its position.

ROUGHLY (J. Payne) - a post-race veterinary examination revealed the mare to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

SPACE TIME (Z. Spain) – rider reported the gelding over-raced during the event. Rolled in approaching the 200 metres.

ARKHAM KNIGHT (J. Toeroek) – jumped away awkwardly, shifted out and shortly thereafter shifted in abruptly and contacted the hindquarters of I BOUGHT A HORSE, and was then obliged to race in restricted room for a number of strides.

TEMPTING FAITH (E. Finnegan) – approaching the 200 metres rolled out and was obliged to be steadied off the heels of SPACE TIME, which rolled in slightly.

RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres (Cont'd)

MOSTLY (M. Neilson) – Mr B. Hayes, acting on behalf of the training partnership advised Stewards prior to the event that he would instruct his rider to attempt to settle back of mid-field with cover. Over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.
