RACE 1 : DON WRAY / SABOIS MAIDEN PLATE - 1430 metres

MOON ARROW (E. Finnegan) – slow to begin. From the entrance of the straight for the remainder of the event, shifted in under pressure. In the vicinity of the 100 metres continued to shift in under pressure inconveniencing NO NO NELL. Rider reprimanded under AR137(a) for careless riding.

NO NO NELL (Z. Spain) – slow to begin. In the vicinity of the 100 metres, was inconvenienced when MOON ARROW shifted in under pressure.

SET TO SURPRISE (D. Caboche) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 2 : PETER LUDWIG / SABOIS MAIDEN PLATE – 1000 metres

The start of this race was delayed approximately two minutes owing to MANNION dislodging E. Finnegan en-route to the barriers and having to be recaptured.

MANNION (E. Finnegan) – dislodged rider en-route to the barriers and galloped for a short distance before being recaptured. E. Finnegan was examined by the First Care Medical personnel and passed fit to fulfil her remaining engagements. MANNION examined by the Club's Veterinary Surgeon on arrival at the barriers and passed fit to start. Trainer, Mrs S. Jaensch was advised a warning had been placed on the gelding in relation to its pre-race manners. A post-race veterinary examination revealed no visible abnormalities.

SORDIDUS (A. Jordsjo) – slow to begin.

TRUE LIBERTY (E. Boyd) – rider reported the gelding felt awkward in its action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

KIRJO'S GIRL (M. Poon) – slow to begin.

RACE 3 : BOB MCKAY / SABOIS MAIDEN PLATE - 1200 metres

HANLON TIGER (J. Potter) – performed below expectation. A post-race veterinary examination revealed no visible abnormalities.

THAI CONNECTION (J. Frew) – slow to begin. Inclined to lay out under pressure in the straight. Rider found guilty of a charge under AR137(b) for failing to ride his mount out to the finish of the race and severely reprimanded.

GAMBLER'S GIRL (R. Hurdle) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : BOB ATKINSON BENCHMARK 56 HANDICAP - 1430 metres

ACCLAIMED CHAOS (J. Maund) – eased out of the event in the vicinity of the 600 metres. Rider could offer no explanation in regards to its poor performance. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr R. Daniel, was advised that the gelding would be required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to accepting for a future race.

CAMERON ROAD (Z. Spain) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

TROUBLED GLASS (E. Finnegan) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

FICKLE TIME (K. Bishop) – slow to begin.

RACE 5 : COLIN RICHARDSON BENCHMARK 64 HANDICAP - 1430 metres

MOOSEM (J. Frew) – slow into stride. Shortly after the start was momentarily inconvenienced when HASTA LA GORBY jumped away awkwardly and shifted out and BLACKTEIN jumped away awkwardly and shifted in.

JESTWIN (Z. Spain) – laid in under pressure over the concluding stages.

HASTA LA GORBY (H. McKechnie) – jumped away awkwardly and shifted out.

BLACKTEIN (D. Thornton) – jumped away awkwardly and shifted in.

RACE 6 : NEVILLE MARTIN BENCHMARK 80 HANDICAP - 1200 metres

LEAD THE WITNESS (Z. Spain) -slow to begin. Laid out under pressure in the straight.

BELARUSKI (D. Tourneur) - jumped away awkwardly and shifted out bumping NORTH BEACH.

HELANDY (E. Finnegan) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

NORTH BEACH (J. Potter) - bumped on jumping away.

RACE 7: NRC AGM 26TH OCTOBER BENCHMARK 64 HANDICAP - 2000 metres

BELLE OF THE SOUTH (Jemma Frew) – adjourned inquiry to a time and date to be determined in regards to whip use on this mare.

CENTRE DIVIDER (E. Boyd) – raced ungenerously in the early and middle stages of the event.

DUQUESSA (H. McKechnie) - slow to begin.

RACE 8: WRATTONBULLY RACE DAY NOVEMBER 18 BENCHMARK 56 HANDICAP - 1200 metres

KOSMOS TERCEDES (Jemma Frew) adjourned inquiry to a time and date to be determined in regards to whip use on this mare.

CAMILLUS (USA) (J. Benbow) – acting on confirmed advice from Trainer Ms A McDonald that the gelding was lame in the near foreleg, Stewards withdrew CAMILLUS (USA) at 1.02 pm.
